1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÁHAN:***

3           **WHEREAS**, the Committee on Rules has oversight of the business, budget, and  
4 activities of *I Liheslaturan Guáhan* (the Guam Legislature); and

5           **WHEREAS**, in order to effectively and efficiently disburse funds from *I*  
6 *Liheslatura*, *I Liheslatura* maintains checking and savings accounts in a local bank; and

1           **WHEREAS**, the bank requires signatures to disburse funds via checks,  
2 withdrawals, and or transfers; and

3           **WHEREAS**, to safely and effectively disburse checks, withdrawals, and  
4 transfers, and to ensure a system of checks and balances, it is recommended that two  
5 (2) signatures appear on all checks, withdrawals, and transfers; and

6           **WHEREAS**, currently the Executive Director of *I Liheslaturan Guåhan* is  
7 tasked with the duty to disburse legislative funds; now therefore, be it

8           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*  
9 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan*, designate and  
10 authorize any two (2) of the following individuals to sign checks, withdrawals, and fund  
11 transfers for all the bank accounts of *I Mina'Trentai Tres Na Liheslaturan Guåhan*: the  
12 Speaker, the Chairperson of the Committee on Rules/Majority Leader, the Assistant  
13 Majority Leader, and the Executive Director; and be it further

14           **RESOLVED**, that the Executive Director of *I Liheslaturan Guåhan* shall ensure  
15 that all banks maintaining *I Liheslaturan Guåhan* accounts are duly notified, and that  
16 all signature cards are amended to reflect the two (2) signatures required; and be it  
17 further

18           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
19 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of  
20 the same be thereafter transmitted to the Members of the Committee on Rules of *I*  
21 *Mina'Trentai Tres Na Liheslaturan Guåhan*; to the Honorable Judith T. Won Pat, Ed.D.,  
22 Speaker of *I Mina'Trentai Tres Na Liheslaturan Guåhan*; to the Honorable Benjamin  
23 J.F. Cruz, Vice-Speaker of *I Mina'Trentai Tres Na Liheslaturan Guåhan*; to all other  
24 Members of *I Mina'Trentai Tres Na Liheslaturan Guåhan*; to Vincent P. Arriola,


