1 **BE IT RESOLVED BY *I MINA'TRENTAI TRES NA LIHESLATURAN***

2 ***GUÅHAN*:**

3 **WHEREAS, *I Mina'Trentai Tres Na Liheslaturan Guåhan Otden***

4 ***Areklamento* (the Thirty-Third Guam Legislature Standing Rules) establishes the**

5 **rules and procedures of *I Mina'Trentai Tres Na Liheslaturan Guåhan*; and**

1           **WHEREAS**, the Standing Rules were duly adopted by lawmakers on  
2 January 5, 2015; and

3           **WHEREAS**, it is the will of *I Liheslaturan Guåhan* (the Guam Legislature)  
4 that all of the members of *I Mina'Trentai Tres Na Liheslaturan Guåhan* be able to  
5 take part in such significant matters of the body relative to the introduction and  
6 timely public hearing of all bills by all sponsors; and


7           **WHEREAS**, *I Mina'Trentai Tres Na Liheslaturan Guåhan* desires to ensure  
8 the public's access to a timely public hearing within one hundred twenty (120)  
9 days of introduction on all bills, now therefore, be it

10          **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does  
11 hereby *amend* the Standing Rules - Part B, Rule VI, Section 6.01 (a)(1), by *adding*  
12 a new Subsection (a)(1)(i) to read: "(i) All bills introduced by a Member or a  
13 Committee *shall* be given a public hearing *no more than* one hundred twenty (120)  
14 days after the date of the bill's introduction. If the Committee to which the bill has  
15 been referred does not hold a public hearing within the one hundred twenty (120)  
16 day timeline, the Committee Chairperson *shall* give a reason in writing to the  
17 prime sponsor for not holding a public hearing. The prime sponsor may call and  
18 preside over a public hearing on such bill and report out such bill directly to the  
19 Committee on Rules."; and be it further

20          **RESOLVED**, that *I Mina'Trentai Tres Na Liheslaturan Guåhan* does  
21 hereby *amend* Standing Rules - Part B, Rule VI, Section 6.01 (a)(1), by *adding* a  
22 new Subsection (a)(1)(ii) to read: "(ii) Bills introduced prior to the adoption of  
23 Subsection (a)(1)(i) of this Section 6.01(a)(1) relative to the one hundred twenty  
24 (120) day rule, *shall* be considered eligible in calculating this timeline."; and be it  
25 further

1           **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest  
2 to, the adoption hereof, and that copies of the same be thereafter transmitted to all  
3 Members of *I Mina'Trentai Tres Na Liheslaturan Guåhan*; and to the Honorable  
4 Edward J.B. Calvo, *I Maga'låhen Guåhan*.


