Relative to amending *I Mina'Trentai Kuattro Na Liheslaturan Guahan Otden Areklamento* (the Thirty-Fourth Guam Legislature Standing Rules) to honor the fallen war heroes of Guam by recognizing the name of a recipient of *I Milåyan Mås Takhilo' Na Sakrafisu* at the beginning of every session.

1           **BE IT RESOLVED BY *I MINA'TRENTAI KUATTRO NA***  
2 ***LIESLATURAN GUAHAN*:**

3           **WHEREAS,** *I Mina'Trentai Kuattro Na Liheslaturan Guahan Otden*  
4 *Areklamento* (the Thirty-fourth Guam Legislature Standing Rules) establishes the  
5 rules and procedures of *I Mina'Trentai Kuattro Na Liheslaturan Guahan*; and

6           **WHEREAS,** the Standing Rules were duly adopted by lawmakers on January  
7 2, 2017; and

8           **WHEREAS,** it is the will of *I Liheslaturan Guahan* (The Guam Legislature)  
9 to recognize the island's fallen heroes and the sacrifices they made to protect our  
10 freedom and defend our country at the beginning of each legislative session; and

1           **WHEREAS**, Part A, Rule I, Section 1.02 (c) outlines the Daily Order of  
2 Business during session; and now therefore be it

3           **RESOLVED**, that *I Mina'Trentai Kuattro Na Liheslaturan Guahan* hereby  
4 *amend* the Standing Rules - Part A, Rule I, Section 1.02 (c)(vi) to read:

5           “(c) **Daily Order of Business.** Unless some other order is adopted by the  
6 Committee on Rules or the Body, the Daily Order of Business of I Liheslaturan  
7 Guahan shall be as follows:

8                   **(i) Call to Order;**

9                   **(ii) Prayer;**

10                   **(iii) Recognition of a Recipient of I Milayan Mâs Takhilo' Na**  
11 **Sakrafisu;**

12                   **(iiiy) Reciting of Inifresi;**

13                   **(iv) Singing of Guam Hymn in Chamorro;**

14                   **(v) Singing of National Anthem;**

15                   **(vi) Roll Call;**

16                   **(vii) Call for Approval of Legislative Journal;**

17                   **(viii ix) Communications and Petitions;**

18                   **(ix) Messages from I Maga'lahen Guahan;**

19                   **(x) Reports of Standing Committees;**

20                   **(xi) Reports of Select Committees;**

21                   **(xii) Introduction and First Reading of Bills and Resolutions;**

22                   **(xiiiy) Motions;**

23                   **(xiv) Legislative Concurrence;**

24                   **(xv) Consent Calendar;**

25                   **(xvi) Second Reading File;**

26                   **(xvii) Consideration of Daily File:**

27                   (1) Third Reading File; and

1 (2) Voting File;

2 **(xviii) Brief Extension of Remarks (limited to five (5) minutes per**  
3 **Member);**

4 **(xix) Announcements; and**

5 **(xxi) Adjournment.**

6 **(1) Suspend Order of Business.** The Committee on Rules may  
7 suspend consideration of any order of business on a Session Agenda or  
8 change the order of business for that Legislative Day, or the next  
9 Legislative Day only, except that consideration of the Daily File may  
10 not be so suspended.

11 **(2) Committee on Rules Shall Set Session Agenda.** The  
12 Committee on Rules, or its authorized Subcommittee, may adopt a  
13 Session Agenda for the next Legislative Day of I Liheslaturan Guáhan  
14 and may add items to be considered under the various categories in the  
15 Daily Order of Business. Notice of a Session Agenda so adopted shall  
16 be published on I Liheslaturan Guáhan's official website within twenty-  
17 four (24) hours of its adoption.

18 **(A) Special Session Agenda.** No bill or resolution may be  
19 introduced, or placed on the Special Session agenda, at any  
20 Special Session called by I Maga'láhen Guáhan, unless it relates  
21 to the subject matter of the call of the Special Session. The rules,  
22 which apply to Regular Sessions, shall apply to Special Sessions  
23 to the extent that they do not conflict with the Organic Act  
24 provision requiring the body only address the legislation  
25 provided by I Maga'láhen Guáhan. A Regular Session may not  
26 be conducted during a Special Session or a recess thereof.

1                   **(B) No Session Agenda.** In the absence of a Session  
2                   Agenda adopted by the Committee on Rules, *I Liheslaturan*  
3                   *Guåhan*, by eight (8) votes, may adopt a Session Agenda or order  
4                   consideration of any order of business on the Session Agenda  
5                   with eight (8) votes, or change the order of business for that  
6                   particular Legislative Day with eight (8) votes, except that  
7                   consideration of the Daily File may not be so suspended. In the  
8                   absence of an agenda, the Session Agenda previously adopted  
9                   shall be the agenda for the following session.

10                   **(3) Hours of Session.** Convening of Sessions and continuation  
11                   of Session meetings shall be after 7:00 a.m. each calendar day, and each  
12                   Session shall be recessed or adjourned on each calendar day no later  
13                   than 10:00 p.m., taking into account finishing the immediate matter at  
14                   hand on the Floor at that hour.”; and be it further

15                   **RESOLVED**, that the following statement be read during the Recognition of  
16                   a Recipient of *I Milåyan Mås Takhilo ' Na Sakrafisu*: “On behalf of a grateful island  
17                   and country, we honor [name] and the family of [name] for the making the ultimate  
18                   sacrifice in service and defense of our island and country.”, and be it further

19                   **RESOLVED**, that the Executive Director of *I Liheslaturan Guåhan* in  
20                   consultation with the Speaker of *I Liheslaturan Guåhan* place the *I Milåyan Mås*  
21                   *Takhilo ' Na Sakrafisu* Roll conspicuously within the Guam Congress Building; and  
22                   be it further

23                   **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,  
24                   the adoption hereof, and that copies of the same be thereafter transmitted to all  
25                   Members of *I Mina 'Trentai Kuåttro Na Liheslaturan Guåhan*; and to the Honorable  
26                   Edward J.B. Calvo, *I Maga 'låhen Guåhan*.
