**BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI KUATRO NA LIHESLATURAN GUÁHAN*:**

**WHEREAS**, Cyle John is a Team Leader of the JeepTour/ Landscaping Department. He leads a team of about 30 team members to care for the Leo Palace Farm, the Leo Palace Jeep Tours and overall landscape at LeoPalace. His day to day operations include bringing guest on sightseeing Jeep tour of the LeoPalace waterfall, the World War II tank and the LeoPalace Farm. When visiting these areas, they incorporate the Chamorro language by teaching guests the Chamorro names, while they harvest and taste the different fruits; and

**WHEREAS**, on July 18, 2016, Cyle John was very instrumental in reviving a guest, Ms. Kimiko Maruyama, who collapsed while on tour of the resort; and

**WHEREAS**, Cyle John observed what was happening and immediately went to Ms. Kimiko Maruyama's aid and caught her in time to prevent from falling down the steps; and

**WHEREAS**, applying his knowledge of First Aid and CPR, he was able to revive her even before paramedics arrived. They closely monitored her condition and ensured that she was comfortable while they patiently waited for the emergency responders; and

**WHEREAS**, Mr. Reye's prompt action is highly commendable and worthy of recognition. It showcased his dedication to his job and his willingness to help and save lives. Ms. Maruyama's family definitely changed their perception about Guam and its people. Ms. Kimiko Maruyama stated she will be forever grateful to Mr. Calvo; and

**WHEREAS**, Mr. Reyes is also a part of the LeoPalace Landscaping team that was recognized in the Guam Pacific Daily News in March of 2015 for helping to control and possibly eradicate the Rhinoceros Beetle that is destroying Guam's coconut trees; now therefore be it
