WHEREAS, the Committee on Ethics and Standards is a Standing Committee of *I Liheslaturan Guåhan* tasked with the duty of investigating any alleged violation of the Code of Ethics and Standards committed by a Senator or employee of *I Liheslatura*; and

WHEREAS, an allocation of Five Thousand Dollars (\$5,000) was allocated to the Committee through Resolution No. 134-34 (COR); and

WHEREAS, the Committee on Ethics and Standards requires an additional allotment of Fifteen Thousand Dollars (\$15,000.00) to exercise its powers and perform the duties granted to it; now, therefore be it

RESOLVED, that the Committee on Legislative Operations of *I Mina' Trentai Kuåttro Na Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan*, allocate an additional Fifteen Thousand Dollars (\$15,000.00) over what was previously allocated through Resolution No. 134-34, from the Central Operations Fund to the Committee on Ethics and Standards; and be it further

RESOLVED, any unexpended balance remaining in the Committee's budget *shall* be returned by the Committee on Ethics and Standards to Central Operations at the resolution of the current case before the Committee; and be it further,

RESOLVED, that the Speaker and the Chairperson of the Committee on Legislative Operations certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of the same be thereafter transmitted to Senator Fernando Barcinas Esteves, Chairperson of the Committee on Ethics and Standards of *I Mina' Trentai Kuåttro Na Liheslaturan Guåhan*; to the Members of the Committee on Legislative Operations of *I Mina' Trentai Kuåttro Na Liheslaturan Guåhan*; to the Honorable Benjamin J.F. Cruz, Speaker of *I Mina' Trentai Kuåttro Na Liheslaturan Guåhan*; and to Jermaine Alerta, Executive Director of *I Liheslaturan Guåhan*.
