1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF**  
2 ***I MINA'TRENTAI KUÁTTRO NA LIHESLATURAN GUÁHAN:***  
3           **WHEREAS,** Lions Clubs International club Twinning fosters friendship  
4 and understanding by linking clubs across international borders. Two clubs from  
5 two different countries enter a formal agreement of friendship and cooperation,  
6 working together on mutual mission statements, organizing identical service  
7 projects in their respective local communities and even traveling together to  
8 another location in need of service that Lions can provide. Whenever possible, club  
9 members are encouraged to visit their twin club's location, attend meetings and  
10 stay in the homes of Lions from their twin club; and

1           **WHEREAS**, this Twinning establishes a relationship between two District  
2 Club chapters in different countries and promotes a “sister-sister” relationship with  
3 the objectives of the exchange of personal visits, ideas, projects and culture; and

4           **WHEREAS**, on August 25, 2017, a milestone of Twinning clubs will be  
5 enacted and celebrated by Guam’s Lions Club International District 204 and the  
6 Lions Club International District 354-H of South Korea; and

7           **WHEREAS**, the mission and goal of the Guam-South Korea Twinning is  
8 with the earnest of intentions and a sincere desire to establish cordial and closer  
9 relationships for greater cooperation and to advance a true spirit of global  
10 brotherhood among Lions and men; and
