Relative to amending Subsections (a), (b), (b)(4), and (c)(1) of Section 17.05 of I Mina'Trentai Kuåttro Na Liheslaturan Guåhan Otden Areklamento, the 34th Guam Legislature Standing Rules, to increase the operative procurement amount from Ten Thousand Dollars (\$10,000) to Twenty-five Thousand Dollars (\$25,000) for supplies and services, and One Hundred Thousand Dollars (\$100,000) for construction related projects.

- BE IT RESOLVED BY THE COMMITTEE ON RULES OF I

1	WHEREAS, I Mina'Trentai Kuåttro Na Liheslaturan Guåhan Otden						
2	Areklamento, the 34th Guam Legislature Standing Rules, establishes the rules and						
3	procedures of I Mina'Trentai Kuåttro Na Liheslaturan Guåhan; and						
4	WHEREAS, the Standing Rules were duly adopted in January 2017; and						
5	WHEREAS, Public Law 34-35, enacted into law in August 2017, increase						
6	the small purchase amount in local procurement law from Ten Thousand Dollars						
7	(\$10,000) to Twenty-five Thousand Dollars (\$25,000) for supplies and services, and						
8	One Hundred Thousand Dollars (\$100,000) for construction; and						
9	WHEREAS, it is the will of I Liheslatura that the operative procurement						
10	amount in the Standing Rules likewise be increased from Ten Thousand Dollars						
11	(\$10,000) to Twenty-five Thousand Dollars (\$25,000) for supplies and services; and						
12	the amount for construction related matters not exceed One Hundred Thousand						
13	Dollars (\$100,000); and						
14	WHEREAS, I Liheslatura desires to ensure greater efficiency with respect to						
15	the conduct of its business; now therefore, be it						
16	RESOLVED, that the Committee on Rules of I Mina'Trentai Kuåttro Na						
17	Liheslaturan Guåhan does hereby amend Standing Rule Part E, Rule XVII, by						
18	hereby adopting and amending Subsections (a), (b), (b)(4), and (c)(1) of Section						
19	17.05, as follows:						
20	"(a) Sealed Bids. Procurement by sealed bid is optional for any						
21	purchase at the discretion of the Purchasing Agent and the Procurement						
22	Officer, but it is mandatory where the total cost is Ten Twenty-five Thousand						
23	Dollars (\$1025,000) or more for supplies and services, and One Hundred						
24	Thousand Dollars (\$100,000) or more for construction related projects, except						
25	as otherwise provided."						

"(b) Open Market Procedure. Procurement on the open market is authorized when the cost is *less than* Ten Twenty-five Thousand Dollars (\$1025,000) for supplies and services, and One Hundred Thousand Dollars (\$100,000) for construction related projects, subject to the following:"

"(4) Two Thousand Five Hundred Dollars (\$2,500) or More, But Less Than Ten Twenty-five Thousand Dollars (\$1025,000) for Supplies and Services, and One Hundred Thousand Dollars (\$100,000) for Construction Related Projects. Where the cost is Two Thousand Five Hundred Dollars (\$2,500) or more, but less than Ten Twenty-five Thousand Dollars (\$1025,000) for supplies and services, and One Hundred Thousand Dollars (\$100,000) for construction related projects, procurement may be made by solicitation of not less than three (3) informal written quotations on the open market of which a written record shall be kept, except that the Procurement Officer with the concurrence of the Purchasing Agent may dispense with such quotations and negotiate directly with a vendor when, in the opinion of the Chairperson of the Committee on Rules, it is deemed more advantageous to I Liheslaturan Guåhan."

"(1) Exceptions to Requirements for Sealed Bids. Where the total cost is Ten Twenty-five Thousand Dollars (\$1025,000) or more for supplies and services, and One Hundred Thousand Dollars (\$100,000) for construction related services, exception to the requirement for a sealed bid is authorized only where at least one (1) of the following conditions exists, and the Purchasing Agent certifies this exception in writing:"; and be it further

RESOLVED, that the Speaker and the Chairperson of the Committee on Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that
