2 detailed to the Technical Research & Appeals Bureau (TRAB) as a Research
3 Appeals Officer; and

4 **WHEREAS**, In August of 2000 to April of 2001, Mr. Herbert S. Fukuda was
5 reassigned back as a Revenue Agent III in the Examination Branch; and

6 **WHEREAS**, April of 2001, Mr. Herbert S. Fukuda again detailed as a
7 Research Appeals Officer in the Tech Research & Appeals Bureau (TRAB). Then
8 on October of 2001, was promoted to the Technical Research & Appeals Bureau
9 (TRAB) as a Research Appeals Officer through February of 2004; and

10 **WHEREAS**, On February of 2004, Mr. Herbert S. Fukuda was detail to the
11 Tax Examination Branch as a Tax Examination Supervisor. And subsequently the
12 promoted to the Tax Examination Supervisor, on December of 2008; and

13 **WHEREAS**, Mr. Herbert S. Fukuda career has an impressive profile at the
14 department. He was able to secure various positions that demanded commitment
15 needed to help the government of Guam and its people. Some of the positions
16 included detail to the Tax Enforcement Administrator on December 2008. He

18 June of 2012 to December of 2017; and
