4 **WHEREAS**, Eddie Baza Calvo, *I Maga'lahaen Guahan* (Governor of Guam)
5 filed a Petition for Writ of Mandamus against *I Liheslaturan Guahan* (the Guam
6 Legislature) with the Supreme Court of Guam on January 22, 2018; and

7 **WHEREAS**, responding to such litigation exceeds the scope of the *I*
8 *Liheslatura's* existing contract for legal services; and

9 **WHEREAS**, such litigation now requires the execution of a new Legal
10 Services Agreement for the aforementioned litigation; now, therefore, be it

11 **RESOLVED**, that *I Mina' Trentai Kuattro Na Liheslaturan Guahan* shall
12 retain the Legislative Counsel to represent the Legislature in the aforementioned
13 lawsuit; and be it further

14 **RESOLVED**, that the sum of Fifteen Thousand Dollars (\$15,000) shall be
15 expended from *I Liheslaturan Guahan's* Central Operations Fund for this matter.
16 Any expenditure greater than Fifteen Thousand Dollars (\$15,000) shall require the
17 approval of the Committee on Legislative Operations; and be it further
