3 **WHEREAS**, Fr. Jonathan Caldeo Alvarez was born on September 26, 1969  
4 to his loving parents, +Jose B. Alvarez and +Shirley C. Alvarez; and

5 **WHEREAS**, Fr. Jonathan is blessed with the love and care of his siblings,  
6 Julie A. Daquiog and Josephine Alvarez; and

7 **WHEREAS**, Fr. Jonathan answered God's call to serve His people and was  
8 ordained in the Sacrament of Holy Orders on October 23, 1997; and

9 **WHEREAS**, Fr. Jonathan's vocation in the Holy Priesthood is not limited to  
10 pastoral duties in the parish as he also serves as a Canon Lawyer for the Catholic  
11 Church and attains a *Juris Canonici Licentia* or JCL; and

12 **WHEREAS**, Fr. Jonathan's JCL is an advanced graduate degree with  
13 canonical effects in the Roman Catholic Church offered pontifical universities and

1 ecclesiastical faculties of Canon Law. Through his JCL, Fr. Jonathan's additional  
2 contributions to the Archdiocese of Agana as Metropolitan Tribunal, Defender of  
3 the Bond; and

5 Philippines and Guam since his ordination. He was assigned to serve as Parochial  
6 Vicar of Our Lady of Mount Carmel in Roxas City from 1997 to 2002; and Dean  
7 of Theology at College de la Purisima Concepcion in Roxas City from 2002 to  
8 April 2007. That year, he was assigned to serve God's faithful in Guam at Our  
9 Lady of Lourdes Catholic Church, Yigo, as Parochial Vicar from April 12, 2007 to  
10 July 31, 2012; Administrator from August 1, 2012 to August 26, 2012; and finally,  
11 Pastor from August 27, 2012 to July 1, 2018; and

12 **WHEREAS**, Fr. Jonathan will be leaving the Yigo community as he has  
13 been given a new assignment as Pastor of *Niño Perdido-Sagrâda I Familia* Parish  
14 in Asan effective July 3, 2018; and

15 **WHEREAS**, the Catholic community of Our Lady of Lourdes will greatly  
16 miss Fr. Jonathan community; and

17 **WHEREAS**, the people of Yigo will greatly miss Fr. Jonathan and offer
