1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI KUÁTTRO NA LIHESLATURAN GUÁHAN:***

3 **WHEREAS, *I Mina'Trentai Kuáttro Na Liheslaturan Guáhan Otden Areklamento***
4 **(the Thirty-Fourth Guam Legislature Standing Rules) establishes the rules and procedures**
5 **of *I Mina'Trentai Kuáttro Na Liheslaturan Guáhan;* and**

6 **WHEREAS, the Standing Rules were duly adopted by lawmakers on January 2,**
7 **2017; and**

8 **WHEREAS, the Committee on Rules was formally notified of a permanent vacancy**
9 **existing in the Chairmanship of the Committee on Appropriations and Adjudication,**
10 **effective 2:00 PM on September 7, 2018; and**

1 **WHEREAS**, Rule II Section 2.09(a) of the Standing Rules of the 34th Guam
2 Legislature states in relevant part: “If a permanent vacancy occurs in the position of
3 Chairperson of a Standing Committee, the Speaker *shall* reorganize, eliminate or reassign
4 to other Standing Committees the duties, functions and budget of the Committee in
5 question, at the Speaker’s option with the majority vote of the Committee on Rules”; and

6 **WHEREAS**, the Speaker has determined that the Committee on Appropriations and
7 Adjudication shall be chaired by Senator Thomas C. Ada, in which shall be vested all duties
8 and powers, in accordance with Rule X Section 10.02(c) of the Standing Rules; now
9 therefore, be it

10 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Kuáttro Na*
11 *Liheslaturan Guáhan* does hereby adopt the reassignment of the duties and responsibilities
12 of the Committee on Appropriations and Adjudication, as recommended by the Speaker,
13 to Senator Thomas C. Ada, effective immediately; and be it further

14 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to, the
15 adoption hereof, and that copies of the same be thereafter transmitted to all Members of *I*
16 *Mina'Trentai Kuáttro Na Liheslaturan Guáhan*.
