4 **WHEREAS,** Corrections Officer III Joseph Untalan Pangelinan hails from
5 Agana Heights and is a graduate of George Washington High School; and

6 **WHEREAS,** Corrections Officer III Joseph Untalan Pangelinan and his wife
7 Marie Pangelinan are blessed with five children; and

8 **WHEREAS,** on June 20, 1983, COIII Joseph U. Pangelinan began his
9 government service career with the Department of Corrections; and

10 **WHEREAS,** On August 08, 1988, Corrections Officer III Joseph Untalan
11 Pangelinan was promoted from Corrections Officer I to Corrections Officer III; and

12 **WHEREAS,** over the course of his career with the Department of
13 Corrections, Corrections Officer III Joseph Untalan Pangelinan was assigned to
14 various units including the Adult Correctional Facility and the Community
15 Corrections Center, which houses inmates on Work Release, Work Credit and
16 Education Release; and

17 **WHEREAS**, Corrections Officer III Joseph Untalan Pangelinan served the
18 Department in various capacities including membership in the Adjustment and
19 Classification Committee, the Disciplinary Board, and the Labor Day Committee; and

20 **WHEREAS**, Corrections Officer III Joseph Untalan Pangelinan is well known
21 by both inmates and staff for his strict enforcement of Departmental Rules and
22 Regulations which he exercised in his supervision of subordinates and inmates; and

23 **WHEREAS**, Corrections Officer III Joseph Untalan Pangelinan well and
24 faithfully performed his duties and responsibilities despite receiving death threats and
25 having his car burned by an inmate in the facility parking lot; and

26 **WHEREAS**, on September 28, 2018, after thirty five years, two months and
27 nineteen days, Corrections Officer III Joseph Untalan Pangelinan's will retire from
28 Government of Guam service with the Department of Corrections; and

29 **WHEREAS**, *I Liheslaturan Guåhan* is cognizant that the job of a Corrections
30 Officer is among the most difficult and challenging in government service and that the
31 people of Guam owe a debt of gratitude to those in this profession for their
32 commitment and dedication in keeping us safe from criminals. Now therefore,
33 be it

34 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Kuåttro Na*
35 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
36 of Guam, recognizes and commends Corrections Officer III Joseph Untalan
37 Pangelinan for his many years of service to the people of Guam and congratulates him
38 on the occasion of his retirement from the Department of Corrections; and be further

39 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
40 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
41 the same be thereafter transmitted to Corrections Officer III Joseph Untalan
