




1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**

4 **WHEREAS,** Corrections Officer III Richard C. Dahill was born and raised in
5 Cuba, New York and graduated from Friendship Central School in Friendship, New
6 York in 1982; and

7 **WHEREAS,** in 1984, Corrections Officer III Richard C. Dahill joined the Air
8 Force as a Firefighter in Oklahoma; and

9 **WHEREAS,** while on the flight on his way to relocate to Guam, Corrections
10 Officer III Richard C. Dahill met his future wife and on March 09, 1985 he and Betty
11 L. Taimanglo married; and

12 **WHEREAS,** Corrections Officer III Richard C. Dahill and his wife Betty
13 have one daughter, Sonya M.T. Dahill who resides with them in the family home in
14 Malojlo; and

15 **WHEREAS,** Corrections Officer III Richard C. Dahill began his career with
16 the Department of Corrections in November of 1985 when he was hired on as a

17 Corrections Officer I as a Temporary Appointment, a position which became
18 permanent on May 12, 1986; and

19 **WHEREAS,** Corrections Officer III Richard C. Dahill was promoted to
20 Corrections Officer II on September 10, 1989, and on March 16, 2006, he was
21 promoted to Corrections Officer III; and

22 **WHEREAS,** over the course of his career, Corrections Officer III Richard C.
23 Dahill was assigned to the Adjustment and Classification Committee, the Disciplinary
24 Hearing Board, the Residential Substance Abuse Treatment Unit and to various other
25 units within the Department of Corrections as Officer in Charge; and

26 **WHEREAS,** Corrections Officer III Richard C. Dahill was also assigned as
27 the Unit Manager for Post 6 Special Housing Unit and currently holds the position of
28 Unit Manager for Post 17 and Officer in Charge of the library; and

29 **WHEREAS,** on September 28, 2018, after thirty two years, nine months and
30 twenty-eight days, Corrections Officer III Joseph Richard C. Dahill will retire from
31 Government of Guam service with the Department of Corrections; and

32 **WHEREAS,** *I Liheslaturan Guåhan* is aware that the position of Corrections
33 Officer is one of the least recognized but most important jobs in our criminal justice
34 system and that it takes a high level of professionalism and dedication to face daily the
35 stress and danger of a corrections facility. Now therefore, be it

36 **RESOLVED,** that the Committee on Rules of *I Mina'Trentai Kuåttro Na*
37 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
38 of Guam, recognizes and commends Corrections Officer III Richard C. Dahill for his
39 many years of service to the people of Guam and congratulates him on the occasion of
40 his retirement from the Department of Corrections; and be further

41 **RESOLVED,** that the Speaker and the Chairperson of the Committee on Rules
42 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of

43 the same be thereafter transmitted to Corrections Officer III Richard C. Dahill and to
44 Honorable Edward J.B. Calvo, *I Maga'låhen Guåhan*.
