1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF**

2 *I MINA'TRENTAI KUÁTTRO NA LIHESLATURAN GUÁHAN:*

3 **WHEREAS**, Paul Anthony B. Todeo was born in 1947 to Mr. Cenon V. &
4 Mrs. Juana B. Tadeo and is the eldest of their 7 children; and

5 **WHEREAS**, Paul Anthony became a foster child at age 10 when his father
6 passed away and his mother sought help from local parish priests to accept him in
7 the Seminary House to continue his studies; and

8 **WHEREAS**, Paul Anthony was an Elementary and High School Scholar.
9 Soon after graduation, he left for Manila to pursue his education in college, where
10 he earned his Bachelor of Science in Liberal Arts with a major in Political
11 Science; and

12 **WHEREAS**, Paul Anthony also found an interest in music and grew fond
13 of playing the guitar. He was scouted by a band manager for a group to play at
14 different clubs, bars and restaurants along the Hotel belts of Roxas Boulevard.

1 Paul was playing in a band regularly and was booked to play at U.S. Military bases
2 (Clark and Subic) and later toured Asia; and

3 **WHEREAS**, Paul Anthony played with the band “The Shapers” and
4 experienced many memorable tours that included Tour in Vietnam at the height of
5 the Vietnam War in the late sixties and early seventies. The band would play and
6 render music for the NCO Officers at different locations in Vietnam. His group
7 was made to wear full gear bullet proof vests and helmets to convoy in helicopters
8 over the field of Viet Cong. The group was shot at by enemies but luckily no one
9 was harmed; and

10 **WHEREAS**, after the war, the band was moved and found new booking in
11 Saipan where Paul Anthony met another Band Manager, Dr. Michael F. Caldwell,
12 who at the time, was a Professor Emeritus at the School of Education at the
13 University of Guam. One of Dr. Caldwell’s endeavors was to encourage young
14 students of Micronesia to pursue college. He offered scholarships to willing and
15 deserving students. Paul was offered to be his personal assistant and helped in
16 coordinating these programs throughout Micronesia. While working with Dr.
17 Caldwell, he stayed with him on Guam; and

18 **WHEREAS**, Paul Anthony’s hobbies include: playing chess, reading news,
19 especially politics; trivia questions and puzzles; gardening; daily evening walks in
20 the neighborhood for exercise; caring for stray cats, dogs, chickens and he
21 achieved a chess championship in 1987; and

22 **WHEREAS**, Paul Anthony was employed for four years playing evening
23 gigs at various hotels on Guam at their Happy Hour Lounges at the Palace, Okura,
24 Guam Reef, Hilton and also on a sunset cruise ship called “Windjammers” which
25 catered to tourists. He worked for 20 years at Mark’s Motor Company, Inc, then
26 later becoming Parts Manager. He also worked for four years as an Auto Parts
27 Technician for Triple J Motors, Honda Department; and

1 **WHEREAS**, Paul Anthony is an active member of the Catholic Faith
2 attending the Padre Pio Novenas every Monday evening with his wife, Ester at the
3 Santa Barbara Parish in Dededo; and

4 **WHEREAS**, Paul Anthony married his loving wife, Ester in 1985, and they
5 have a daughter, Phoebe Estelle; and, now be it;

6 **RESOLVED**, that *I Liheslaturan Guåhan* and the people of Guam
7 recognize and offer our best wishes and many blessings to Paul Anthony B. Tadeo
8 on the occasion of his 70th birthday, and that he may enjoy his special day and
9 many more celebrations to come, and, be it further;
