Rodriguez, Jr.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA' TRENTAI KUÅTTRO NA LIHESLATURAN GUÅHAN:

- **WHEREAS**, the Speaker of *I Liheslaturan Guåhan* was formally notified of a permanent vacancy existing in the Chairmanship of the Committee on Rules on June 30, 2017; and
- WHEREAS, Section 2.09(a) of the Standing Rules of the 34th Guam
 Legislature states in relevant part: "If a permanent vacancy occurs in the position
 of Chairperson of a Standing Committee, the Speaker *shall* reorganize, eliminate or
 reassign to other Standing Committees the duties, functions and budget of the
 Committee in question, at the Speaker's option with the majority vote of the
- 11 Committee on Rules"; and
- WHEREAS, the Speaker has determined that the functions of the Committee on Rules should be reorganized and reconstituted as two (2) separate Committees of the 34th Guam Legislature; and
 - WHEREAS, the Speaker has determined that said Committees shall be: 1) the Committee on Rules, to be chaired by Senator Régine Biscoe Lee, in which shall be vested all duties and powers relative to the processing of legislative bills,

certificates, resolutions, and other documents; the receipt of Committee Reports, as 1 required by Section 6.04(c) of Standing Rules, from Standing Committees; and 2 whose Chairpersonship shall execute general supervision of the Clerk of the 3 Legislature and Legislative Counsel, except when directed by the Speaker when I 4 Liheslatura is in session; and 2) the Committee on Legislative Operations, to be 5 6 Chaired by Senator Dennis G.
