1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTAI KUÅTTRO NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, the Committee on Rules of *I Mina'Trentai Kuåttro Na*
4 *Liheslaturan Guåhan* passed Resolution No. 69-34 (COR) in which one of the
5 provisions contained within created the Guam Congress Building Mortgage,
6 Maintenance, Security, and Equipment Reserve Fund in the amount of One Hundred
7 Twenty-six Thousand Dollars (\$126,000); and

8 **WHEREAS**, monies from the Guam Congress Building Mortgage,
9 Maintenance, Security, and Equipment Reserve Fund may only be expended as
10 directed by a resolution from the Committee on Rules of *I Mina'Trentai Kuåttro Na*
11 *Liheslaturan Guåhan* adopted by no less than six (6) of its members; and

12 **WHEREAS**, the installation of fence doors at the area of the Guam Congress
13 Building in which the generator and air conditioning systems are located is necessary
14 to ensure the security of equipment critical to the operations of *I Liheslaturan*
15 *Guåhan* at the Guam Congress Building; and

1 **WHEREAS**, the Acting Chief Procurement Officer of *I Mina'Trentai*
2 *Kuåttro Na Liheslaturan Guåhan* has obtained a price quotation (*Appendix A*), in the
3 amount of One Thousand Six Hundred Thirty-two Dollars and Forty Cents
4 (\$1,632.40), which will sufficiently meet the security needs for the Guam Congress
5 Building outlined in this resolution; now therefore, be it


6 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Kuåttro Na*

17 to Jermaine Alerta, Executive Director of *I Liheslaturan Guåhan*.



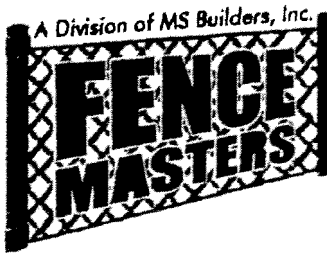
