3 **WHEREAS**, Rufina Calvo Perez is the wife of Benito J. Perez and they have
4 been married for 58 years. They have six (6) children: Gerard, Rowland, Kenneth,
5 Germaine, Dymphna and Dominic and eleven (11) grandchildren;

6 **WHEREAS**, Rufina C. Perez has been an active member of the Guam
7 Memorial Hospital Volunteers Association (GMHVA) since October of 2001 and
8 remains in good standing. She has given fifteen (15) years of service and contributed
9 5,000 volunteer hours; and

10 **WHEREAS**, since becoming a member, Rufina has served as a cashier at the
11 GMHVA hospital Gift Shop every Wednesday afternoon, and regularly attended
12 monthly Membership meetings; and

13 **WHEREAS**, Rufina was involved in the many different volunteer roles in the
14 capacity as a committee or participating member in the various programs and
