- 3 WHEREAS, Henk Rogers, raised in Holland until age 11, attended New York
- 4 City's specialized school for mathematics, science and technology, Stuyvesant

- 1 High School. He then went on to study computer science at the University of Hawaii,
- 2 where he currently resides; and
- 3 WHEREAS, in the 1980s, Rogers' groundbreaking work in Japan's then-
- 4 fledgling computer game industry led to the development of Japan's first-ever Role
- 5 Playing Game (RPG), Black Onyx (published by Bullet-Proof Software); he is known
- 6 in Japan as "the father of RPG"; and
- WHEREAS, Mr. Rogers is also recognized as a global leader in the gaming
- 8 industry. One of his software companies holds the exclusive intellectual property rights
- 9 to Tetris, the world's most popular video game (over 125 million units sold). Rogers
- revolutionized the industry when he brought the now legendary game to U.S. and world
- 11 markets over three decades ago; and
- 12 WHEREAS, in 2007, Mr. Rogers founded Blue Planet Foundation whose
- mission is to end the use of carbon-based fuel worldwide; and
- 14 WHEREAS, Mr. Rogers currently serves as Chairman of Blue Planet
- 15 Foundation's Board of Directors and is among one of the world's leading advocates and
- 16 activists for reducing, and eventually eliminating humankind's dependence on fossil
- 17 fuels; and
- 18 WHEREAS, his organization's tireless efforts helped the pave the way for
- 19 Hawaii to enact a policy that calls for electric utilities throughout the state to rely on
- 20 100% renewable energy by 2045; and
- WHEREAS, Mr. Rogers' efforts are focused beyond Hawaii to help others enact
- 22 mandates for 100% renewable energy in their regions and has spoken at three Inter-
- 23 Parliamentary Union assemblies, where he collaborated with the one seven eight
- 24 hundred (178) member countries to draft an emergency climate change resolution; and
- 25 WHEREAS, Mr. Rogers' in his mission to help other jurisdictions reduce their
- dependence on fossil fuels, has inspired Guam to be more ambitious and to make firm
