Relative to recognizing and commending Lornis Rhaym for providing civilian first response efforts to the people of Guam and its tourists.

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, Lornis Rhaym was born on June 28, 1972 on the island of Moch in
4 the Mortlock region of, Chuuk. He is forty-seven (47) years old and has one child, Airi;
5 and

6 **WHEREAS**, being a fisherman in Moch, Mr. Rhaym's life revolved around the
7 ocean. He contributed to his family by providing sustenance that the ocean yielded. He
8 familiarized himself with the tides and the weather conditions surrounding his island.
9 Mr. Rhaym's life was and is in the water. His compassionate nature and willingness to
10 help others, stems from the cultural values of his home island of Moch; and

11 **WHEREAS**, Mr. Rhaym moved to Guam in 1995. From 1998 to 2019 he found
12 himself working in the ocean at the Alupang Beach Club. He assisted tourists and other
13 patrons with various marine activities including parasailing and dolphin watching.
14 Water safety was always his primary concern; and

15 **WHEREAS**, in 2019, after over ten (10) years at the Alupang Beach Club, he
16 sought out employment at Jeff's Pirates Cove. Mr. Rhaym holds with him First Aid and

1 CPR certifications as well as basic training in a pool setting. With less than one year
2 employed with Jeff’s Pirates Cove, Mr. Rhaym has already responded and saved one
3 life; and

4 **WHEREAS**, Mr. Rhaym plays a vital role on the Jeff’s Pirates Cove’s rescue
5 team. He is one of the main “go-to guys”, when responding to distress calls. Rayhm and
6 Douglas Phillip are the dynamic duo who are sent directly into the rough waters of the
7 Togcha channel. His bravery ensures that their team remains strong, with an unwavering
8 drive to help those in need; now, therefore be it

9 **RESOLVED**, that the Committee on Rules of *I Mina'trentai Singko Na*
10 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
11 of Guam, recognize and commend Lornis Rhaym for providing civilian first response
12 efforts to the people of Guam and its tourists; and be it further;

13 **RESOLVED**, that the Speaker and the Chair of the Committee on Rules certify,
14 and the Legislative Secretary attest to, the adoption hereof, and that copies of the same
15 be thereafter transmitted to Lornis Rhaym; and to the Honorable Lourdes A. Leon
