4 daughter of Dominador D. Jorge and Maria A. Jore; and is from San Juan St. Samal,
5 Bataan, Philippines where she attended high school at Saint Catherine of Sienna
6 Academy and graduated in the year 1975. Mrs. Dizon graduated with her degree in
7 nursing from Arellano University, College of Nursing in the year 1980; and

8 **WHEREAS**, after meeting and wedding her beloved husband Wilner Dizon, an
9 engineer from the Philippines, moved to Guam in the month of September 1994 and
10 they are blessed with three (3) sons; Karlo Isaias Dizon, Paolo Lorenzo Dizon, and Julio
