WHEREAS, Mrs. Lerma Galsim Duarosan was born in the Philippine province of Tarlac on December 29, 1960. She received her undergraduate education from the University of Pangasinan, in Dagupan City, Philippines and completed her initial Bachelor of Science degree in 1982 in Foods and Nutrition. Mrs. Duarosan would later go on to earn another Bachelor of Science degree in 1983 at the Nicanor Reyes Memorial College (Far Eastern University) in Tarlac City, Philippines in Secondary Education; and

WHEREAS, In 1983 Mrs. Lerma Galsim Duarosan married Isidro C. Duarosan
an Engineer Supervisor at the Guam Department of Public Works. They would later go
on to have their daughter Blanche A.G. Duarosan who works as a Hospital Pharmacist
at the Guam Memorial Hospital; and

WHEREAS, Mrs. Lerma Galsim Duarosan began her nearly twenty-eight (28)
years of government service at the Department of Public Health & Social Services on

1 July 13, 1992. There she worked as a Nutrition Assistant with the Bureau of Nutrition 2 Services' Women, Infant, and Children (WIC) program. She would later be promoted 3 to Program Coordinator I of the WIC program in 2001, where she provided assistance 4 and support to women and children who were determined to be at nutritional risk. Mrs. 5 Lerma Galsim Duarosan would continue her work at the WIC program for another four 6 (4) years where she worked as a Farmers' Market Nutrition Program Coordinator. As a 7 Farmers' Market Nutrition Program Coordinator Mrs. Lerma provided fresh, nutritious, 8 unprepared foods (fruits and vegetables) from FMNP authorized farmers' markets and 9 roadside stands to women, infants, and children who were participating in the Special 10 Supplemental Nutrition Program for WIC program; and

11 WHEREAS, from August to October 2005, Mrs. Duarosan Program briefly served as a Program Coordinator II at the Department of Integrated Services for 12 13 Individuals with Disabilities (DISID). As a Program Coordinator II, at DISID she 14 worked to ensure the inclusion, independence, and productivity of people with 15 disabilities. On October 31, 2005, she accepted a promotion as a Program Coordinator 16 III back at the Department of Public Health & Social Services, where she worked under 17 the Division of Public Welfare, Bureau of Social Services Administration at the 18 Program Management Section up until her retirement on March 27, 2020; and

WHEREAS, Mrs. Duarosan currently resides in the village of Dededo and during her times of leisure enjoys several activities, such as traveling, dancing, and exercising at her local gym; and, now, therefore be it
