3 **WHEREAS**, Mrs. Vickey Manglona is a proud resident of Guam and is married
4 to her supportive husband Richard Manglona. Together they have six (6) children –
5 Jacinta, Demi, Devica, Victoria, Tyler, and Richard Jr. Mrs. Manglona is also fondly
6 known as “Gammy” by their six (6) grandchildren; and

7 **WHEREAS**, on June 25, 1986, Mrs. Manglona began her career in the Guam
8 Educational Telecommunications Corporation, also known as PBS Guam, KGTF

10 program descriptions in order to stay ahead of PBS Guam's live broadcast. She prepares
11 and prints the material for the monthly Program Guide and inputs the monthly program
12 schedules on the PBS Guam's website; and

13 **WHEREAS**, Mrs. Manglona is known as a loyal and hardworking employee in
14 addition to running a strong operation in her department at PBS Guam. Mrs. Manglona
15 has proved to be a valuable asset to PBS Guam by overcoming challenges to accomplish

17 fellow colleagues by exhibiting excellent leadership; and
