Won Pat International Airport; and to further expressing gratitude to him for thirty-four (34) years of commitment, dedication, and outstanding service to public safety and to the people of Guam.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'TRENTAI SINGKO NA LIHESLATURAN GUÅHAN*:

WHEREAS, Robert D. Camacho was born on January 31, 1962 to Pedro Alvarez Camacho and Josefina Blas Camacho. He is one of twelve (12) siblings, and was raised in the village of Mongmong. He is a 1980 graduate of George Washington High School, and a 1984 Cum Laude graduate of the University of Guam, earning a Bachelor of Science Degree in Criminal Justice. In 1984, Robert also graduated from Officer Basic Course Military Police School in Fort McClellan, Alabama; and

WHEREAS, Robert D. Camacho is married to Pauline Camacho and together, they have three (3) children, Robert D.C. Camacho, Ria N. Camacho, and Isa M. Camacho. Robert currently resides in Agana Heights with his wife and children; and

WHEREAS, Robert D. Camacho has held numerous positions in public safety within the Government of Guam. From February 25, 1985 to September 16, 2007,

1 Robert was employed with the Department of Corrections, starting off as a Parole
2 Officer I. Through his hard work and dedication, Robert was promoted to Deputy
3 Director of Corrections, and on May 12, 2004, he became Director of Corrections. On
4 May 17, 2007, Robert was moved to the Guam Customs and Quarantine Agency,
5 taking on the role of Acting Director. From October 1, 2008 to September 26, 2009,
6 Robert served as Deputy Chief of Police for the Guam Police Department. Robert held
7 his final role in public safety, serving as Airport Chief of Police with the Antonio B.
8 Won Pat International Airport from September 27, 2009 until his retirement on
9 February 25, 2019. Robert has also served as both Chairman and Vice Chairman for
10 the Peace Officer Standards and Training (POST) Commission from 2012 to 2018;

12 **WHEREAS,** Robert D. Camacho has served our island and our nation through
13 his years of service in the United States Army. He began his military career with the
14 368th Military Police Company, U.S. Army Reserve in March 1982 as Private First
15 Class. Robert became a Cadet E-5 in March 1983, then Platoon Leader, Lieutenant in
16 May 1984; and in October 1985, Robert was promoted to Commander. From January
17 through May of 1991, Robert was deployed to Saudi Arabia as Company Commander
18 Captain with the 731st Military Police Enemy Prisoner of War Processing Company,
19 U.S. Army Active Duty- Operation Desert Storm. Upon returning home from
20 deployment, Robert transferred to individual ready reserve and in December 1991, he
21 was honorably discharged from the U.S. Army.

22 **WHEREAS,** Robert D. Camacho received many awards and recognitions
23 during his years of service with the U.S. Army, including the Bronze Star, Kuwait
24 Service Ribbon, Southwest Asia Service Medal (Post War Award), Saudi Arabia
25 Service Ribbon, Governor's Meritorious Service Medal in November 1991, Army

1 Service Ribbon, National Defense Service Medal, Expert Pistol -.45 Cal., Expert
2 Grenade, and Army Lapel Button; and

3 **WHEREAS**, throughout both his military and civilian career, Robert D.
4 Camacho has given back to our island community through professional, community,
5 and civic involvement. Robert was a member of the University of Guam's Aikido
6 Club, ranked Deputy Dan in the Tae Kwon Doe Clubs of Mongmong and the
7 University of Guam, member and Public Relations Officer of the Latte Jaycees of
8 Guam, member of the Governor's Veterans Memorial Committee, member of the
9 Men's Cursillio Catholic Prayer Group, member of the Knights of Columbus, sponsor
10 married couple with his wife, Pauline, for Our Lady of the Blessed Sacrament Parish
11 in Agana Heights, Vice President for Pacific Probation and Parole Association,
12 Chairman for the 2006 Governor's Christmas Light Project at Adelup, Chairman for
13 the Guam Liberation Day Parade Committee in 2006 and 2007, Member of the 2007
14 and 2008 Christmas Light Festival Committee, and Board Member for the Salvation
15 Army in 2008 and 2009; and

16 **WHEREAS**, Robert D. Camacho enjoys many hobbies, including computer
17 graphics design, digital photography, collecting antique objects, and home design and
18 architecture. Robert also finds great joy and satisfaction in coordinating community
19 activities, especially those that help the less fortunate in the community and make a
20 significant impact for the entire island; now therefore, be it
