WHEREAS, First Sergeant Angelo Nomer C. Bumagat, a son of Guam and the Philippines and resident of the village of Dededo, was born on December 26, 1979 to Faustino V. and Mercedes C. Bumagat; and

WHEREAS, in addition to the guidance and love of his parents, First Sergeant Bumagat is blessed with the support of his family, which includes his wife, Stephanie

WHEREAS, First Sergeant Bumagat is a proud graduate of John F. Kennedy High School in Tamuning, where he graduated from in June of 1997. Shortly thereafter, he began his service and enlisted in the Army as an Infantryman, and attended One Station Unit Training at Fort Benning, GA; and

WHEREAS, throughout his twenty-one (21) years of distinguished service, First Sergeant Bumagat has held many leadership positions from Fire Team Leader to Company First Sergeant and has spent over fourteen (14) years on airborne status in numerous Airborne and Ranger assignments. His various duty assignments include 60mm Mortar Gunner, 81mm Mortar Gunner, Section Sergeant, Rifle Fire Team Leader, and Rifle Squad Leader with 3rd Battalion, 505th Parachute Infantry Regiment in Fort Bragg, North Carolina; Ranger Instructor and Senior Ranger Instructor with 6th Ranger Training Battalion in Eglin Air Force Base, Florida; Reconnaissance Sergeant and Air Operations Sergeant with the 75th Ranger Regiment Special Troops Battalion in Fort Benning, Georgia; Long Range Surveillance (LRS) Detachment Sergeant, LRS Company First Sergeant, and Reconnaissance Troop First Sergeant with 3-38th Reconnaissance & Security Squadron in Joint Base Lewis-McChord (JBLM), Washington; Brigade Operations Sergeant with the 201st Expeditionary Military Intelligence Brigade in JBLM, Washington; and

WHEREAS, First Sergeant Bumagat has participated in unit deployments within the PACOM AOR and proudly served in combat deployments in support of Operation Enduring Freedom in Afghanistan and Operation Iraqi Freedom; and

WHEREAS, apart from his deployments and assignments abroad and around the U.S., First Sergeant Bumagat was stationed on Guam in 2009 and 2015 where he served as Infantry Advisor and then later as Battalion Operations Sergeant with 3rd Battalion, 196th Infantry Brigade in Barrigada. While in these positions, he worked very closely with the leadership of the Guam Army National Guard and other military personnel on island in support of numerous training and other operational activities; and

WHEREAS, First Sergeant Bumagat's military education include completion of the Warrior Leaders Course, Advance Leaders Course, Senior Leaders Course, First Sergeant Pre-Command Course, Ranger Course, Basic Airborne Course, Static Line Jumpmaster, Special Operations Military Freefall, Pathfinder, Air Assault, Basic Combatives Trainer, Tactical Combatives Trainer, Special Operations Combatives Program – Level I, EMT-Basic, Tactical Combat Casualty Care, Heavy Weapons Leaders Course, Army Instructor Training Course, Tactical Certification Course, Equal Opportunity Leaders Course, Master Resilience Training Course, Navy Antiterrorism Officer Course, DIA Advanced Critical Thinking Course, and JITAP Combatting Insurgency and Terrorism Course; and

WHEREAS, First Sergeant Bumagat also completed an Associate of Arts Degree in General Studies, and will complete a Bachelor of Arts Degree in Homeland Security this coming spring; and

WHEREAS, First Sergeant Bumagat has received many awards and decorations, including the Bronze Star Medal, Meritorious Service Medal (3), Army Commendation Medal (6), Army Achievement Medal (7), Army Good Conduct Medal (6), National Defense Service Medal, Iraq Campaign Medal, GWOT Expeditionary Medal, GWOT Service Medal, Military Outstanding Volunteer Service Medal, Non Commissioned Officer Professional Development Medal (3), Army Service Ribbon, Overseas Service Ribbon (3), Combat Infantryman Badge, Expert Infantryman Badge, Ranger Tab, Master Rated Jumpmaster Badge, Military Freefall Badge, Pathfinder Badge, Air Assault Badge and Brazilian Parachutist Badge; and

WHEREAS, aside from his military career, First Sergeant Bumagat was previously involved with Big Brothers Big Sisters of Guam and was recognized in 2012 as Big Brother of the Year; and
