WHEREAS, Mr. Ben "Guelo" Rosario is a well-regarded cultural practitioner, who is known for being an avid promoter of CHamoru culture, and he has skills in constructing a range of traditional *guma'* (structures). He also continues to improve his knowledge of celestial navigation and canoe building; and


