COMMITTEE REPORT DIGEST

Bill No. 294-31 (LS) — “An act to amend §66103 of Chapter 66, Title 10, Guam Code Annotated relative to the Civilian Volunteer Police Reserve, to add a new §66103.1 to said Chapter relative to establishing the ‘Accessible Parking and Law Enforcement Fund’, and to amend §3401.1(e) of Article 4, Chapter 3, Title 16, Guam Code Annotated, relative to accessible parking for persons with disabilities.” — by Senator Adolpho B. Palacios, Sr.

I. OVERVIEW

The Committee on Public Safety, Law Enforcement and Judiciary convened the public hearing on September 12, 2011 at 8:35 a.m. in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of Bill No. 294-31 (LS) - “An act to amend §66103 of Chapter 66, Title 10, Guam Code Annotated relative to the Civilian Volunteer Police Reserve, to add a new §66103.1 to said Chapter relative to establishing the ‘Accessible Parking and Law Enforcement Fund’, and to amend §3401.1(e) of Article 4, Chapter 3, Title 16, Guam Code Annotated, relative to accessible parking for persons with disabilities” sponsored by Senator Adolpho B. Palacios, Sr.

Public Hearing Requirements:

Notices of the hearing were disseminated via facsimile and email to all senators and all main media broadcasting outlets on September 2, 2011 (5-day Notice) and on September 9, 2011 (48-Hour notice) pursuant to meeting the requirements of the Open Government Law. Notice of the hearing was also posted on the Guam Legislature’s website.

Helena Kubo, DSS Administrator, Department of Integrated Services for Individuals with Disabilities, provided oral testimony on the Bill.

Benito S. Servino, Director, Department of Integrated Services for Individuals with Disabilities, provided written testimony on the Bill.

II. SUMMARY OF TESTIMONIES

Chairman Adolpho B. Palacios, Sr. convened the public hearing of the Committee on Public Safety, Law Enforcement and Judiciary on Bill No. 294-31 (LS) at 8:35 a.m., read the agenda for the public hearing, and then called Lieutenant Michael Arcangel and Sergeant Jasmine to testify. The Chairman stated that a report by the Office of the Public Auditor had catalogued a number of inactive accounts, including the Accessible Parking Fund. Chairman Palacios stated that the accessible parking account was not closed, despite the repeal of the Accessible Parking Fund law. The Bill intends to create an Accessible Parking and Law Enforcement Fund to provide funding for the equipment and training for Police Reservists and CAPE volunteers. The Chairman called Ms. Helena Kubo to testify.

Lieutenant Michael Arcangel read the prepared written testimony of Chief of Police Fred E. Bordallo. Chief Bordallo stated that the Department supports Bill No. 294-31 (LS). He said that the Fund will help provide for equipment and training for the Civilian Volunteer Police Reserve. (*See attached written testimony.*) Lieutenant Arcangel said that he also supports the Bill. He stated that the Civilian Volunteer Police Reserve (CVRP) and the Civilian Assisted Policing Effort (CAPE) are very helpful to the Department and that there is need of additional funding to support their law enforcement capabilities.

Sergeant Jovito Jasmine stated that the Bill would greatly enhance the capabilities of the CAPE and CVPR programs in assisting the Department in enforcing the law.

Ms. Helena Kubo read the written testimony of Director Benito Servino. In his written testimony, Director Servino stated that his support for re-enacting the Accessible Parking Fund with restricted purposes, to be administered by the Department for Integrated Services for Individuals with Disabilities (DISID). (*See attached written testimony.*)

Chairman Palacios stated his intent to hold a mark-up meeting and to include DISID and GPD.

Chairman Adolpho B. Palacios, Sr., declared that Bill 294-31 (LS) has been duly heard. The hearing was adjourned at 9:35 a.m.

No further written testimony was received within the 10-day period following the public hearing of Bill No. 294-31 (LS).

IV. FINDINGS AND RECOMMENDATION

First (1st) Mark-up Meeting on Bill 294-31 (LS) on September 21, 2011 at 9:03 a.m.:

Proceedings:

Chairman Adolpho B. Palacios, Sr., convened the meeting at 9:03 a.m. at his office. He stated that the Office of the Public Auditor had indicated in a report that the Accessible Parking Fund was an inactive account, the revenue of which should revert to the General Fund. The Legislature since repealed the Accessible Parking Fund law, but revenues from the enforcement of Guam's accessible parking law have continued to be deposited into the account, despite the repeal of the law. He stated his position that there can be mutually beneficial revenue-sharing for the DISID and GPD.

Chief Fred E. Bordallo stated that he had reviewed the Office of the Public Auditor's report and Public Law 24-14. He said that the original mechanism for the enforcement of accessible parking was private security with optional enforcement for GPD. The OPA recommended the closure of the account because the DISID enforcement officer position was vacant and there was no effective enforcement mechanism. Chief Bordallo discussed the establishment of the Community Assisted Policing Effort (CAPE) program, which enforces the accessible parking law. He said that GPD is best prepared for enforcement. The Chief said that proper enforcement will deter people from violating the law and gave the example of litter citations from the Guam Environmental Protection Agency which was transferred to the Department.

Director Benito S. Servino stated that the budget for the predecessor to DISID was very low in the past and that there was poor enforcement of the accessible parking law. He envisioned a public ad campaign and improved signage. Director Servino explained why the accessible parking fund was established and discussed his earlier efforts with accessible parking.

Chief Bordallo asked Director Servino if they would get proper signage for public agencies and private entities.

Captain Mark Charfauros discussed the creation of the CAPE and Civilian Volunteer Police Reserve (CVPR) programs to enforce the accessible parking law. He said that the expenses that the Director pointed out in his written testimony are justified as costs of

enforcement. Captain Charfauros stated that not all of the funds were used to administer the CAPE and CVPR programs. He said that the increased compliance from aggressive enforcement eventually decreases the revenue due to improved compliance with the law. The Captain pointed out that establishing quotas for citations are illegal.

Chief Bordallo talked about the beginning of the CAPE program and said that without community-based enforcement, enforcement of the accessible parking law would fall short.

Chairman Palacios said that he sees a need for revenue sharing. He asked Director Servino to provide a list of the mandates for DISID, which does not include the enforcement of accessible parking at this point. The Chairman said that enforcement of proper signage/spacing, etc. could perhaps be enforced by DISID. He suggested that funds for GPD derived from the accessible parking enforcement could go to the Police Services Fund.

Sergeant Jovito Jasmine stated that they provide documents for public awareness of the accessible parking law.

Captain Charfauros stated that law enforcement is expensive.

Major Leon Ryan stated that there has been an intention to acquire additional equipment for the CAPE and CVPR programs, but funds have not been available.

There was discussion about the potential for confrontations in enforcement.

The Chairman reiterated his intent to hold another meeting to discuss the topic of revenue sharing between DISID and GPD from the accessible parking-related revenues.

Director Servino discussed noncompliance in government by providing insufficient parking space(s) and improperly marking them.

Chairman Palacios suggested the possibility of deriving additional revenue from improper signage.

Lieutenant Michael Arcangel talked about enforcement on individuals in government in their professional capacity.

Director Servino discussed the intent of the Accessible Parking Fund.

Sergeant Jasmine mentioned issues with enforcement in the courts, including improper signage and/or markings on accessible parking spaces.

Discussion continued on the enforcement of the accessible parking law and Director Servino expressed interest in creating a role for DISID in the enforcement of signage and markings.

Sergeant Jasmine suggested that clients of DISID be encouraged to join the CAPE program as volunteers.

Chairman Adolpho B. Palacios, Sr., concluded the meeting.

Second (2nd) Mark-up Meeting on Bill 294-31 (LS) on October 3, 2011 at 2:00 p.m.:

Proceedings:

Chairman Adolpho B. Palacios, Sr., convened the meeting at 2:00 p.m. at his office. The Chairman explained the legislative process following the mark-up meeting. Chairman Palacios discussed the idea of splitting the funds from enforcing the accessible parking law and depositing a portion into the Police Services Fund. The Chairman discussed getting more DISID clients involved in the CAPE program.

Director Benito Servino asked whether any funding is provided specifically to the CAPE program in the 2012 Fiscal Year Budget. Chief Fred Bordallo responded that there is no appropriation specifically for the CVPR or CAPE programs.

Chairman Palacios asked how CAPE has been funded. Chief Bordallo talked about the Accessible Parking Fund support for the CAPE program. Director Servino asked whether CAPE's operations are budgeted. Chief Bordallo said that some funds were budgeted, but insufficient for the program. Chief Bordallo discussed training upgrades that are intended for the programs.

Chief Bordallo stated that there are between 30 to 40 CAPE volunteers and about 30 CVPR officers. Director Servino discussed the need for a multimedia campaign to promote awareness of the accessible parking law. Chairman Palacios discussed the potential for federal funding for such an awareness campaign. Director Servino stated that there are no grants available since accessible parking is seen as a policing issue. Director Servino talked about rampant abuse of the accessible parking spaces.

Chief Bordallo said that many volunteers have taken the accessible parking as a responsibility because they feel it is right. He discussed capacity building in the CAPE training program.

Director Servino discussed the expansion of CAPE jurisdiction into littering enforcement. Chief Bordallo said that drug enforcement draws upon forfeiture to strengthen the program. He discussed increasing training through the funds.

Chairman Palacios asked that the focus be on how funds derived enforcement of the accessible parking fund will be divided. Director Servino suggested that 60% go to DISID and 40% go to GPD. Chief Bordallo agreed with that division of funds.

Chairman Palacios asked how accessible parking signs will be made. Director Servino stated that the Department of Public Works used to handle it, but that they would be able to be made more quickly if it were contracted out to private vendors.

Discussion continued on the division of the current balance of the Accessible Parking Fund. Director Servino and Chief Bordallo agreed to the same 60-40 division of funds.

Director Servino related a personal experience with accessible parking. He asked whether private security can enforce the accessible parking law and Chairman Palacios stated that guards are able to if they have received appropriate training.

The meeting concluded at 2:44 p.m.

AN ACT TO AMEND §66103 OF CHAPTER 66, TITLE 10, GUAM CODE ANNOTATED RELATIVE TO THE CIVILIAN VOLUNTEER POLICE RESERVE, TO ADD A NEW §66103.1 TO SAID CHAPTER RELATIVE TO ESTABLISHING THE "ACCESSIBLE PARKING AND LAW ENFORCEMENT FUND", AND TO AMEND §3401.1(e) OF ARTICLE 4, CHAPTER 3, TITLE 16, GUAM CODE ANNOTATED, RELATIVE TO ACCESSIBLE PARKING FOR PERSONS WITH DISABILITIES.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan*
3 finds that the Accessible Parking Fund ("Fund"), established as the *Disabled*
4 *Parking Fund* in 1985 through P.L. 18-28, was originally used to pay for the
5 installation and maintenance of accessible parking spaces at government of
6 Guam buildings. The *Disabled Parking Fund*, administered at the time by
7 the Director of the Department of Public Works, was also used to cover
8 costs for the installation of appropriate parking signs and for the fabrication
9 of removable windshield placards for registered users.

10 *I Liheslaturan Guåhan* finds that in 1995 through P.L. 23-11, the
11 *Disabled Parking Fund* was renamed to its current nomenclature and the
12 Governor's Commission on Persons with Disabilities was assigned the
13 responsibility of maintaining such fund. Proceeds of the Fund were

1 designated for use in an aggressive media campaign to help educate the
2 public about the human aspects of parking in an accessible parking space
3 and its impact on persons with disabilities.

4 In 1997 through P.L. 24-16 *I Liheslaturan Guåhan* further amended
5 the Fund's enabling statute, 5GCA §50111(c), and assigned the Department
6 of Integrated Services for Individuals with Disabilities with the
7 responsibility of maintaining fund proceeds. *I Liheslaturan Guåhan* also
8 mandated that the Fund be used to cover costs associated with monitoring
9 compliance of accessible parking laws.

10 Nearly a decade later P.L. 28-130, through recommendations made in
11 the Office of the Public Auditor's Report No. 06-03 dated April 2006, *I*
12 *Liheslaturan Guåhan* repealed 5GCA §50111(c) which effectively closed
13 what was reported to be an inactive fund account of the government of
14 Guam. P.L. 28-130 also appropriated Five Thousand Dollars (\$5,000.00)
15 from a balance of Five Thousand, Five Hundred Sixty Six Dollars
16 (\$5,566.00) to the Guam Police Department (GPD) for the purpose of
17 training volunteers who would assist with the enforcement of accessible
18 parking laws. The remaining balance was to be transferred into the General
19 Fund.

20 *I Liheslaturan Guåhan*, through information recently received from
21 the Chief of Police, finds that the Accessible Parking Fund was not closed
22 and that fines and fees continue to be deposited into the Fund. As of the
23 latter part of August 2011, the Fund has a balance of approximately Two
24 Hundred Fifty Thousand, Two Hundred Seventy Six Dollars and Eighty
25 Eight Cents (\$250,276.88). Based on this information the Chief of Police
26 has requested the assistance of the Chairman of the Committee on Public
27 Safety, Law Enforcement and Judiciary by introducing legislation that

1 would authorize GPD to use proceeds from the Fund for the Civilian
2 Volunteer Police Reserve (CVPR) and Community Assisted Policing Effort

Buenas yan Hafa Adai Senator Palacios and Members of the Committee on Public Safety, Law Enforcement & Judiciary.

My name is Ben S. Servino, and I currently serve as the Director for the Department of Integrated Services for Individuals with Disabilities (DISID).

I have reviewed Bill 294-31 (LS) and commend the Guam Police Department (GPD) for their efforts in addressing the enforcement mandates of the Accessible Parking Law.

I have also researched and confirmed with the Department of Administration (DOA) that the "Accessible Parking Fund" (Account # 5236C081200GA021240) was not closed and that fines are still being deposited into the Fund. As of September 9th, 2011, the account balance is **\$250,604.89** (Please see attachment A).

During FY 2010-2011, there was a total expenditure of **\$61,111.47** from the "Accessible Parking Fund" (Please see attachment B) which was supposedly accessed and utilized by GPD for the purchase of the following vehicle, multimedia equipment, office supplies, clothing, stipends, telecommunication services, and computer/printer supplies:

1 - 2010 Ford Sport-Trac Pick/Up (\$28,875), 100 - Saunder Clipboards (\$2,600), Landlines for the Mangilao Koban (\$53-\$73/month), Stipends for Civilian Volunteer Police Reserves (\$6,500), 100 - Traffic Vest (\$2,685), 50 - SWAT Side Zip (\$4,350), 149 - Tactical/Khaki Pants (\$6,407), 1 - Lumens Multimedia Projector (\$659), Printer and Computer Supplies (\$471), including Printer/Toner Cartridges (\$3,374).

I have also had an opportunity to review the FY2012 SUMMARY OF BASE OPERATIONAL APPROPRIATION for GPD that was highlighted on Page 71-72 of **Bill No. 304-31 (LS)** and noticed that **\$250,000** was allocated for **Supplies and Materials** (\$215,000/General Fund and \$35,000/Police Services Fund), **\$126,700** was allocated for **Miscellaneous Costs** (\$44,559/General Fund and \$ 82,141/Police Services Fund), and **\$464, 719** was allocated for **Contractual Services** through the Police Services Fund.


After reviewing these documents, I am concerned that some of the equipment and supplies that were purchased with resources from the "Accessible Parking Fund" may not be used exclusively for the purpose of enforcing the public's compliance with the accessible parking law. I also feel that GPD has adequate resources to pay for equipment, supplies and repairs to highway patrol vehicles through their 2012 Budget Allocation.

As a result, I highly recommend that the "Accessible Parking Fund" be re-enacted and that the Department of Integrated Services for Individuals with Disabilities (DISID) be assigned the responsibility of maintaining the proceeds of the funds with expenditures restricted for the following purpose:

- 1) Establishment of a collaborative multi-media campaign between DISID, GPD, Rev & Tax, and the PBS to help educate the public about the provisions of the Accessible Parking Law, the human aspects of parking in an accessible parking space, and its impact on persons with disabilities.
- 2) Providing stipend payments to Consumers with Disabilities for assisting DISID in conducting site assessments of Private Businesses and GovGuam facilities to ensure that adequate accessible parking spaces and accessible path of travel are provided.
- 3) Providing resources to help support the costs of training Civilian Volunteer Police Reserves (CVPR) and the Community Assisted Policing Effort (CAPE) program as it relates specifically to the enforcement of the Accessible Parking Law.
- 4) Covering the costs for the procurement and installation of "Accessible Parking" signage and maintenance of accessible parking spaces within all GovGuam buildings.

I thank you for providing me this opportunity to provide input on Bill 294-31 (LS).
