**COMMITTEE REPORT DIGEST**

**Bill No. 220-31 (COR) – “An act to amend” §67.407 of Article 4, Chapter 67 of Title 9 of the Guam Code Annotated relative to the Guam Uniform Control Substance Act.” – sponsored by Senator Frank F. Blas, Jr.**

**I. OVERVIEW**

The Committee on Public Safety, Law Enforcement and Judiciary convened the public hearing on June 15, 2011 at 9:06 a.m. in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of Bill No. 220-31 (COR) – “An act to amend” §67.407 of Article 4, Chapter 67 of Title 9 of the Guam Code Annotated relative to the Guam Uniform Control Substance Act,” sponsored by Senator Frank F. Blas, Jr.

**Public Hearing Requirements:**

Notices of the hearing were disseminated via facsimile and email to all senators and all main media broadcasting outlets on June 8, 2011 (5-day Notice) and on June 13, 2011 (48-Hour notice), pursuant to meeting the requirements of the Open Government Law. Notice of the hearing was also posted on the Guam Legislature's website.

Fred E. Bordallo, Jr., Chief of Police, Guam Police Department, provided oral and written testimony in support of the Bill.

## II. SUMMARY OF TESTIMONIES

**Chairman Adolpho B. Palacios, Sr.** convened the public hearing for the Committee on Public Safety, Law Enforcement and Judiciary at **9:06 a.m.**, read the agenda, recognized the Senators present, read the title of the Bill and deferred to the author to give an overview of the Bill. Chairman Palacios called the panel of Chief Deputy Attorney General Phil Tydingco and Chief of Police Fred E. Bordallo, Jr., to testify.

Senator Frank F. Blas, Jr., stated that the intent is to include enhanced penalties for those who distribute drugs to pregnant women. He also intends to clarify Drug Free School Zone statute. He stated that it is not apparent when one is guilty of violating the statute. Senator Blas said that there are gaps and areas which need to be strengthened in the drug codes.

Chief Deputy Attorney General Phil Tydingco stated that the Attorney General's Office supports the intent of the Bill. He said that the Bill is consistent with Bill 221.

Chief Fred E. Bordallo, Jr., stated that he supports the Bill. He thanked the author for bringing the Bill forward.

Vice Chairman Thomas C. Ada questions why those who are under eighteen (18) and those who are pregnant are singled out, while persons with disabilities are left out. He also questioned the definition of schools. Mr. Tydingco replied that Vice Chairman Ada raised some good points. He stated that generally minors and people with certain disabilities are the targets for enhancements. Mr. Tydingco stated that minors are clearly a vulnerable population. He added that people who are disabled may also be considered particularly vulnerable. Mr. Tydingco said that originally crafted, the provisions about schools are probably intended to protect minors. He believes that the intent is to prevent the distribution of drugs to a vulnerable population. Senator Blas stated that the definition of Drug Free School Zone includes post-secondary. Vice Chairman Ada asked whether the language should include persons with disabilities and Mr. Tydingco agreed.

Senator Blas stated that he considered expanding the vulnerable population. He was concerned about the reach of mental disabilities. Mr. Tydingco stated existing statutes may adequately address the definition of mental disability. He said that the prosecution would only bring a charge that there is evidence for, which would include one's mental capacity. He said that there would be no point in adding an enhancement if he believed it was unenforceable. He emphasized that doctors or psychiatrists could

testify to one's capacity. Senator Blas stated that he would support creating such an enhancement.

Chairman Palacios stated that he supports inclusion of the enhancement for the mentally disabled.

**Chairman Adolpho B. Palacios, Sr.**, thanked the panel for their testimony and declared that Bill No. 220-31 (COR) is duly heard. The Chairman concluded the hearing and requested that written testimony be submitted. He adjourned the hearing at **10:54 a.m.**

### **III. WRITTEN TESTIMONIES**

**Fred E. Bordallo, Jr., Chief of Police, Guam Police Department.** (*Summarized in Section II.*)

**Wilfred G. Aflague, Director, Department of Mental Health and Substance Abuse.** (*Summary follows.*)

**Wilfred G. Aflague, Director, Department of Mental Health and Substance Abuse.** Director Aflague stated that the Department supports the Bill. He stated that the punishment fits the crime. (*See attached written testimony.*)

No further written testimony received within the five (5) day period after the public hearing.

### **IV. FINDINGS AND RECOMMENDATIONS**

#### **Substitute Bill 220-31 (COR):**

The Committee on Public Safety, Law Enforcement and Judiciary has created a Substitute for Bill 220-31 (COR). The Bill has undergone significant modification since its introduction.

The title was amended to correct errors. There was a stray quotation mark and the title lacked a comma to separate the clauses. Additionally, the reference to the Chapter 67 title was in error.

The only substantive change in Section 1 was the addition of "a person suffering from a mental illness, disease or defect" to the object enhancement classes in subsection (a) and (b) of §67.407, along with the already included persons under the age of eighteen (18) and the pregnant individuals added in the Bill as introduced. The term "pregnant individual" was replaced with the term "pregnant person" so that the meaning is clear. Additionally, the title of the §67.407, amended by Section 1, was changed to reflect the



enhancement for distribution to persons suffering from a mental illness, disease or defect, and a title of Section 1 was added to reflect the new title of §67.407.

The Section 1 states that it amends §67.407, but the Section failed to include subsections (e) and (f), though it had included all other subsections. For clarity that those subsections are not repealed, they are included in the text. All other changes relate to grammar or style.

**Recommendations:**

The Committee on Public Safety, Law Enforcement and Judiciary hereby reports out **Bill No. 220-31 (COR), as substituted by the Committee**, with the recommendation **TO PASS**.

Imposition or execution of such sentence shall not be suspended and probation shall not be

2 served the additional five (5) year sentence prescribed by this Subsection.

18 years imprisonment. Imposition or execution of such sentence shall not be  
19 suspended and probation shall not be granted. Parole or work release shall not  
20 be granted until the offender has served the additional three (3) years prescribed  
21 by this Subsection.

22 (e) It is not a defense to a violation of Subsections (a) and (b) that the  
23 accused did not know the age of an individual to whom a controlled substance  
24 was distributed.

25 (f) It is not a defense to a violation of Subsections (c) or (d) that the  
26 accused did not know the distance involved.”

1           **Section 2. Severability.** *If* any provision of this law or its application to any  
2 person or circumstance is found to be invalid or contrary to law, such invalidity shall  
3 *not* affect other provisions or applications of this law which can be given effect  
4 without the invalid provisions or applications, and to this end the provisions of this  
5 law are severable.




