

On the agenda for this evening's virtual confirmation hearing is the appointment of Maria-Flor L. Hererro to serve as a member of the Board of Trustees, Guam Educational Telecommunications Corporation (KGTF/PBS Guam). The Committee will receive oral testimony for *I Maga'håga's* nominee and will continue to accept written testimony from the general public, which shall be made a part of today's public hearing record.

I'd like to go ahead and just recognize who is here. We have Maria-Flor L. Herrero. We also have Miss Ina Carillo, who is the Executive Director for KGTF/PBS. We also have Board member Miss Rosemary Clement and board member Joseph D. Franquez who have joined us here today, and we're very pleased to have you. We always have the opportunity to have many board members attend.

We're very grateful that you were able to make that time today. I also have from my office, my Chief of Staff Mr. Roland Villaverde, and my Community Liaison Mr. Victor Lujan, who is here. They will be attending to some of the technicalities of running this hearing.

Thank you so much for joining me. Before we receive and open our discussion, we will first go over some general rules of conduct for those participating and in attendance. The conduct of this hearing shall be as follows. All participants must abide by rules of conduct and quality assurance

standards, including broadcasting from a quiet room with little to no interruptions. The use of virtual backgrounds is not permitted. Broadcasting from a room with adequate lighting specifically to ensure that a participant space is not backlit, but visible at all times when speaking and to please ensure that you are unmuted and that you are speaking clearly into your microphone when you are called upon to speak. Perhaps, if we're not all muted, this would be a good time to go ahead and mute yourself. The chair will invite the nominee and then recognize individuals that have signed up to testify on the nominee. Individuals providing oral testimony shall first be recognized by me before speaking and shall state their name and title for record-keeping purposes. The order of questioning will begin with the Senators present to the nominee. This may be a Committee of one for today. Each Senatorial panel member will be allowed to pose one question to the nominee and then be provided another round to ask for the questions to the nominee or testifying panel. Oral testimonies shall be confined to the substance or nature of the agenda. A personal inference to the nominee's character, Senator, or any individual testifying is not permitted. Any violation of this general rule of conduct will result in removal from the host's virtual public hearing. I ask that all participants keep their comments or testimony to within five minutes. But we're a small and cozy group. If you have more than five minutes of testimony, I think we can easily accommodate that.

Håfa Adai. PBS Guam has come a long way from its humble beginnings in 1970 and has provided its viewers throughout its 50 years of existence with outstanding public television programming. Programming centered on science, history, nature, and public affairs. Those are what PBS is known for, including programming with diverse viewpoints and front row seats to world-class drama and performances. PBS Guam also integrates live sporting events and local productions at events.

In 1975, through Public Law 12-194, the legislature officially created the Guam Educational Telecommunications Corporation with a seven-member Board of Trustees and a general manager to operate a non-profit public corporation to which we know today as PBS Guam.

PBS Guam is committed to serving the public interest by providing Guam people with quality educational and cultural programming that will entertain and offer important information about the world around us and our island. We have an obligation to maintain and assure that PBS Guam will continue to provide its services for public educational and local event television for many years in the future.

A board or commission member's work involves much volunteer time and commitment and provides an important link between public and agency, the legislature, and the Governor. Each board is unique in its purpose, mission, and role. It is especially important that members be familiar with the board's governing statutes or other authorizing directives to understand the framework within which the board must operate. With all that being said, I want to call upon Maria-Flor L. Herrero to provide her testimony to serve as a member of the Guam Educational Telecommunications Corporation, otherwise known as KGTF/PBS.

As I mentioned earlier, I want to recognize that we have both the general manager and two board members that are here in support. We will begin with Miss Maria-Flor L. Herrero and have her provide her testimony, and we will then receive testimony from the others that are here that are signed up to do so.

Mrs. Maria-Flor L. Herrero, if you would like to begin your testimony, and then even though I've said your name several times if you could begin with your name for record-keeping purposes.

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: Good evening and håfa adai. Senator Kelly Marsh (Taitano), Ms. Rosemary Clement, Mrs. Ina Carillo, and Dr. Joseph Franquez. My name is Maria-Flor L. Herrero. I am here today because of my desire to serve as a member of the Board of Trustees of the Guam Educational Telecommunications Corporation, otherwise known as KGTF/PBS Guam. I feel that I will add significant value to this governing body for several reasons.

Firstly, I have been a resident of Guam since 1977. During this time, I have seen the island grow and mature along with it. All along, the Guam Educational Telecommunications Corporation or KGTF/PBS Guam has been pivotal for our island's growth and well-being.

Fostering information, communication, education, enlightenment, and self-reliance among young and old alike, it would be a great privilege to serve on the Board of Trustees of KGTF/PBS Guam, so that I may continue to give something back to the island that has given so much to me.

Through my service on the boards of the Guam Council and the Humanities Agency, CAHA, the Department of Chamorro Affairs, *Inafamåolek*, and lately, the University of Guam Board of

Regents for seven and a half years, I am well versed in the responsibilities and expectations that go along with serving on a board of this caliber.

Secondly, as a female entrepreneur for the last 35 years, I bring a unique and valuable perspective to the table. I am the President of Luria Industries, Inc. A wholesaler of wines, liquors, olive oils, and other specialty items that I began in 1987. Over the course of time, I have dealt with both wholesale and luxury retail. In fact, I still receive comments regarding Barcelona Lane, the very first business lady's boutique, which I started back in 1988, even though it has been closed for the last 10 years. In any case, my current clients include major grocery retailers, hotels, restaurants, military retail outlets, and smaller mom-and-pop retailers.

My direct ground-level exposure to such a wide range of clients has given me insight into our island economy's unique business conditions. My experience has allowed me to bridge the gap between critical social-economic concepts as well as educational and environmental concepts and doing business in the real world. An essential perspective for shaping the direction and program mix of the various KGTF/PBS Guam programs.

Thirdly, I would like to assist the Guam Educational Telecommunications Corporation in growing this appeal and visibility. I believe it is possible for KGTF/PBS Guam to develop as the University of Guam has done so successfully from good to great. KGTF/PBS Guam has grown tremendously throughout its nearly 50 years history, including producing local shows and various projects from only four and a half hours of programming in the 70s. It currently operates from 6 am to midnight, 7 days a week, and original materials from PBS Guam have been contributed to the American Archive of Public Broadcasting. I believe that KGTF/PBS Guam has done a fantastic job of programming in so many diverse categories for news and the theaters. Like Masterpiece, the Science and Technology like Nova, to the commentary documentaries, fitness, health, sports, society and politics, food and cooking, kids programs of course as well as local programs. It is precisely in the local programming, which I believe PBS Guam still has a lot of growth potential. *CHamoru* culture is rich and colorful. It has endured trials and difficulties throughout its history. Despite so many outside influences, the *CHamoru* culture has been able to retain its essence and, at the same time, benefit from these external influences. This is why PBS Guam must foster, promote, and develop our local history, language, culture, and heritage.

When people are knowledgeable and aware of their roots, they become stronger in their principles and identity. Yet PBS cannot reach his full potential without funds, without members, without

volunteers, without business partners, and so on. I can help in this process by facilitating membership drives, fundraising, pursuing new volunteers, and building strong relationships with our business partners through donations and advertising.

Lastly, my late husband, Anthony A. Leon Guerrero, or simply Tony, was a great champion of education as he was known to most of you. He was mostly acquired through communication and information. He believed that the only lasting way, indeed, the best way for people to advance in life was through a sound education. These lead to critical thinking, challenging the status quo, and the promise that future generations will push beyond the boundaries of those who came before them. I firmly believe the dedicating my time and efforts to fostering education and unbiased information in Guam is the single best thing I can do to honor his memory, foster his legacy on my grandchildren, continue his dream, and advance his beloved CHamoru people. Thank you.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: That was a very thorough testimony. You covered quite a few topics of talking about your contributions and hearing about your goal of doing some of this as a legacy to your late husband. It was very informative, and you answered quite a few of my questions already. I appreciate your thoroughness in your testimony. I just want to clarify. I want to make sure that I'm not leaving anybody out. I think everybody is here in support that we greatly appreciated but for Mr. Franquez, were you wanting to speak or just be in support?

JOSEPH D. FRANQUEZ, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, BOARD MEMBER: I would like very much to say for the acknowledgment of Mary Flor. Thank you so much. I enjoyed listening to your testimony, and every point you brought out in your testimony seems to be in alignment with what we definitely would like to have on the board as it is right now. We have a dynamic in a very hardworking staff and faculty up at KGTF. We are looking forward to having you as a new member, and I like some of the points that you're bringing out regarding some of your goals and how we can improve getting PBS to be well more supported by the community by membership by great musicians. Of course, that's a very vibrant part of the testimony that captured my attention. I welcome that, and we definitely will be using that to the best of your ability and looking forward to working with you. Thank you so much for making the time for clarifying some of these goals and objectives that you have set up for you and the board as well, welcome! Thank you so much.

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: Thank you so much to you. I will be very honored to be a part of the board.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: Si Yu'os ma'åse' for that testimony, Mr. Franquez. It's very much appreciated. If I go over some of the points, it was very good to hear about your business background and different board backgrounds. It has quite a wide range of the boards you've been on and the memberships you have had. I agree! I think that this will really serve PBS well because they also have this broad array of interests and this broad array of those needs that you mentioned volunteers, business partners, and alike. It seems that you have a lot of those well-rounded qualities where you can bring them to the forefront. I just want to mention, and maybe the general manager can help me clarify some of this. There have been some exciting developments over the last year and a half at PBS. I believe that PBS now has a 24-hour kid's channel. Is that already up and running, Miss Carillo?

INA CARILLO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, GENERAL MANAGER: Yes. In June, we launched PBS Kids 24/7. It is actually 18 hours because we sign off at midnight. But it is 18 hours of 100% of children's educational programming. It airs on PBS channel 12.1.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: Yes. That's been an exciting development. They have just gone through with PBS University, where there was a huge learning curve, and we are incredibly grateful as a community. I heard that they created something like 300 lesson plans and that these are top-notch. They are something that you would see across the nation. It doesn't matter where; they would recognize its high quality. We are very proud of PBS for that and for all the teachers who had that learning curve along the way to serve our community. And I think the general manager was saying that 700 programs were coming up over the next nine months. I noticed Mrs. Herrero that you do have a teaching background. Would you mind if I ask what subject you taught?

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: Yes. I graduated from the University of Guam. My bachelor's degree was in Education majoring in economics and a second in history. After I graduated, I did teach history in Simon Sanchez for about three years, but they also taught

Spanish. Even though my major was not Spanish, they instructed me to teach Spanish, which I enjoyed.

My husband was transferred to San Francisco to start the Bank of Guam there, so that's how I left. When we were in San Francisco, we stay there for three years. My second daughter was born there, but I also attended the University of San Francisco to pursue my Master's in Business Administration. However, we had to come back. We came back in 1986. I haven't finished my master's yet. What I did was I transferred from USF to the University of Guam. I graduated again from UOG with a Master's in Business Administration in 1987, wait a minute, 1988, because that's when my son was born. He was born on April 22, and I graduated May 8 or something like that. I have been a teacher, and I love teaching; however, since I left the island then I had my children, I realized that I wanted to be a mother first and foremost, and I couldn't do that if I teach. By opening my own business, I can use my own time.

Also, I have discovered along the years that owning your own business is not necessarily easier. You really work harder because you work 24/7. But you have more flexibility as to the time that you work. My major was education majoring in economics, history, and then, of course, business.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: I see. That really fits in a lot of ways with the way that PBS has grown. I mean, it's always specialized in education for our community and our youth, but with the PBS University and this new 24/7 Kids channel, I see that that background really comes in handy as well as well as those other areas that you mentioned. You did mention time. As a busy person in our community serving on the Board of Regents and running your businesses and other time commitments, do you feel that you have the time for this board? It meets once a month, and I'm not sure if there are additional commitments beyond that.

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: I found out that the as busy that I am, the more that I can do, the more that I can produce, and you know, I am widowed. My children are all married and have their own children. I have four grandchildren, which I love them, and I spend as much time as I can with them, especially at the weekend. But other than that, I do enjoy being part of the community. I do enjoy and contribute the best I can. I mean, this is the way I am. I also belong to other clubs like Guam Women's Club, Rotary Club, and so on, but I do feel that if am going to contribute by my time, I want to be selective as to which organizations and certainly the University of Guam, KGTF and anything that has to do with promoting education in Guam.

That is my weakness. Yes, I will dedicate the time. I do think I'll have the time. The University of Guam has been a pleasure. I mean, I really enjoy it, and yes, we do have several meetings a month. And yes, I chair the nominating Committee actually for seven and a half years, which I really enjoy. I also chair the student affairs committee, but I find out that it is has been really easy. The University of Guam is a very well-run organization. The administration does a fantastic job.

Basically, my job and the job of the other members of the board are basically read what is put in front of us and be critical and examine it, look at it, and see what we think about this. Is this best for the University, for our students, for the community, and then decide? I find it actually very enjoyable. I am pretty sure that being on the board of KGTF would be just as enjoyable. I would like to think also very productive.

I didn't mention in my speech, in my testimony, that I have been a client of KGTF. I have been advertising with KGTF for the longest time because I sell wine and liquors. I know that wines do not appeal to everyone but appeal to this clientele who are maybe between their 40s and 60s. They like to enjoy a nice glass of wine in the evening, especially when they watch their how do you say, the Masterpiece. Yes, I have advertised with KGTF, and I know how to approach, and I know that if we are direct and persuasive in approaching other businesses and customers in Guam, we can have them advertise to increase the cash flow so that we can produce more programs for the community. I am actually looking forward to it, and I am sure that it will be a very enjoyable time in my life.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: It is very good to hear about that commitment and your understanding of those kinds of needs for PBS because that is really important for them as a public corporation. They receive a certain amount of governmental monies, but you know a lot of it. I believe, has to be raised and so forth. That has been an integral part of PBS since. I'm sure they're grateful for any support that they can get from a board member who realizes that it will be part of that kind of effort to help support PBS.

The other question that I had is that you do your own businesses, do you foresee any conflict of interest between the work you do with PBS and your businesses?

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: I don't think so. No. As a matter of fact, I also did not mention in my testimony that I had contributed to the past several times to fundraising

for PBS. I have donated wines when they have their wine tastings. I don't think they have done wine tasting for a while. But I do remember about maybe eight, ten years ago, they were doing yearly fundraisers for wine tasting and they approach the various distributors in the community, and I was one of them, and I always donated and contributed to it. I don't really think that there would be any conflict of interest. I will be willing to donate and pursue my colleagues and associates to donate whenever we do fundraisers.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: Are you familiar with the process of recusing yourself? That if for any reason that it came up, they did feel that there was a conflict, that you would be able to recuse yourself?

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: Oh yes. Of course. I will. There's no question about it. As a matter of fact, I remember at the University of Guam at one point. There was a discussion that had something to do with the Bank of Guam. I mean, I have nothing to do with the management of the Bank of Guam directly. But of course, my whole family works there. I own stock there. I did recuse myself from voting on this aspect. If at any point during my tenure as a board member of KGTF or any issue regarding conflict of interest with my businesses, mine or my family's that is Bank of Guam comes into question, I will certainly recuse myself. Yes.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: That's very good to hear. It's just important to have that assurance. When other Senators go through this nomination to prepare, they will read through this community report, and they will have read that on the record, you have talked about such things, and that will mean a lot to them to hear that from you.

The other part you mentioned with the fundraising is that we've been talking about it a little bit amongst ourselves, which is such a different time for us. It's perhaps going to be a time for the board and the general manager to really think about how to move forward with this.

I know that the board members are very dedicated. The general manager has shown creativity, as well. There have been many new and very interesting and very successful fundraisers and ones that really engage the kids sometimes and encourage education or reading habits and other things or healthy lifestyles. I look forward to what the board is going to continue to do with local programming with the ways that you're going to reach out and engage our youth and the rest of the community. I just picture the continuation of very many good things here. Was there anybody

else who wanted to make any statement or have a question? Yes, Mrs. Clement, if you can unmute yourself and then start with your name.

ROSEMARY CLEMENT, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, BOARD MEMBER: I'm Rosemary Clement. I've been a board member for several years now, and I welcome Mary Flora to our board. I think she'd be a great asset with her business background. Several of us are more into education, and I think we really appreciate that, and I'm very touched that she mentioned the legacy of her husband Tony, whom I also knew quite well, and I really appreciate that she said that. And I know this is close to her heart. I really welcome her to join us.

MARIA-FLOR L. HERRERO, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, MEMBER NOMINEE: Thank you, Rosemary. I'll try to prove true to my testimony.

ROSEMARY CLEMENT, GUAM EDUCATIONAL TELECOMMUNICATIONS CORPORATION, BOARD MEMBER: I'm sure you will.

SENATOR KELLY MARSH (TAITANO), PHD., CHAIR: Yes. It's very good to hear that. Thank you for sharing that, Mrs. Clement. If there's nothing further, we can go ahead and start closing up our confirmation hearing.

We've completed our line of questioning and hearing the testimony. Therefore this concludes the confirmation hearing for Miss Maria-Flor L. Herrero to serve as a member of the Guam Educational Telecommunications Corporation, otherwise known as KGTF/PBS Board of Trustees.

The time is now 6:37 pm, but I guess we can just wish everybody safety and well wishes for their family before we go. We know that this is a really just challenging time, and I'm very proud that PBS is here to get the community and our kids through some of these challenges by some of the work they're doing.
