

First of all, I'm very appreciative of Jillette Leon Guerrero's nomination of myself to be on the Board of CAHA. Just by way of background, I came to Guam in 1976. I was a high school biology teacher. I taught for three years, then went back to law school in Washington, D.C, and I've been back in Guam practicing law since 1983. Humanities have always played a big role in my life from my early teenage years. I enjoyed art. I loved to sketch and paint, although I've lost all that over the years. I kind of got distracted with other things. I've always enjoyed history, and I have been the recipient of two grants from the Guam Humanities Council. One was back in 1992-93 when I did an exhibit on the history of Japan and Micronesia. I traveled throughout Micronesia, gathering information about the Japanese administration. Not World War II, but between World War I and World War II. It was a fascinating experience it culminated in an exhibit. I think I had over 250 pictures and artifacts that were on display. Then a few years later, really as a result of that, Don Rubenstein recommended that I consider being in the Micronesian studies program, and I found that fascinating. It took me a while to get my degree my master's degree in Micronesian studies, but I did it, and again it exposed me to so many new things and just how many different cultures we have in the area. Those cultures' contributions sometimes involved art, learning about art history in some of the areas.

It was just a fascinating experience. Over the years, I've also written a number of articles on different matters. Between 2014 and 2017, I had a weekly column called Love, Life, and the Law, which was more centered on law but looked at different issues.

After that, I'm currently sitting on the Board for Humanities Guahan. I've been doing that for the past year or so. I've never forgotten my love for humanities. If I have any quality that I would potentially take to CAHA, it would be my sense of curiosity. I love to learn. I like to learn from other people, so it's really with that curiosity that I was curious when Jillette recommended I think about this. I thought, yeah, I think this is something that I would enjoy, and I think with time, and after the learning experience, I'll have some contributions to make.

With that said again, I am appreciative of this nomination, and I'm humbled by it and again, thank you very much.

SENATOR KELLY MARSH (TAITANO) PH.D., CHAIR: Excellent. I think where we met was in the Micronesian Studies Program, and I to be returning students, it can go a couple of different ways. You can get through it more quickly, but if you're working and have family obligations and other things, I say I took the scenic route. I took my time to get through the program.

WILLIAM D. PESCH, GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY, MEMBER NOMINEE: I think I took seven years, Senator.

SENATOR KELLY MARSH (TAITANO) PH.D., CHAIR: I just wanted to make that clear that I've known you for a real long time and have appreciated you and the way that you contribute to the community and the way that you think about our island in our region. I think that you are working in so many different ways to make those beneficial sorts of contributions. In thinking about your nomination and your background in Micronesian studies, I was thinking. You discussed it a little bit that we live in a region with so many different art forms, from chanting to visual arts to weaving, carving, and cooking culinary arts. The list goes on and on and not just Micronesia but Southeast Asia, of course, and all of this, so I think that educational background, having lived here for so many years, is not mandatory, but I do think it brings something with it. Some experience, some understanding, some depth of knowledge about potential and possibilities, and what exists there and one of the things that I found and perhaps have had come to similar realizations is Art within our region I think can be unified.

We do talk about the struggles of discrimination and things like this. There are a lot of efforts in Hawaii that are going on to try to get past some of those issues of discrimination. I think Art is one of the ways that they're bringing people together. To talk about some of those uncomfortable issues in place or otherwise, I was teaching "Fatinas i Latte" or latte carving. We were exploring together the possibility of how latte carving might have been to try to recapture it. I learned so much about how on Yap island and Yap's outer islands, to use modern terms. Places like Feis and Wooly Eye and then farther out, Okinawa and just elsewhere had these traditions of stone pillars and carving stone, and you know we were able to have this be something that people could see themselves in whether they were from Guam or not. I just think that there's so much potential in what you offer and not only in the Micronesian studies, but I think that can be a strong element to it.

I did want to ask about the Humanities *Guahan*. This is an interesting nomination because your nomination wouldn't go into effect until January, I believe. When is the Government of Guam ever like a few months ahead of time? Apparently, we're very organized sometimes. I was curious with the Humanities Guahan. Are you still going to be on the Board then, or is that when your Board seat would end?

WILLIAM D. PESCH, GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY, MEMBER NOMINEE: No, I will still be on the Board. I want to be upfront. I still have a couple more years on with them. To be candid again, I wasn't sure how the two would melt together if that poses any type of a problem.

SENATOR KELLY MARSH (TAITANO) PH.D., CHAIR: I'll leave that up to the Director to figure out, but I think actually in many ways it may have some very good potential. We are a small community. We have a limited size number of organizations. I think what better than to know very directly, firsthand, what both of the humanities entities are doing so that they're running in tandem, they're coordinated. They're doing different roles. Whatever it ends up being, that may end up working out very well, I think. I hadn't noticed that until just before this hearing started. I don't think it'll be an issue. I think it can be something that can be quite beneficial, actually. We will continue to sort that out, but I think that's going to be okay.

You spoke about your background and some of what you hope to do or see. Is there anything further that you'd like to see about types of Art to promote?

MEMBER NOMINEE: You know we were talking before about the fact that Guam today is a multicultural place. We have many different cultures here, and you were also talking about how Art can unite, so I really would like to see if amongst all these different cultures here, how has that influenced Art. Do we see some influence, let's say, from traditional *CHamoru* Art creeping into other ethnic groups artwork? I think that's one thing that would be a fascinating plus to see a number of shows about different artwork of different ethnic groups. I like the idea of trying to expose as many people in the community to Art and into the humanities and something I'd like to see and is maybe bringing it to shopping malls, to bring it to the mall where we have where it can be on display for a period of time so that more and more people are getting exposed to it.

I'm interested in just seeing a broader exposure of the Arts to the community and taking advantage of the different technologies we have. With the pandemic situation, this whole thing exposes the older generation a lot more to technology, and I'm thrilled with it. I think it's so interesting that the potential is there to use this technology to really get information about the humanities out to everyone. So I think that's where I'd like to go. I'd like to see it infiltrate more community areas and more approaches within the community to expose people.

SENATOR KELLY MARSH (TAITANO) PH.D., CHAIR: That sounds very exciting. Art, as you're mentioning, it's very dynamic, and you know I don't know the true history about I do, for a storyboard for Palau. When storyboards became an art form on Guam, you know maybe it is because of Palauans' interaction. But I don't know that history.

WILLIAM D. PESCH, GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY, MEMBER NOMINEE: Absolutely.

SENATOR KELLY MARSH (TAITANO) PH.D., CHAIR: I think having maybe even some discussions. I mean, obviously, it's up to the Board to decide. I would find it something really beneficial to the community to see the hundreds or thousands of years that they've been interacting with each other and how these art forms have impacted and influenced and inspired one another over time. When I sit down with weavers, I know they'll talk about the Yapese style and the Palauan style, and I think those could be some really beautiful moments that highlight our weavers here. But all of the influences and all of the weavers here and their different art forms. I always get excited. I always look forward to these confirmation hearings with CAHA because we talk about art, which I love doing. I appreciate that very much. Your other hat is being an attorney.

We're just waiting for the GSA to finish that, and if that happens, then we will have a place, actually a meeting place that we can use to have small events and book readings and exhibits and lots of things.
