

James Casallo: Yeah, I am feeling better already.

**Senator Telo Taitague:** James I, I appreciate you uh wanting to serve the people of Guam and stepping up to the plate. You mentioned you are working with the Guam Contractors Board for the last four years is that correct?

James Casallo: Yes Ma'am.

**Senator Telo Taitague:** And now your serving as the Chairman of the Guam Contractors Board and that's and voted in by your other colleagues is you know, says a lot about you. And you did talk about your work in Government of Guam before. Other than yeah, so it was GTA that you worked. Were you an engineer or you were what were you at GTA or what kind of other background do you have?

James Casallo: Actually, I was the engineering manager for GTA.

**Senator Telo Taitague:** Right on. That probably explains because of your background James, that they put the guy in charge who has that engineering expertise though I think they chose it. And so, James in the event there is something that you may have a conflict of interest with me.

**James Casallo:** Most of the contractors know each other so I myself as actually a contractor, I am also electrical engineer. I do a lot of design with the Navy, the Airforce, and local government and private industries. I have a lot of design work that I have been doing so I know a lot of the contractors on island.

**Senator Telo Taitague:** But did you, if there is ever a conflict of interest would you be willing to recuse yourself?

James Casallo: Yes yes.

I've also had a chance to be part of the Guam Realtor Property Research Task Force. Which is also a part of the Guam Association of Realtors. I am very excited to join the Guam Building Code Council. I did get a chance to meet all the members, the current standing members in last week's meeting Tuesday, July 28th and so I am very excited just to start my service within for this Guam Community and yeah that's all I really have to say and I am just ready to get to work. Thank you.

**Chairman Jose "Pedo" Terlaje:** Thank You very much Tony, let me go back to James. James I just want to because one of the issues that was when I was in the army and I used to own my own construction company also. You know whenever we have, what is the timeline on if there is an appeal regarding some of the things that when a contractor not really doing the work that they need to do and they file a grievance regarding you know the, what is the timeline to hear the appeal?

**James Casallo:** Usually we would, try and convene at the earliest possible date and then we would gather all the information and usually we would ask the AG's office for his opinion. And normally he sits on the board and comes in and we discuss, deliberate, and check all the background and check evidence and try to find out. We try to be fair, fair for the contractor and the owner. So, it usually takes about a couple of weeks takes about two weeks, before we try to resolve the case and try to be amicable and you know we try to be fair for both sides.

**Chairman Jose "Pedo" Terlaje:** So James if the contractor did not meet the merits of being fair and all of that, and the determination by the board comes out like you know, do they, if they need to take action, what kind of action do they take? Do they suspend the license do they or what do they do? I have been to those hearings already so what happens that you know.

James Casallo: We do, we do put out a fine, and we're trying to figure out the fine. Because sometimes you can go up to 50 percent of the contract, but you know we try not to go out that high. That's why I told the guys, the CLB staff, Executive Director, I said you guys have to try to, or figure out a cost for, first offense, second offense, and third offense. We tried to, you know, we have to put in writing just to make sure and say this is your first offense, this is your fine. So, we don't want to really go up to that because sometimes the contract can be up to five hundred thousand dollars, and if you go up fifty percent that's two hundred fifty thousand dollars. So that's obviously way way too much. I told the guys, and the staff I said you guys have to figure out you know succeeding costs, and we have to write it out and make sure and then I think senator, I think we were trying to figure out did they come up to your office yet? How to, what was the, because we tried to get escalation. I think we have to get a vote from the from, what they call this, the legislature, to find out exactly what can we do and then we just figure out a fine for that non-conforming contractor.

**Chairman Jose "Pedo" Terlaje:** Understood. James, have you ever come across a violation from a contractor that does not, does not really follow the building code, and just to buy the materials cheaper they do it for us on something like that? Where you deny the contractor to renew the license?

**James Casallo:** Yes, yes senator. We do suspend sometimes, we suspend like three months, we suspend three months, and if they're not you know conforming to what is needed, we extend the suspension. Sometimes, yeah, we did that for one project. So, our project, they didn't get the permit, they didn't get the certifications, and we suspended the contractor.

**Chairman Jose "Pedo" Terlaje:** James, so the fine is based on the violation that's the fine dependent on the violation of the contractor?

James Casallo: Yes sir.

**Chairman Jose "Pedo" Terlaje:** Okay James thank you, thank you. Let me let me go back to Tony. Tony Are you ready?

Anthony Paulino: Yes sir.

Chairman Jose "Pedo" Terlaje: If you can share your thoughts, let me have it.

Anthony Paulino: What's that? Sorry.

Chairman Jose "Pedo" Terlaje: I said if you can share your thoughts let's have it.

Senator Telo Taitague: Yeah actually Mr. Chair Tony just gave his opening remarks.





Anthony Paulino: Yes.

Senator Telo Taitague: He already did.

**Chairman Jose "Pedo" Terlaje**le: Let me have some of the things that that entice you to really apply for for this job. That's what I am trying to ask.

**Anthony Paulino:** Over the last two years, I've been asked to at least guide, or advise whether it's within my expertise or not. Just advise developers on building different types of project from single family houses to multi-family houses, and really I just saw this as an opportunity to learn and to grow with people who have been in the business for over 20-30 years and been surrounded by these types of projects right? So I'm just looking to get my experience and really learn how to learn how things work and to learn and hopefully advise you know our future youth, once I have the experience so yes that's that's my take.

Chairman Jose "Pedo" Terlaje: Okay. Thank you, Tony. Go ahead Senator Telo.

Senator Telo Taitague: Si Yu'us Ma'ase Mr. Chair, Tony how's it going?

Anthony Paulino: I'm good, how are you?

**Senator Telo Taitague:** I'm fine. Thank you. I really love your enthusiasm. Definitely sounds like you're a go-getter, and you're looking forward to getting started right away. Just showing up at the board meeting says a lot about you. You could have waited until you confirmed but I'm glad that you're already diving in into this and finding out the responsibilities of this particular board. Is there anything you want to share with us? I mean I'm sure you have a lot of ideas, and plus you've been in this line of work. Do you, is there anything you would like to see that this board could do to improve the real estate on Guam.

**Anthony Paulino:** Me and Brent were actually talking about this. Brent Weise is the Chairman. Two things or the first thing we had off our bat was creating a website a website that would create transparency on what the Guam Building Code Council actually does because I believe half the population here on Guam don't really know it exists and I think for me and Brent our first task was to create and publicize the website which would showcase all of our conferences that we will hold. It will showcase the schedule of events; it'll showcase the work we're doing right and probably showcase an agenda of what we tackled for each monthly meeting. So, I think once we get the website going, we could further reach out and be transparent to the public and work with them to kind of create this synergy moving forward. So, yeah that's all right that's our project.

Senator Telo Taitague: you said my favorite word and that's transparency. So, just by saying that word you have my support and it is a great idea Tony. I mean of course to put that out there and also put down any kind of rules and regulations anybody wants to follow as well so it's as easy as just going on the site and ensuring that they comply to certain codes or anything moving forward. But wow you had me at transparency, so I thank you so much for stepping up to the plate and I'm encouraging on both nominees to ensure that you do attend these meetings. People really count on you; you know by taking on the confirmation or taking on this position and accepting it comes the responsibility of always showing up during the board meetings it's so important to move things through by your presence alone but I thank you so much again and I wish you the very best and you definitely have my support Tony. Thank you and yours too James you have my support my friend. Okay, thank you. Thank you, Mr. Chair.

**Chairman Jose "Pedo" Terlaje:** I just wanna you know you're a certified Military relocation professional. What do you do?

Anthony Paulino: So, we actually took the it's a designation that um it's part of the national association of realtors continuing education programs and so it basically boots us on the VA loan process um what families military families actually go through when they do relocate their process and line of work. The timelines of when they would need to find a place from when they hit home right or when they do arrive to Guam and how they have a temporary lodging allowance which is about 30 days. But within those 30 days they need to find a place outside whether outside base or on base. They have 30 days to find a home so we're trying to. It's more of understanding that process and trying to sympathize with these military servicemen who relocate every three years so that's what the whole training was about and yeah the VA loan process is um what do they qualify for here on Guam . If they were to purchase a single family or multi-family unit so that's what that's to summarize that's what the military relocation professional is about.

**Chairman Jose "Pedo" Terlaje:** So, your actually involved in uh with the military and as far as relocation for servicemen on the common island and even off island I assume.

**Anthony Paulino:** We work directly with Navy and Air Force housing to get these tenants who are looking to move off base and yes we were tasks sometimes we need to find them a place within three days sometimes it takes two months but yes just working that's my primary market right now just working with single military and military families.

**Chairman Jose "Pedo" Terlaje:** Thank you, Tony. I would like to congratulate the both of you for taking the challenge and I know you guys are gonna do good and with the record that you have I know you have been you've proven your you know your enthusiasm to continue on making sure that you know we build Guam and especially for Tony. You know the advice that he gives to this military personnel coming on island and I'm pretty sure you tell them about you know

how we live here on Guam and you know what we expect so thank you. She's a good friend of mine. She's a good lady and I know she's going to be in the 36 Guam Legislation. Thank you, Telo.

**Senator Telo Taitague:** and thank you Mr. thank you for those kind words, but I definitely didn't want to miss out on Tony give Tony and James the respect to be here tonight. You take the time out to serve the people and you deserve us being here tonight to that thank you for that.

**Chairman Jose "Pedo" Terlaje:** We need to we really need some of the construction here and I've been involved in construction and I know a lot of construction companies that kind of undermine you know the building codes sometimes because you know they get cheaper materials and things like that and by the time they enclose you know whatever you know the building is done and everything is painted and they cannot see what's behind that paint so uh James watch out for that please.

James Casallo: Yes, sir will.

**Chairman Jose "Pedo" Terlaje:** I would like to thank all of you uh for your participation in today's confirmation hearing for James M. Casallo and Anthony C.
