

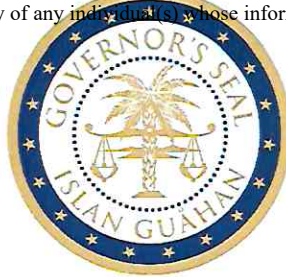

II. SUMMARY OF TESTIMONY & DISCUSSION

The confirmation hearing was Called-to-Order at 2:03 p.m.

→ **Chairman Jose "Pedo" Terlaje:** Good afternoon ladies and gentlemen. Before I share some of my thoughts here, I want to thank each and every one of you Senator Telo, Cell and Bernadette for being with us this afternoon. Let me just say that this public hearing is now called to order today's date is Friday, December 04 and the time right now is three minutes after two o'clock. The Committee on Public Safety, Boarder Safety, Military and Veterans Affairs, Mayor's Council of Guam, Infrastructure and Public Transit is now conducting a public hearing today for the appointment of Mrs. Bernadette D. Wiemann to serve as Member of the Board of Directors for

the Guam Regional Transit Authority and for the record and in conformance with Section 8107 of Chapter 8 Title 5 GCA. The first public hearing notice was sent out on Friday, November 27, 2020 to adhere to the five working days requirement and the second public hearing adhering to the 48 hours-notice was sent out on Wednesday, December 02, 2020 and in addition to these notices were sent out to all the media and posted on the Guam Legislature's website. I would like to thank my colleague Senator Telo is the only one here right now and I want to thank you very much because she's always very active and things like this and thank you very thank you very much senator. First of all, let me go over some of the general rules the rules of conduct during this session the host of this hearing will mute all participants until called upon by the chair. When called to speak please ensure that you are unmuted and that you are speaking into your microphone. Members of the committee and the legislature wishing to speak may indicate the desire to the chair through the in-app chat feature. Individuals testifying shall first be recognized by the chair before speaking and should state your name for record-keeping purposes. The order of the questioning will begin with the panel of senators, who shall complete their lines of questioning for each respective item on the agenda. Upon completion of the panel's line of questioning, the chair will pose questions. Each member will be allowed to pose a question to an individual testifying for a round and will be provided another round, if needed. Questions and testimony shall be confined to the substance or nature of the agenda. Personal interference as to the character or the motive of any senator, or any individual testifying, is not permitted. Any violations of this general rule of conduct will result in removal from the public hearing by the host and we will now have those that are testifying for Mrs. Bernadette Wiemann proceed first and then we will have Mrs. Wiemann testify for herself and let me just first kind of just I'll go with the oh by the way we have Senator Sabina Perez with us and my favorite Senator James C. Moylan thank you Jim for being with us and also the Manager for the Guam Mass Transit Authority thank you Cell for being with us and most importantly Madam Wiemann, thank you very much. So, we're gonna I'm gonna start with uh since Telo was the first one here. I want to start with her.

Senator Telo Taitague: Si yu'os ma'åse Mr. Chair for the opportunity. Håfa adai, Bernadette um thank you for stepping up to the plate. I was hoping to hear what you had to say before I spoke, but I guess I could ask the question first that normally if there is any um conflict of interest that you have in your pos as you sit in this position and is there any conflict that you may foresee that may happen um are you willing to recuse yourself and you can unmute your button Bernadette now.

Bernadette D. Wiemann: Okay, here we go can you hear me now. Buenas yan håfa adai thank you for all of you to um my confirmation hearing today um there is no conflict of interest that I foresee as far as conflict-of-interest um meaning the GRTA versus uh like any interest with the transit authority.

Senator Telo Taitague: yeah, or any other asking well sometimes yeah sometimes you can have um relationships with people that have contracts with the Guam Mass Transit you know you can so it's things like that uh but in the event that should happen are you willing to step aside and basically recuse yourself.

Bernadette D. Wiemann: right, no I don't have any uh conflict with of interest.

Senator Telo Taitague: okay, that's good that's very good to hear and again I thank you so much for stepping up to the plate. One last question, why this board? Why would you like to serve on this board Bernadette?

Bernadette D. Wiemann: oh okay, I um I started writing the Guam Transit Authority since 2015

and I have experienced I have seen the difference between the back then like say five years ago to where uh Mr. Cell Babauta have really taken over and have produced a lot since his management um I've seen the difference and I can see myself uh as far as being a rider and then the experiences that I have back in the states that I've seen compared to our little island of Guam. I really love to improve and serve the people and that falls in the Guam Transit Authority.

Senator Telo Taitague: and Bernadette what are some of the responsibilities as a board member uh for the Guam Mass Transit or Guam Regional Transit Authority what is some of the requirements?

Bernadette D. Wiemann: okay I am very new and um I will learn responsibility okay as far as the values and as far as the directorship of the leadership and management right now I need to comprehend and follow and also the values um the transparency and everything that falls under the directorship under the leadership of Cell Babauta and I know I know he's doing a great job and I really want to compliment him uh and thank you also uh you know for giving me a chance. I want to be given a chance uh because I have uh oh gosh just um and everything that I do I want to do my very best and serving the people of Guam. I am from Guam and uh I like to start by um starting with this board to be a board member.

Senator Telo Taitague: uh well you know thank you for saying that if all the like Senator Pedro Terlaje mentioned I tend to try and go to all the confirmation hearings as well as any kind of public hearing out there and I have to tell you Bernadette but it's the first time that I've heard someone uh asked to give me a chance you know to do what you want to do and that sit on this board and that's the first time I've ever heard that and that's very touching it's honest it shows your honesty right now and um how you're willing to do your best it's very admirable and my last question uh is what kind of background do you unfortunately I don't have your packet in front of me uh I didn't see it here. Um so, if I may ask what is your background?

Bernadette D. Wiemann: oh, my background I um I love the Catholic Church as a Roman Catholic I um I lead the Legion of Mary as president. I served two terms um back in Washington State um called Holy Trinity Catholic Church. I was the president and I served two terms there. We had members um some members between eight to fifteen members and um I think uh we did a good job uh as far as uh the priest came up to ask me to start the Legion of Mary because it was uh fading. It was really just fading out at our church and he asked me to start it and um I'm grateful that uh you know being close to God with my faith I uh I led and uh I think that was a great job so that and then also um I tend to love people I have good customer service I have empathy for people um that are marginal um you know as far as helping people and I think this uh this category as far as that Guam Regional Transit Authority I think I love to start there and serve there to the best of my ability so.

Senator Sabina Perez: Yeah, uh Senator Pedro. I was hoping if I could uh listen to her testimony prior to any questions if that's ok no problem. James, do you have any anything to start out with before Bernadette comes on.

Senator James Moylan: Um, likewise I would like to listen to what she has to state. Thank you, Mr. Chairman.

Chairman Jose "Pedo" Terlaje: Okay, Bernie go ahead and give us your thoughts.

Bernadette D. Wiemann: All right. Oh yes, Senator Pedro or Pedro I have a brother named Pedro and uh he loves his name. Uh, Senator I'm encountering this is uh an exciting time in my life uh as a senior and uh just seeing uh the new faces of Senators in the legislature and the new boss Mr. Cell Babauta I can attest that I came last August back from the states um you know being a senior and then um kind of retired you go back and forth. What do we do as seniors and more like retired on the retired side and being on the elderly side of course we love to you know meet up with our grandkids and our children and travel and I just love to travel so um I'm very thankful and grateful that you know I can speak in front of you your panel um senator all senators and uh Mr. Cell Babauta that uh the experience in my life now um we have a lot of wisdom to give the young people here on our island and uh the more affirmation that we have the more beautiful experiences and just show them how to be good citizens and to be uh just by our examples really makes the difference in life and I hope and pray that whatever legacy that my parents have shown me um you know I can show our island and the people of Guam and uh everybody that I meet um just to better our island. Should she be confirmed by the legislature to be one of the GRTA's board member. For over 20 years I've known her as a military spouse who worked hard to care for her family. She has traveled lived in the states and experienced riding on public transportation. With her relentless work ethnics, I believe that she will work hard to provide guidance and policies which will contribute significantly in affording Guam with the viable transit system. Her membership on the GRTA board will unquestionably allow her to share her experiences as a transit rider in the states as well as here on Guam with the Guam Regional Transit Authority's paratransit system. GRTA continues to achieve challenging milestones such as providing paratransit riders with their transportation needs. We'll be purchasing electric buses and cars, building its own facility, implementing the uber route mass transit system, park and ride and much more. For sure Mrs. Wiemann will be instrumental in forgoing policies that will

Chairman Jose "Pedo" Terlaje: Thank you very much Mr. Manager. Thank you Cel and now we'll go to Senator Perez go ahead Senator Perez.

Senator Sabina Perez: Thank you, Mr. Chair and thank you Barbara for stepping up to the plate. I know it's a big decision to come out of retirement and to provide public service. But, looking at your resume it's something that you've always been committed to serving the public through your faith and I know Cel Babauta has done great work over GRTA and he's definitely turned in around you know from not having operational buses and just seeing the huge change and I'm sure that relationship that you've had with him for many years I think he sees you know definitely that you can contribute to further this you know improvement. So yeah, it's interesting I was looking over your uh your history and uh you were in Guam uh you worked at DOE up until it doesn't say to what year, but I think I'm guessing the 70s is that correct. So, uh you know once we hit the senior of 55 years that's uh our prime time and that's like um we're wondering where are we going to serve and um and I'm happy to say that discerning also I'm back over at Piti Church. I do lecture there um every Saturday night at the pms and so um it's beautiful having our faith. Our faith is what makes a an individual strong and uh the integrity to do anything uh to the ability and the transparency is really really needed here on our island also.

Senator Sabina Perez: So, I'm hearing yeah, the calling perhaps to really serve our community and I do appreciate you stepping up to the plate to do this and um yeah, I feel the heart that's coming.

Bernadette D. Wiemann: yes, um it's not much but it would take me um I would do more than what is needed if um I research or anything to go out and talk to the people. I would love to do more than what is requested of me you know as a board member and this is exciting because uh, I think this is well one thing that um probably maybe to-do list you know like um I was a young mom and then all of a sudden um you know I had to grow up right away. Um, but serving in the capacity of you know back like say to the uh to our island is like serving um being from here. How to grow to just grow to just grow and uh more to be in leadership that's the way I see myself.

Bernadette D. Wiemann: oh, um well this afternoon or I'm sorry this morning there was an amble meeting with GRTA, and I guess I came in at the last part of the meeting but um I would sure follow up on that. I have seen the improvements um with the GRTA. As far as Cel Babauta his leadership I have seen new bus buses have been retired. Just the mechanical sometimes I hear you know the bus breaking down and so these are beautiful improvements by Mr. Cel Babauta new buses um new cars now they're into the tablets instead of the phone they're calling in. The tablets are enforced in the cars. There I think it will be you know I'm hearing less and less complaints from people but um the improvements will come I'm sure it's just with this pandemic it's really uncertainty as far as where everything is going right now.

Senator Sabina Perez: okay, so as far as you committed to attending the board meetings do you would that be something, you're committed to attending all the board meetings and such.

Bernadette D. Wiemann: oh yes, whatever um I how many times a meeting a month uh I would go definitely. I um you know if I'm committed to something, I will adhere to my um it's like a prom just like anything else you walk the talk and you know do the very best you can.

Senator Sabina Perez: okay, um as far as um working with board members uh or groups um have there been any situations where like for instance the majority of the group believed in something, but you felt it was different you had a different idea. How would you go about resolving any kind of issues if you're working in a group setting?

Bernadette D. Wiemann: well, the main thing is everyone should try to be on the same page and the leader would be uh our leader would be Mr. Cel Babauta. I have never I attended more like a public hearing with the GRTA. I didn't sit on the board, and I look forward to meeting everybody the board members and we just have to comprehend and just have a peaceful talk and resolution as far as uh conflicts and everything there's always a resolution. Solution to everything and uh and then happiness goes after.

Senator Sabina Perez: Well, thank you. Thank you, Bernadette. You have my support. Si yu'os ma'ase.

Bernadette D. Wiemann: Thank you very much. Si yu'os ma'ase. God bless.

Chairman Jose "Pedo" Terlaje: Senator Jim.

Senator James Moylan: Thank you, Mr. Chairman. Uh thank you Bernadette for accepting your nomination I'm looking forward to looking forward to seeing some good good work with you and your other board members. I just want to really express that um your kind of our eyes and ears over there and feel free to come to your senators your chairman there as well and bring to our attention things that you see uh need improvements especially with the laws that could be adjusted. So, it's in writing now but if it could be put better or improved on then that's where we're hoping I think that the board members will be able to explain that and express that to us

I'm also hoping that uh you know there's a lot of good things on going on, but I think you got the vision of what our other senator was trying to explain as well that you'll also look for improvements uh to provide the service to the people. So, please anything that you think you need our help with go ahead and reach out to us and we want to do our best for the transit system too. So, thank you for accepting your nomination I'm looking forward to your confirmation hearing. Thank you, Mr. Chairman.

Bernadette D. Wiemann: Yes, okay thank you Senator James.

Chairman Jose "Pedro" Terlaje: Just a couple of questions that I wanted to ask Bernadette. Um, since you arrived uh Bernadette and you've been over at the mass transit authority facility. What would be the first thing that you might want to recommend to Mr. Babauta in as far as services or additional vehicles or maybe more stop signs for the pick-ups what would be your number one you know uh issues regarding you know satisfying the services of the mass transit authority.

Bernadette D. Wiemann: Okay, one thing I hope I'm answering because you were fading out Senator Pedro in uh the question but um when I go over to the Public Works the transit authority there it looks like it's in a building that is right there at Public Works that is okay but that would be nice to probably be uh you know be able to go to a transit station downtown meaning Hagåtña uh where it's where people are more accessible to the transit station. Uh, because everywhere you go back in the states like every city or every little town you can go to um you know to the station and there's the buses there, there's the train, there's places where you can purchase your tickets and so what I kind of like to see is downtown Hagåtña. That is our capital and I'd like to see that transit office or uh you know one of the main office maybe down in Hagåtña. You know that's just an example.

Chairman Jose "Pedro" Terlaje: Bernadette, one of the things that you might be really thinking about is are you gonna base the bus pick-up based on the population or the size of the village. How are you gonna work on that one like Dededo is actually got more you know people than in the southern area so maybe what you might be thinking is maybe putting more bus shelters bus stops in those areas that are more populated than in areas that are not so populated and I know Cel have come out with the solutions for that so I just wanted you to maybe give your insight because you've been at the states and you probably experienced some of the situations and some of the things that they do in the states and maybe some of your input would probably uh reinforce the problems that we have in as far as the numbers of bus stops or whatever rules and regulations that we need to put in place. I'm pretty sure that Cel Babauta have already mentioned that to all the board members so may I ask how many board members do you have right now because I know we've been waiting for Bernadette to come to actually meet the numbers of members to prove whatever we need to do with the mass transit.

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): GRTA Mr. Chairman GRTA has four board members so with Bernadette it'll be five. So, then we'll have a little bit more flexibility but on the other hand we need a couple more board members and we're working on that.

Chairman Jose "Pedro" Terlaje: Okay, so how many would you recommend that we need?

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): Pardon me Mr. Chairman.

Chairman Jose "Pedro" Terlaje: How many board members do you think you might want to have

to smoothly come out with the you know the services that you know mass transit is doing. Are you enough with the five members because if you do need more board members then maybe I can get together with the Governor and ask her to give you more board members and you know more members to the board?

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): Mr. Chairman, thank you for that question. We currently with Bernadette we have five the law allows us to have seven board members and I believe that seven will be just fine for GRTA so with the help of two more board members I think that will be very beneficial for the Guam Regional Transit Authority.

Chairman Jose "Pedo" Terlaje: So, you actually need two more?

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): yes sir.

Chairman Jose "Pedo" Terlaje: okay and let me just say because probably you mentioned this to some of the things that's happening at the mass transit Bernadette you know the building that they have up there was telling Cel that you know the space the building that they're occupying right now it will suffice but I think there's a process to construct a mass transit authority facility. That you know it's financed through the federal funds and pretty sure pretty soon everything I think the only problem there is that they're working on the plans for the structural plans for that so once that is done, we're probably gonna start the bidding process on who's gonna construct. Right Cel.

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): Yes, Mr. Chairman. As a matter of fact, for your information as well as the other senators we're 30 percent designed complete on for our facility and our facility will have a maintenance part of it uh transit management center and also uh administration of finance. So, we're 30 percent complete on that and we have funds from the federal government to build our facilities so as soon as the design is done I'm hoping that by you know the first quarter of 2021 we'll begin to uh to um you know hopefully we'll have groundbreaking you know but really one uh initiative that we're very excited on is the fact that we're you know we're going to be buying uh electric buses and electric cars to meet the demands of transportation for you know the most vulnerable people in Guam throughout the island but you know with Dededo and Yigo and of course the Anderson Air Force Base and the Ben Blas Marine Corps Station you know we're looking at again we have funds uh the FDA awarded us nine and a half million dollars. We're going to build a park and ride facility and we're going to use electric buses and we're going to use electric cars and the purpose of the electric cars is really um in addition to that we're also buying a transportation management system that will allow our riders to download the app schedule their rides and get picked up with electric cars brought over to the park and ride and get on a bus on an electric bus to go to you know whatever destination they like to go to. So, that's kind of like uh the big plans that we have for up north. But, on the other hand we're also working on other projects for the southern part of the island. So, it's been a big challenge, but you know I have a good team and a good set of board members and I think that with Mrs. Wiemann we'll be able to do a lot more for the people of Guam and you know one thing that I like to remind people is the fact that we've only been on board less than two years but we're working hard to provide for the people of Guam.

Chairman Jose "Pedo" Terlaje: and I thank you for that Cel because you know we've been in touch you know we've been talking about improving the services and you've done a lot. How many transportations do you anticipate to have to satisfy the services?

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): Well, you know if you take a look at the 2030 Guam transportation plan, they mentioned about Guam needing 50 buses

but then again that's with the old concept of transit operations where you have buses going from one bus stop to the other hoping that a rider will be there. Well, our mindset is to come up with mobility on demand. Something that's uh coming up rapidly in the states where you know you have a transportation management system with technology. They will allow our riders to download the app schedule their rides. It's like uber back in the states. So, when we send out a van to pick-up I mean send out a van that van is going out to pick-up riders it's not going out hoping that somebody be there to pick-up we're going to be able to send a van out through technology and pick-up riders and that way we'll be able to be a little bit more efficient in our management of resources so we don't have to be buying gas and you know uh doing more maintenance on their buses without having any riders on buses. So, that's a concept as a matter of fact GRTA again was awarded 1.9 million dollars. These are competitive grants we compete with other transit agencies in the states. We won 1.9 million dollars to do a feasibility study to use uber route match transit system and we're going to be working with the University of Guam to do a feasibility study using that type of transit system in Agat, Santa Rita, Piti and Naval Base Guam and the results of that study will enable us to step back and say hey is this transit system going to work well for Guam. If it is that's something that we're going to bring up to of course the governor and the legislature and allow us to use that for Guam, you know. But, uh it's just uh transit system is very very very important for Guam in order to grow an economy in order toin order to build the economy, reduce congestion allow more healthy environment for our people. So, we're working hard despite the limited resources that we have as a matter of fact Mr. Chairman I just wanted to let you know that even though the budget has been passed we're already looking at the budget for the next year because you know our budget is minimal. If we and if we want to further improve our transit system, we need to provide a little bit more priority for the Guam Regional Transit Authority and I'll tell you what we have a lot of people out there who are willing to work but they don't have transportation. So, with a little bit more resources I think we can allow people to go to work build our economy and have less dependency on social programs in Guam.

Chairman Jose "Pedo" Terlaje: Cel, you know I've recommended a couple of people you know drivers for mass transit authority and I know that's going to be a challenge for you because you know we do have a lot of vehicles coming in and the challenge is going to be it's not going to be easy to recruit you know bus drivers transportation for mass transit because you're going to have to interview them and they're going to have that those experience in driving you know buses and things like that. So, that's going to be a challenge but I'm going to continue to do that search for drivers for mass transit authority. With that ladies and gentlemen, I would like to thank all of you for your participation in today's public hearing for the appointment of Mrs. Bernadette Wiemann and if you have any written testimony you can email it to senatorpedo@senatorjpterlaje.com or hand deliver it to my office at 140 Aspinall Avenue Bridge Point Building Hagåtña, Guam 96910 and the time now is currently quarter to three and the Committee on Public Safety, Boarder Safety, Military and Veterans Affairs, Mayors' Council of Guam, Infrastructure and Public Transit is now adjourned and I want to thank each and every one of you for being with us today. Thank you and we're going to just we have I have another hearing we're going to recess until 3 o'clock for Bill No. 413-35 and I think that's Sabina's uh that's I think that's your Bill. Thank you.

Celestine Babauta (Executive Manager, Guam Regional Mass Transit): thank you very much senators.

Senator Telo Taitague: Thank you, Celestine.

The confirmation hearing was adjourned at 2:45 p.m.
