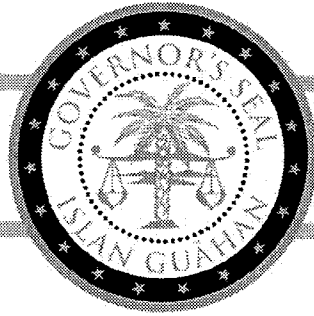

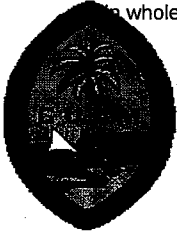

- Appointed by *I Maga'hågan Guåhan* on March 20, 2019, to fill the unexpired term of Katherine C. Sgro, expiring on July 5, 2021;
- Appointment packet forwarded to *I Liheslatura* on March 22, 2019;
- Appointment packet forwarded to this committee for public consideration on March 26 2019.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 5: 10 PM.

Vice Speaker Telena Nelson: *Hafa Adai*, Good Afternoon, thank you all for being here. The Committee on Education, Air Transportation, and Statistics, Research and Planning will now convene this Confirmation Hearing. Today is May 23, 2019, and it is currently 5:10pm. For the record and in accordance with the Open Government Law, public notices were sent out via email to all senators, stakeholders, and all main media broadcasting outlets on May 16, 2019, and the second notice on May 20, 2019 Notice of today's Public hearing was also available on the Guam Legislature's website. With me today is Senator Amanda Shelton, who is also the Vice Chair on education. Senator Telo Taitague, Senator Regine Biscoe Lee and Senator Therese Terlaje, who is the vice chair for the overall committee. Thank you, senators for being here. On today's agenda, we have the appointment of Mr. Brian Bamba to serve as a Member of the A.B. Won Pat International Airport Authority Board of Directors. The appointment of Mrs. Doyon Ahn Morato to serve as a Member of the A.B. Won Pat International Airport Authority Board of Directors. I would now like to invite those who would like to provide testimony on his behalf. For the record, please state your name and if applicable, the agency or organization you represent.

Mr. J. George Bamba: Thank you madam chair and members of the committee. It's an honor to be here with you today in this historic building and I also want to first thank you for scheduling the hearing for Brian and also to thank the Governor Lou and Lieutenant Governor Josh for the confidence they have in appointing Brian to an important board. I'm sorry I don't have any written testimony, but I feel since I've known him since birth, I could probably speak with some authority and knowledge about his background, character and his accomplishments. Joyce and I are extremely proud of Brian, since graduating from USF, the first position he ever had coming back to Guam, he was with one of his classmates and they were hired by the airport authority at that time was undergoing a massive modernization. They were responsible for developing the financial plan and the bond financing plan as Part of the overall masterplan for the airport authority. I was privileged to have served at the legislature at that time, which gave the final approval to proceed with the expansion program. So it's kinda come full circle for me, certainly, to be sitting here because it comes at a time where they're embarking on another major expansion plan and I think that the people that they have certainly, I believe are much more capable in enacting and ensuring that the vision of the master plan and the projects that are going to be completed, will continue to improve Guam's future and for now into the future for all of the people. Most especially, for the development of the island. So it is a critical board and I could say without hesitation that Brian is well qualified, having served and worked in the private sector primarily for both transportation and fuel supply operations as well as other private sector businesses. But I just wanted to mention in addition to his experience, he's also been very involved in the community organizations and I didn't really know this until much later that he took up Jiu Jitsu and work himself up to a black belt. I found out when he was actually setting up a gym to be

able to mentor young kids and have them participate in the sport and instilling discipline in them and just being able to mentor their progress. So of course he is also very supportive of non-profit organizations that always benefit the community such as the hospital volunteers and other notable organizations that have to do with the community. As I said, it really brings a deal of pride and joy to be able to see the next generation of leaders in addition to yourselves that will be guiding this island into a brighter future with a vision that would provide hope for our people as well as sustain the economic development and social development of our island into the next generation. So thank you and I humbly ask for you support for Brian and that he will be confirmed to serve on the board. Thank you.

Vice Speaker Telena Nelson: Thank you very much.

Mr. Jim Oehlerking: Thank you madam chair, my name is Jim Oehlerking and I'm the CEO of IT&E here. I haven't known Brian for his whole life. I've been here for 4 years, but I've worked very closely with Brian and I really feel he represents a very unique and important mix of qualities that I think would be critical in the development and activities currently going on at the airport. I think he has demonstrated in the 4 years I've worked with him, a level of innovation and creativity balanced with a strong business sense and a tremendous commitment to the community. I feel the airport projects going on are critical to the tourist industry, being the first entry point into Guam and creating the image of first views of the environment here, I think the work that is going on now is going to be critical for the long term prosperity of the tourism industry and the image that Guam gives off to the visitors here. I think that his balance of creativity innovation and solid business sense will be valuable in the activities that are going on and that will continue to go on at the airport. It's a very qualified and unique skill set that I think would provide great value and I fully support his activity to be a member of the board. Thank you.

Vice Speaker Nelson: Thank you sir.

Candy Okuhama: Good afternoon senators, my name is Candy Okuhama. I remember sitting in front of most of you just a year and a half ago, for my ABC confirmation hearing and thank you all again for supporting me. I'm here to support Brian Bamba for position on the Guam International Airport Authority. I've known Brian on a professional level for over 20 years and I believe he would be an excellent choice as a board member. Brian possesses all the necessary qualities to help shape a successful organization. Additionally, he desires to stay at the top of his game. It's clear he consistently offers a fresh perspective and creative approach to projects. He remains focused on the big picture and leads the organization towards its goals. If given the chance to serve, Brian would become a strong member of the Guam International Airport Authority Board.

Vice Speaker Nelson: Thank you very much Candy. Mr. Bamba?

Mr. Brian Bamba: Thank you. *Buenas and hafa adai* senators, madam chair, thank you for accommodating me during this time. My name is Brian Bamba and I am honored to appear before the committee regarding my nomination to serve as a member of the Guam International Airport Authority Board of directors I'd like to thank everyone that came and supported me. It's quite humbling and I've never really had this experience but I feel very undeserving of your kindness and I'm very grateful appearing in this historical building. It brings memories of my life as a child in a political family. I attended Cathedral right across the way and I would come to this very building and every single day after school and kind of it was my playground and I was part of a generation of some unpaid runners. Namely the Tanaka's the Derkings, Palamos and the Duenas' you know who we'd run around this place and while our parents and our grandparents were forming the fabric of our community so it's pretty humbling and so I'm also appreciative and humbled by the governor by governor Leon Guerrero's and Lieutenant Governor Tenorio's confidence in considering me for a board member of the airport. I've spent 99% of my career in the private sector. I think my dad even recounted more than I remember of myself and my career and coincidentally my one job in government service was in the airport authority as an administrative assistant starting out and learning the operations and dealing with the folks who were master planning the expansion of the first expansion of the airport and so I'm fairly familiar with the airport operations and the business of the airport but by no means am I an expert you know I'm pleased to see that many of the folks that I have worked with at the time continued their development and now hold leadership roles in the authority and it's a testament to you know the employees and the leadership up at the airport. The airport's in good hands I believe in Mr. Ada and Mr. Quinata who are proven leaders in their own right and as well as the hundreds of dedicated employees who service thousands of customers airlines and tenants who frequent and call the airport home. I feel that my experience in the private sector where I lead over 300 employees enables me to contribute to the policy leadership at the airport my colleagues serve thousands of customers daily and our business plays a very vital role in the quality of life that we enjoy here on our island and I think the same as well as in the region and I think the same can be said about the airport I'm also experienced in large-scale capital improvement projects in our own businesses as well as complex commercial transactions and disputes and you know similar to what the airport finds itself facing today at the end of the day I'm a citizen of this community and I want what it's good for us and for our people. I'm a frequent traveler and I am a customer of airports not just our own and I understand what expectations customers have for airports when we travel and you know my views at airports move economies and I don't I don't need to explain what the importance of the airport has on our tourism business which is the backbone of our economy and so the challenge is that the airport is facing are not small or insignificant and redeveloping them requires collective efforts of the board and

management and I'm committed to the role of policy and equipping management with tools necessary to effectively run the airport. I believe that's the role that I've been nominated for and so I commend you for your service to our community and I look forward to your consideration of nomination thank you.

Vice Speaker Telena Nelson: Thank You Mr. Bamba. I'll open up any questions that my colleagues may have for you. Senator Shelton would you like to go first?

Senator Amanda Shelton: *Si yu'os Ma'ase'* madam chair, thank you very much Mr. Bamba for accepting the governor's nomination and I thank all the people here today who came to testify in support of you. I'm very impressed by what everyone here has said. These are people who are very respected in our community and so that gives me a lot of confidence in your ability to serve on the airport board. I know that you have held this leadership position in your current role in the private sector and I'm glad to hear that you do have some experience at the airport, which I think will bring value to your position there. So I just wanted to ask if you feel that taking on this role you are obviously a very busy man and your dad did mention that you're very involved in the community and that's how I know you in these different community positions where you're very giving of your time and I just want to make sure that you have the time to give to the airport and to these meetings and to give your efforts here and this another position to add on.

Mr. Brian Bamba: Sure I know it's a huge commitment and it's something that I'm looking forward to so yes.

Senator Amanda Shelton: Okay thank you very much. Thank you madam chair

Vice Speaker Nelson: Thank You senator Shelton. Senator Taitague?

Senator Telo Taitague: Thank you madam chair and thank you for everyone being here today to testify in support of Brian. I've known Brian for many years in fact I have to ask the question to sissy do you agree with this confirmation? Okay you got you got the head of household agreeing to you sitting here today and that's a half of the process you know. Having your family behind you and backing you up doing this because it does require a lot of time a lot of your time and Brian it's good to see you here because you know you there's a lot of things that you can be doing and now you have the opportunity to give back to the community by serving in this capacity. I thank you for that because I know you're a wealth of knowledge and I really appreciate you doing that there is one thing when you do go to the airport there is some funding in another agency that I feel that the airport has should always been able to. I know you collaborate with but and I know Airport is always looking for funding and I think that a more closer relationship with the Guam Visitors Bureau and the airport might given advantage to the airport especially

when it comes to funding and so I hope that you reach out to Guam Visitors Bureau and really be a have a proactive approach with them and moving forward because that's where you're gonna find the money.

Mr. Brian Bamba: I agree.

Senator Taitague: Okay thank you so much Brian. Thank you and to your family.

Mr. Brian Bamba: Thank you.

Vice Speaker Nelson: Thank You senator. Senator Lee?

Senator Régine Biscoe Lee: *Si yu'os ma'ase'* madam chair and I also want to thank the governor for putting forward your nomination to this board Mr. Bamba I want to thank you. I want to also want to thank your family for committing this time and accepting the governor's nomination I want to thank Senator bamba and Senator JQ, you have also joined us this afternoon and supported your confirmation. One of the questions that I wanted to ask is just in terms of conflicts of interest so I know that you were employed by IP&E and you also have shares in a business as I wanted to ask you if you believe that your involvement your business involvement in this company and in the company that you work for could potentially create any issues with conflicts of interest.

Mr. Brian Bamba: So the company that I'm a partner of isn't domiciled on Guam so no I don't see any issues there on the matters of confidence of interest. I think there's a you know at least in a very professional environment there are processes for handling potential conflicts and I'm very transparent about that so I don't have any issues of recusal or non participation and anything that represents a potential conflict No.

Senator Régine Biscoe Lee: Excellent thank you. As a previous speaker had mentioned tourism as our number one industry and the airport is the first and the final encounter that many of our tourists have with our beautiful island and so you had mentioned that you are an avid traveler and so I wanted to ask you in your travels what are some examples that might we might be able to apply to our local Airport that you've seen I mean maybe even some low-hanging fruit that we might be able to go after to improve our Airport.

Mr. Brian Bamba: Well as a user of airport services wherever I go I'm always trying to get connected and so some airports are not as easy to get connected I'm talking from a telecommunication standpoint and so when you are flying red-eye flights and you're in an airport for any amount of time that you kind of just want to get out and get a shower but the only thing you can do is sit around and so being connected is something and I think the airport has room to improve and its ability to service customers in that manner you know. There's a number of things that I don't really like to spend time sitting in an airport

but the experience that you have when you're laid over is you need to be comfortable and amenities need to be accessible and bathrooms needs to be clean and the place needs to be as convenient as possible.

Senator Régine Biscoe Lee: Thank you very much for the thoughtful response. I also want to encourage you, should you be confirmed, to really look into Family Services in our airports it is a challenge for many young families who are visiting us especially from the region. I'm sure you visited airports like Narita and Incheon and they have excellent Family Services, family restrooms. I think that's one of the areas where we're lacking so I'd really encourage you to look into that as well as opportunities for our small local businesses to be able to be featured in our airports I think there has been a movement towards that in the in the recent past but encouraging more of that I think is a good idea so I want to thank you again for accepting the governor's nomination and thanks to our community stakeholders for coming out in support of Brian and I look forward to voting in favor of your confirmation. Thank you.

Mr. Brian Bamba: Thank you

Vice Speaker Nelson: Thank you senator Lee. Senator Terlaje?

Senator Therese Terlaje: Thank you madam chair, thank you all for your testimony it's very helpful and Brian of course thanks for accepting this nomination. If you don't mind I'm gonna ask you some questions. For the record, you talked earlier about whether there would be any potential conflict and you talked about your business as a shareholder in but what about your work? You're still working for IP&E and does IP&E do any business with the airport?

Mr. Brian Bamba: I don't know that we have business with the airport. We've done business before with the airport where we've sold or provided fuel to a generator but I do business with Airlines and my company does supply jet fuel, which I don't view as a conflict because has nothing to do with the airport authority but as I mentioned earlier I think the process you know for my involvement, if any, that has to do with my company would be a recusal or identification of any potential conflict adventures and you know there should be processes in the authority and within the laws to allow that to be dealt with.

Senator Therese Terlaje: Thank you and I'm glad that you stated that for the record that you would be able to attend the meetings and participate despite your busy schedule and public service that you are already doing. The courts have cited GIAA recently for violations of transparency open government what are your feelings on that?

Mr. Brian Bamba: I mean, just my personal opinions I don't want to speak out on you know, towards anything that is currently in litigation or that you know, I couldn't even tell you who the legal counsel is so I mean I think it's warranted that I discuss and get familiar with that but I do believe that the issues of transparency are prerequisite and the community demands that so I don't have an issue with that. I just think that for this specific case, because it is before the courts, I don't think I'm at liberty to have an opinion either way.

Senator Therese Terlaje: Are you willing to put in the work to learn the open government law?

Mr. Brian Bamba: Absolutely

Senator Therese Terlaje: And you know take the time to challenge the attorneys and be briefed and you know it looks like that's what the board is going to have to do going forward to make sure that they've covered all aspects are potential liability. Similar with the procurement so of course there's a big procurement challenge and we're not going to talk about that one in particular but how would you improve I mean do you think you have a role in the board to improve procurement make sure that it's fair.

Mr. Brian Bamba: I believe so in my current business we procure large items small items everything under the Sun and you know there are processes which we follow so that we eliminate a lot of these opportunities to create disputes you know and so I think it's worth looking at you know the procurement process I believe there is a good procurement process at the airport and sometimes these things occur you know but it's a matter of reviewing them looking at what works and doing more of that and doing less of what doesn't work I'm open to that and to learn the open government law I mean it behooves me to stay out of trouble so of course yes.

Senator Therese Terlaje: Yes yeah there's a lot of suspicion I think from the public that boards you know are procuring from their favorite vendors sometimes and so we want our board members to be sure that you know they do whatever it takes to show the opposite that they're trying their best to be fair but they were not writing specs that are specifically geared towards one company and that we avoid that whenever possible. I wanted to follow up on your intentions regarding GVB and also the airport is also you know sometimes we come in here with customs and one of customs biggest contentions is that they're being charged by the airport the airport says they're required to do that because of bonds but I think it still behooves the airport to find another way I mean you know to be creative so I'm happy that to hear that almost everybody who testified said that that's one of your strengths and I really believe in creativity when it comes to things like this that we can find a way to take care of government services right

let those custom services be provided and so we can expand customs so that we can get the inspections that are needed but what are your intentions for the GVB I heard your answer earlier to one of my colleagues.

Mr. Brian Bamba: I don't have any specific ones but my view is tourism drives our economy and I don't think any one agency has a corner on its responsibility I think everybody has a responsibility to work together because it is our main driver of our economies and I think we be naive to say that you know GVB is the sole owner and responsible for bringing all those tourists into Guam and likewise everyone that steps off a plane has to fly one into an airport they don't fly into two to one and they have to process through customs so there isn't one independent ownership of that tourism engine so I think it requires everyone to be on the same page.

Senator Therese Terlaje: Absolutely I think you're right because the airport is one of the most noted things I think on surveys when they talk about you know it's their experiences leaving coming in that time that they spend like you described earlier waiting in lines versus other things and right now the airport's under construction so I think I know GVB explained to us the efforts that they made for Golden Week to really go out of their way to help the tourist process faster through the airport in conjunction with many partners and so yeah that's what I'm looking for with GIAA that what they do it's really going to impact our tourism very much and so yeah they've got to make it as convenient as possible right convenience I think is key and so you're gonna be partnering with federal agencies other local agencies such as customs and I the better we can help each other and I think that's gonna make a better experience for the tourists.

Mr. Brian Bamba: I agree, thank you.

Senator Therese Terlaje: All right those are all my questions but I thank you again for your commitment to this I know it's going to take a lot of time because I know the other people who serve on the board they are really very committed and hard work this is one of our challenging agencies because the stakes are very high right so it's a it's a really global business soldier thank you again for your commitment and thank you again for all your testimonies thank you.

Vice Speaker Nelson: Thank you senator Terlaje. Mr. Bamba I just want to acknowledge that all of my colleagues they come from specialties and so a lot of them come from experience we're working with GVB working with families and local businesses and then of course the attorney aspect of the law so I want to thank you for being here and please take everything that was been said to you with a grain of salt and to do the due diligence right now the airport is facing a lot of obstacles and challenges it challenges one of them is the third-floor corridor expansion and I say this to every appointee that comes forward

we are but in the multi-millions exceeding the cost that we anticipated to spend now we are trying to refinance bonds and perhaps purchase another bond through the airport and that's a little bit scary to me because we are very close to our debt ceiling. The second issue is again the continuous litigation between Lotte and DFS and in also it comes with a caveat with the violation of open government law which is why I believe senator Terlaje has stated very valid points that we need to understand the open government laws so that we don't make these mistakes and perhaps they're not intended and perhaps they weren't malicious, but for that for the ruling to be made that the board violated open government law is something very serious especially if you are a member on the board. Last term I worked with customs and quarantine and some of the challenges they had was because of the bond covenants is to have to pay an enormous amount of rent but how they would channel that money is the airport would receive the fees and then take off the top what they felt was owed to them and then they distributed the rest of the agency and I'm hoping that the board will take a look at this process and perhaps reevaluate and streamline that the CQA get the money directly and then they pay the airport back in return for the server for the space that they occupy. But essentially the airport cannot function without customs and quarantine agencies so it's kind of like we are hoping that there's a partnership that can be formed to alleviate some of the expenses the rental expenses that customs and quarantine agency has to pay for because without CQA, the airport not be able to open its doors to cargo or even to passengers. Another thing that you might want to keep an eye on is passenger fees. Last term we are looking to increase passenger fees but customs and quarantine was not able to give us a solid plan and definition of what they would do and how would they would implement the crash interface and so I'm understanding perhaps they're going to try and address this issue again however I feel that as part of the legislature they have the fiduciary responsibility and the jurisdiction does belong to CQA negotiating with the airport and the airlines and so I'm hoping that you can work with them you can work with the leadership at CQA so the legislature doesn't have to put forth a bill saying that we are going to raise passenger fees for CQA. They have that adjudication process already available to them. I want to thank you again for giving of your time. I don't think many people understand the importance of this agency this is our port of entry and it's very dire to our economy and so this board is a very special board and with a multitude of responsibilities especially legal aspects that we have to be aware of when we start negotiations or decisions that impact specifically this agency but again it will impact our island because it's part of the stepping stone of our economy as my two colleagues stated earlier. So thank you very much and you have a good day and thank all of you for coming and giving testimony on Mr. Bamba's behalf. We really appreciate you taking out that time.
