I. OVERVIEW

The Committee on Environment, Revenue and Taxation, and Procurement convened a virtual public hearing on August 4, 2020 at 9:00 a.m. via Zoom Conference platform. - Appointed by Governor Lourdes A. Leon Guerrero on July 15, 2020, to serve for two (2) years: July 1, 2020 to June 30, 2022
- Appointment packet forwarded to *I Liheslaturan Guahan* on July 20, 2020
- Appointment packet forwarded to this committee for public consideration on July 22, 2020

Public Hearing notices were disseminated via email to all Senators and all main media broadcasting outlets on July 28, 2020 and again on July 31, 2020, fulfilling the 5-Day Notice and 48 Hour Notice of the Open Government Law requirements respectively.

II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Perez: I will now go over the rules of conduct. The rules of conduct for this virtual public hearing are as follows: the host of this hearing will mute all participants until called upon by the Chair. A virtual background should not be utilized during these hearings and participants face must be visible at all times. When called to speak, please ensure that you are unmuted and that you are speaking into your microphone and please ensure that you identify yourself prior to speaking. Members of the committee wishing to speak may indicate their desire to the Chair through an in-app chat feature. The order of questioning will be in the order of request, line of questioning will begin with the Chair and upon completion the Chair will open up the floor to other members. Each member will be allowed to pose questions to an individual. Individuals testifying shall be recognized by the Chair before speaking and those that are speaking must state their names for record-keeping purposes. Questions and testimonies shall be confined to the substance or

nature of the agenda. Personal inference as to the character motive of the senator or any individual testifying is not permitted any violations of this general of conduct will result in removal from the public hearing by the host.

Now to begin our agenda is the confirmation hearing for two of the nominees but to begin, the Alcoholic Beverage Control Board consists of five members, appointed by the Governor with the advice and consent of the Guam Legislature. The ABC board has the power to license the importation of manufacture, sell of alcoholic beverages and to suspend revoke or reinstate such licenses. Every member of the ABC board and every compliance inspector has the power to enforce the laws on alcoholic beverages. So, to begin our agenda with the executive appointment of Ms. Candy C. Okuhama to serve as a member of the Alcoholic Beverage Control Board. So, my apologies we do have Ms. Bernie Valencia from Matson Guam that will be testifying on behalf of the nominees. So, I'd like to recognize Ms. Valencia to provide some testimony so if you can unmute yourself and identify yourself as well.

Bernie Valencia: Good morning nice to see everyone. Sorry I'm a little late. I've seen most of you guys recently, for those that don't know me. I'm Bernie from Matson but I'm not testifying on behalf of Matson today. I heard about this this public hearing today and I wanted to just uh submit testimony in favor of the appointments, of both Candy and Ray Llaneta, to serve as members of the Alcoholic Beverage Control Board.

Candy and I have known each other since our high school days at Academy, so if you look at Candy you can tell that was only a few years ago that we graduated. We also served together on the Guam Chamber of Commerce board for a few years. As you know she's the Vice President of sales and client relations at ASC trust, which is where I put all my investments and where Candy handles all my personal financial matters. I trust her completely. Obviously with an organization like hers, I trust her and she's honest and dependable. Her presence on the ABC board means the board will continue to operate in a responsible and practical manner with regard to upholding the rules and statutes governing the sale and serving of alcohol beverages on our island.

Chairperson Perez: Thank you so much Bernie for your testimony and thank you for being here this morning.

Ms. Valencia: Appreciate it.

Chairperson Perez: I would like to now give the floor to the candidates or sorry the nominees to provide their testimony. Beginning with Ms. Candy Okuhama.

Candy C. Okuhama, *Appointee, Alcoholic Beverage Control Board:* Good morning Senators. I'm Candy Okuhama. I currently serve on the Alcoholic Beverage Control Board with three other members. Chairman Ray Llaneta, as you can see, he's on the screen. I was appointed in March 2017 for a two-year term and my term was renewed last year. Since then, my understanding and application of the ABC policies have allowed me to apply best practices in our review process duties. While it's been rewarding experience, I remain committed to serving with fairness and integrity that this position commands. It is my pleasure to serve another term on this board. I thank

the people Guam and the Legislature, the confidence placed in me to serve in this capacity. Thank you.

Chairperson Perez: Thank you, Ms. Okuhama. At this time, I'd like to recognize Senator Will Castro who has joined us here today. Thank you, Senator. I'd like to open up the floor to questions. Let's start with Ms. Candy Okuhama first. Thank you, Ms. Okuhama, for accepting the nomination for the second term. It's my understanding that you... I've heard that the board works really well and they're able to meet twice a month. I think this is a really, very important board because you know a lot of our businesses are depending upon the board for licensing and also for the government to ensure that compliance is made. I guess a question that I have for you is, do you have any conflicts of interest and how do you determine whether a conflict of interest exists in regard to licensing or revoking licenses?

Ms. Okuhama: Well first of all, to handle a conflict of interest I would recuse myself from any decision making. As far as my relationship with alcohol beverage, I do not own any businesses or have any partnership or interest in an alcohol business. I would recuse myself from decision-making if conflicts arise. Usually, we have an agenda before we go into meeting and it's been a good practice amongst all of us four members, if we see conflict, we usually recuse ourselves.

Chairperson Perez: Thank you. So, as far as compliance is concerned, do you, does the board receive a lot of complaints and regarding certain handling of alcohol sales?

Ms. Okuhama: I don't think we get a lot of complaints and Chairman, if you can chime in as well, but we don't have any complaints, but we do get a lot of requests for guidelines, especially during the application process.

Chairperson Perez: Okay that's good to hear. What do you see as some of the shortfalls in some of the laws that we have? Is there something that, I guess as a board, you're there to carry out the law, but do you see any areas that maybe need to be looked at in handling some of the clients that you that reach out to you?

Ms. Okuhama: Well different situations arise in every meeting and as a group, as each individual, we come collectively as a group. We analyze situations and we evaluate alternatives. We take the best solution. I would say that we don't really have any issues.

Chairperson Perez: Going back to the nominee. Ms. Okuhama, thank you for your response. Just a thing about the board, you know quorum, as Mr. Llaneta said is so important when quorum is lacking. It really makes it hard to do the job of the board and I'm very appreciative that you've accepted this nomination. I understand that you had, it almost perfect attendance and even if you weren't there in person you were there virtually. Can you speak to your attendance on the board?

Ms. Okuhama: I'm sure the Chairman can attest to this, I actually have perfect attendance right Chairman? I have perfect attendance. Actually, me and one other board member, we actually meet in person with ABC staff and then we have the two other board members, they Zoom in. My job requires me to travel quite often. Last year I would call in. I would call in to make sure that we

have quorum but this year there's no travel plans. I plan to attend in person at DRT for all our meetings and that's a perfect attendance, so far.

Chairperson Perez: Excellent. Thank you so much, amidst all your other duties as well. So, I think at this time I would like to... First of all, I'd like to acknowledge Senator Mary Torres who has joined us here today. Thank you Senator, and Senator Pedro Terlaje. Thank you very much. So as of this time I would like to open the floor to my colleagues for any questions. So, beginning with Senator Kelly Marsh (Taitano).

Senator Marsh (Taitano): *Si Yu'os ma'åse'*, Madam Chair and just so that I'm doing this correctly should I address them just to Ms. Okuhama or did you want us to address both of the nominees?

Chairperson Perez: Thank you Senator. For transcription's sake, let's just focus on Ms. Okuhama first and then we'll go around the second round for Mr. Llaneta. Thank you.

Senator Marsh (Taitano): Very good yes and it's very good to have heard so much from both of you. We can tell that your experience is really part of the qualities that make you so well qualified to continue your service. So, thank you for accepting that. I'm sure meeting twice a month, it takes quite a bit of time and with the research and other things that it necessitates. Again, we thank you for taking that time. So, we heard a little bit about some of the highlights and some of the needs which I think are so important. There are many things we can do in government to streamline by moving in the direction of technology and things like that. We also need to remember when it comes to human power or people power, that we are really struggling to meet our mandates. So, I just hope people keep that in mind that when they're calling for government to streamline and to really live within its means. The other things that we need to find are those areas that we need to become more efficient at. I think it's important to hear the real testimony as Mr. Llaneta expressed. If there is a shortage of people and they're not able to make their mandates, which then doesn't serve the community. We really need to hear that and see how to tackle that but sorry that got a little off talking a topic even though I didn't mean to. So, it was good to hear how you would handle conflict of interest and so forth because you have been there already could you, Ms. Okuhama, tell us maybe something that's been a highlight personally for you that you've learned the most about or has caused you to be the most concerned in the role that you play on the ABC, for the community.

Ms. Okuhama: Sure, so it helped me. First of all, it's a great honor to be reappointed again and I hope I get confirmed today. I've learned a lot about the ABC laws and a lot of the policies that are set forth in dealing with approving applications and making sure that all the establishments that have, uphold the licenses abide by the policies and the laws. Also, to be part of the ABC board it gives, it's my way of giving back to the community. It does take a lot of my time because I also belong to another, I'm also serving on the Guam Chamber board. So, I feel that this is my way of giving back to the community and being able to do that for, because Guam has been really good to me. I grew up in Guam, the last 40 years even though Bernie said we just graduated last week but yeah, I'm a Guam product and I like to keep giving back to the community and this is a good way to give back.

Senator Marsh (Taitano): That's so good to hear. Perhaps all of us within this particular hearing are...we're very proud. I'm very proud to be a Guam product as well and I really like the way that you said that. It's important that those that are serving on the boards, that they have that feeling of wanting to give back to the community. That's part of what drives them, so that's also very important to hear. So, thank you for that. If I could just ask, there was a bit of discussion about some of what's lacking and what needs to be built up. Do you have a particular focus that you'd like to tackle that may be different than what Mr. Llaneta discussed?

Ms. Okuhama: I would personally like to see, to help currently because during the pandemic there's a lot of businesses that are not on... that are unable to operate on the normalcy. So, I would like to see alternatives for those businesses that are not able to serve alcoholic beverages at this time. I'd like to see some alternatives that can help them sustain their business because when they sustain, they pay taxes and it helps our economy grow.

Senator Marsh (Taitano): So, it sounds a little bit like you're talking about the bill to be able to sell alcoholic beverages as takeaway, is that some of what you're thinking that might be?

Ms. Okuhama: That is definitely an option and if there are other options out there, we would definitely come together as a board to make a decision based on the ABC board policy and our guidelines. That would that would definitely be one alternative.

Senator Marsh (Taitano): *Si Yu'os ma'åse'* Madam Chair I don't wanna ask you many questions. I wanna give others a chance. *Si Yu'os ma'åse'* for allowing me to ask a few questions.

Chairperson Perez: *Si Yu'os ma'åse'* Senator Kelly Marsh (Taitano). Senator Régine Biscoe Lee do you have any questions for the nominee.

Senator Lee: Good morning, Madam Chair. Good morning colleagues and thank you very much to both Candy and Ray for being on with us this morning. Thank you to Ms. Bernie Valencia for her testimony this morning, for just giving us a little bit of background and insight into Candy, for folks who don't know her. Candy, I really want to thank you for your past service and for again accepting the Governor's nomination. I did have a question about quorum but since you have perfect attendance, we can just dispense with that. I had a question and I want to thank the Chair for asking regarding conflicts of interest. I appreciate your response to that. Recently there was a bill introduced by Senator Joe San Agustin, bill 384, which is relative to updating and clarifying statutes concerning licensing sales in service of alcoholic beverages. I just wanted to ask if the board will be providing testimony on this measure and if you had a stance that you would like to share with the committee today, on what your thoughts are about this bill or if there are any other things that the Legislature should consider regarding updating the licensing and sales.

Ms. Okuhama: I would like to definitely attend the hearing and I know the Chairman and I had this discussion during our last meeting. I would definitely like to attend the hearing, get more, collect more information and get other input from all the Senators and those who will be attending this hearing. As far as my position at the ABC board, again we're going to make a decision based on our guidelines and then our policy.

Senator Lee: Okay, excellent, thank you very much Candy and then Madam Chair we're going to go around as a second round for Ray?

Chairperson Perez: Yes, we are.

Senator Lee: Yes, okay, thank you very much, Candy, and thank you, Madam Chair.

Chairperson Perez: All right, thank you Senator Lee. Senator Muña, if you have any questions.

Senator Muña: Thank you very much. I just want to thank Candy again for continuing her service to the ABC board. I was going to direct both of my questions to both of them, but I'll just go ahead and reserve one of my main questions to the Chair, but I just also want to comment that I didn't know that Bernie was that young taking a look at Candy. I just wanted to say thank you very much for stepping up to the plate. I do remember most of my weekends growing up, even up to this day, all the bars were always afraid of anybody in the ABC board. Whenever they would walk into the clubs, like the ABC board is here, everybody just stand guard and make sure that you're aware of all of your surroundings. What you do bring to the table is maybe not so much fear but at least like people to bars and in lounges to be compliant. I just want to thank you again for your service. Thank you, Candy.

Chairperson Perez: Thank you Senator Muña. Senator San Agustin.

Senator San Agustin: All right thank you. Thank you, Madam Chair. Candy if I'm correct I was on the oversight; I was the oversight Chair last time you were nominated, and we were able to approve you. I expect you to get approved again. I haven't heard anything bad about you and I've already heard good things about you. If you know Bernie, then I guess you must be on in a good crowd. I'll make comment because Candy, I used to work at Revenue and Tax. I used to be the compliance supervisor. Other than congratulations Candy, you got my full support, both you and Ray but I'll wait for part two to chat on Ray. Thank you. Thank you, Madam Chair.

Chairperson Perez: All right thank you, Senator San Agustin. I'd like to recognize at this time Senator Telo Taitague who has joined us. My apologies you came a little earlier. All right so I think the next person that came on was Senator Castro, if you have any questions for Ms. Okuhama.

Senator Castro: No questions. I just want to state for the record that I've known Candy since '86 when she was a hard-working member of the family, in the family's sporting goods business. I'm sure a lot of you can remember those days. This is more of a character reference. She's extremely personable, tremendous customer service skills. Definitely her love for the island is unquestionable and I want to thank her again for her generosity and wanting to continue to serve this community. Thank you, Candy, you have my full support.

Chairperson Perez: Thank you Senator Castro. Senator Torres.

Senator Torres: Thank you. It was nice to hear the dialogue between Ray and Candy, it shows that there is a good working relationship in the ABC board, which is always a perfect first start. I don't have any other comments, other than I know that our island has a very big problem with

alcohol abuse and all the regulations associated with regulating the sales of alcohol and particularly the consumption of alcohol by minors as well. I hope that in the days to come that we can collectively look at how to best approach the problem of alcohol abuse on Guam, which we know is really the root problem of so many other issues on Guam, domestic violence, truancy and the like. For the most part I support your nominations and I thank you for not only your dedication to your role on the board but also your camaraderie as a board member. I think that is very helpful going forward. *Si Yu'os ma'åse'* to both.

Chairperson Perez: Thank you Senator Torres. Senator Pedro Terlaje.

Senator Terlaje: Thank you, Madam Chair, Good morning everybody. I also want to thank Candy from what I'm hearing from the virtual hearing right now, I'm in support for your confirmation. I also want to thank Bernie, very much, Bernie thank you very much. We've met a couple of times and I want to thank you for being so active in helping, our island our people to the shipment of goods coming in into our island. Thank you very much. At this point in time I don't really have anything other than to ensure that I support all the nominees.

Chairperson Perez: Thank you so much Senator Terlaje. Senator Taitague.

Senator Taitague: *Si Yu'os ma'åse'* Madam Chair for the opportunity. I apologize for being late, I had an interview earlier and I didn't want to miss the opportunity to hear the nominees. Whatever I missed, I'll review the tape, but I want to first and foremost thank you both for stepping up to the plate and continuing to serve the people of Guam. It's not an easy job sitting on a board. There's the good, the bad and the in-between. I appreciate that and Candy I think I've heard someone saying that you have a perfect attendance. Bravo, that's one of the hardest things for some of these board members and I know you're well-traveled, but I guess it's keeping you home right now. I know that you make every effort to be on these meetings and I appreciate both of you. I have been noticing in the paper that there have been quite a bit of bars that have been, they've been in violation or they've been shut down for some reason. It's like wow, all of a sudden now, this is happening. I mean it's a good thing because if they're in violation, I mean a lot of bars have not paid attention. These bars that are in the back, behind another building and stuff like that. People are starting to go out and do these inspections. I'm really happy. I'm gonna ask you Candy is that, any reflection on what the board is requesting for them to do? Renie go ahead. Yes, no I'd like to hear from both of you actually and I appreciate this because I think it needs to be... hopefully you guys are pushing them to get their work...

Ms. Okuhama: Well that's pretty much it. It's actually from the other government agencies that starts the inspection and then ABC basically acts as it's a partnership and then unfortunately that establishment would have to be shut down for violating. More on that, like the Chairman said the social distancing laws and all the COVID health protocol violations.

Senator Taitague: It's good to see. I mean I think there's a lot of bars out there who think that nobody ever comes and inspects them, that they can get away with a lot of things. Right now, I think... they're realizing now that government of Guam is on top of this and they will continue to monitor your bars and clubs. This is a good thing. I think now you're going to see a lot of bars fixing up their place and making sure that they're in compliance, for sure. I greatly appreciate

again for you stepping up and taking this on, continuing to take it on. I know it takes time away from your families but it's a good thing to give, to give back and that's what you're doing for Guam, to your community, you're giving back, greatly appreciate it. *Si Yu'os ma'åse'* and of course you have my support. Thank you so much. Thank you, Madam Chair, thank you.

Chairperson Perez then adjourned the confirmation hearing for **Ms. Candy C. Okuhama** at 10:21 a.m.
