



Senate passes the decade's biggest public lands package

WASHINGTON - The Senate on Tuesday passed the most sweeping conservation legislation in a decade, protecting millions of acres of land and hundreds of miles of wild rivers across the country and establishing four new national monuments honoring heroes including Civil War soldiers and a civil rights icon.


The 662-page measure, which passed 92-8, represented an old-fashioned approach to dealmaking that has largely disappeared on Capitol Hill. Senators from across the ideological spectrum celebrated home-state gains and congratulated each other for bridging the partisan divide.

"It touches every state, features the input of a wide coalition of our colleagues, and has earnedthesupportofabroad, diverse coalition of many advocates for public lands, economic Majority Leader Mitch McConnell.

It's a paradoxical win for conservation at a time when President Donald Trump has promoted development on public lands and scaled back safeguards established by his

The bill, which the Congressional Budget Office projects would save taxpayers \$9 million, enjoys broad support in the House. The lower chamber is poised to take it up after the mid-February recess, and White House officials have indicated privately that the president will sign it.

The measure protects 1.3 million acres as wilderness, the nation's most stringent protection, which prohibits even roads and motorized vehicles. It permanently withdraws more than 370,000 acres of land from mining around two national parks, including Yellowstone, and permanently authorizes a program to spend offshore-drilling revenue on conservation efforts.



I want to share how grateful I am to Maga'haga Lourdes Leon Guerrero and Sigundo Maga'Lahi Joshua Tenorio, currently our Acting Governor, for having the confidence to name me as the nominee for the Director of the Department of Revenue and Taxation (DRT).

I come to you with almost two decades of management experience and with two and a half decades of experience in accounting and finance. I am a Guam licensed CPA. I have sat on the Guam Board of Accountancy, the Board which licenses CPAs, since 2008. The Purpose of DRT is set forth in 11 GCA Chapter 1 which states that "[DRT] shall be charged with the enforcement of the tax laws of Guam and the collection of revenue."

From the start, our number one priority has been collections. Our goal is to increase overall collections. However daunting this task may seem or be, our team is ready to take this head on.

Over the last month and a half, our team has been working to lay the foundation for success in our collection efforts through the review of our processes and through ensuring our team is trained and continues to receive regular training. We have reached out to the IRS to assist us with collections training as they set the standard in terms of collections. In the meantime, we are working to leverage our in-house technical expertise by having our senior level members conduct our training.

We have met with and are grateful to Attorney General Leevin Camacho for his and his team's willingness to assist us in our efforts to bring taxpayers into compliance and we will be referring cases to the Office of Attorney General in the near future.

In addition to collections, we are also working to develop a standard of excellence in our customer service. In particular, we recognize there is a need to address long lines and our phone system. Our team has been tasked with reviewing these areas. In the Driver's License Division, we will be temporarily opening up on Saturdays in the month of March to address the increase in the demand for Real IDs. In addition to this, our team has also been tasked with working on the development and implementation of a call center so we can better service our people.

Because of the vast amount of services we provide, we believe data is critical in the management of our organization. We are currently working to establish a data analytics team so that we will be able to develop performance measures and work to manage our operations utilizing those measures. Part of the team's responsibilities will also be to work to use technology, in particular automation, to streamline what we do.

My mother was my best friend and probably the best person that I ever knew. She and my husband basically have the same mantra which is to work to make a positive difference in everyone you meet. She would always say to me "God never fails us", and although I am not at the point where I can say my mother's death is a blessing, I believe that there are lessons to be learned from her passing. My mom's death taught me about the true volatility of life – you can be here one minute and then be gone the next, so I do my best every day to appreciate every moment that I have, every person who comes my way, and to live the best life that I can. Most importantly, I have learned that when you have the opportunity as I have right now, to make a positive difference in the lives of so many, to take that opportunity head on.

Before I begin I would like to first acknowledge my husband, John Shimizu; our children and spouses and grandchildren, who may not be here but who are always in my heart, Robert and Amber-Ruth, Thomas and Chelsey-Fenah, Josefina, Leon and Clai, Sera-Fenah, Fermina and our newest addition to our family, who just came the other day, Anastasia Taylor. I also would like to acknowledge my father Felix Castro Mansapit, my parents-in-law Frank and Meming Shimizu, the staff of the Guam Department of Revenue and Taxation, members of the Mansapit, Tatague, Shimizu and Gumataotao families and my dear friends who are here to support me and who have sent other people to support me and who have also sent in testimony, I think prior to this today. I want to share how grateful I am to Maga'haga Lourdes Leon Guerrero and Sigundo Maga'Lahi Joshua Tenorio, currently our acting governor, for having the confidence to name me as the nominee for the Director of the Department of Revenue and Taxation.

I come to you with almost two decades of management experience and with two and a half decades of experience in finance and accounting. I am a Guam licensed CPA. I have sat on the Guam Board of Accountancy, the board which licensed CPAs since 2008. I attended the University of Guam where I earned both my Bachelor of Business Administration in Accounting and my Master of Public Administration. Most recently, I served as the Vice President of Finance/Chief Financial Officer for StayWell Guam, Inc. and Island Home Insurance Company where I oversaw the Accounting, Enrollment, MIS, HR, Actuarial and Underwriting and Facilities Departments. As part of my over my responsibilities, I had oversight over the collections team. I started off my career in accounting at Ernst & Young in 1995 just days after my last day of classes at the University of Guam. I later went on to work for J. Scott Magliary and Company, a local CPA firm which is now a Burger, Comer, Magliari. I served as a controller for various companies and organizations, including the Guam Board of Accountancy, StayWell insurance, Guam Harley-Davidson and Tumon Aquarium, so I have experience in various industries, including insurance, retail hospitality, food and beverage. For a short period, I worked on my own, preparing tax returns and financial statements for various clients. I come to you also with the history of service for our community, having served on various boards and been part of various organizations such as Catholic Social Services, the Agana Cathedral chapter of Christian Mother's, Soroptimist International Marianas and the Cathedral Basilica Finance council.

I was born on Guam and raised in the village of *Merizo*. I attended *Merizo* Martyrs Memorial School where my paternal grandmother, Maria Castro Mansapit, worked as a teacher's aide. I grew up watching my maternal grandmother, Delphine Babauta Taitague Barao, work to make a living by making and selling empanadas, siopao, potu, onigiri and other food items to tourists who visited Cocos Island and to people in our village. My maternal grandfather, Jupiter Barao, was a merchant marine who came to Guam from the Philippines in the 1950s. My paternal grandfather, Joaquin Maguadog Mansapit, proudly served in the United States Navy where he retired as a Master Chief. I am proud to say that my parents, Felix Castro Mansapit and Dorothy Taitague Mansapit, both have service in the government of Guam. My father worked at the Department of Education and

currently works at the University of Guam where he is a Safety and Security Administrator. My mother was a stay-at-home mom until I was in high school and my youngest brother was in kindergarten. She was in her 30s when she, with the support of my father, began to go to college. She later graduated with a bachelor's degree in Education from the University of Guam, a Master's Degree in Education from the University of Portland, she became an elementary school teacher, and worked at *Merizo* Martyrs Memorial School for over 20 years until she passed away unexpectedly just this past October. From my parents and grandparents, I learned the value of hard work. As a teenager, I work to make my own money during my summers, a couple of summers I spent as a waitress and general helper from my neighbor's restaurant in *Merizo*, where I waited on tables, chopped vegetables, swept the floor and washed dishes. While attending the University of Guam, I worked full-time for Island Girl, a local fishing/charter boat company.

I've been blessed to have had the opportunity to work for the various companies and organizations that I have, and I believe that the experience that I have will be invaluable to DRT. I have also been blessed to have the opportunity now to work with the hard-working men and women at the Department of Revenue and Taxation. DRT has approximately 180 employees who serve in various divisions including: driver's license, vehicle registration, real property tax appraisal, real property tax assessment, insurance security banking and real estate, compliance, general license and registration, weights and measures criminal investigation, tax examination, tax collection, income tax assistance and processing, electronic data processing, central files, tax accounting, tax research and appeals, business privilege tax, the passport office, and the Department of Transportation Motor Carrier. The purpose of DRT is set forth in 11 GCA Chapter 1 which states that DRT shall be charged with the enforcement of the tax laws of Guam and the collection of revenue. From the start our number one priority has been collections. Our goal is to increase our overall collections for the general fund. However, daunting this task may seem or be, our team is ready to take this head-on. Over the last month and a half, our team has been working to the lay the foundation for success in our collection efforts through the review of our processes and through ensuring that our team is and continues to receive regular training. We have reached out to the IRS to assist us with collections training as they set the standard in terms of collections. In the meantime, we are working to leverage our in-house technical expertise by having our senior level members conduct our trainings.

We have met with and are grateful to Attorney General Leevin Camacho for his and his team's willingness to assist us in our efforts to bring taxpayers into compliance and we will be referring cases to the office of the Attorney General in the near future. In addition to collections, we are also working to develop a standard of excellence in our customer service. In particular, we recognize there is a need to address our long lines and our phone system. Our team has been tasked with reviewing these areas. In the Driver's License Division, we will be temporarily opening up on Saturdays in the month of March to address the increase in the demand for real IDs. In addition to this, our team has also been tasked with working on the development and implementation of a call center so we can better service our people. Because of the vast amount of services, we provide, we believe data is critical in the management of our organization. We are currently working to establish a data analytics team so that we will be able to develop performance measures and work to manage our operations utilizing those measures. Part of the team's responsibilities will also be to work to use technology, in particular automation, to streamline what we do.

My mother was my best friend and probably the best person I knew, excuse me. She and my husband basically had the same mantra which is to work to make a positive difference in everyone

you meet. She would always say to me God never fails us staff, and although I am not at the point where I can say that my mother's death is a blessing, I believe that there are lessons to be learned from her passing. My mom's death taught me about the true volatility of life, you can be here one minute and be gone the next, so I do my best every day to appreciate every moment that I have, every person who comes my way, and to live the best life that I can. Most importantly, I have learned that when you have the opportunity as I have right now to make a positive difference in the lives of so many, to take that opportunity head-on. In closing, I would like to say thank you again for your time and consideration and I ask you for your support of my nomination so I can truly make a difference, not just for our DRT family and for our government but for our people and for our island. Thank you so much, *Un Dangkulu Na Si Yu'us Ma'ase*, Dafne Mansapit Shimizu.

Chairperson Perez: I just want to acknowledge that I understand the Herculean task that you have before you and my door is open and I do want to work closely with you. I understand that Department of Revenue and Taxation is deeply in need of resources and we're here to work with you at this time, thank you.

Dafne Shimizu: Thank you senator.

Chairperson Perez: At this time, I would like to recognize my colleagues, Senator Mary Torres Senator Louise Muna, Senator James Moylan and Senator Kelly Marsh Taitano, thank you for joining me today. I would like to open up the floor to my colleagues if they have any comments or questions for Ms. Dafne Shimizu starting from the far-left.

Senator Marsh Taitano: *Håfa adai* and *Si Yu'os ma'åse'*, I see it's quite a packed house here today so it's good to see everybody coming out. We've been going through quite a few of these confirmation hearings and it's a very positive note overall. We're seeing well qualified individuals such as yourself and we're very much looking forward to all the work that's going to be happening. We realize that there are a lot of issues to be contending with and so it's that much more important that we have such qualified dedicated people and I've looked through your packet. There are so many letters of support. It's very reassuring that you are well equipped to handle the task ahead of you. So, with all of that support that I see here and the testimony that I've heard from you I'm very supportive of your nomination *Si Yu'os ma'åse'*.

Senator Moylan: Thank you Dafne. Wow, I looked through your resume, it's like I see controller controller, controller, controller, that's awesome. I think you're perfect there for the position at Rev and Tax. I know there's a lot of learning curve to go through but that's what we need at DRT, a controller and to get our collections under control. So, I'm looking forward to that. I can see you're going to be missed at your private enterprise there, President Jim Mac, Stay Well, is it's like the sunshine is gone you know but you're going to be truly missed there. West Cassady is also talking highly about you as well. If I wasn't sitting behind this desk, I probably write a letter too for you so it's really exciting. I like what Bob Steffy had to say also in regard to customer service and you had that as well. Your experience in private enterprise I think to make a difference in the atmosphere at that department. I think they'll be looking at you and probably smiling a lot more when I come to pay my taxes over there too. Otherwise Dafne you're right, a small business, you know I'm a small business advocate and from your experience there with your grandparents experience as well. That's my passion and I'm going to be working closely with you on different bills to help our small businesses grow, so I'm going to be working closely with you. Especially

we were talking a little bit on that one stop and know you have some tests and wanting to come up for that. So, I'm looking forward to that as well. So, congratulations especially on welcoming your new family member to your wonderful family here. So, thank you and I'm looking forward to working with you. Thank you so much Dafne.

Dafne Shimizu: Thank you senator and thank you for your support.

Chairperson Perez: Thank you Senator Moylan, Senator San Agustin.

Senator San Agustin: Thank you madam Chair, Dafne thank you for accepting the nomination. Let me start off with that and I can tell you have tough skin because you're married to Shimizu and I'm Shimizu. I know you got to, I see John in the back, my cousin saying yes, she's got tough skin and especially when Senator Moylan says her controller, that I got my Uncle Frankie. I know your dad, you know, you better do right, and your mom would have said the same thing and you know Dafne being a former employee of Revenue and Tax. There are many changes that I know, and I look for you to accomplish and we've spoken since your appointment or even before that. So as the oversight on the Office of Finance and Budget and Appropriation. I look forward to seeing more money coming in so that we can help the people of Guam and make sure that the government is more stable. You can expect and you will get my support on your nomination all right, thank you.

Dafne Shimizu: Si Yu'os ma'åse' Senator San Agustin.

Chairperson Perez: Senator, thank you Senator San Agustin, Senator Therese Terlaje.

Senator Terlaje: Thank you all for your testimony and for being here this morning, it's great to see the support for this nominee and Dafne thank you for accepting this position. It's a very tough one and we're looking for. There's a lot of pressure on you for results and I want to applaud you for your priorities, the enforcement of taxes, the tax laws, the collection of revenues and excellence in customer service. Its, I have to say we all know that Department of Revenue and Taxation is really takes the brunt of criticism in the government from the business sector from all sectors really from everyone because of these things and so I'm hoping this new start will you know help the Department of, the whole department highlight its hard work and its successes because sometimes those get overlooked of all the criticism so I am very optimistic. I just want to make sure so you have a couple businesses listed here and in your financial interest is there anything here that you think might become a conflict in your position now?

Dafne Shimizu: No, I actually don't actively practice and so you know really, it's only when my family and my friends asked me and I really can't turn them down but I don't actively practice and so that's something that at least at this time. I'm working to not actively practice so I don't believe that there's any going to be any issue.

Senator Terlaje: All right and then um I noted that yeah there's so much testimony in support and it's there's testimony from the insurance industry even your competitors and there's a testimony from the accounting industry and those are really very valuable and I just wanted to ask. I know you've only been in place for about a month and a half but at this point you know at the end of March fiscal year 2019, funding for Medicaid appropriations will be exhausted and Guam may be forced to give up you know their Affordable Care Act grant money and the approximately forty

million dollars because of the lack of matching funds and you know there's so many other things. GMH their roof and all the other things that the fix has been said to be collections right and so I just wanted to ask if at this point, do you have any and at the end of the last session or those the last few sessions that the previous legislature had, the Department of Revenue and Taxation had come in and give us estimates of how much we really could reasonably expect to collect and so I guess I wanted to ask you if you've been able to look at those and if you've you have any opinion on whether you know, we are going to be able to collect additional revenues and how much above the current revenue projections for FY 2019. I'm sure in 2020 yes but I guess I'm curious do you think that we might see anything sooner than 2020.

Dafne Shimizu: Well I can say that what we've done over the last 30 or 40 plus days is really to look at our collections and our receivables and I think it would be, it's a little bit too early for me to be able to say really how much we're going to be able to increase. I am proud to say that we have some cases that will be referred. I'm proud to say as well that in the enforcement side we're actually going to be working to enforce on Airbnb, so in the next couple weeks and I'm very proud of a lot of the successes that our team has worked on. Our team is so hard-working, and we have a lot of great institutional knowledge. I wish that I could tell you really how much you know; our goal right now is pretty general. It's really that we want to come in over what has been projected for this year but in terms of exactly how much senator I'm sorry at this time that's not something I can say.

Senator Terlaje: All right I appreciate that and um yes and I'm glad you pointed out the enforcement aspects and that's another thing and I think you coming to this agency is going to bring some trust and I mean you know additional trust to the employees that have, they have the hardest job on Guam is to go and do the enforcement on tax collections and business licensing and so I very much appreciate your willingness to do that. I just want it to note for my colleagues Dafne was a student at Notre Dame High School, she was a mock trial team when I was a coach there and I always told her go to law school you would be excellent an excellent lawyer and she probably did way better than that *Si Yu'os ma'åse'*.

Dafne Shimizu: Si Yu'os ma'åse' Senator Terlaje.

Chairperson Perez: Thank you Senator Terlaje, Senator Torres.

Senator Torres: Håfa adai Dafne, you know the people that have come out to support you speaks volumes of you. Certainly you are well, superbly qualified for this job and have excellent experience behind you but what I think is most notable about you is you have a sense of mindfulness and humility and a lot of us are looking, the island of Guam, when by say us, are looking for a director who can bring fairness and justice to all those taxpaying residents of our island and I see you as an asset to this agency and I believe we are quite fortunate that you were willing to step up and accept the appointment by the Governor. I wish you well. I certainly think you're going to sell through without any problem in your confirmation and I know that you will you will do well in your position because you have the grounded-ness and the foundation not only from your family but all those who have worked with you and alongside you to ensure that you succeed. I wish you the best and Si Yu'os ma'åse' for stepping up and accepting this and as my colleague Senator Terlaje pointed out the key word here is trust and I think a lot of us are looking for a Director in a very critical agency at a very critical time in Guam's history where we can trust

that you will not only enforce the tax laws of Guam but that you will bring a sense of justice and fairness in the community. So, Si Yu'os ma'ase' for that.

Dafne Shimizu: Si Yu'os ma'åse' Senator Torres.

Chairperson Perez: Thank you Senator Torres, Senator Louise Muña.

Senator Muna: Good morning Dafne and håfa adai to your family. Thank you so much for all of them, I'm sure for being here today and I know that you're definitely going to need them throughout this journey if you're lucky enough to get confirmed and I'm sure you will. I did get a lot of phone calls throughout the week in support of your confirmation today. So, I just wanted to let you know that there's a lot of people out there that are standing behind you and encouraging us to support you for this this journey that you're on and when you started talking about your mom I said don't look at Dafne because I know we're going to start crying and it's going to turn into a crying fest but I've known your dad and your mom for a long time. Your dad and I were co musicians in Taotaotano and Lina'la back in the day and so I had a chance to watch him you and your sister grow up as well. So, I want you to know that I do know your family and I know that you're very well loved and even though your mom's not here she's just take that longing for her and make it be your strength to guide you through this process. I think also in in terms of your private sector knowledge and your expertise I think it's going to be very beneficial to revenue and tax and I think you being in there now will bring a fresh perspective and fresh mind, fresh eyes and a great heart. So, you have my support, thank you Dafne.

Dafne Shimizu: Si Yu'os ma'ase' Senator Muña.

Chairperson Perez: I also want to add that there are people here that provided testimony and, in your support is overwhelming as well. Some of the names are Chen Mack, President CEO Staywell, West Cassady, General Manager/CEO Pacific Indemnity, Michael B. Brown, Frank Campillo, Sandra McKeever, Laurie Palomo, Julie Cruz, George Tyquienco and I'm sure there many others that aren't here today. So, I really appreciate you being here and thank you for accepting this nomination and we're you know with communities this be here to support you Si Yu'os ma'åse'.

Dafne Shimizu: Si Yu'os ma'åse' Senator Perez thank you very much.

Chairperson Perez then adjourned the confirmation hearing for Ms. Dafne Shimizu.
