### Summary of Testimony and Discussion

**Vice Speaker Nelson:** I will now call on Donald Weakley Sr. and we have listed to give testimony, oh it's written testimony. Is there anyone who would like to give oral testimony for Mr. Weakley? Okay Mr. Dan Tydingco, please.

**Dan Tydingco:** Thank you madam chair. I've known Mr. Weakley for the better part of probably three maybe close to four decades. We're close family friends, his son Michael and I work together in this legislative hall as well. Back in the mid-80s and his wife, his late wife, worked alongside my mother for a very very long time and they're very close friends over at the Guam Waterworks Authority. Mr Weakley certainly has the character and the temperament to be able to serve the board of directors over at the AB Won Pat International Terminal Airport well. So I fully endorse him. Thank you.

**Vice Speaker Nelson:** Mr. Weakley

**Donald Weakley Sr.:** We don't have this kind of things down in Inarajan so bare with me okay, Just a brief written. I'm unable to provide details about all the aspects of the airport obviously, but I have a good working knowledge of what's going on without going into weeds, but I'm assuming I'll get into weeds after I'm up there a few months, you know. But some of my things that I would look at when I get up there would be, and these are not in priority by the way, is the concession agreement and how important that is to the operations of the airport. And I know it's in going through litigation and stuff right now, but without that concession agreement, the airport basically would have been in the red last year. They would have lost money. As it is they admitted like seven million dollars, but they have 15 million they're getting every year so it's important to this new third floor they're making there. That they're building and it's important to just about everything they're doing up there I mean they just wouldn't, they get all these CIPS lined up and it's gonna be difficult to do because now all their efforts are on that third floor arrival area. But that's one thing I wanted to look at when I get up there but important that we retain a concession all the time. That we have to, it's roughly almost 20 percent of their total revenues. The airport so, next would be just the overall reception of tourists and our local people also. I've been a strong thinking about first impressions when you get off an airplane at an airport somewhere, let's say you're on a five-day vacation or something that you get down, the bathrooms are dirty and customs people are mad or grouchy and immigration people, you get a bad impression that's your first impression before you even start your vacation. And you carry that through with you all the way and I notice I've arrived there at 4 o'clock in the morning, the bathrooms are not up to par, and the baggage area and baggage is slow coming out and things like that. All those things that I'll work with the board on improving I hope. And again the economy of our island is so dependent on that airport virtually a hundred percent of our tourist come through there and that's the major economy of the island, that's the driving economy of the island so that's something that we always got to bear in mind. CIP projects, I'm not too up on them, I know where there's some pending for the parking area, I think it's going to be a parking building and of course the arrival area which is a little bit running over that's funded by FAA and bond money. But I think that Senator Ada said it might go over by around 120 million. A lot of that's the thought of not having as built drawings, in other

words the contractor didn't know what was in there when it was originally built and I understand that those drawings were lost in a storm or something. So they wouldn't know until after they bid and started construction and started looking in there and finding all these things that they didn't plan on when they bid on a project. So in that case you'd have to expect an overrun and the other thing is I should mention this concerning a concession, they've negotiated the airport's negotiated a agree, but they reduced that by 175 thousand dollars to makeup for the inconvenience of the caused by the construction. Because the concession had to shut down some of their stuff and blah blah blah. That has more impact on revenues right you know, so the airport finances as I think I've talked about that, they run about 80 million years in revenue and about 45 million and then about 7 million they had profit last year so something like that. And airport staffing of course, my concern no matter where I work is always about staffing. The staff, the people. Their security, how they're doing things like that because they are the engine that runs the airport. So I notice we have roughly 34 LTAs at the airport, 245 employees, 34 LTAs, out of my security and to look at him you think they're airport police, but really they're not. They can't carry firearms or anything like that. I have discussed this a little bit without senator Ada and what these people need, the security people, is more training so they can qualify for a regular police officer, carry weapons and stuff like that. But I don't think they got 240 some vacancies up there and a lot of our police officers. So that's something else we'll look into. I don't have anything else, but if you got questions.

**Vice Speaker Nelson:** Thank you Mr. Weakley, and also to caveat to that, a lot of the security personnel are being tasked for the flow through for the international passengers that come in which is of course in as result of the lack of the third floor corridor as you've mentioned, that has been over budgeted and it's increasing in cost. I'd like to open it now to my colleagues. Senator Pedro Terlaje, thank you for joining us today and Senator Lee, thank you as well. Do any of my colleagues have any questions, go ahead and pull the mic. and introduce yourself and ask a question.

**Senator Shelton:** Thank you madam chair and *hafa adai* Mr. Weakley. Thank you very much for accepting the appointment, I was glad to hear in your testimony you spoke about overall cleanliness of the airport and I was concerned to see in an exit survey from GVB, that only 23% of Korean tourists that visit our island strongly agreed that the airport is clean so if you can expand a little bit more on your plan to improve the perception of the cleanliness of our airport for our visitors.

**Mr. Weakley:** Well we just, of course that's a management thing, but as a board member, we would encourage that, we would start shaping up. Of course some of that is structural, no matter how much you clean them, they still wont look good, but you know they just finished the bathrooms in the baggage area, less than a year ago, but you still go in there and it's not being kept clean and that's a fairly new bathroom. Things like that. I mean I worked at public health and I was an administrator and it was shined all the time, you know, it's just you got to empower the house keeping people and encourage them and support them, pride. We don't want people to come to Guam and leave them with a bad impression, its dirty and things like that. They could go to other locations and find better cleanliness and stuff. But that's something that I will always have in my mind as a board member and do something about it.

**Senator Torres:** *Hafa Adai* Mr. Weakley, I see from your resume that you've had experience with the government, with the Bureau of planning and the Guam Memorial Hospital and Public Health, but most recently, you've had a lot of experience with a construction consultant which, at this phase in the airport's efforts with the third floor corridor, divider between inbound and outbound passengers, I can see that you're knowledge of construction and management would be an asset to the general manager. I also know you to be a very upstanding person and I certainly would support your nomination. Thank you

**Mr. Weakley:** Thank you

**Senator Muna:** As my colleague who just spoke to as well about your diverse between being in the hospital and in health care and then all the way into construction and I really just wanted to commend you and thank you for stepping up to be a board member for the Guam Airport Authority. I've just in my recent travels was in that corridor there trying to board a plane and I saw all the tourists there just sitting on the floor waiting to board a flight and it was kind of disheartening so I'm sure with your expertise and the board support towards the airport authority management we can get that done as soon as possible so thank you very much.

**Senator Marsh:** *Hafa Adai* Mr. Weakley. *Si yu'os ma'ase* for accepting the nomination and I also want to lend myself to similar statements as those that have preceded me. I know you to be a person of upstanding character and somebody who really cares about the community and improving it so I was very pleased to hear some of the issues that have been going through your mind and that you would like to make sure to bring up as a board member from just the different aspects what our airport is and what it needs. How people interact with it, the impact that it provides in the ways that it fits into our economy to management issues and making sure that we're working towards improvements and the improving the overall experience so I just want to mention those things and give a general statement of support. *Si yu'os ma'ase*

**Mr. Weakley:** Thank you

**Senator Taitague:** Thank you madam chairwoman for the opportunity to speak. Hi uncle Don. My father and uncle Don are first cousins, so Auntie is my father's first cousins and I've known you all my life and my family and my cousin Michael over there and greatly appreciate. You have a wealth of knowledge and experience to give to the Guam Airport Authority and appreciate you stepping up to the plate. There is a bill that I have introduced, it's number 8. It's regarding commercial leases and I'm hoping that you'll look at that bill, it lifts the limit of five years to 10 years to lease property and I know that this is something that most agencies are looking forward to. It allows to bring in more revenue and actually investment into the properties that they hold under their department to generate revenue so I'm asking you to look at that bill and make sure you hear it at the public hearing for that bill as well. Secondly, I was at Guam Visitors Bureau for a couple of years and one of the things I noticed is that Guam Airport Authority needs help with funding. They also work well with GVB but I really think that GVB can stand to support with some funding to the Guam Airport Authority. Without planes bringing our tourism

in, we won't have any tourists and it begins with the flights bringing in and if there's anything you want a lobby for over there, I suggest you lobby GVB for some funding for you as well.

**Mr. Weakley:** We'll look into that. We understand or I understand and I'm sure the board does, how important it is to interface with GVB and everything we do, it was far as tourism. So and we're already and we'll continue to do it when I'm there. Thank you

**Mr. Weakley:** Mr. Weakley, congratulations. Looking forward to working with you. Thank you so much.

**Mr. Weakley:** Thanks

**Senator Pedro Terlaje:** Thank you. It wasn't a long interview and that means your support. Donald, let me just say to the governor, lieutenant governor that the appointment to service board of director and the airport authority is really really good. I just wanted to bring up something about, you mentioned something about the 40 police officers that is needed up at the airport and I oversee the committee on public safety so I do have jurisdiction over trying to remedy some of the problems that we have up there in regards to the lack of law enforcement and biggest problem that I face right now is that I think police officers have to complete the BELEA program under the GCC and also the police department are also having problems with the recruitment o that because you need to pass the EN100 course before you get recruited and they do have problems in as far as recruiting police officers. So my plan is, I wanted to include the BELEA program with that of the police officers at the airport and expand instead of two and a half for the BELEA, do it for six months so maybe, the reasoning for that is that I want to apply the five points that the veterans get on the initial entry and I think our good senator here, Senator Telena brought that up already because right now as you go up into the ladder, the veterans over passing those people that have more service in the police department that is because of the five point preference. So what I'm saying here is that it's easier said than done and that's why I wanted to really expand the training because there's only two courses that you need for the BALEA and the police department to gain that five points and that is education and your physical training so in that regards you think that would be a good idea to expand the training so that we can give those guys that done have five-point preference the five points when they graduate from the BELEA and the police training so that they can also be part of the five-point preference when they do the initial application for entry.

**Mr. Weakley:** You're talking about the five percent points for veterans?

**Senator Pedro Terlaje:** The five points

**Vice Speaker Nelson:** Just to clarify, the bill that was passed within the legislature was to create equity for those our veterans; so that they use the five points upon application of the job in previous years they were using the five-point preference also for promotions so we wanted to create some kind of equity for everyone that is looking to get promoted or to compete for promotion to remove the five-point preference. And just to clarify what

Senator Terlaje is saying is that I believe he wants to include that upon completion of the BELEA, you will get a five-point preference if you have completed the BELEA course.

**Mr. Weakley:** Yes, I'm familiar with that. I saw that. Yeah the five point preferences is the people are getting it when they begin employment and then when they go up for promotion they were getting it again right and you wanted to do away with that which makes sense. But right now, some of the LTAs up there are serving as police officers; they have like 17, 18, years as LTAs so I mean we just got to do justice by them. We'll look into it but I don't know what I say 40 some vacancies up at the airport, I don't know how many of them are these I think there's like maybe my future chairman knows they don't know, but we're gonna be on that. We'll be looking into it and I'm sure Tom's gonna be working with them the committee

**Senator Pedo Terlaje:** You know Donald, Dan I call you, I never call you Donald, I always call you Dan, but anyway. I've known you for the longest time and you've always been loyal to supporting, not only our government, but also out people especially in the southern areas, so I support the appointment and I also support the appointment of my friend over there Dave because I know I used to work with the wife under Senator Mark Forbes and the appointment was a very good choice, good appointment. Thank you very much.

**Mr. Weakley:** Thank you senator.

**Vice Speaker Nelson:** Mr. Weakley, I'd like to thank you for accepting this nomination. I also like to thank you for doing some extensive research on some of the challenges that the airport faces and bringing that into light during your confirmation hearing. There are times when some of the board appointees or even the directors come without really understanding the complexities or the need of the agency so thank you very much for being well aware and getting ready to delve into the challenges that Guam Airport Authority has.

**Mr. Weakley:** Thank you madam chair. I'd like to endorse this guy to the left of me is my future boss.

**Vice Speaker Nelson:** Alright, thank you. We're done with your confirmation hearing. Thank you
