II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 5:10PM.

Vice Speaker Telena Nelson: Okay now we will move forward with Mrs. Doyon Morato. If there's anybody that would like to testify on her behalf please come forward.

Ramona Jones: *Hafa adai* senators my name is Ramona Jones and I am a lifelong friend of Doyon's, and by lifelong I mean that we went to school since elementary together. I have slept over at her house, I know her parents, I know how to say hello and goodbye in Korean and different customs because of her family's warmth towards me and while she was being raised in this family, I also was able to see how important education was to her parents. She has an older sister who is an attorney and Doyon was the creative daughter and artistic daughter. Doyon went on to study art and architecture in college and she traveled also to Paris and studied architecture there as well. I think that one of the things that's been said several times today is that the experience that we give our visitors is something that we have to think about from the moment that they step off the plane until the time they get back on it and those bookends are done at the airport and part of it is some of this hard aspects of which are absolutely critical the safety of the customer. Making sure that the items that are brought in are also safe but there's also a soft experience, how the place looks, is it clean, does it smell good, is it welcoming, what is the brand of Guam that we're putting out. Doyon, as an entrepreneur has been in the branding and digital design industry. She's started her own business, she's promoted our culture, and I think that she would be an outstanding addition to the GIAA board. I have served on a board and I understand some of the difficulties. You have a loyalty to the person who appointed you and you also have a responsibility to the people of Guam and sometimes that can be a challenge to try to figure out really. What's the best thing to do and I can give you my strongest assurance that Doyon is a strong moral character. She's honest, she's charitable, she's thoughtful and she's smart. So when these issues come before the board and we can't know all that they would be I know that this person, the person beside me, is going to be somebody that you can trust to put the best interest of our visitors and of our people always in the front of her mind when she's making those decisions. Thank you for your time.

Vice Speaker Telena Nelson: Thank You Ramona. Doyon?

Doyon Ahn Morato: *Hafa adai* and *annyeonghaseyo* chairwoman Nelson and honorable senators of the 35th Guam legislature. I'm honored to be here to give testimony from my appointment as a member of the board of directors of the A.B Won Pat International Airport Authority. I appreciate all of you for being here, especially at this time and to the other senators who are unable to make it, but who will be taking time to consider my confirmation. I truly was not expecting this call to public service, but I'm humbled by the responsibility that the governor has given me and the rest of the airport board of directors and executive manager to operate improve and grow Guam's International Airport. Some of you have known me throughout the years some more some less some not at all. With

that in mind I would like to share how I came to Guam and why I'm so committed to serving our island. I have to first and foremost thank my parents for bringing us to Guam. Their hard work, courage and ambition to create a future for their family is astonishing to think of. My parents are both from South Korea and moved to Guam in the early 1970s. My father was an architectural engineer for a large Korean construction firm and my older sister had just been born. Because of the Vietnam War there was a sudden growth of military personnel on Guam and a need to build infrastructure quickly. When my father's firm decided to pursue work here he did not hesitate, not only had he already served as an engineer at a US military base in Vietnam, in the middle of the war slept through a bomb raid and survived and then returned to Korea safely, he still had the courage to move his family to a small undeveloped island in the Pacific Ocean. I am proud to say that I was made on Guam born in Korea and then raised here. Since I was a year old my mother was a champion as she raised her two loving daughters here with no other family around. By the time my friends and I were applying to colleges, we were ready to get out and explore the big city, four seasons of weather and new people. We took Guam for granted as kids, but soon after we had lived away, the beauty of our island, warmth of our people and our unique Chamoru heritage and culture was glaringly obvious. Since then, Guam has given me so many opportunities professionally and personally. I met my wonderful husband here, I pursued my career in marketing and design, I became an entrepreneur and finally started my family here. My love, pride and appreciation for our Island is truly a passion. I not only built my first companies "Zories Only" on promoting the language culture and fun idiosyncrasies of Guam in greeting cards, but I am also my own Guam ambassador. My heart hurts inside when a visitor does not have a good experience or a military dependent is not fitting in. My appointment to the airport authority the board of directors is taken very seriously. I am fully aware and appreciate the importance of our Airport in our economy. Not only is it the first impression of our visitors to our island, but it is also the last. It is also where locals sent off their loved ones and greet them with tears of joy when they return. It is a vital part of our economy, our community and our gateway to the world. I look forward to working with the new board and executive manager and having a continuous flow of dialogue and communication with the legislature and the integral agencies to ensure that we take in all necessary considerations. There are many priorities and tasks that need attention and development but I can assure you that I will proceed with my duties with the diligence integrity and acumen that is needed to efficiently and successfully run this vital part of Guam's present and future. *Si yu'os ma'åse'* and *kamsahamnida* for your time and consideration of my appointment.

Vice Speaker Telena Nelson: Thank you. I'll open up the questions for some of my colleagues. Senator Telo, you have any questions or statements?

Senator Telo Taitague: I'm the nice one. I want to thank you so much. Your resume is so impressive and the willingness to take the time out to serve the people of Guam in this capacity. You know I asked to sissy about Brian so I'm gonna look at Chris and Chris is it okay to with you? Because you do need that family support and I know you're really busy and it's important that you have them behind you and I know you do because Chris has mentioned this to me before about you serving and he supports it so that's a good sign you have. And then watching you and Ramona, you had me in tears here I was like tearing up. Both of you guys if you guys were gonna really let the tears out I was gonna cry with you. You know to have and Ramona I've so respected her for so many years and what she does too for the island giving back many times over having her come and testify I didn't realize how close you guys were you know just seeing you guys tear up every time you looked at each other I could see you guys are very close and coming from Ramona, having her be here today to support you speaks very well of yourself in character and I'd like to thank her for being here to do that today. I wish you luck with this and I hope you still have time with the family, please incorporate that time for yourself and rest as well but I'm sure you're gonna do a great job and I'll allow my other colleagues to drill you on the other stuff. Good luck to you.

Senator Régine Biscoe Lee: *Si yu'os ma'ase* madam chair, I also want to thank the governor for placing forward your nomination, *kamsahamnida* Doyon and Family, for Chris and Nikita I know it is going to be a big sacrifice for you to take time away from them to take time away from your work to dedicate to this board, so I want to thank you in advance for saying yes and for putting yourself out there to serve our island. Ramona thank you very much, it's really important for the committee and for us as senators to hear feedback from the public and from people who have known these nominees their entire lives, because that tells us so much more than what we could read in a packet and what we can see on somebody's CV or resume so thank you for really bringing all of that to light. That being said I have had the privilege of knowing Doyon personally and working with her professionally over the last few years and it's certainly been a privilege of mine and I know the kind of integrity and hard work that she brings to all of her different roles that she plays, so I'm really excited about her nomination to this board. And Doyon, as I asked Brian in the previous nomination, I do want to ask you it about any conflicts of interest that you might have in terms of your business or any businesses that you're affiliated with and I want to ask about any conflicts of interest that you might have with regard to this board.

Doyon Ahn Morato: Thank You senator. I definitely appreciate all of your concern. That would be my same concern for anyone who was joining a board, and I understand if we did not allow people in the community who are trying to make their own careers or make a living for their families that they would not be able to serve on a board if there

were not rules and regulations in place to make sure that there would be no conflict. And it would not allow anyone to participate in their community if that was the case and if there were to be any conflict whether through business or the company that I work for, I would recuse myself I will immediately actually look into the the rules and regulations of the board and what would be in advance the necessary steps to take so that I already know what to look out for because I would never want to do anything that was a conflict or never have any impression of any impropriety and proprietary actions or behavior and that's very important to me in anything that I do and I would only expect that of my fellow board members whether on this board or another.

Senator Régine Biscoe Lee: Thank you very much actually earlier today we had an oversight hearing for GPA and this same kind of issue was brought up in terms of the the chairman of the board not being aware of certain aspects of open government law and with regard to illegal pay raises that were given out and so it's incumbent upon us at each opportunity to kind of remind ourselves with the rules of the game are and to just inform ourselves going forward so we can be as transparent as possible and we can run this government to the highest level of excellence and integrity that our people deserve so I appreciate that response from you. You also mentioned in your testimony ways that we can operate improve and grow our islands Airport so I just wanted to give you an opportunity to inform the committee of maybe some ideas of how we could accomplish that.

Doyon Ahn Morato: Knowing how important and what a significant contribution the airport provides to our economy, it is almost like its own entity it is a business enterprise we have to manage it properly we have to be profitable and we have to be able to grow with the times and do this all very responsibly and fiscally responsible and so for me going in with the new construction that's going on I would want to I want to think ahead I would want to study what is going on. I've already done a site tour of all the construction and just to make sure while we still have time during this construction phase to make sure that we're doing things that are going to last long into the future and that we're thinking of technology and our varying kinds of tourists that will visitors that are coming here and also with our local population because we use it just as much as they do and to implement things like you were saying I mean when we travel especially in the Asia region and right now that is our current biggest tourist base it could change at one point but we should also be thinking of what are they needing as far as traveling to our island so like the family-friendly restrooms and facilities and amenities all of those things I think are improvements that we can do as we start looking ahead and making sure that as we are getting creative with our funding you know I think with my varying experiences and career paths I've learned to be able to think resourceful, my sister being an attorney and many attorney friends I know how to also think like an attorney in a way and with my

husband and my father and friends who are business owners in our conversations learning how they think about how to run a business how to be in you know I've been an employee too so I also know what it's like on the other side and so I really like to look at issues from all different angles and just looking to help me our International Airport a thriving business for Guam.

Senator Régine Biscoe Lee: Thank you very much. I also just feel like you get it, you know in conversations that I've had with you and and I understand really what motivates you to do a lot of the things that you do and you know you're a mother I think that's really important just in terms of wanting to give our children an opportunity and much more opportunities that we probably didn't have when we were growing up and having that kind of vision for Guam. So again I just don't want to thank you for accepting the governor's nomination and I look forward to supporting your confirmation. *Si yu'os ma'åse.*

Vice Speaker Telen Nelson: Thank You senator Lee Senator. Senator Terlaje?

Senator Therese Terlaje: Thank you very much madam chairperson. Thank you for the testimony Ramona and thank you for accepting this nomination. I agree with Ramona, one of the most important factor really that we are supposed to try to gauge is whether you know a person, who we're putting on a board is going to be able to balance correctly this loyalty to a person who put them on versus you know the best interest of all the people of Guam. As much as you can, it's what people I think are optimistic about when we change administrations that's what they're looking for that's the hope that they always have when they change legislatures - same thing they're looking for that they want to see that you know who are you loyal to. Is this a matter of just taking care of your friends or is it going to really be a matter of taking care of the people, we are very little to gauge that on in reality as senators I think I've always felt that challenge so we appreciate testimony and you know we look at testimony, we look at your resumes and we look at your you know other things that you do in the community to see if when you say I'm you know committed to the community we try to gauge from these papers whether that's true or not or from whether we know you. Some of we know you very long so that's why I want to thank everyone for all the testimony today and thank you for you know you have to also when you serve on these boards everyone has to put all those things out there for the public so I know that's not always easy. That was the biggest thing for me, I'm a very private person I never had to tell anybody you know what am I doing with my life until it came into this you know public service so I appreciate you of being willing to do that and it you know we're gonna ask you now write about your conflicts your business things like this so I appreciate you answering and so attendance at the meetings is that going to be an issue?

Doyon Ahn Morato: No not at all.

Senator Therese Terlaje: And the transparency I talked about this earlier with Brian but you know GIAA is really the one everybody's looking at the moment for transparency really they're looking all over the government for transparency they want it here they want it everywhere so it's one of the things I think every member of the board is going to have to step up and find ways and I'm glad you're a marketing person and you seem to be creative in that type of thing that how are you going to help the airport show the public right what you're doing why you're doing it and be as open as possible and I'm wondering you know they're under criticism now you don't know the reality you know I just want to know I guess your thoughts on those kind of things transparency and whether we can make procurement fair and not cater towards you know friends.

Doyon Ahn Morato: I definitely want to take that issue very seriously because having been privy to government procurement the issues that happened the contest that people I'll bring up when they feel like there's something unfair going on and the how I feel first is the airport is highly regulated you know you've got TSA, FAA customs quarantine and so we have to be I feel like we have to be extra careful and I would be anyway regardless but there there's a whole other level I mean if we jeopardize anything in that regard it's a major funding source for not just our Airport but for other government agencies and I you know when you when you brought up the question of you know there people will just naturally have a sort of a dilemma maybe some more than others on who they're supposed to be loyal to are they supposed to be loyal to themselves or to the person who appointed them or to the company or agency or organization that they work for and I just follow my own set of rules and that would go anywhere and the reason why I was probably surprised that the governor nominated me is when we worked on the Guam Women's Chamber of Commerce together as founding board members I argued with her and disagreed with her quite a few times when I didn't agree you know or questioned some of the things that she might have been thinking and so after she appointed me and I saw her at a function like the following week I sat down and you know of course I thanked her and accepted when I received a call but I had to ask her I really wanted to know why would you choose me for this board and one of the things she said is because I know you're not a "yes" person, she knows I will question when it needed to be questioned to make sure that I'm making the right decision always.

Senator Therese Terlaje: well I appreciate that very much so thank you I hope we're able to support you in that and GIAA is also an autonomous agency so they're a little bit different than the rest of the government agencies and they have a lot more autonomy right there the some of this autonomy has come up with for example GPA recently right their ability to set salaries is different than the rest of the government's ability to do that kind of thing and I just wanted to I guess point that out that that's something else that you

know there are many reasons that they're going to you know that they talk about pay scales being different in these autonomous agencies but I just think for a person like in my experience who's you know just a normal regular person it always looks a little unfair it looks a little unfair that autonomous agencies get to set certified pay versus line agencies you know they they're stuck with waiting and waiting for the government's balance sheets to look better where an autonomous agency can take it's just one it's one balance sheet and then do that so I'm not opposed to raises but I just think you know we've just got to help each other right and so I've seen different ways where the legislators tried to you know get some help from autonomous agencies and the autonomous agencies have really been restricted because of the covenants that they've entered into with their bonds for example sharing land sharing space with customs is how that comes about right so I just want you to be conscious and to be very critical maybe of the covenants that you're entering into isn't Airport and how that will affect not just the airport but all the people of Guam because we built that Airport for the people of Guam. We want it convenient also for the people of Guam we want it you know to feel like we want the people to feel like that's their Airport and I've always had an issue with these parking being so very inconvenient sometimes and it's really changed our culture of seeing people off at the airport because of the restrictions and the and the hassle it is and even picking them up you know now we only send one person to the airport versus for all of us going to greet them right it's changed if you remember you know growing up so I'm just saying those are little things maybe in the big global picture of an airport and I know they're all driven by other factors perhaps like TSA and different you know security reasons but as much as you can. I'd like to ask you to just bear those things in mind that you know we are still this is still our community and we want our Airport to reflect that and to enhance our quality of life as much as we can. I heard what you said about the improvements for families and I'd like to the discussion earlier about the internet it seems like I can't understand why all airports don't have that right for free so I hope that you can pursue those types of things but most importantly yes I'm glad to have you on the board I look forward to your ideas you're not being a guest person and you're being able to just be very critical I think the more critical you are upfront the less the less problems the airport is going to have in the end right that's what that's what you want for them so I appreciate you bringing that to the board thank you thank you very much.

Doyon Ahn Morato: thank you

Vice Speaker Telena Nelson: Thank You senator Terlaje. I guess before I continue, I just want to thank my colleagues for all of their input no man is an island and I appreciate all the aspects that they touched from the details of the restrooms to the parking to a lot of the covenants that the airport is under and then also to the security measures that we take I know you here for Mr. Bamba's confirmation hearings so I don't want to repeat myself

but we have had a meeting and I've shared a lot of my concerns with you and I have full faith and in the both of in the both of you and your capability to move airport forward in a very transparent and thoughtful process to improve also not only the quality of life for the people but our community as a whole to improve the services that we give them at the airport authority I'd like to thank your family and everyone that came here to show support for your nominations and also thank the governor for your appointments it's a welcomed appointment to heaven and good luck and we wish you the best take care.

Doyon Ahn Morato: thank you very much and I also want to thank my family and friends that are here and my support and also my other colleagues and mentors who have submitted written testimony that I'll submit and I think they've also already submitted to your office absolutely.
