The Agana Branch Library within the Guam Public Library System shall have the name *Nieves M. Flores Memorial Library*.

§ 80103. Use.

All the libraries in the Library System shall be available for use by all persons in Guam in accordance with the rules and regulations promulgated by the Board. However, the Board shall have the authority to impose fines for lost books, late return of books or other misuses of the library resources. The Board shall also have the authority to establish fees for other services provided by the library pursuant to the provisions of the Administrative Adjudication Law.

§ 80104. Collection of Locally Authored Books and Materials.

The Library System is hereby authorized to actively solicit or purchase, if necessary, books and written matter authored by local residents which contain information of significant historical and cultural value to the people of Guam. The Library System shall insure that all materials so acquired will benefit the people of Guam and the Library System's Guam collection. The Board shall establish and promulgate rules and regulations pursuant to the Administrative Adjudication Law for the implementation of this Section. The Library System is authorized to request funds for the implementation of the provisions of this Section to be included in the Library System's annual budget request submitted to the Governor for submission to the Guam Legislature.

Of the appointed members, one (1) member shall be a full-time student, in compliance with 4 GCA § 2105.1; at least one (1) shall be employed as a librarian throughout the term of appointment; at least one (1) shall be a classroom teacher throughout the term of appointment; at least one (1) shall be employed in the field of Information Technology throughout the term of appointment; at least one (1) shall be a business owner or a senior manager employed with a private business throughout the term of appointment.

The Board shall have authority to solicit for and accept on behalf of, and in the name of, the government of Guam from any government or agency thereof, or any person, advisory services, grants-in-aids, gifts, donations of money and other property for the benefit of the Library System, or the Guam Archives; provided, that any grants-in-aid, gifts, donations or other form of assistance involving an obligation on the part

of the Library System or the Guam Archives or the government of Guam shall require the approval of *I Maga'lahi*. The Guam Public Library system may, upon approval of the Board, engage in fundraising activities for the benefit of the Public Libraries. The Board shall submit an annual report on such fundraising activities to *I Maga'lahi* and *I Liheslatura*.

§ 80123. Confidentiality of Library Records.

(a) A library or library system operated with public monies shall not allow disclosure of any record or other information, written or oral, which identifies a user of library services as requesting or obtaining specific materials or services or as otherwise using the library.

(b) Records may be disclosed:

- (1) If necessary for the reasonable operation of the library.
- (2) On written consent of the user.
- (3) On receipt of a court order.
- (4) If required by law.

(c) Any person who knowingly discloses any record or other information in violation of this section is guilty of a Petty Misdemeanor.

§ 80124. Friends of the Library Volunteers.

The Board may institute a program within the Guam Public Library System to be entitled, 'Friends of the Library'. The Board shall make necessary rules and regulations for the employment and use of said volunteers within the System. The Board may obtain liability insurance coverage for said volunteers. Title 4 GCA § 2112 shall apply to volunteers hereunder.

§ 80125. Separate Budget for Branch Libraries.

The Board shall submit a separate budget to *I Liheslatura* annually for the operations of each branch library. The budget shall include sufficient funding for personnel, utilities, books, periodicals, computers, internet access, etc. necessary to operate a branch for *not less than* twenty (20) hours per week. The Board may transfer funds within each

branch library budget among object categories, however, such transfers of funds shall not impede a branch's operating for the minimum hours prescribed herein.

§ 80126. Procurement of DSL, Cable and Wireless Broadband Services.

The Guam Public Library System is authorized to procure, from private companies doing business on Guam, DSL (Digital Subscriber Lines) services, cable television/internet services and/or wireless broadband services as a means of providing internet access to its employees and patrons. In the procurement of such services, the Guam Public Library System shall consider the cost, the amount of bandwidth, and the reliability of the service. The Department of Administration shall not require the Guam Public Library system to use the Government of Guam's data network to provide internet access to its employees and patrons.

§ 80127. Use of *Hagåtña* Library Parking lot.

(a) The *Hagåtña* Library parking lot *shall* be reserved for parking of vehicles operated by patrons and employees of the Guam Public Library System (GPLS). Parking in the *Hagåtña* Library parking lot by persons other than those, *supra*, *shall* be a violation and punishable by a fine of Twenty-five Dollars (\$25) per violation.

(b) The Director *shall* be required to maintain a roster of those persons authorized to park in the *Hagåtña* Library parking lot. The form of such roster *shall* be determined by the Board. The Director *shall* post a sign at the entrance of the parking lot that states, 'In accordance with the provisions of § 80127 of Title 5 GCA, this parking lot is reserved for the exclusive use of Guam Public Library patrons and employees. Patrons parking in this lot *shall* be required to sign in and out when entering and leaving the library building. Violators are subject to a fine of Twenty-five Dollars (\$25) per violation.'

(c) Enforcement of the provisions herein this Section *shall* be the responsibility of the Guam Police Department; however, the Chief of Police may authorize any employee(s), designated by the Director, to issue citations for violation of this Section.

§ 80128. Authorization for Solicitation and Contracting for Lease.

(a) The Guam Public Library System is hereby authorized to solicit and contract for the lease and operation of the Internet Café located at Nieves M. Flores Memorial Library in Hagåtña to provide drink and food services for library patrons and the general public, for the purpose of generating a source of revenue to support library infrastructure and attracting patrons to the establishment.

(b) All funds received from the contract for the lease of the Internet Café shall be maintained separate and apart from any other funds of the government of Guam, and independent records and an independent bank account shall be kept in connection with this Fund. The revenue from the contract for the lease of the Internet Café shall be used for facility maintenance, improvements, supplies, and programs. The use of these funds shall be subject to the determination and approval of a majority of the Library Board members, and subject to legislative appropriation through the annual budget act.

(c) Funds directed, as a result of revenue received from the contract for the lease of the Internet Café, shall be subject to an annual audit by the Office of Public Accountability.

(d) The Library Board shall establish interim policy and procedures for the administration of this § 80128 until the promulgation of rules pursuant to the Administrative Adjudication Law.

Good afternoon Vice Speaker Nelson and Senators of I Mina'Trentai Singko Na Liheslaturan Guahan. My name is R. Arlene Santos, Acting Director of the Guam Public Library System. For the record and in accordance with the Open Government Law, Public Notices were sent out via email to all stakeholders, main media broadcasting outlets and senators on Monday, August 17, 2020 and the second notice on Tuesday, August 25, 2020. Notice of today's virtual confirmation hearing was also available on the Guam Legislature Website.

Today, we have with us, Senator Kelly Marsh (Taitano) and Senator Will Castro. Thank you, colleagues for joining us. Before, we proceed with the virtual confirmation hearing, the legislature has general rules of conduct that must be followed. All must abide by rules of conduct and quality assurance standards. Please keep video on at all times and ensure you are in a room with little interruptions and adequate lighting. Specifically, to make sure the participant's face is visible at all times. The host of this hearing will mute participants until called upon by the Chair. When called to speak please ensure that you are unmuted and that you are speaking into your microphone. Members of the Committee wishing to speak may indicate via the in-app chat box. Individuals testifying shall first be recognized by the Chair before speaking and shall state their name for record-keeping purposes. Each member of my colleagues will be allowed to pose questions to individuals testifying. Questions and testimony shall be confined to the substance or nature of the agenda. So, on today's agenda we have the confirmation hearing of Dr. Monique R.C. Storie as a Member Librarian Representative to the Board of Directors of the Guam Public Library System and then we also have the roundtable hearing on ASD.

So we'll start with the testimonies, those that are here to speak on behalf of Dr. Storie and then we'll move in with Dr. Storie, giving testimony on her behalf. So, is there anyone that would like to speak on Dr. Storie's behalf? Is it just you Dr. Storie? Oh, there, Ms. Annette Santos, okay, yes, Mrs. Santos, please proceed.

R Arlene Santos: Did you mean Arlene Santos?

Vice Speaker Telena Cruz Nelson: Yes, I'm sorry. I'd also like to recognize the Minority Leader... Sorry, I know I'm sorry. I was thinking of another...

R Arlene Santos: I was looking for the nickname.

Vice Speaker Telena Cruz Nelson: Sorry, Mrs. Santos.

R Arlene Santos: That's okay. Well good morning, Vice Speaker Nelson, I see Senator Telo Taitague, Will Castro and Senator Kelly Marsh (Taitano).

Good morning and good morning guests that are here this morning attending this virtual hearing with me.

Please see attached testimony.

Vice Speaker Telena Cruz Nelson: Thank you, Mrs. Santos. Is it just you now, Dr. Storie that's here? Okay. Please proceed. Good morning.

Dr. Monique R.C. Storie, Nominee: Good morning. My name is Monique Story and I do have a prepared statement which means that I'm going to be looking off camera for a little bit so, please excuse me for that. So, I'm Monique Story and I currently serve as the Dean of the University Libraries at the University of Guam and an Assistant Professor of Library Science since the academic year 1995-1996; where I've helped patrons to find information for assignments and personal interest, I've helped develop library collections and I've helped to develop the island's Cadre of School Librarians.

While I've had many career achievements and an interesting life as a librarian. I have been a patron of Guam's libraries my entire life. My father, Dr. Ken Caravo was a librarian and Dean of the RFK Memorial Library. So, my brother and I, spent many afternoons in the RFK Library waiting for my dad to finish work where we got to explore the library.

As a student at Tamuning Elementary, I was selected to be a library aide where I learned how to check out books, check them back in and how to shelve. I remember feeling very proud of my job. I wasn't aware at the time that apparently that was going to be my life goal and my passion. Every other weekend, my family would go to the Dededo Public Library to check out books. My brother and I would decide which books we wanted to check out. Basically, we strategized what books we wanted so, that we could double the reading pleasure that we got.

In middle school and high school. I discovered Anne of Green Gables, Don Quixote, the Green Mansion and Stephen King's It and many other classics on the shelves of the library. Libraries were an important classroom during my college years whether I was pursuing my degree in Spanish or in Librarianship or in Language, Reading and Culture, which is a subsection in multicultural literature because I was able to pursue answers to my own questions.

When I became a parent, I would bring my son to participate in the Saturday Reading Hour in the summer reading programs or even to check out every single book available on whatever interested him at the time. As I said, libraries have always been a part of my life. I've come to understand through my life experiences and through my education that public libraries play different roles in our community.

Libraries are a place for people to find answers, they're a place for discovery, it's a place for growth, a place for adventure. Libraries are a community resource and libraries are community. Through these roles, I've come to understand that libraries are a reflection of and an investment in ourselves and in our community.

That's why I'm honored to be nominated to be a part of the Guam Public Library's Board, to be its advocate and through this advocacy, I hope that the library will be the strong force for our island. Thank you.

Vice Speaker Telena Cruz Nelson: Thank you, Dr. Storie. I want to congratulate you on your appointment. I'll open it up to my colleagues. Senator Kelly Marsh, do you have any questions or any comments?

Senator Kelly Marsh (Taitano), Ph.D.: *Si Yu'os ma'åse'* Madam Chair and you know I really wanted to make sure to be here. Time just flies by and so, I was calculating while Dr. Storie was going through her testimony and I've known her for twenty-five (25) years. It doesn't feel like it's been that long and a little bit of what she was describing you know just really reminded me of my childhood as well spending time in the libraries – like the importance of books and you know I knew it ran in the family a bit but that her father was also the Dean Librarian for RFK. I hadn't quite remembered.

I wanted to ask her a few questions. I also want to highlight as the Acting Director has that Dr. Storie just has such strong credentials. She has that twenty-five (25) years of experience because I did indeed meet her at a library, I met her at the MARC Library. So, she has twenty-five (25) years of experience that I'm aware of and both a Master's Degree and then her Ph.D. focusing on specifically local literature and other literature.

I also wanted to point out that she belongs to the Guam Library Association, the American Library Association and even the Pacific, its more broad, I believe Archives Libraries and Museums, she belongs to that as well.

So, I've heard such good things about the Board. I've really liked seeing the way the library has kind of organized itself this last year or two (2) and so, I think she'll really contribute. Part of what I've thought about is you know how do we modernize libraries, Monique and I or Dr. Storie and I grew up in the libraries in certain ways and so, I'd like to hear from her if she has any thoughts as to whether one needs to modernize our approach or she sees any trends that might be useful here or just some of her visions for what we might do as a whole system.

Dr. Monique R.C. Storie, Nominee: Sure, the quick answer is the step that we need to start with really is to look at the community. I had been asking the library technicians you know what do they understand of their roles in the library and one (1), of the things that they have articulated as well as what I've noticed that there needs to be an understanding of what the library's role in the community is. We need to understand who the patrons are and that's what actually will be able to drive programs.

So, there are so many different models that you know we can talk about but it really is going to have to start with what is it that our community wants and what is it that our community needs and then that's the way that we modernize and so, as I said there are different models you know it could

be that we look for partnerships with the public school system. It may be partnerships with organizations, community organizations or it could be that you know we do make investments in more virtual resources but again it really needs to... we need to go back to what is it that the community wants and what does it need the library to be. Do they want more sources for entertainment? Do they want more sources for education? Are they looking for programs that are going to help them to if they aren't wanting to go with the post-secondary education route? They don't want to go to GCC. They don't want to go to UOG. How do they get to advance their own education and so, our modernization needs to also... it needs to take into consideration what our community is truly looking for in its library and it's time to revisit that?

Senator Kelly Marsh (Taitano), Ph.D.: *Si Yu'os ma'åse'* for that answer. I really like the different facets of it. Each community is its own specific set of dynamics and certainly here we know that we have very specific dynamics. We have villages. We have a lot of community members who are part of that digital divide and don't have access to online resources and so, yeah I just think there are so many ways that we can continue to build on the good work that's been happening this last year. We have a bookmobile that's now ready to get up and running. We have a brand new archive. So, I just see so much potential and I think with the other good board members that are there. I can see everybody moving forward really well together. So, I'll just keep it brief and just have that one (1) question but *Si Yu'os ma'åse'* Madam Chair for letting me ask that.

Vice Speaker Telen Cruz Nelson: Thank you, Senator Marsh (Taitano). Senator Telo Taitague?

Senator Telo Taitague: Okay, there's the mute button. *Håfa adai* and good morning everyone. Thank you for being here and Monique, I have a little secret about me that most people don't know but way back when there used to be a program called summer training. So, during summer school... at summertime people were given jobs to the Government of Guam and my very first job was working at the library at NCS and I don't know if you remember her but her name was Mrs. Denight. I think first name Catherine Denight, she was the Librarian there if you remember and for a long time she was great inspiration to me.

So, I worked there when I was fifteen (15) years old and one (1) thing I loved about her she let me bring me guitar to the library but then one (1) thing she taught me was you know to be organized and I think that stuck in my mind because I organize everything, ask my colleagues on my desk, I've got everything organized and it's because of how she taught me to categorize certain things and put them in order.

So, I love it you know I enjoy it and I think you're going to be a great asset looking at your background. I do have a questions, why Arizona? I noticed that you went to Tempe and my son lives in Arizona but why Arizona?

Dr. Monique R.C. Storie, Nominee: Well I actually started my college career as an Architecture student and at the time Arizona State had an excellent Architecture Program. Once I got there, I

fell in love with the Spanish culture and language and so, it just gave me the opportunity to explore a whole lot more by being in the Southwest. Plus, I really don't like the snow.

Senator Telo Taitague: That's good enough for me. That's probably why my son is there too but it's extremely hot. You know, I know your background having Senator Marsh talk highly of you and knowing you for so long and I know having her endorsement says a whole lot and I don't know you personally but trying to read your background and I think you have a love for it you know, it runs in the family. I wish you the best of luck and I hope that you continue and I think it was during the Joe Addis time they had the governor's conference on librarian, do you remember that?

Dr. Monique R.C. Storie, Nominee: Yeah.

Senator Telo Taitague: You know being a part of that has that continued on... do you plan on, you know implementing that or continuing with this conference that started back in 1990, I think it was...

Dr. Monique R.C. Storie, Nominee: Well I haven't actually thought about that. What we do have which is the Píala Conference. That is an annual conference that travels from island to island and so, through that we actually have the opportunity to interact with the librarians from Micronesia as well Hawaii and American Samoa and so, we that way we're actually able to create more of a regional network for when we have questions from people who come from those different islands and they want more information about their home islands. And so, that way we can support ourselves both in terms of getting new information about the field of librarianship as well as learn about what new resources are available in the region. And so, then also the public school system they have their own conference that is specific to what the school library needs are. So, we may not necessarily have one (1) that is designed at the executive level but we do have different organizations and conferences that allow us to develop ourselves and then to promote the idea of librarianship and information exchange across the region.

Senator Telo Taitague: Well that's very good to hear Monique and I thank you for staying involved in that and sharing your knowledge with our brothers and sisters in the Pacific too. So, thank you Madam Chair for the opportunity and Monique you definitely have my support. Thank you so much for all your work and serving. Thank you.

Dr. Monique R.C. Storie, Nominee: Thank you.

Vice Speaker Telen Cruz Nelson: Thank you, Senator Taitague. Senator Castro?

Senator Wil Castro: Thank you Vice Speaker. *Håfa adai!* Good morning Monique. Vice Speaker, I've known Dr. Storie since '95, I think Dr. Duenas and I were just undergrads at the University. Monique was just Monique and Dr. Duenas was just Asher Dee. So, we've come a long way and I can't say publicly and on the record because this is being broadcasted that you're definitely a

woman of upstanding character and it really makes me happy to see people from our walks of life make it through life.

I'm very proud of your accomplishments and I'm so touched to see you give back in ways like this. I think you're the perfect bridge between this community – learning resource environment and the University of Guam and maybe if time permits at another time we can have a little reunion and I can share my thoughts and experiences about what I saw when I was in New York with the evolution of the learning community and learning centers.

When Starbucks moved into the Columbia Library you knew something was changing and I just want to say congratulations and you have my support. Thanks for giving back. Monique I remember your dad, he was a great member of that university community as well. So, God bless you on your new journey and you being a lot of value to the Public Library System. Thank you so much.

Dr. Monique R.C. Storie, Nominee: Thank you.

Vice Speaker Telena Cruz Nelson: Okay, thank you, colleagues. Dr. Storie, I have some questions but you pretty much answered them. So, thank you for that. I also want to share that it's been a pleasure seeing you at the MARC Library. I used to go there to pass the time and you're always a frequent face so, it was kind of a reassurance that something was constant. Thank you for giving your time and also for the service. Accepting this appointment and we look forward to your confirmation. Okay, thank you and God bless and have a wonderful day and be safe.

Dr. Monique R.C. Storie, Nominee: Thank you.

Vice Speaker Telena Cruz Nelson: Okay, everyone, now we will move forward with the Autism Spectrum Disorder roundtable hearing.

The public hearing was adjourned at 08:54 A.M.
