

Chairman Joe S. San Augustin: Good morning, ladies and gentlemen, the Committee on General Government Operations, Appropriation and Housing, convenes this public hearing notices were given to the media on Monday, October 07 on Wednesday, October 09. the second notice. For the record today's Tuesday, October 15, 2019 and the time now is nine o'clock. The committee will hear and accept testimonies for the referral of appointment of Frank J. Pangelinan - Position: Member, (Real Estate Broker), Guam Real Estate Commission. Term Length: Four (4) Years from the Date of Confirmation. Rules for public hearing, the conduct of this public hearing shall be as follows: Those testifying be recognized in the order of sign up on the sign-in sheet, and we have Mr. Pangelinan sign-in. Written testimony may be read lengthy testimony should be summarized about five minutes and written testimony shall be submitted to the committee please provide our Legislature staff with your written testimony for photocopy. Frank J. Pangelinan: Good morning and *Håfa Adai*, chairman San Agustin, I thank you for giving me the opportunity to appear here for this confirmation hearing as you know, I'm the recent appointee to the Guam real estate commission and I feel very honored and privileged to have been asked to serve as a member of the Guam real estate commission. I am presently the principal real estate broker for not Latte Stone properties, a company that just celebrated its tenth year this month. Latte stone properties is a local company and provides full real estate services. I am also 80 percent owner of the company, I was a member of the Guam Building Code Council and my term expired this past April and I was called by the Governor's office and I was asked if I would wish to continue as a member of the Guam Building Code Council or to accept an appointment to the Guam real estate commission I chose the latter and so senator I'm not much into blowing my horn. I don't get too excited about that so I'm just going to hush up now and allow you to ask me any questions you wish.

**Chairman Joe S. San Agustin:** Thank you sir, Mr. Pangelinan, do you believe or do you see in the near future if you were confirmed any possible conflict of interest and in any decision, you may make with the Real Estate Commission?

**Frank J. Pangelinan:** I don't think so sir I don't believe so when I first joined the real estate I had known and it was part of the pre licensing examination that there's such a commission

such as the Guam real estate commission which was not active at all it wasn't until maybe about four or five years ago that was reactivated when I joined 12 years ago this industry I saw a lot of improvements were needed particularly in the area of protecting our consumers. Do we have laws that really would protect Tan María's Cruz when she wants to sell her property or Tun Ramon who wants to buy a house for his grandson there are a lot of loopholes and as you know we have lots of laws on Guam that are not enforce or they there are no laws existing. Recently last December the 34th Guam Legislature enacted a law that protects that has is a Landlord and Tenant Act okay that went into effect became a law in December so we have something but we still have quite a bit most recently the real estate commission as I learned has started out and it has drafted up a bill that would be certainly introduced on sellers disclosure. This is a requirement; this is an industry requirement that should you want to sell your house you know you've got a crack on your roof that would cost \$30,000 you paint the crack and you sell the house and fail to disclose that or purposely omit that from the disclosure. We don't have such laws and you could sell the house and if the buyer buys the house and it's going to cost him twenty-five thousand dollars (\$25,000) to repair that roof because a hey it was your fault you bought it. We need laws like that and the real estate commission would be a source for drafting laws like that and policing whatever laws we have committed.

Chairman Joe S. San Agustin: So, oh that sounds great Mr. Pangelinan, I look forward to that if the real estate commission does drop one and you're looking for a senator to up to introduce it, I'd be more than welcome because I would love to protect every consumer, we have and not only that I'll actually be asking the real estate commission to take a look at that. I'm not too sure if there's any true law that protects group that you know the owners of properties against what they call the you know, the folks that just occupy your property they're called, cause I'm trying remember the name I see it on TV a lot where people just come in and just take over the homes or take over the property and the actual thing they can just get away with it and that's what it shouldn't be. There's a lot of improvements that we can make all right yes thank you, sir.

Frank J. Pangelinan: Thank you well I'm going to look forward to that oh they're called squatters.

Chairman Joe S. Well we still have you know the agents and real estate brokers and things like that's another area that I would like to see some improvement. I was once told many years ago that the status of a real estate Agent, a real estate broker it's just one not over as used car salesman and that's a pretty bad image and the reason for that is they were probably doing some unethical things so that's another area that I would like to see so many prove much all right thank you sir. Sir just to advise you that I will be submitting this packet, your packet to the whole committee recommending that you be confirmed in our upcoming session, so there being no one else that are as present to testify for or against you the committee will continue receive testimony

for the next few days.
