



**§ 1105. Powers.**

The Authority shall have and exercise each and all of the following powers:

(a) Acquire, construct, reconstruct, purchase, better, extend, improve, operate and maintain airports and related facilities owned or used by Guam for civil aviation purposes.

(b) Acquire by grant, purchase, gift, devise, lease, permit, right of entry or by the exercise of the right of eminent domain in accordance with the provisions and subject to the limitations of laws of Guam including 5 GCA Chapter 5 [Procurement Law], and hold and use any real and personal property necessary, convenient or useful for the carrying out of any of its powers pursuant to the provisions of this Chapter, and to dispose of the same.

(c) To construct, operate and maintain runways, taxiways and related airport facilities on property owned by the United States and used by Guam pursuant to agreement with the United States.

(d) To assume the benefits and obligations of Guam under that certain Joint Use Agreement executed between Guam and the United States on July 19, 1974, and to assume or enter into agreements executed pursuant to said Joint Use Agreement, all the above being performed as an instrumentality of the government of Guam.

(e) To impose, prescribe, revise and collect fees, rates, rentals, landing fees and charges for the use and services of, and the facilities and commodities furnished by the airports operated by the Authority and to charge and collect any fees permitted by the Joint Use Agreement, and to pay charges and costs imposed by said Agreement upon Guam.

(f) To acquire from the United States, under any appropriate federal statute, lands made available for airport purposes to Guam and to comply with the conditions

established by the United States as necessary for the acquisition of such lands.

(g) To apply for, receive and use, all according to the terms thereof, grants-in-aid, or grants-in-kind from the United States for use by the Authority for airport purposes.

(h) To make and enter into contracts, leases, concession agreements and permits and to execute all instruments necessary or convenient in the exercise of its powers, including without limitation, the purchase of liability and casualty insurance for airport purposes, adopt a seal and sue or be sued in its own corporate name.

(i) To, at any time and from time to time, issue general or special revenue bonds pursuant to Article 2 of this Chapter.

(j) To enter into leases with the government of Guam or with the United States, provided that no such lease shall exceed forty (40) years in duration.

(k) To employ agents and retain or contract for the services of qualified consultants, specialists or experts, as individuals or as organizations, to advise and assist the Authority and its employees, all of which may be accomplished without regard to the portion of the Personnel Laws relative to compensation.

(l) To adopt such rules and regulations, pursuant to the Administrative Adjudication Act, as may be necessary for the exercise of powers and performance of the duties conferred or imposed upon the Authority or the Board.

(m) To do any and all other things necessary to the full and convenient exercise of the above powers.

Nothing contained in this Section, or by implication in this Chapter shall be construed to be in any way in derogation or limitation of powers conferred upon or existing in the Authority or in the Board by virtue of the Organic Act, the laws of Guam or the Government Code.

CH. 1 GUAM AIRPORT AUTHORITY**

**§ 1106. Board of Directors.**

(a) All powers vested in the Authority, except as provided herein, shall be exercised by the Board, which shall consist of seven (7) members, called directors, who shall be nominated and appointed by the Governor, by and with the advice and consent of the Legislature. Each director shall serve a term of three (3) years from the expiration of the term for which such director's predecessor was appointed, and until a successor is appointed and qualified, or in the case of a director appointed to a newly created membership in the Board, such director shall serve a term of three (3) years from the date of initial appointment, and until a successor is appointed and qualified. All vacancies occurring in the office of director shall be filled by the Governor in the same manner as for full-term appointments, but only for the unexpired term of the director whose vacancy is being filled.

(b) Four (4) directors shall constitute a quorum of the Board for the transaction of business. The Board may adopt rules and regulations governing the conduct of its affairs. It shall elect a chairman and a vice-chairman from among its members. It shall appoint a secretary who shall not be a member of the Board and who shall maintain all records and minutes of the Board.

(c) Each Director shall receive the sum of Fifty Dollars (\$50.00) for his attendance at any meeting of the Board, but such compensation shall not apply to more than two meetings in any one calendar month. No Director shall receive any other compensation, but shall be reimbursed for actual travel, subsistence and out-of-pocket expenses incurred in the discharge of his responsibilities, including authorized attendance at meetings held away from Guam.

Madam Chairwoman, and members of the committee,

Please accept my testimony in opposition to the confirmation of Bic Sobti to the airport board of directors.

It is my belief, based on Mr. Sobti's recent actions, that he will abuse his position as a member of the airport board of directors to his personal benefit.

The CNMI House of Representatives Special Committee investigating the use of pandemic federal funds by CNMI Gov. Ralph Torres is pursuing the matter of a \$2.58 million sale of supposed personal protective equipment (PPE), by Mr. Sobti's company International Royal to the CNMI government.

On the record so far is an invoice detailing his unbelievable markup of PPE at the height of panic in the CNMI for pandemic preparedness. CNMI legislators, on the record, have compared unit prices of products supposedly delivered to Saipan to the unit prices of the exact same products quoted by other companies at a two-thirds discount.

Indeed, Mr. Sobti sold 250,000 generic face masks to the CNMI government for \$3 a piece, and sold the same exact face masks to the Mayors Council of Guam for \$2 a piece. To put this into perspective, those face masks sell at retail in Guam stores for \$0.20 a piece.

This is just one item entry on one invoice I decided to use as an example. There are \$1.75 million in other sales at severely-inflated prices in that one invoice alone.

An egregious fact to consider, and which is under full consideration by the CNMI Legislature's investigative committee, is that International Royal has never been and still is not a registered company in the CNMI. Another fact under consideration is that even on Guam, where the company is registered, it is a uniform, clothing, and tailor shop - not a medical supply company.

The CNMI Legislature, and I would imagine the Federal Bureau of Investigation, is investigating how a uniform and tailor shop from Guam, whose owner has physically been on Guam during the contracting period, came to receive a \$2.58 million sole source contract in the CNMI for medical supplies using federal dollars.

This matter is a monumental embarrassment for Guam, an indication of shameless disrespect by Mr. Sobti - and by association - the people of Guam to the struggling people of the Commonwealth, and more importantly showcases the extent Mr. Sobti will go to make a buck.

Is that who we want on a governing board overseeing the expenditure of \$100 million in contracts?

Thank you for your time and kind consideration. I ask that my testimony be read into the record.

**Troy Torres:** *Please see attached testimony.*

**Vice Speaker Telena Cruz Nelson:** Thank you, Mr. Torres. Bic, you're welcome to proceed with your testimony.

**Gurvinder "Bic" S. Sobti, Appointee:** Thank you. Good afternoon and *Håfa adai*, Madam Chairperson and members of this esteemed Committee. I'm honored. I'm privileged to be before you today for my confirmation hearing. I desire to continue my public service as a Member of the Board of Directors for the A.B. Won Pat International Airport Authority Guam.

I would like to convey my appreciation to Governor Lou Leon Guerrero and Lt. Joshua Tenorio for having the trust and confidence and reappoint me to GIAA Board. My initial tenure in the airport board started in 2013 and my experiences then carries forward into my continued participation and contribution to the airport.

We are facing unprecedented times with the COVID-19 pandemic. We need to build and sustain confidence that our airport is safe and secure as we recover. We need to make the right decision. Explore all options to keep the airport, our airlines and concessionary financially viable. There is much work that remains for Guam Airport.

**Vice Speaker Telena Cruz Nelson:** Thank you, Mr. Sobti and we also have a pair of support from Mr. Bamba and Mr. Quinata. Some of the questions that I have is what contributions do you plan to provide to the Guam International Airport Authority?

**Gurvinder "Bic" S. Sobti, Appointee:** I've been on board for a while and you know I mean I've been in several committees. The last committee I've been with is the CIP and Finance Committee and the last few months with this pandemic.

We've been suffering but the airport has been very blessed. We just got about \$21 million dollars from FAA to help with our partnership with all the airlines and our concessionary. So, we are working very closely with them to help them sustain this problems with I mean their financials.

So, we can keep them as a partner for long-term and the CIP, Mr. Belanger is a new member which is a big asset to a company, a big asset to the airport. He has the experience and being a part of this started this third floor corridor. We are in full progress and like he mentioned we should be done by next year and there's full speed with that.

**Vice Speaker Telena Cruz Nelson:** Thank you. For the length of 3 years that you will be serving. What are some of the priorities that you foresee for the Guam International Airport Authority?

**Gurvinder “Bic” S. Sobti, Appointee:** I think so, the first thing we need to bring is safety for the airport and bring that tourism industry. So, we our marketing department and cut down on our other contracts which we can save money until the tourism come back.

So, we need 2 priorities are for the marketing and to cut down on the airport cost so, we can manage for the next few years until our tourism come back.

**Vice Speaker Telena Cruz Nelson:** Thank you. What contracts do you foresee being cut?

**Gurvinder “Bic” S. Sobti, Appointee:** I would say some cleaning contracts to trash contract to you know because we have less tourism. So, there’s less... those 2 contracts and we are most likely...we’re not doing anymore construction for the next few years.

So, airport will be holding 10%. We most of the money come from the FAA but 10% committed from the airport fund. So, we’ll be holding back on those construction too.

**Vice Speaker Telena Cruz Nelson:** Okay, thank you very much. Minority Leader Senator Taitague, you are recognized. Do you have any questions at this time?

**Senator Telo Taitague:** *Si Yu’os Ma’ãse’* Madam Chair for the opportunity to speak. First, thank you for willing to serve the people of Guam and you know Bic, there has been some allegations toward you and I want to be able to hear from you on any of those allegations, if they’re true or not?

**Gurvinder “Bic” S. Sobti, Appointee:** That’s not true. I’ve been supplied to different islands. Anybody needs goods. I’ve been doing this from the last 40 years. It’s not my new business and this is my old business and I’ve been doing that from the last 39 to 40 years.

**Senator Telo Taitague:** So, you don’t think there’s anything wrong with these allegations of price gouging or anything like that?

**Gurvinder “Bic” S. Sobti, Appointee:** During those times, it was tough times and I had to go source this. So, everything the shortage was so bad that we had to get these goods at a premium prices and look at the for example, the price for the gloves; the company prices have gone from \$5 to \$12 a box today because there’s a shortage of gloves.

During that time all these factors which we are buying and shipping. And shipping stopped completely so, we had to bring everything from DHL or airlines not by sea shipment because we have to pay 3x the price to bring these goods in.

**Senator Telo Taitague:** So, I guess my last question is, are you being investigated by the CNMI government at this time?

**Gurvinder “Bic” S. Sobti, Appointee:** No, not to my knowledge.

**Senator Telo Taitague:** You're not being investigated. Okay, well if that's what you're saying. I'm kind of seeing the news lately and your name is out there. Sorry, go ahead Bic.

**Gurvinder "Bic" S. Sobti, Appointee:** They haven't called me yet.

**Senator Telo Taitague:** Oh yet. Okay. Thank you, Madam Chair for that opportunity. Thank you.


