



Good Morning Honorable Chairwoman Dr. Kelly Marsh (Taitano), and Honorable Senators. Thank you to all my friend and family gathered here to support my nomination today. My name is Ina Villanueva Carillo and I come before you today to seek confirmation for the position of Station Manager at the Guam Educational Telecommunications Corporation also known as PBS Guam KGTF Channel 12. I am Married, and a mother of three boys, a 20-year-old, a 17-year-old and an 11-year-old, they are my life and the reason I have worked as hard as I have to be successful.

I graduated high school with a full college scholarship but let that opportunity slip away when I got pregnant. I was devastated but had to accept the consequences and begin my career here in Guam to support my son. As young mother in sales at Guamcell Communications I quickly found a passion for marketing. I then moved to media sales at Hit Radio 100 where I eventually earned my way up to senior accounts. It was around then I decided I needed to diversify, I started working in business development at Graphic Center Inc and developed a line called Milestones Pacific. I was offered the position of Sales Director at GU Magazine. At the same time, I started my consulting work as a Political Media Strategist. I was asked to work alongside our new Lt. Governor Josh Tenorio in the Obama for America campaign as the media buyer in 2008. Because of my work with the Obama for Amercia campaign, I have also worked with numerous senatorial and gubernatorial campaigns since then. Not long after that I started my career at Marianas Cablevision I handled network programming, sales and marketing and managed MCV's nonprofit arm MCV Cares. I was tasked with keeping subscriber costs low and keeping programming at the highest quality. While in charge of that department, my team and I initiated TV Everywhere that allowed subscribers to view their cable channels online anywhere in the world with an internet connection. We also produced events in support of the community and raised funds for the Guam Police Department and children's organizations

Throughout my professional career I have been a problem solver that tried to work collaboratively with my team. I never have led by delegation, I consider myself a team player that looks for the best idea, regardless of its origin to address whatever problems arise in the production of an event or implementation of a new policy.

I've been blessed in my professional capacity to have had some very influential business leaders' mentor me in the process of leading others and finding solutions to problems. I've

worked closely with great men like Jay Shedd, Ernie Galito, Lt. Governor Joshua Tenorio and Thomas Higa. These men have shaped my business acumen and helped me to be able to step into a new project, assess its obstacles, and work with my colleagues to determine the best direction to move forward.

These men and others that I've worked with gave me the confidence to step out on my own and open my own business which has been my toughest journey yet. I started a business out of my home in 2013 and 2 years later, I announced to my husband that I was leaving my well-paying corporate job and I opened a brick and mortar storefront. A year later, we expanded, and I opened my second store and haven't looked back. I employ 7 wonderful people and together we do our best to make our islands women feel beautiful on the most important days of their lives, such as proms, banquets, galas and most especially their wedding day.

I tell you about my experience not to speak highly of myself, but so you can clearly see my character and the amount of energy I apply to be successful. I work hard at everything I do, and I always give it my all. Some may call me stubborn, but in my opinion, I'm driven, driven by the fear of letting my children down, driven by the want to make things better, and driven by desire to give back to an island that has given so freely of herself to me.

After being honored with my appointment by our first Female Governor Lou Leon Guerrero, I met with the staff at PBS and together we got to work. We had to determine what obstacles were holding the station back, and what we could do to advance the station into the new millennium. What I learned was the biggest obstacle PBS Guam faced was it's ability to pay for PBS program licensing. As I thought, finances we the root of our troubles. Each department has established new goals and objectives including the creation of new signature fundraising programs, restoring and renewing inactive accounts and implementing new modern fundraising activities. We will be reinstating the recurring membership program, and begin developing quality local and diverse programming. We will also continue to host and support meaningful community outreach programs. While PBS Guam has a fantastic staff of professionals that love their job and are determined to meet its mission, PBS has been "making it work" with minimal resources and antiquated equipment. Our building has sufficient space but desperately needs an update.

Putting that aside, exciting changes are on the horizon, with a renewed vigor and support from sister agencies, PBS has increased its production sales, and we've been able to hire one

of the most premiere filmmakers in the Micronesia region, Don Muna of the Muna Brothers recently joined our team as our executive producer. We recently had our "Fall in Love" with PBS Guam annual telethon/pledge drive where thanks to generous donations from many of you, we were able to raise over \$10,000, the biggest overall telethon fundraiser in PBS's history. PBS Guam is currently wrapping up our annual Read-A-Thon fundraiser with Guam Department of Education. PBS Guam works with our island schools to encourage our children to read and from this program we are on track to raise another \$15,000.

We have applied for a Technical Assistance Program grant with the Department of Interior, this grant is designed to promote education in insular areas, and we intend to create high quality programming and support local producers and groups like Nihi and others cultural practitioners. We will be producing LIVE sports and have entered into an agreement with UOG to broadcast their sporting events Live starting in October and look towards partnering with the other sports leagues like IIAAG to do the same. We will broadcast the State of the Island address tonight, be the official broadcaster of the Liberation Day Parade and we want to begin talking to the Department of Education to invite Middle School and High School students to produce their own quarterly magazines of activities going on at their schools. This is a version of the Hiki No' program currently instituted by the PBS Hawaii group. We will be working with along side with them to develop and incorporate their program here on Guam. This will basically be produced by students with some creative oversight from our executive producer Mr. Muna.

In order to achieve these goals, we desperately need to upgrade our equipment, we still use tube televisions to monitor programming, our cameras are old and outdated and most of the production equipment we have is over 20 years old. Our On-The-Go Broadcast van was acquired in the 90's and is outdated and our studio needs an overhaul. There are many other challenges, but we are working collaboratively as a team to find a way forward.

PBS Guam has come a long way from its humble beginnings in 1970, and I'm proud to work with these men and women behind me to continue the tradition of providing our viewers with outstanding television, educational outreach services and events.

The challenges we have are many, the resolve the employees have is great, and in my mind, with the proper amount of will, anything can be achieved. Its been a great honor to sit before you and speak about myself and my mission as Station Manager of PBS Guam. I ask for your

vote of confidence regarding my confirmation and I'm open to answer any question you may have for me. Thank you.

For the record, today is Thursday, April 11th, 2019, and the time is 8:36 am. The committee will hear and accept testimonies both oral and written on the following, the confirmation hearing of Ina V. Carillo to serve as station manager for the Guam Educational Telecommunications Corporation also known as KGTF / PBS (Guam).

Later, we will be hearing the appointment or going through the process of the appointment of Pale' Felixberto Leon Guerrero, *I Liheslaturan Guåhan's* appointment to serve on the Commission on *CHamoru* language and the Teaching of the History and Culture of the Indigenous People of Guam.

Following that we have a confirmation hearing of Rita T. Franquez to serve on the Board of Commissioners for the Hagåtña Restoration and Redevelopment Authority.

I see that Clifford the big red dog has just joined us, what a welcome addition, and then we will be ending our session today with the confirmation hearing of Maria Eugenia Leon Guerrero to serve on the Board of Commissioners, Hagåtña Restoration and Redevelopment Authority.

So...I'm very pleased this morning to be joined by the honorable Senator Therese Terlaje, to my right and I'll go ahead and go over the general rules for the public hearing. The conduct of this public hearing shall be as follows; those testifying will be recognized in the order that they have signed up on the signup sheet; written testimony may be read; if it is a lengthy written testimony, we ask that it be summarized to about three to five minutes. Written testimonies shall be submitted to the committee. Please provide our legislative staff with your written testimony for photocopying. Testimony shall be confined to the substance at hand. Persons will be allowed to present oral testimony only once. Once you are done, you may be asked to remain in the room for questions or for additional testimony as may be desired by the members of the panel here. When you speak, please make sure that the microphone is on, there's that button to push; and, that you speak into the microphone....microphone and please state your name for the record, and then you may begin. We are also joined by the vice chair of my committee; as this is Speaker Tina Muña Barnes, so we're also very pleased to have her here this morning.

We will now begin to hear testimonies on the confirmation hearing of Miss Ina V. Carillo to serve as station manager for the Guam Educational Telecommunications Corporation dba KGTF/PBS (Guam). So...looking at the sign-up sheet, I think we can all fit at one table, if everybody is fine with that...for those that are coming to provide oral testimony; and, I think most people are here providing written and oral testimony. So, if I can have Joey San Nicolas, Miss Ina Carillo, Don Brooks, John Ryan, and Leanna Hernandez. I believe and then we have others that will be testifying will be calling on them later, to come up later. So, let's go ahead and begin with Mr. Joey San Nicolas. JOEY SAN NICOLAS: Thank you, hafa adai, Good morning, Senator Kelly Marsh Taitano, Senator Terlaje, and Speaker Muña Barnes. It's always a pleasure to be here before you my name is Joey San Nicolas. I'm a firefighter and a soldier. Most importantly, I'm a very good friend of our Governor's appointee, Miss Ina Carillo. I have known Miss Ina Carillo for over 25 years and I take great pride in highly recommending her for confirmation to serve as a station manager for the Guam Educational Telecommunications Corporation. I can personally attest to her tenacity, entrepreneurship, commitment to success, and passion to contribute to our island of Guam.

Ina was at the forefront of the cultural renaissance as a member of the *Taotao Tano* Cultural Group and *Pa'a Taotao Tano* Board contributing to the practice and preservation of our language and culture. She possesses over 20 years of experience working from the ground up in the communications field. Excelling quickly to management positions where she led several community efforts in print and broadcast media such as Nickelodeon's Kids 4 Kids Carnival, charity events advertising and promotions. But, what I believe is her biggest accomplishment, thus far, is her success as a small business owner. Miss Carillo is...is an example to all of us. She chased the American dream turned an idea...an idea into a reality and is now leading her own organization that contributes to the quality of life for our community. It's created jobs for our citizens and that adds to the health of our economy.

I believe Ina, has once again showing her genuine care and passion for Island by taking on the challenge of government service of which I know well. She is the right fit to lead the mission of PBS (Guam), to deliver quality educational and cultural programming which will not only entertain but offer important information about the world around us. This requires an honest professional and open leader who can build relationships in the community. Miss Ina Carillo meets and exceeds these qualities. She is a dynamic and inclusive leader determined with a strong work ethic and passionate to serve. She is a great mother and values the family and what she cooks for our pot-lucks is okay and her sense of humor is great.

Miss Ina Carillo is the best candidate for the station manager of the Guam Educational Telecommunications Corporation or KGTF/PBS (Guam), and humbly deserves your confirmation. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse' for your testimony. I will go ahead and save Miss Carillo for the last we'll go ahead and hear from Don Brooks next.

DONOVAN BROOKS: Good morning, Senator, Marsh (Taitano), Senator Terlaje, Speaker Muña Barnes, my name is Donovan Brooks. I'm the present chairman of the board of the PBS (Guam) Corporation.... And, I'm very happy to be here this morning and supportive in Miss Carillo.

I've had the privilege of serving with PBS under three administrations under Felix Camacho; under Eddie Calvo; and, now under Governor Leon Guerrero. And, I have seen general managers come and go. All too frequently I might add.

In Miss Carillo, I see a light on the horizon. I see, hope for our station over the 10....10 years that I've been on and off part of the station. It has faltered continuously because it just hasn't had the right person in the....in the driver's seat for the appropriate amount of time, a lengthy period of time and....and because of that, the station has suffered. So, I'm hoping that with Ina, has leadership and I have seen in the short time that she has been in the chair....leadership. And, I'm...I'm enthusiastic. I'm hopeful and I hope you will support her confirmation. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse', for your testimony as well. So, we're off to a very good start with two powerful testimonies and I would like to call on John Ryan next.

JOHN RYAN: Thank you and good morning. My name is John Ryan and I'm here to testify in support of the nomination of Ina Carillo as general manager of KGTF/PBS (Guam). My experience in broadcasting includes content creation and production in news and entertainment and management positions in local and national-international media organization....since the early 1980s. Much of that time is spent....spent here in Guam. I've also co-founded and managed a video production company and other businesses and have worked as a media public relationspublic policy, business development, and crisis communications consultant in both the public and private sectors and from 1999 to 2003. I was the communications director for Governor Carl TC Guiterrez.

Throughout my career. I've had the opportunity to supervise and be supervised both professionally and in volunteer causes...by many very talented people. That list of talented people absolutely includes Ina Carillo.

Ina's media in business background speak for themselves and clearly it is why our governor has nominated her as general manager of KGTF. I believe Ina possesses all the skills necessary to lead KGTF/PBS (Guam), today, and position it for growth and sustainability for years to come Ina has strong media credentials her experience as a sales representative and marketing executive across multiple media platforms will be a tremendous asset to Guam's public TV station particularly in four areas that are crucial to the success of all public broadcasting stations. Those are fundraising, volunteer participation, content development, and attracting viewers.

Because the Corporation for Public Broadcasting was created by Congress and is the effective parent Organization for PBS and NPR, many people mistakenly think that local PBS stations like KGTF are just another government agency that receives a great largess from Washington. That's

not the case, as I know you folks on the Dyess, there, are well aware funding flows to local PBS stations via grant and funding formulas that take into account the many different factors....not handouts. Ina understands this. Her experience in the business world makes her uniquely qualified to help KGTF become more competitive and successful and the competition for PBS grants sought by 1500 locally owned public TV and radio stations across the country.

Ina has great people skills as the founder of her own non-media business. She knows firsthand the importance of gaining, by in-among all members of her team, and, in this case from board chair, to janitor at Adelup to this very building and community wide.

Ina is a roll up your sleeves leader who leads through sweat equity and by example, she encourages and inspires those around her to be their very best. KGTF needs this can-do type of leader to strengthen its volunteer base.

Ina understands the relationship between quality, relevant, content programming, content in programming, and its relationship to attracting grant funding donors and sponsors. Her experience in the business world will be a huge plus to improve and sustain KGTF's financial footing. She embodies the spirit and historical can-do it-evenness of the govGuam workforce. She understands what it means to be a public servant. I have every confidence that over the next few years the example she sets it KGTF will gain notice. Well beyond the confines of 194 Sesame Street in Mangilao. Ina's ability to forge partnerships professionally and in the community, on island and off, will be an integral part of the success as general manager at KGTF. At one time or another in each of the past four decades, I have worked in commercial broadcasting. The changes, I have witnessed to that industry during the time have convinced me that at this time in history, public broadcast stations are more important and more valuable an asset to community such as ours, than ever before. And, I believe now more than ever Guam's only public TV station needs the leadership talent and dedication that I know I know Ina, will bring as general manager. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse' for that. We also have Miss Lorainne Hernandez. If you could provide testimony...of, there we go. Oh, sorry Lorainne, sorry and then....I can address here. If they have some questions for the panel before they leave, and I do also just want to point out that Mr. Clifford, the red dog, is at the table as well. So, it's very good to see his support as well.

LORRAINE HERNANDEZ: Buenas yan hafa adai, madam chairman, Speaker Barnes, Senator Terlaje. My name is Lorraine Hernandez. I've been working with PBS (Guam), KGTF for over 37 years. I am here to testify in favor of Miss Ina Carillo as general manager of PBS (Guam), KGTF. For the last three months of Miss Carillo's acting capacity, for this reason, I am in favor of Miss Ina's Carillo to be confirmed as general manager position, as PBS/KGTF manager. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'ase' again. So, if I could have the vice Speaker, excuse me, the Speaker, my vice chair if you have some questions or comments.

SPEAKER TINA MUÑA BARNES, VICE CHAIR: Mana'na Si Yu'os, thank you very much Madam chair. No specific questions. I just want to take the opportunity to thank the board members and those working with PBS to....for coming out this morning. Mr. John more importantly Donovan and Lorraine 37 years...you really do have a lot of institutional knowledge as it relates to...to all the directors that have been or general managers that have been at your station and you being here this morning. I really bring some positive support for a lady that we've known for many years and I just want to say thank you to all of you guys because it is that collaboration and it is that coming together that will help PBS be what it has always been for our children. The best broadcasting system for our children, and I just want to say thank you. Thank you, madam-chair and thank you for all of you being here this morning.....no questions.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse' for that. Hi, so we do have one more member at the table and I want to give you an opportunity to testify and then....yes, so Miss Bertha Kalimba, and then I'll turn it over to Senator Terlaje to continue with your questions and comments.

BERTHA GALIMBA: Yes, good morning Senators. I have Clifford with me here today. Say hi Clifford. So, I have had the pleasure of working with Ina Carillo. Her professionalism and dedication are the highest.....are of the highest order. She is Dependable reliable hard-working conscientious...ahh, conscientious and honest. I'm nervous. So, she has been on board as PBS general manager. She has attempted the following.

She has identified a grant to broadcast level production equipment today. We are currently awaiting on the results of this grant. Through her leadership and guidance our station was able to raise \$11,000 during our pledge drive all in one night in which was never done before amazing.

I know Carillo has proven herself to be an exceptional leader and a cooperative team player. Her positive disposition makes it easy for others to get along with and follow her lead. She knows how to empower her employees to get to their best performance overall. Ina Carillo has been integral to the many success of PBS (Guam) with such a short amount of time. She is described by many as hard-working dedicated, giving, kind, caring, nurturing, and dependable.

Her love for the station is awe-inspiring and her initiative in taking on various responsibilities and roles to help improve the station is admirable. She is definitely an asset to the station. I have no doubt that she will have a direct positive impact on our community. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse'. So, I'd now like to recognize Senator Terlaje and see if she has questions or comments.

SENATOR THERESE M. TERLAJE: For the panel members, just thank you for your testimony. It's a...it's helpful to hear different perspectives for example, her contributions to the community, for a long, for throughout her life. I appreciate that and...and her professionalism, and in her work experience in the past. And, in as to the impression that she has made at PBS, and the short time that she's been there three months. I appreciate that very much and especially from long-term employees. *Si Yu'os Ma'âse'* and Clifford the big red dog, hi, thanks for being here. We'll take that as a support right, thumbs up. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Yes, I want to say also the testimony has been so comprehensive that really I'm just left as...as my colleagues are to comment at this point; and, there's so many wonderful important things that you guys have brought out; the experience....that the dedication, the kindness, the nurturing, just the capabilities in so many areas; and, so it is....it's very important to hear about all of those; and, coming from such a body as yourself. People that have been there, as Mr. Brooks has, through three Administrations. And then, as Miss Hernandez for 37 years, I mean, these are amazing testimonies to be hearing from, because you really have that experience to be able to comment on; and assess, her performance over the last three months. And.....the same for Mr. John Ryan. You're being part of the industry for so long and being able to comment as you have, are really important. And, the same with Mr. San Nicolas as having known Miss Ina for so long....25 years. Certainly, you're very important in being able to testify to her character and I must say, it's no small thing on Guam to be able to contribute well to a potluck. So, it's good to hear that. There's that aspect as well.

So, I thank you very much for your testimony...was very thoughtful. You definitely took the time to really think through what we needed to hear and what we needed to be reassured by; and, the ways that you have that experience to be able to give this quality assessment. So, thank you very much. You can go ahead and sit and be part of the rest of the public hearing we might keep Mr. Clifford the red dog, if he's willing to stay. We'll keep Miss Ina Carillo and then I'll call up if Mr. Carlos Pangilinan wanted to come and provide testimony. Yeah, so, thank you again very much.

And, then I have a couple people here for support if they desire to give testimony as well. I have Mr. Don Muña and Mr. John Leon Guerrero. So, if you're here to provide testimony, please come to the table. If not, we've acknowledged your support and we're very appreciative for your attendance in your support. So, let's go ahead and start then with Mr. Pangelinan.

CARLOS PANGELINAN: Senator Taitano, oh Speaker, Senator Terlaje, I didn't know about the hearing until last night and I didn't really plan on being here. But, just to kind of show you how important this is to me, I called my boss right away. And I said, you know what? I really need to go down to a hearing and testify on something. It's an appointment to the PBS woman, you know, I

had to get permission and I went out of my way, signed leaving everything. That's how important it was for me. A lot of good things have already been said about Miss Carillo. A lot about her professionalism her character and so forth. I don't know if there's a very much more I could say except that perhaps on a personal level, on a personal note what I do know about Ina, is that she has a remarkable way of overcoming adversity and really turning things around and really building things. And, if you really think about PBS, and it was a very interesting what the chairman was saying about how things sometimes flounder, you go through different directors and managers, to me. PBS is probably a really-good opportunity for Ina because it's the kind of organization that you can look at. You could see what talents there are, what meager resources there are, and really build it up. And, if there's anything that Ina has demonstrated in the past. Is...is that she really knows how to build things up. And, I think that...that just makes the job perfect for her, perfect for that job. So yeah, that I don't have much more to say...but a thank you and please support her confirmation.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse', being able to hear from such a breadth of the community, and, to have so many people come out. It really sends a lot of strong messages for us to be considering. So again, I'll see if the Speaker has any further comments or Senator Terlaje. So, thank you very much. We'll now hear from Miss Ida Carillo.

INA V. CARILLO - GOVERNOR'S NOMINEE: Good morning. It's really hard to speak after all of that. Good morning honorable chairman...charwoman. Dr. Kelly Marsh Taitano, Speaker Tina Muña Barnes and honorable Senator Therese Terlaja. Thank you to all my friends and family who have gathered here to support my nomination today. My name is Ina Villanueva Carillo, and, I come before you to seek confirmation for the position of station manager at the Guam Educational Telecommunication Corporation. Also known as PBS (Guam)/KGTF Channel 12.

I'm married. I'm a mother of three boys. Twenty (20) year old, 17 year old, and an 11 year old. They are....they're my life...and the reason I've worked so hard to be as successful as I am. I graduated high school with the full college scholarship. But let that opportunity slip away when I got pregnant with my oldest son Leon. I was devastated but I had to accept the consequences and begin my career here on Guam to support my son as a young mother in sales Guam Cell Communication. I quickly found a passion for marketing. I then moved into media sales at Hit Radio 100, where I eventually learn...earned my way up to senior accounts.

It was around then when I decided I needed to diversify. I started working in business development at Graphics Center, Inc., and developed a line called Milestone Specifics. I was offered a position as a sales director of GQ Magazine and at the same time I started my Consulting work as a political media strategist.

I was asked to work alongside with our new Lieutenant Governor Josh Tenorio in the Obama for Guam campaign as the media buyer in 2008, because of my work with the Obama for Guam campaign. I have also worked with numerous senatorial and gubernatorial campaigns since then. Too many to count not long after that. I started my career at Marianas Cablevision there I handled Network programming sales and marketing and managed MTV's nonprofit arm MCB Cable Cares. I was tasked with keeping subscriber Costello and keeping programming at the highest quality while in charge of that department my team. And, I initially initiated TV Everywhere that allowed subscribers to view their cable channels online anywhere in the world with an internet connection.

We also produced events and supported the community and raise funds for the Guam Police Department and children's organizations. Throughout my professional career. I have been a problem solver and tried to work collaboratively with my team. I have never led by delegation. I consider myself a team player that looks for the best idea regardless of where the origin is and tries to address the problems that arise in production in the production of event or implementation of a new policy. I have been blessed in my professional capacity to have had some very influential business leaders mentor me.

In the process of leading others and finding solutions for problems. I've worked closely with great men like Jay Shed, Ernie Gallito, Lieutenant Governor, Joshua Tenorio and Tomas Higa. These men have shaped my business acumen and helped me to be able to step into a new project, assess its obstacles, and work with my colleagues to determine the best direction to move forward. These men and others that I work with have given me the confidence to step out on my own and open my own business, which has been my toughest journey yet.

I started out my business at home in 2013 and two years later, I announced to my husband that I was leaving my well-paying corporate job and opened the brick and mortar storefront later that year. I expanded. I opened my second store and I haven't looked back. I currently employ seven wonderful employees and together we do our best to make our island's women feel beautiful on the most important days of their lives; like proms, banquets, and Galas....and most especially their wedding days. I tell you about my experience today. Not to speak highly of myself but, so you can see the character and the amount of energy I apply to be successful. I work hard at everything I do, and I always give it my all. Some people call me stubborn. But in my opinion, I'm driven...driven by the fear of letting my children down, driven by the wants to make things better, and driven by the desire to give back to an island that has given so freely of herself to me.

After being honored with my appointment by our first female Governor Lou Leon Guerrero, I met with the staff at PBS and together, we got to work. We had to determine the obstacles that were holding the station back and what we could do to advance our station into the new millennium. What I learned was the biggest obstacle of PBS, that PBS faces, was its ability to pay for PBS, the PBS program licensing, as I thought finances were the root of their problem.

Each department was each of each department has established new goals and objectives including the creation of new signature fundraising events restoring and renewing initiative inactive accounts and implementing modern fundraising activities. We will be reinstating our recurring membership program and to begin developing local quality local and diverse programming. We will also continue to host a support and support meaningful community outreach programs. While PBS (Guam) has a fantastic staff of professionals that love their job and are determined to meet its mission, PBS has been making it work, with minimal resources and antiquated equipment. Our building has sufficient space but really needs....desperately needs an update.

Putting that aside, exciting things are on the horizon at PBS with renewed vigor and support from our sister agencies. PBS has increased its production sales in the little time that I've been there. We've also been able to hire one of the most premier film makers in the Micronesian area. Don Munoz, Muña brothers, recently joined our team as our executive producer. We recently had our 'Fall in Love' with PBS (Guam) annual Telethon pledge Drive where we were thanks to generous donations from many of you. We were able to raise over \$10,000 which was the biggest overall television telethon fundraiser in PBS history. PBS (Guam) is currently wrapping up our annual read-a-thon fundraiser with the Guam Department of Education. PBS (Guam) works with our island schools to encourage literacy amongst children. And, with this program, we're on track to raise 15 another \$15,000. We have applied for a technical assistance program Grant with the Department of Interior. This grant is designed to promote education in the Insular areas and we're intended to do and we intend to create high-quality programming and support local producers and groups like NIHI and other cultural practitioners. We will be producing live sports and have entered into agreement with the University of Guam to broadcast their sporting events live starting in October and look forward to partnering with other sports leagues like the double I, double AG, to do the same. We will be broadcasting the State of the Island Address tonight.

We will also be the official broadcaster of the Liberation Day parade and we want to.....we want to begin talks with Department of Education to invite middle school and high school students to produce their own quarterly magazines and activities that are going on in their school. This is a version of the Hiki-No Program currently instituted by PBS, the PBS Hawaii group. We will be working alongside with them to develop and incorporate their program here on Guam and it's basically all produced by the students with some creative oversight from our producer Mr. Muña.

In order to achieve these goals, we desperately need to upgrade our equipment. We still use tube TVs to monitor programming. Our cameras are old....are out...and outdated and most production equipment that we have at the station are over 20 years old. Our on-the-go broadcast van was acquired in the 1990s. Its outdated and our studio needs an overhaul with many of these challenges. There are many of these challenges but we are working collaboratively with our team to find a way forward. PBS (Guam) has come a long way from its humble beginnings in 1970, and I'm proud to work with these young.....with these men and women behind me who continued the tradition of providing our viewers with outstanding television educational outreach services and events. The challenges we have are many. The resolve the employees have is great, and in my

mind with the proper amount of will anything can be achieved. It's been an honor to sit before you and speak about myself about my mission as station manager here at PBS and I ask for your vote of confidence regarding my confirmation and I'm open to answer any questions you have for me. Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse', I'll go ahead and save my comments and questions for the...the end, but we'll start with those....Speaker Muña Barnes.

SPEAKER TINA MUÑA BARNES, VICE CHAIR: Si Yu'os Ma'ase' Madam Chair...and thank you for giving me the opportunity to comment to Miss Ina Carillo and thank her husband who's here in the audience...Chris and her three boys. Thank you so much for being here for Mom. I do want to say, before, I say my comment that there was somebody who looks exactly like me who called me up this morning in a panic saying; I'm, I was headed to go to Ina's confirmation hearing Tina, but please Speaker...can you please tell Ina that I got diverted by Derek to go to work because to cover and she just wanted to show her support. So...auntie Donna sends her love, her support to you and says that, continue to do the good work that you're doing. Madam Chair, I do want to acknowledge that I've known Ina since....since ever since....we can say but more importantly is his/her. You heard it from a lot of the members in the community who talked about her hard work, her willingness to bring people together, her not being afraid to step up to the plate, her nurturing....for me personally, it's having been worked closely with her for more than three or four terms in my seven terms as being a senator. I...I just want to say that she has a very special calm in her and...and being able to bring people together no matter how difficult the...the challenges or what comes to her, in front of her that she's ready to roll up her sleeves; and, work and when I see folks like Donovan and Lorraine and just the team of KGTF back there.....I just want to say thank you. I had the opportunity Madam Chair to be at the...the Telethon that happened; and, you were a part of that, helping out. And, I just want to...bringing the community back in....bringing leadership back into the station to help out. That literally meant a lot because the compliments that came from remembering that KGTF has been here for many..many decades. I want to see what 49 years.. 39, 49 years right? Almost! I just want to say that that bringing some fresh new ideas perspective bringing in a renowned executive producer, but also acknowledging the fact that the staff is excellent. I want to say thank you more importantly just within the last couple of weeks, you have...you even see a bigger picture and stepping up to the plate. To, may be accepting the challenge of something that I've been working on for....I want to say, since I started the legislature in the 27th Guam legislature instead...that's the film office...when legislation was created. It was to literally promote Guam to the rest of the world. Possibly bringing in industry of over 22 million dollars here. It was supposed to be seated at the Guam Economic Development Authority and with the cooperation of them. And now you stepping up to the plate, we see that opportunity further going into seeing its full fruition and literally giving world renowned companies, movie companies, who are coming here to just asking where to go, what to do, how to do it, and even sharing with us. That if there's one thing that Guam is missing, is a film office of film industry and...and I just want to say thank you for that. You see the bigger picture. You see where the opportunities are. With your expertise, with your marketing

background, but also starting a lot of programs on your own. Even your business. I want to say this is not going to be easy, but you stepped up to that. And you have, my full one hundred percent support and my...my twin sister auntie Donna said, that that she's there for you. Maybe not today....in spirit, but will always be there to support you. Madam Chair, I want you to know that...I hope her packet can be expedited for our April session, so that she can get confirmed. Saina Maase.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: Si Yu'os Ma'åse' for that...and next, we'll hear from Senator Terlaje.

SENATOR THERESE M. TERLAJE: Good morning Ina. Thank you for your testimony and your willingness to accept this task. It's a, I appreciate that from the testimony of those before you and from your own testimony that you have an ability to assess obstacles. You got the tenacity to deal with...probably what you're going to find to be little resources, available to PBS at the moment, but it looks like you're on your way to finding more of those. Your resourcefulness and your willingness to give back and empower the employees. I think that's also very important. And so, I don't...I don't have any questions as to your capabilities, but I, if you don't mind I would just like to ask you some questions while you're here regarding your...your plans for PBS and, so.

First of all, I just wanted to find out. You talk about developing quality local and diverse programming and then creating high-quality programming and supporting local producers and groups like Nihi and other cultural practitioners. So I want to know, how much discretion does PBS have and how much like available time. So, I know you run some other shows from the network, but so how much time is available for local programming and what kind of parameters do you have for that...the overall?

INA V. CARILLO - GOVERNOR'S NOMINEE: Thank you for your question Senator. At the overall goal for PBS is to increase local programming. When I came aboard in January, we didn't have any local programming. So, the way that PBS national licensing, our licensing membership fee works...is it depends on what sort of content that you're running? And right now, we're taking the full line of PBS programming, so we're running programming from the moment we sign on, to the moment we sign off. My goal, eventually, is to create more local programming that will allow for at least thirty percent of total time with PBS. And what a lot of people don't know is we actually have two channels. We have 12.1 and 12.2. So, we can actually...we can fill a lot more local programming. It's just a matter of creating the content. But we do have plans to fill that. We're about to start...we're about to start renovations on our studio. And once we complete that, we'll have a pretty much state of the art studio that will be able to produce all kinds of content and looking toward the Guam film office, we'll have, we'll be able to, we'll be able to assist with even off-island producers for anything they'd like to produce. But anyway, we have two shows in the works as soon as that's done and then we also plan to do, like I mentioned in my in

my testimony, local sports as well as....so, we eventually, the end goal is to meet that thirty percent local programming and then 70% National PBS programming.

SENATOR THERESE M. TERLAJE: Okay. What about....are the, when you partner with UOG, for example for the live sporting broadcasts, do they contribute to PBS?

INA V. CARILLO - GOVERNOR'S NOMINEE: We have an agreement with GTA....I mean with the UOG right now, currently. So, it's a little bit of a barter and they are making a little bit of a donation as well. We recognize that the University of Guam currently, this...isn't in a position to pay for full production of local sports. So, we look to underwrite that with privates...private parts...private partnerships. So the University of Guam is paying for a portion of it there. Also, we haven't...we have another fundraising activity happening in June. It's our PBS kids carnival, where we're going to be doing like a live. If you can imagine Sesame Street Live Carnival show and so UOG will be the venue. And, so we bartered a little bit for the field house as well as having them make a small donation to PBS. And in turn, we're working together.

SENATOR THERESE M. TERLAJE: Okay, that sounds great even resourceful. Yes, the technical assistance program grant with the Department of Interior....is this new or is this something PBS has always tried to go after.

INA V. CARILLO - GOVERNOR'S NOMINEE: From what I know of, PBS has not applied for any additional grants besides our CPV grant in maybe a decade....and a long time. So one of my first, my, one of the first things that I did coming into PBS was like scrub and look for any sort of grants that we could do after I assess the station and the major problem with PBS was everything in the...I mean all the equipment they've acquired is just...it's just....it's out of date. There's no technical support any more, like it's just out of date 20 years and older, I think. And so, we really needed to upgrade all of our equipment. I think the figure if we were looking at is 1.3 million dollars to do that and I knew that after speaking with Dr. Marsh Taitano, that, probably the governor of Guam could not pay for that. So, you know, we looked for Grants and I found this this technical assistance grant and so I went straight up to the lieutenant governor's office and talk to the grant Clearinghouse and I just wouldn't stop bothering them until we figured out how we could apply for this grant and I think that was sometime in February. The grant application was due March 1st. And so, we just hustled and did what we had to do and we made it and we made it in time and applied for the grant and we have good chances of getting it through 500,000.

SENATOR THERESE M. TERLAJE: Congratulations. That's that's good work. Thank you to all of you for on that. That's really good work. I'm looking forward to the local programming for sure. I've heard a lot of agencies say oh, yeah, we want to partner with PBS also. So, I expect that you're going to have a high demand actually for local programming and your board is going to be challenged with how do you prioritize what...you know...which ones are we going to come first? How are you going to partner, just kind of, community programming versus sponsorships. Right?

If it depends on sponsorships and it's going to be led by....by businesses and versus....but I think you have to balance that. Right? With what....what's good for the community, what the community needs what's lacking? Especially, I know even the *Kumision gi Fino CHamoru*, they have plans for PBS and the Decolonization Commission has plans with PBS. They're hoping to partner and I also just my, you know, I go to things like...I went to a *Mes CHamoru* event at I think it was J.Q San Miguel.

One of the best things I saw was this skit that the fifth graders performed. This was last year and I love that skit and I want to put that skit on the TV and I want everybody to see it and...and then I went to an event where UOG, they were, you know, introducing a book by Fred Quinene, the poet, but he was performing his poetry at this event. And his performance of it was to me so remarkable, and I want that to be also saved forever. So, I'm hoping that PBS can help do things like that because yeah, lots of potential. I you've hired great people. I don't know how you did that, but congratulations. I like to thank you. So, thank you again for all your good work so far and your...your willingness to continue and give back to the community. I said, I appreciate that. Thank you.

INA V. CARILLO - GOVERNOR'S NOMINEE: Thank you.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: I've had the pleasure of being able to meet with you a couple of times. You kindly gave me a tour of the station and one of the things that I noted is...one of the first things that you pointed out...were the people that are there at PBS. How wonderful they are as staff. How dedicated they are. How most of them have been there for over 20 years not counting the new hires and that actually, the Newbie on the Block had been there for eight or ten years, which really says something about PBS. The value it has for our community, the dedication of the people that are there, to serve us. So, we really appreciate...but then also in your leadership taking time to acknowledge and really appreciate that in them, and, in what you have to work with. So to me, that said a lot and in hearing from everybody, but also in being able to see you in action in. From our meetings, I know that you've been very active. And, that is very good for all of us, I believe so, I'm very pleased with that. And, I think what I'll do...I had a few questions but we've covered things pretty comprehensively, in a lot of ways. I think, I do provide my support along with the others who have been here, and, the Senators who were up here and so we're hoping for a successful nomination. And along with that, with, if the nomination is successful, then we will work together to develop an informational hearing and then some of the questions that I have, about allowing you to provide explanation for our community....to help them understand how PBS serves the community; and, how it is different than some of the other stations that we have here because it is a non-profit. And so, it has different mission and it serves the community in different ways. Although of course, they all serve the community, but we'll save some of that for them. So, I guess one of the things that I'm really looking forward to in all of your vision is I think so many of us if not all of us grew up with PBS. I still remember the Electric Company. We don't hear about it as much as the Sesame Street anymore, but I really was a fan of the Electric Company as well. And so, I think so many of us are just looking forward to having that local programming and to having PBS just continue to be such an important part of our lives, but certainly our children and our grandchildren's lives. I have grandchildren here and I really want them to be raised by some of the programming that PBS offers. And, to be able to be kept a better abreast of what's going on in the community and being served there. I think one of the other agreements that you've been working with is with NIHI and so I know that that serves our youth very well, so I look forward to that kind of programming. But with that, is there anybody else here who wanted to provide testimony before I close? Okay, there being none. The Committee will conclude the public hearing for the confirmation hearing of Miss Ina V. Carillo to serve as station manager for the Guam Educational Telecommunications Corporation, which does business as KGTF/PBS (Guam). So, Si Yu'os Ma'ase everybody who was here...in support of Miss Carillo, and we will then be moving on to our next, I'd like to say exciting. I like all of the things that we're doing today. The next activity that we're participating in; and, that's going to be the appointment of one of the commission members, so we'll be getting to that. So again, thank you, Miss Carillo.

III. FINDINGS & RECOMMENDATIONS
