



I attended PC Lujan Elementary, St. Anthony Catholic School and I graduated from Notre Dame High School in 1993. I earned my bachelor's degree from Loyola Marymount University in Los Angeles. Upon graduating from Loyola Law in 2000, as Mike said, I returned to Guam and started my legal career at the law firm now known as

Calvo Fisher and Jacob. I'm married to Omar Damian and my parents-in-law Charlie and Doreen Damian. Omar and I have three daughters - Kaia, who will be starting her junior year at ND, Kalle who just graduated from St. Anthony and will be joining Kaia at ND and my youngest is Kamia, who will be starting 4th grade in August.

As you can see, I am working, and I did not accept the Governor's appointment to the board hastily. I knew that if I accepted the appointment, I must be willing to commit my time to perform the duties of a board member. I would like to assure you that I am fully committed and eager to begin working with the other board members should this body confirm my appointments. When I mentioned to family or friends that I have been appointed to the Board of Equalization, their first question is usually what does that board do? Not many people are aware of the Board of Equalization and the important work it does. Early in my career I worked on a case brought by Governor Felix Camacho seeking the Guam Supreme Court's interpretation of the debt limitation provision in the Organic Act. During my work on that case I developed a better understanding of real property tax assessments and the role of the Board of Equalization in that process. I learned that the board has two major responsibilities: to ensure that the real property tax roll is available for public inspection every year and to review taxpayer applications for adjustments to their property tax assessments. I tend to approach my work with the board the same way I approach my legal work, diligently, ethically and deliberatively. I will put in the time and effort to get the job done efficiently and expeditiously. I will always be mindful of my ethical obligations as a lawyer and as a public servant and I will be guided by applicable laws and regulations when considering matters that come before the board.

My practice over the last twenty years has focused mainly on transactional and government work. I have assisted private clients with corporate governance issues, acquisitions and real estate transactions. I have assisted government clients with local and federal regulatory compliance matters, procurement issues and bond financings. I believe that my work with both private and government clients provides me with a unique background that will allow me to contribute in a meaningful and substantive way to the board. I would like to end by thanking Governor Leon Guerrero and Lieutenant Governor Tenorio for putting their trust in me to serve on the Guam Board of Equalization. Thank you again for allowing me to provide this testimony and I asked for your support of my appointment, so I may have the opportunity to provide this important public service. thank you.

Chairperson Perez: Thank you so much Ms. Damian and thank you for accepting this nomination amidst your busy lifestyle. Just a couple questions regarding serving. I know that you were committed to being at the meetings and being at any hearing possibly, considering your family, you have your family to attend to, as well as your professional life. Just one thing, a question that's always asked, is do you have any conflict of interest and how do you determine whether a conflict of interest exists?

Mrs. Damian: Thank you, Madam Chair for that question. So, when I did first get appointed, internally within our law firm, I did run a conflict's check just to make sure that we don't have any pending matters before the Board of Equalization, that I would need to disclose or request and that came out clear. I think that the board, the conflict issues would arise with board members when we review applications and as I do with my legal work whenever I get a new assignment, the first

thing we do is assess whether a conflict exists, look at the conflict rules and I would do the same thing here. There are rules governing board members on when situations require their recusal. So, I will look at those rules and I would assess whether a particular matter requires my recusal, whether it be because the applicant is a client or a family member then at that point now, I would recuse myself.

Chairperson Perez: Okay great. I think that's all my questions. I would like to yield to my colleagues for any questions. Senator Shelton, do you have any questions for the nominee?

Senator Shelton: Thank you very much, Madam Chair. You asked one of my questions as well and I was glad Mrs. Damian that you addressed the issue about time and the commitment to the board, knowing that it will be time-consuming and a very important role you will play. I'm glad to hear that your commitment and dedication, that you're pledging here today. I'm thankful that you have answered this call to service and obviously you're very qualified and seem experienced with the board and the role of the board. I look forward to your service up on the board. Si Yu'os ma'åse', thank you.

Chairperson Perez: Thank you, Senator Shelton. Senator Kelly Marsh (Taitano)?

Senator Marsh (Taitano): *Si Yu'os ma'åse'* Madam Chair. Yes, so it was very good to hear the testimony of the Chair and colleague and of course they both said the highest of comments, which is very reassuring. It's very important to us to be able to hear about the integrity, the dedication, the experience and then from the candidate herself it was important testimony to hear. We appreciate that very much and as has been mentioned, it's important to hear that you've taken that time to assess the time commitments and some of the other commitments that are involved or some of the other possible conflicts of interest that might be involved in. Everything that I've heard thus far is very reassuring. It's exactly the type of information that we're looking for and with all of that, I along with the others, thank you for accepting the nomination. I think we're very fortunate that it has worked out that you will be able to have the time commitments are expected. So again, I thank you for accepting the nomination and I look forward to your nomination going through.

Mrs. Damian: Thank you Senator.

Chairperson Perez: All right, thank you Senator Marsh. Senator Telo Taitague?

Senator Taitague: *Si Yu'os ma'åse'* Madam Chair and hi Janalynn. I'm so, I'm happy to see you. When I heard it was your name, as you know I know your family very well, your husband's side of the family. I'm related, so for the record and of course you know there's no doubt in my mind that you can do an excellent job at this board. Having 'Cube and Michael here, I, I have total respect for these two individuals and when they gave their endorsement to be here today on your behalf, I knew for sure that my yes vote for you is true to form. If there's anything you know, again thank you for stepping up. I know you're very busy but like I said I know your family and the most important thing is having that family support to allow you to serve the people of Guam and I know

you have that behind you because you have a lot on your plate. It's good to have family support. I wish you the very best and once again, thank you so much for stepping up to the plate and if there's anything at all I could do to help you. I know that you guys do some, not conflicts, but appeals, certain appeals or even things to help the board out in any way that we can, my door is always open. Funding it always something boards usually need, so my doors open to you and good luck to you, you have my vote.

Mrs. Damian: Thank you Senator.

Chairperson Perez: Thank you, Senator Taitague. Senator Torres?

Senator Torres: Thank you Madam Chair. I just want to express my appreciation to you Janalynn for accepting this nomination and also for expressing your knowledge of the importance of this board. I think that is the best foundation but over the years you certainly have gained my respect and admiration. Not only as a member of the Guam Bar all these years but also in my experience working with you when you were Legal Counsel to the airport, and I was the Executive Manager. You certainly are very well qualified and we're very fortunate that you've accepted this nomination. You have my full support.

Mrs. Damian: Thank you Senator.

Chairperson Perez: Thank you Senator Torres. So, I think that concludes the questions from my colleagues and also as well as any testimony. So again, I would like to thank you Ms. Damian for accepting this nomination. I think the board really welcomes you in this role considering, you know they need the support from somebody who has well-versed in both the public and private sector and especially when dealing with land issues. So, thank you so much and I appreciate you taking the time and especially your commitment for the next four years, I believe so.

Mrs. Damian: Thanks Madam Chair, thank you.

Chairperson Perez: Okay great, so this concludes this part of the agenda. So, if you're, feel free to leave at this point, for those that are here for Janalynn's testimony. *Si Yu'os ma'åse'* thank you.

Chairperson Perez then adjourned the confirmation hearing for Mrs. Janalynn C. Damian.
