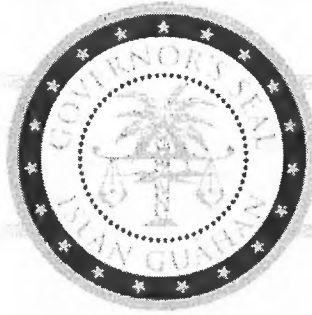



I'm not sure if he was able to stay. And then, I'm sorry that I'm struggling with reading a couple of the signatures but just showing that there is quite a bit of support here. So, I want to recognize again that we have Senator Therese Terlaje who is with us here today and Senator Telo Taitague. So, I see that we are three of the T's of the Senators. We have Terlaje, Taitano and Taitague. So, we're representing the T's very well. Okay so with that, if we can go ahead and have Mr. Joaquin Bellis provide his testimony. *Si Yu'os Ma'ãse* and *Manana Si Yu'os* this morning.

JOAQUIN BELLIS: *Hãfa adai* Senator Kelly Marsh (Taitano), and other members of the Committee. My name is Joaquin Arriola Bellis. I'm happy to be before you today as I seek your confirmation of my appointment as the youth member of the Board of Commissioners for the Department of Parks and Recreation. I want to serve on the Board of Commissioners because I would like to contribute back to my home and I believe I have a great deal to contribute to the department.

First is my work experience. I've been working since I was 14 years old. At that age, I was a busboy at a restaurant called Cajun Delight. There, I learned the importance of cleanliness and presentation. I believe that cleanliness and presentation are very important for how the department operates the 75 parks on the island.

I then worked in a maintenance division at the Guam Legislature for summer. During that time, I helped maintain and clean the old Legislature building, as well as the groundskeeping for one part of Plaza de España. In that job, I learned that the hard work it takes to maintain the government buildings and parks. I believe that my experience at the Guam Legislature helped me understand the hard work that the Department of Parks and Rec. employees put in every day.

The following summer, I worked at Cabras Marine Corporation as a tool room supply attendant and later worked full-time as a water combo apprentice. On some projects, we worked nine-hour days for most of the week; the longest lasting for more than a month. Well over a month. Here, I learned the importance of hard work and perseverance. I believe I can bring these qualities to my work as a commissioner. Now, I'm currently employed at the Bank of Guam at their human resources department specifically in the Systems Division. I am also a student at the University of Guam studying for a bachelor's in business. At the Bank of Guam, we call it "*familia*," but it could also be translated to "fellowship." This is an important part of any work environment and that's what I hope to bring to the Board of Commissioners.

In addition to my work experience, I also bring along a long family tradition of public service. My grandfather Joaquin Camacho Arriola was speaker of the 9th and 10th Guam Legislatures and my grandmother, Elizabeth Perez Arriola was a six-term Senator in the Guam Legislature. And my mother, father, aunts and uncles have all served in various capacities of public service. Based on my experience and background, I believe I could contribute greatly to the Department of Parks and Recreation and I humbly ask for your support.

If confirmed as a youth member, I would like to suggest the following improvements: prepaid passes that could be obtained online to use at museums or to rent facilities including a small service fee to use the restrooms at the parks, which would help fund the facility to help keep it clean. I would also like to see a private-public partnership for companies to adopt parks and help maintain and operate it. *Si Yu'os Ma'åse*.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: *Saina ma'åse'* for your testimony and for highlighting some of your thoughts and some of your experience. I will now go ahead and turn this over to the Senators who are with me here today. So, Senator Therese Terlaje or Senator Taitague?

SENATOR TELO TAITAGUE: Thank you Madam Chair and *håfa adai* Joaquin.

JOAQUIN BELLIS: Håfa adai.

SENATOR TELO TAITAGUE: This is a really nice write-up that you put together. It was written by yourself?

JOAQUIN BELLIS: Yes, ma'am. Thank you.

SENATOR TELO TAITAGUE: Joaquin, I particularly like the last paragraph on some ideas that you want to bring to the table and how, you know, prepaid passes online using, you know, technology to simplify and actually make things a little less expensive. So how do you feel about cameras--the use of surveillance cameras? And, if you were given that ability to purchase them, what would you do with them?

JOAQUIN BELLIS: I'd probably put them around some of the parks. I don't want to say sketchy but that are sometimes people feel unsafe and in some areas and some parks and I feel like especially in the atmosphere that Guam has been in lately with the rise in crime and you see it in the papers, I feel like I would put them all around to still help keep the parks safe.

SENATOR TELO TAITAGUE: Do you think it's a good idea to use cameras?

JOAQUIN BELLIS: I do. I think it's a good way to prevent crimes and just let those would-be perpetrators know that we're watching.

SENATOR TELO TAITAGUE: Thank you for that. And you know, Joaquin I know you're very capable of this position and I hope that I can encourage you to stay on top of the ability of using surveillance cameras, ET cameras. I know that the Parks and Rec. received a grant, from the Interior and if I'm not mistaken, it's going to take about a year before they have it up and running or at least be able to get the money. But in the meantime, there's a lot of things that you can do, you know strategic planning and also procurement process and what kind of cameras to use. I know that the Director... in fact, I was just speaking to him because they want to be able to use one of these cameras. That where GPD was able to obtain some money; just recently through a bill that was passed. And I told them, well if you need this one so desperately down at Matapang right now. Then, talk to the Chief of Police because now, he has some money and this camera, so I think, this would be a great project for you. Sorry to push this on you. I know you probably have some other ideas.

JOAQUIN BELLIS: No, I think that's a great idea.

SENATOR TELO TAITAGUE: Okay but see you're the techie guy. I mean, you're the youth. You know, you bring that technology, you know, the new guard...

JOAQUIN BELLIS: Yes.

SENATOR TELO TAITAGUE: You know, to the Board and so I'm hoping you bring that technology there because, it's very innovative, it's cost efficient and it's a route to go. So, get with the director if you can and find out about how I believe at \$170,000, I know it's not enough to cover all the parks, but that would be a great strategic plan

JOAQUIN BELLIS: Yes.

SENATOR TELO TAITAGUE:for you. And I also noticed Joaquin in your packet there's a section here. You're certified OSHA?

JOAQUIN BELLIS: Yes, ma'am for the OSHA 40. Uh, I believe in 2016 at GCC.

SENATOR TELO TAITAGUE: Well, that's tell me a little bit about OSHA.

JOAQUIN BELLIS: So, I was certified to be what's the word? Excuse me, sorry...

SENATOR TELO TAITAGUE: No, it's okay...

JOAQUIN BELLIS: ...so, I would know like the hazards of the working environment that I was in at the time so they could hold me liable to any accidents that happened on the job site.

SENATOR TELO TAITAGUE: That's great, you know, even though you're going to be the youngest member of this board, I bet you're the only one that certified in that area. So, you're going to bring; become a great asset to this board and you have my full support. Thank you for stepping up.

JOAQUIN BELLIS: Thank you Senator.

SENATOR TELO TAITAGUE: Okay.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: *Saina Ma'āse'* Senator Taitague and Senator Terlaje?

SENATOR THERESE M. TERLAJE: Thank you. Thank you, Joaquin, and hello to all the family members and friends and co-workers that are here. Speaker Arriola, *Buenas*.

Joaquin, I like your testimony also, so thank you for it and for preparing for this hearing and it seems that you're serious about this role. So, I appreciate that. I also like that you started off with this importance of cleanliness and presentation. And so of course, this is the big issue right now for the public regarding our facilities and for our tourists as well. So, everybody's been working together to try to solve this and it evolves. So, it was first that they were the restrooms

were broken. So, we got them fixed. Then it was that they were just not being cleaned regularly, so we started to have that done. But now I think vandalism has become really the biggest issue. So, they were all fixed, now they're all broken, you know, and vandalism. So, I think that discussion about security cameras and Parks and Rec. is working on a plan. So, I guess maybe you could help bring urgency to it all, right?

JOAQUIN BELLIS: Yes.

SENATOR THERESE M. TERLAJE: This is the thing with the board, so that we want especially youth members. When we put youth members on the board, we want to make sure that these boards are not operating; or, that the directors and the agency itself are just not operating in a vacuum. That they are very aware every day of what the community feels; what they need, what they want and how they feel. So, Parks and Rec., you know, it's got our regular parks, our beaches, it also has parts that are very much historic properties. Ancient parks, I mean, ancient places that we are of course trying to preserve but also to showcase. Right? What Guam really is, and so I'm hoping you also, you know, try to help them focus on that too. That these places are not just a place that's the same as every other place. It's very unique and they; some of them are you know are thousands of years old. The other thing about Parks and Rec. is the Rec. Right, the recreation?

JOAQUIN BELLIS: Yes.

SENATOR THERESE M. TERLAJE: So, yes I appreciate that you, as you know, because you are the youth member, I'm sure they're going to look to you to really be a strong voice in that. So, you're going to have to push them. Right? Were you a paddler? Were you ever a paddler?

JOAQUIN BELLIS: I was never a paddler but I like to watch paddling.

SENATOR THERESE M. TERLAJE: Okay, So, did I was never a paddler either but when I watch paddling, I always felt bad for the paddlers because particularly when they're using Matapang Beach. It seems like some of the issues go on forever and ever. For example, the flooding in the parking lot. So, there are issues that have like jurisdictions with different agencies and that's sometimes where they get stuck. Right? Because it's not all Parks and Rec's jurisdiction, some of it has to do with DPW, some of it has to do with drainage systems down there. But I think if you could just keep pursuing also those even though you run into walls, don't give up. Just keep, keep pushing it because I'm sure you've witnessed the same thing that I have in the different places that you've attended and you know, even just as a watcher that we go

periodically. But those who paddle, go every day and I can't imagine why we keep continue to let them live like that. Right?

JOAQUIN BELLIS: Yeah.

SENATOR THERESE M. TERLAJE: So, I'm hoping the bathrooms, that I guess it what we've been told that Matapang and Ypao are the number; the two most vandalized places. They're also the places with regular maintenance, you know, regular repair but almost regular vandalism. So, data is going to help you with your job, right?

JOAQUIN BELLIS: Yes.

SENATOR THERESE M. TERLAJE: Which are the most used. Why, find out the “why” so that you know, what it is that they like about this place that you can then help, you know, the other places become like that, too. I like your ideas on the bottom that you suggested some ideas. After I read them, I'm like, oh my gosh! Yes, that seems so obvious but it then reminded me of New York, and I've only been to New York once. But maybe you've traveled and you've seen these that are incorporated at other places and they make absolute sense and it seems to be very convenient for the travelers. Right?

JOAQUIN BELLIS: Yes.

SENATOR THERESE M. TERLAJE: For our visitors and one of the reasons why I won't get a swimming pool pass is, really in my mind, it's a hassle to go track it down. But it's a great idea to just get these online. As to the private-public partnership for companies to adopt a park, this is a popular idea and it's been done over the years also. And I just want to point a couple things out to you. So, for example Ypao, we've got, I think, they adopt pavilions down there. Different pavilions are adopted by different people. We've got other parts up in Dededo adopted by like Lions Clubs and things like this. But I just want you to please be careful with these parks when they adopt them, what you allow them to do because it changes sometimes the nature of the park. These some especially historic parks; parks that are historic areas or landmarks or anything. We don't want to turn them into commercial advertisement places.

So that to me; I'm sure businesses they want to get involved and they'd like some advertising done but we have to strike a balance between preserving the historic nature of a place or the recreational use of a place with what they are doing.

There's also other measures that are before the Legislature right now that you might have to weigh in on regarding, you know, regarding using our parks for commercial enterprise and so they try to sell that to us with that's how they will take care of these parks. But it seems, you

know, that we allow them to do exclusive business on the park like vendors. I'm sure you've seen it in other countries that they do this. They would have the exclusive access, as vendors to these, you know, to conduct business at these parks and in exchange, they will keep it clean. But I'm hoping that we can you know, look for a way that, first of all, we have to incorporate the current money that Parks and Rec. is going to receive from DOI. And that should make a huge change; and the other thing is like, you know, these parks, a lot of them are, if you think about the southern parks in Umatac, For example, they are part of the village right? I just think we should always incorporate, if we can, if they are village parks that the village, you know, sometimes they talk about cottage industries or just something that makes it so that as many people as possible can...can feel comfortable there. As many people as possible, if there is going to be business conducted, that perhaps you consider as many people as possible. That's just my concern. Because I hate to see a park where, you know, the people of Umatac; it's run by one company, one business company, and then you know, we just don't feel that welcome there.

JOAQUIN BELLIS: Yeah.

SENATOR THERESE M. TERLAJE: Those are just some things... but I look forward to your service. I'm glad that you've been a hard worker it seems and you're continuing to pursue your studies, so I think but please, that you know, you're serving on a board too. That's a government board. So, it sounds to me like most of the members are going to be new. This is a unique, but maybe, you're going to be the oldest member on the board when they all come on. Is that right? And you might be the first member, that I've seen. So you'd be the experienced one and you tell them what to do. No?

But that just don't let them, you know, tell you what to do because you're there for a reason. You're there for the youth perspective and don't let them because they're older or because you know, they think they have more experience in these areas. That's not what we want. We want your perspective. We want your youth perspective. We want your new perspective and we want you know, your ideas. So, every idea is good. Put it on the table and if you have questions, make sure they answer them. Don't make a decision if you're not informed. You do your work and you ask the questions. And if they try to avoid, you get back to them and you get the information before you act because you're going to be the one accountable to the public as to why you acted this certain way. Right? So, why the restrooms in Matapang continue to be vandalized? They're going to start asking you now. Not us anymore, you know, because we're going to have a board in place. But those types of things, it's a big responsibility and I thank you for stepping up to it. *Si Yu'os Ma'ãse.*

JOAQUIN BELLIS: Thank you Senator.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: *Si Yu'os Ma'ãse* Senator and so keeping along with our theme of having Senators whose last name begins with a T. We have Senator Pedro Terlaje, who has joined us. Senator, do you have any comments or questions?

SENATOR JOSE TERLAJE: For the youth, I do have a lot of comments... but let me just first, in sharing my thoughts, I want to just congratulate you for taking the challenge because I know that there is a lot of things that youth can do it in-as-far as supporting. And they mentioned the parks and everything else. So, what I want to ask is that, if you need anything from any of the Senators, come and approach us and we'll try our very best to support you in all matters concerning. You know, as supporting the programs that you have in mind and all that. So, thank you very much.

JOAQUIN BELLIS: Thank you Senator.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: *Saina ma'ãse'* Senator. So as I begin, I just want to mention that I know your parents and I know some of your other family members, I've known them for quite some years and in a variety of ways. I just want to make that clear and I want to point out as has been discussed by some of the senators already that the Parks is on its way to progress. So, it's already made a lot of great strides. It's already opened up the two pools that were closed in Dededo and Hagåtña. We have community members that are now utilizing them on a regular basis. We have a \$5.6 million grant from the Department of Interior that you will be part of overseeing as a board member; how that is implemented and making sure that it meets its timelines and its intended goals.

Some of that will involve security cameras as Senator Taitague had mentioned, amongst other things that it's going to be doing. It's going to be repairing benches and bathrooms pretty much throughout the island for quite a number of parks, as well as other work.

We have a cleaning contract. So, the Department of Parks and Rec. told me just before he left today that it will be starting tomorrow. So, I think that will be a huge relief for the community at large that we'll start seeing that be activated and that comes from a long period, I believe, I've been told that the cleaning contract had not been able to be finalized. It sat through and just had not been able to be finalized all of last year. So, the fact that we have that now in place as of tomorrow, that will be something that's really positive.

And I've been meeting with entities like GVB. So, the Adopt a Park Program, there were very good comments there previously by Senator Terlaje and part of what we want to do is strengthen that program. And so I think, again you'll be very key in some of that, being able to be part of those discussions and creating that relationship between GVB and the Department of Parks and

Rec. which is a very historic relationship. They go hand-in-hand and what they do overlaps in so many ways.

So, they've talked about or we've talked about, coming up with a Facebook page and ways of recognizing those that are adopting a park so that there's an incentive, there's appreciation for them. We've talked about volunteer programs and so forth. And as Senator Terlaje mentioned, it's so important to keep the nature of the parks in many ways intact. They're part of the village. They may have history unto themselves and we have seen some changes in some places where maybe the community members don't even feel like they should be visiting that park anymore. And so we really want to make sure that we're finding ways for them to continue using our parks and our beaches. Right now, they're a heavily used resource and we love that. It's a part of our lifestyle to spend as much time at our parks and beaches as we have.

So, with that, the next thing that I wanted to look at is just discussing as has been touched on by yourself in some of the other senators that I think that you bring a lot of positives with you. Your experience in the field of maintenance. That is a major part of what the Parks does. They have a crew that goes out there and maintains these very diligently. But they have specified that they want to bring in new employees and they're looking for those new employees to be younger, if possible, if it works out that way, because they want them to be a part of the park family for a long time. So, that again may be something that you can help them with. You've had; your family has experience with public service; with OSHA being very detail oriented and I think that will serve as well as we implement that \$5.6 million grant of capital improvement projects.

I also like the idea of prepaid passes. Perhaps having them available online. So, those kind of out-of-the-box thinking; or, thinking about how we can update and better develop some of parts of the Department of Parks and Rec. program are really important.

I just want to mention also that I think there's great opportunity. And again, I think you'll be a perfect partner for this. The War in the Pacific Park that we have here, has a lot of outreach components to it. They have a Junior Park Ranger Program. So, I think you could really be part of working with that War in the Pacific Park and seeing how you might be able to work with if there's anything that can be brought over. Or, somehow you; it could be a joint program together that could be something you could explore. I'm interested in developing a service-learning component. We have our Island youth. Every single one of them has to get 70 hours of service learning and so we can easily put together a service-learning package that is tied into the parks. I think that has a lot of value.

Then there are some plans that are underway to certain degrees and I think that you will have some very important perspectives to offer. There's a recreational water use master plan that's

supposed to be either, I believe it's just to be updated. But that there's already one in place. So, perhaps looking at that and understanding it from the youth perspective and how they're utilizing the park, the parks could come in really as an important factor. And then they're going to be updating the comprehensive outdoor recreation plan. So, again, I think there's going to be a lot of opportunity for you to be able to weigh in with your particular perspective.

The appointment is for four years. So if you'd like to address that a little bit about your willingness to put in the time and have the commitment over the long haul over those four years, if you'd like to speak about that a little bit.

JOAQUIN BELLIS: To me, the four-year commitment is... it seems pretty little when comes to my home. You know, I want to make; Guam is my home and I don't mind spending even a lifetime contributing to it; making it better.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: *Saina ma'åse'* for that and I don't know how widely it is spread throughout the youth community but it seems like there have been quite a few youth who have that passion and that dedication. So it's very good to see that you also have that. I think that there may be ways for you to harness that and put that desire that they have to do good for the community, to make sure that our environment is going to be there for your children and your grandchildren, to appreciate and value and have just like we have had all these years. So, there may be some really good opportunities for you to really harness, that maybe it's a movement that's going on amongst youth your age and around that age.

So for me, that's pretty much what I wanted to go over. I know that I said a lot, to absorb but as Senator Pedro said, anytime that you have thoughts or ideas or want to have discussion, I'm sure that any of us Senators here, or throughout the body would be very willing to listen to you and provide support where we can. Did anybody have any closing comments or questions?

SENATOR JOSE TERLAJE: You know Joaquin, being appointed to or nominated to be a board member of Commissioners, I'll tell you man, that's one of the highest appointment, a youth can get. So I trust that you're going to do good and I think with your record, I think that's where the appointment or the nomination came by. Because of your talent and the things that you have inspired to really go for it and do the program for the youth under the Parks and Recreation. So, thank you again. Thank you very much and I'll tell you, you got my support.

JOAQUIN BELLIS: Thank you Senator.

SENATOR KELLY MARSH (TAITANO), PH.D., CHAIR: So, I just want to close with saying that I think going forward, I believe that there's been quite a bit of support shown here. And if everything goes through, in as this goes forward and you are nominated and become part

of the board; that you're going to be there for an exciting year of progress. As I mentioned, we've already seen so many things happen. We have our pools, we have cleaning happening and all sorts of other things that are in the works. I think that it's going to be an exciting year where we're going to see our parks getting back to where we want them to be.

Si Yu'os Ma'åse for everybody being here and I just want to say to have a good rest of your day, but then I'll close it out formally.

Is there anyone here who has not yet testified who wishes to testify? There being none, the Committee will conclude the public hearing for the confirmation hearing of Joaquin A. Bellis, to serve as the youth member on the Board of Commissioners, Department of Parks and Recreation.

For both his and Patricia Ann Ada's confirmation hearing, I want to send out a reminder that the Committee will receive; will continue to receive testimonies over the next few days.
