





Thank you for the opportunity to be here today on behalf of the Guam Education Board to testify in support of Governor Lou Leon Guerrero's nominees for the Guam Education Board — Mr. John Burch and Mr. Ray Chargualaf, Jr. As you know, the GEB is comprised of nine voting members, six of whom are elected by the public and three of whom are appointed by the Governor with the advice and consent of the Guam Legislature. At this point, there are only four elected members, including Chairman Mark Mendiola, myself, Ms. Lou Benavente, and Mr. James Lujan. This leaves two elected positions vacant for which the Governor may nominate members to fill these vacancies for the remainder of the term. Dr. Ron McNinch is currently the only remaining appointee, serving as the business community representative. The Governor may nominate individuals to fill the appointed vacancies reserved for a parent and a retired educator.

We urge the Guam Legislature to act quickly in considering and approving the nominations of Mr. Burch and Mr. Chargualaf to the GEB. With only five members on the board now, all five GEB members must be present at every official meeting in order to meet the minimum quorum requirement as well as the minimum number of votes needed to take any action. Any absence, illness, or delay threatens our ability to conduct business, and this has been our challenge over the past few months. Having two additional members on board as quickly as possible will help immensely.

It is no easy task to be a member of the GEB. We may meet once a month for our official meetings, but we also hold numerous work sessions and community meetings as part of our effort to engage all of our stakeholders. The fact that Mr. Burch and Mr. Chargualaf have agreed to be nominated already speaks volumes to their commitment to children and public education. We look forward to them joining us in the near future. Thank you for the opportunity to provide testimony. Si Yu'os Ma'ase.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 9: 36AM

Vice Speaker Telena Nelson convened the hearing at 9:36 a.m. on Thursday, May 9, 2019.

Vice Speaker Telena Cruz Nelson: We will begin with Mr. John Burch as a Member of the Guam Education Board. Is there anyone that wants to give testimony on Mr. Burch's behalf, please come forward to the table. We'll go with Mrs. Gutierrez first. Please state your name and your position.

Maria A. Gutierrez: Good morning. My name is Maria Gutierrez. I am the acting chair of the Guam Education Board. With me this morning is my colleague Mr. James Lujan. *Mrs. Gutierrez greeted the senators present*. When I heard about the appointment of Mr. Burch, I know Mr. Burch from a long time ago as a former educator, president of GFT. For Mr. Chargualaf, I really don't know much about him, but when I was told that his mom is a teacher, his son is a teacher, his grandparents are both teachers, and his uncle, rest in peace, Chief John Martinez is also a teacher. I feel very confident that we have two good appointees to the Guam Education Board. *Maria Gutierrez read from written testimony that has been appended to this committee report*.

Vice Speaker Telena Cruz Nelson: Si Yu'os Ma'åse' Mrs. Gutierrez. Mr. Burch?

Mr. John T. Burch: Thank you Madam Chairwoman and senators. Good morning to all of you... I'm very happy to be here before the Committee on Education and the 35th Legislature, to be nominated or appointed to the Board of Education. *Mr. Burch read his written testimony which has been appended to this committee report.*

Vice Speaker Telena Cruz Nelson: Thank you, Mr. Burch. I'll now open up any questions that my colleagues may have for you. Senator Castro?

Senator William Castro: Thank you, Madam Chair, no questions for the appointee, but I do want to highlight a few things of Mr. Burch. His resume will reflect a highly educated individual. He's come through the ranks as a teacher at DOE, he's a former associate professor. As he mentioned in his testimony, he was a labor leader, and so I think he's come full circle. What I'd also like to mention for the public record, when considering this appointee, he's a responsible and contributing member of the beautiful village of Barrigada. He raised wonderful children, all law-abiding contributing members of this community. Mr. Burch is a responsible Harley rider, and I can tell you this based on personal experience, personal and professional experience by the way. For the record, I've known some of his children for thirty (30) years, but I think the one quality, Mr. Burch, that I appreciate the most is the fact that you're not afraid to speak up. I've seen you in action as a labor leader. You spoke out for those who you felt were disenfranchised or being treated unjustly. For what it's worth, Madam Vice-Speaker, and I'm sure you could appreciate this as well he's a not a "yes ma'am" "yes sir" kind of appointee. I think he's (going to) speak out, he's (going to) be a very divergent thinker, and if that can mix things up at the department to make us a better community, you have my unqualified support.

Vice Speaker Telena Cruz Nelson: Thank you Senator Castro. Senator Taitague?

Senator Telo Taitague: Thank you, Madam Chair. He has a qualified support, definitely qualified for this, but oh my gosh, I don't know what else I can say other than what Senator Castro mentioned. I totally agree. You're well rounded. What stands out to me though is your time at DYA for children who are less fortunate and who run into issues and problems, and I'm so hoping that you bring that to the

table of the Board. Don't forget those children that need a little help, a little assistance and sometimes it's at no fault of their own that they come into these problems. I'm so glad you have that experience, and I'm not a Harley rider, but I'm a dirt bike rider, so I hope you don't hold that against me. I really appreciate most especially for you coming up and stepping up to the plate to do this because it's not an easy job. I'm sure you've seen what's happened in the last eight years, you know what the Board has gone through, and it's very important to not just get one opinion, but two opinions when you're moving forward with anything, you know what I'm saying? Again, John, thank you so much for your commitment to this because I know you're going to put 120% into this.

Vice Speaker Telena Cruz Nelson: Thank you, Senator Taitague. Senator Moylan?

Senator James Moylan: Thank you, Madam Chair. Mr. Burch, thank you for coming out of retirement and coming back to serve the people of Guam. Your educational experience is exactly what we're looking for and your experience in other fields as well as excellence. I think this is a great opportunity if you have that excitement to go forward and make some changes that through your experience as a member of the board, that's a great opportunity for you, so I'm looking forward to seeing your name on the next session that we have to place our vote. Congratulations for accepting the nomination. Thank you.

Vice Speaker Telena Cruz Nelson: Senator Kelly Marsh?

Senator Kelly Marsh (Taitano), PhD: We've got quite a full house, and thank you for the testimony that you have provided, so in going through it, as has been mentioned your qualifications are very strong for this sort of position. I want highlight some of them, one being that you went to high school in Hawaii. I don't know if you grew up there for most of your life. Were you just there for high school?

Mr. John T. Burch: just for a short time to finish high school.

Senator Kelly Marsh (Taitano), PhD: I see. I think educationally in some ways, we've looked to Hawaii as an example for certain things, language immersion, cultural immersion, and some of the approaches as to the way that an indigenous community living within a larger, more diverse nation, and how they approach things, so I think that experience probably serves as well, that you can bring some things from that experience of having had those years in Hawaii and probably stay attuned to some of what is going on there, so the fact that you went to UOG, you understand our systems. You've been an educator yourself and through having worked at Guam Community College, the Labor Council of the Western Pacific, the Guam Federation of Teachers, the Guam Department of Education, again, those all speak very well of your being able to understand the breadth of what needs to be looked at and how to manage and navigate all of that. Another thing that I was very pleased to see is that you were a co-author for one of the Hale-Ta series as a fellow social studies and history instructor and professor, the Hale-Ta series in my opinion has been so incredibly important for our community at large. I've seen a real difference in the students that I teach after the Hale-Ta series was written. It looked for ways to critically rethink of the ways that we were imparting information to our youth and the adults that because I've used it at the university level with adults there and even just thinking about what and how they should be learning this information about themselves and about their island and how it all fits in together the publication that you co-wrote. So, I appreciate the whole series, but in particular, I do reference I Ma Gobetna-Na Guam I use that one quite a bit or I just admire the way that it reads, the way that history is

told and presented to our populations so I think that does speak well of your ability to think out of the box, to have some of that critical examinations, those efforts that you've been a part of to the Board as well and I think we need a lot of that, so I think those were the main points I wanted to highlight. I did want to ask you just a couple of questions, so with all of that background, is there something that you would point to as your strongest attribute that you'll be bringing to the Board?

Mr. John T. Burch: I think it's my understanding of the education system as it is here on the island having taught at various levels from middle school to high school and at a college level. I understand a transition that students must go through as they progress through each grade level, and I definitely understand the culture and that the issues that many of our children are faced with today, and I've dealt with children. I mean I've taught classes not just at a college level, I started out teaching as a special-ed teacher, so I understand how they react, children who comes from families who have disadvantages, so I have seen that and because of my work at (the Department of Youth Affairs). I have seen children that have been locked up not because they had caused trouble or the acts that were accused of would have had them locked up as an adult, it's simply because they were children and they had no one to take care of them, so I see the disadvantages that families have had to go through. That's why, for the majority of my life, the jobs and the work that I've worked in have all been toward helping people out whether they've been at the Youth Affairs office or as a teacher or as a labor leader, my whole life has been geared towards helping others and even today, as a lecturer in our parish. I've been a lector there now for over 32 years with my wife. It's all been geared toward others, and yes, I did take a break. Maria Gutierrez and I have worked together, we sat on opposite ends of the table arguing issues back in the 90s and early 2000s, but we've always been friends because we've always had the same goal in mind to accomplish what we need to help the children that are attending the classes in our schools and of course to make sure that we have the proper teachers and administrators and others in place. We'd know we didn't always agree on the way to get there, we always agreed that we had to get there, and that's why we always walked away with an idea of what we wanted to do, and Rosie Tainatongo was here. She was a superintendent at the time, she and I got along very well and we worked towards the same goals, and I think that's why I say that's a time where there you saw a lot of cooperation between the labor union and Department of Education at the time and although we did have issues back then, and the same issues are still carried forward to today -- there are ways that I believe that we can resolve these issues, (it's) just coming to an agreement on how to get there and that's where all the disagreement has been on it. Everybody wants to do the right thing. It's how do you get there, that's the biggest issue, that's where the disagreement has always been. Understanding and knowing how to work with it because not only have I worked inside of labor, I was also Director of Department of Youth Affairs, so I've been on a side of the executive management with the government, so I understand both sides and I was trained to be a manager when I went to school having my degrees in business management and public administration, and then I re-educated myself and decided that I wanted at one point in time to become an educator, I went back to school and got my education in that area, so I think my strongest is understanding what needs to be done and trying to convince others how to do it.

Senator Kelly Marsh (Taitano), PhD: It's incredibly important to me to hear about that experience and that range and especially your heart and your consideration for those that are disadvantaged. One of the things for me, maybe it doesn't seem that way, but I had what I would consider a pretty hard childhood in a lot of ways, and so, for me, that's a lot of where my heart and consideration are as well as they mentioned for our schools, we have a really high number of students that are coming from disadvantaged situations, families that are struggling to make ends meet and so forth, and so it's good to

hear that you have that real understanding. We don't know, as you mentioned, what they're dealing with it at home. We don't know if they're going home to a type of dwelling that doesn't even have electricity and yet they're competing against other students that have computers and all sorts of other advantages, so I think understanding our community in that way is going to be really important to help us understand how to bridge all of that, how to come together and to meet their needs and lift them up so that they can be succeeding and they can dream for themselves that they came come from a hard life but they can do great things with that life, so I look forward to being able to bring those skills and those understandings along with you.

Vice Speaker Telena Cruz Nelson: Mr. Burch, I want to thank you for accepting this appointment and giving of yourself. I appreciate the fact that you're a teacher and that you have especially, your integration with special education so you understand the hardships of even the littlest ones. I do have several questions for you. What is your vision for Guam Department of Education?

Mr. John T. Burch: Well, it has been for a long time to see that the students and classrooms are given the highest of all priorities. In the past, I know that the current Superintendent has made a lot of improvements. I congratulate him for that. He's pulled the department way ahead of what it was before I retired, but many issues are still the same. We still need to bring and make sure that we have a teacher in every classroom, we have textbooks or because we're becoming modernized, tablets where they can download electronic textbooks for every child to make sure that they have that because currently, that's not the case. When I was in the system itself, that definitely was not the case. Many times, teachers and even to this day, still produce their own materials because they simply don't have enough and to make sure that the assessments of our students as they go through school are good enough so that they can get and if they want to advance even into higher education, in some colleges or universities or trade schools, to make sure that have the basic skills that we need today and that includes skills in areas of technology. not just academics, so it's making sure that children have the right and correct resources available to them and that the teachers have access to these materials and of course that we have qualified administrators in there that recognize this. I understand that the great majority of administrators in Department of Education come from the teaching ranks, so they're very much aware of what it takes to be a teacher in the frontlines because that's where everything takes place is when you are in the classroom, you meet with the children, you meet with your students, and then you make contact with the parents, that's where the learning actually occurs but teachers can't do it alone. You need the support. You can't just walk in a classroom and turn on the lights unless there's maintenance people to make sure that occurs, but you need to have people that are well-versed in maintaining the rooms. You need to have administrators that make sure you get your resources in, and then of course, their children that do have many issues where you need counselors, whether it be health counselors or guidance counselors because they do have all kinds of problems, and it's not unique to each child. Each one is different. They're all different, and I've been faced with that where you deal with children that you have in your classroom, especially today where the issue now is to mainstream all children, even those (with) disabilities into regular classrooms. How do you rate these or assess these students when they're in classrooms with other children that are operating at a higher level, so this makes it difficult on the individual teacher, but if we make sure that they have the correct resources available to them, we can make it easier for them and coming from the classroom, I'm very much aware of how that occurs. I mean. I've dealt in a regular classroom with having children in there who have autism and trying to deal with an autistic child in a regular class setting is difficult, but there's ways to do it. It's just that not everyone has the training for it, and we can't expect, or we probably don't have the finances to go out

and pay for every single teacher to be trained in every single area, nut we can probably get some people that are experts to come out and assist in them, so hopefully, we can do that and they can expand and make the concentration on the classroom. I was a classroom teacher. I still feel the same way, and although I've been in management in many situations, I still refer back to my experiences on the front lines of the classroom itself, that's where the experiences are.

Vice Speaker Telena Cruz Nelson: thank you. In the most recent years, the Guam Department of Education opened the success academy and they did away with alternative school. Perhaps in your time there, there was PACE. During some of my visits to the schools, especially at the middle school level, some of the teachers have been asking to return alternative school. What is your perspective on that matter?

Mr. John T. Burch: I agree with the teachers. When PACE was active, I was a teacher at Oceanview Middle School, so we were neighbors with PACE. I know that teachers dealt with PACE. These were for students that were extremely disruptive in a classroom, I mean, extremely. They're not the regular student you would deal with on a day-to-day basis. What they did was they removed them from the regular classroom environment and placed them in a controlled environment because all it takes to disrupt your class, so you have a class of thirty students, it's one child and the whole hour of education is gone because you're dealing with the issues of one child, and all of a sudden, you're trying to take care of that child and because of necessity, because of the safety of that classroom, because of the outbursts and the violence that does occur with these children, you're concerned about the safety of the other children and you simply stop teaching and you go into a safety mode. I've done that while I was at JFK. I was a teacher at JFK, when I was teaching special education there, and when I walked in, one of my classrooms, one of my students walked up to me and said Mr. Burch, be careful. I (asked) why. He says (that) there's a student with a knife who's (going to) stab another student in a classroom, so of course, I watch out for that child when he came in, I grabbed the bag, took the knife away from him, we had a monitor, so I press those buttons on the wall and called the office, they sent somebody over and took him in that same day. Another child had bullets in his and a brown bag with lists of names including one of the assistant principals that they were going to shoot on the same day. That's what PACE was for, to remove these violent students and remove them from the classroom, so I was really disheartened when I heard that PACE was dismantled or stopped. I'm glad they have this other program coming in, but I still see a need especially now that the required age to attend school is up to the age of 18. Many of those students at that level will be bringing this into the classrooms and how many teachers do we have that are capable of disarming a student with a knife or gun? There's not that many out there, and so much violence has been happening in our schools in the states, and we don't ever want to see any of that happen here on island, but we can't train everyone to disarm somebody. When you walk into a classroom as a teacher, I hear from many teachers starting from middle school, they said watch out for students who wear a necklace around their neck because on the end of that is not a medallion, that's a knife or something of a point that they're using as a weapon, so little things like that. They carry socks, they put padlocks in it, so you hit somebody in the head and knocks him out pretty hard. I've seen that. PACE was made for that, for those disruptive students and so when they took PACE away, it took that avenue away that teachers had where you could remove a student from the regular environment with other students and place them in a controlled environment while they're in school. If you met any of those PACE teachers back then, they were tough. When I met them, I think I'm glad I'm not where you're at, but we did meet them, and I think we probably still need them, and now that we have older students who are not just older, they're bigger, they're stronger, and not all teachers are six feet tall. You

have students that play basketball and football that are giants out there, so if you have one of them turn violent, how do you take care of it? Do you just put him in a room on campus and say, well you're (going to) be in that room for one month until you settle down? PACE was something totally different, and it set up a learning environment, maybe it could have been improved. I'm not aware of why they discontinued it, but I do remember the need, and I do remember referring a few students and some that have been placed into that program.

Vice Speaker Telena Cruz Nelson: just one last question. Are you looking to introduce any board policies or is there something that you'd like to introduce and why, I mean, you (could) introduce the board policy to bring PACE back?

Mr. John T. Burch: It's a topic that I am very much concern about that PACE is something, and I did read in the paper how they created something, not like PACE but similar to it, it doesn't necessarily remove students from the classroom environment, but it is definitely something that I will bring up before the board because yes, it's one of those programs, I thought that was one that was really good that helped the classroom teacher out and many of us have heard about the violence that have been occurring in some of our classrooms and how some teachers and administrators have been able to handle it, but I think one of the safest ways is to isolate violence and remove that student if necessary, and there was a process for it back then. I'm not sure how that's going to work today, but yes, hopefully we can do something about that.
