

Through hard work and persistence, Mr. Carbullido has brought stability to DOC with clear values rooted on transparency and integrity. He empowers all around him through his ability to delegate with the necessary balance of accountability and holding everyone to strict timelines with clearly laid out expectations. He does so with an understanding that the barriers faced daily can be overcome only by working together.

Mr. Carbullido had doggedly pursued and challenged barriers of which there is a mountain within Government of Guam to include: getting overtime pay; advertising and filling essential positions; getting supplies and necessary equipment for those in his charge to do their work; adamant expectations that grant demands be met; has pressed everyone on the importance of meeting timelines and managing the administrative needs of the department, to name a few.

Greetings to the reviewing authorities,

In the 27 years that I have been a part of the Guam Police Department, I have had the distinct privilege to work as a colleague with Capt. Joseph S. Carbullido. From that unique perspective alone, I would certainly endorse Capt. Carbullido for the Directorship of the Guam Department of Corrections. But among all of his contributions in service within the Guam Police Department, it is his style of leadership that distinguishes him within the Force.

His leadership among his fellow officers has become a staple throughout his career from his earliest days as a Police I Patrol Officer protecting our citizens in the Old Northern Precinct back in the late 1980's to his formative days in the criminal investigation/homicide and robbery units respectively that would both help shape and define his earlier career through the early to late 1990s.

This solid background would prove invaluable when as a Police Officer III, he took on new branch assignments through much of the early 2000s to again tackle the streets of both Dededo and Agat Precincts as for their Neighborhood Patrol in joint operation with the civilian Neighborhood Watch Programs.

Another milestone for his service and the Guam Police Department was when he was assigned as the PIO for the newly-branded "Crime-Stoppers" program from 2004-2006. This dual community outreach and criminal investigation unit had both the best elements of the Patrol and Neighborhood Watch programs as public safety and awareness were brought full-blown to the Citizens of Guam. The hybrid program was highly effective due in large part to the PIO information and leadership brought on by Capt. Carbullido.

His decorated service up to that point helped him evolve into the final major piece of his Police Service up to this point in holding positions as Operations Chief in the Criminal and Auxiliary divisions of the force to stints as Acting Precinct Commander in both the Hagatna and his previous position as the Precinct Commander of the Northern Precinct at the heart of Dededo, since 2012.

Capt. Carbullido has throughout his career garnered 22 medals and citations for combined meritorious service and valor as well as 35 letters of combined recommendation, appreciation and commendations over those same years.

A large part of Capt. Carbullido's success is due to his rigor in academic excellence. Before even all of that, he had an honorable military service record in the United States Marine Corps from 1979 through 1983 serving in both electronic Communications and as an education NCO towards the end of it, receiving both a rifle expert award and an Overseas Deployment Ribbon. At the core of his career he had then graduated in the 29th Police Cycle of the then Guam Public Safety Division.

Capt. Carbullido garnered both a Bachelor of Arts in Criminal Justice and Public Administration Graduating Summa Cum Laude (both a President, Regent and Dean's Scholar from the University of Guam) as well as attaining Top Academic Honors in Public Administration as a recipient of the Doc Pedro Sanchez Scholarship culminating in a Master's Program.

I had personally worked with him over the years in both the Neighborhood Patrol and the Criminal Investigation Division of the Guam Police Department. Serving as his assistant in this department until now (I currently am the Acting Chief of that division). I will say that over the years, his dedication to not just the job, but his meticulous body of work in attaining both training and instructing classes on criminal law and police procedural courses have been outstanding.

Those in the Force know of his appetite to expand his horizons on understanding the concepts of the Police and Public Safety professions. Literally thousands of hours of completed and instructed courses involving the spectrum of public safety policies and protocols have flowed through his career. From Police Force protection- to include Homeland Security protocols, through the heart of his profession with homicide and burglary investigations to even responding to disaster-level preparedness. I would say in a large part, that I (among others of his peers) had taken note and followed his lead in taking these courses of theory and putting it to best practices in the day-to-day operations within the Guam Police Department.

In the literal prime of his career, I summarize the aspects that had impressed me the most in my working and personal relationship about Capt. Carbullido was that through his own rigor to be the best he could be in the Force; the ability to accumulate and effectively use education to project unto current Police Theory and Law Enforcement Policies; and his ability to effectively promote and represent those ideals of the Guam Police Department in carrying them through various programs like Crime Stoppers and the Neighborhood Patrol/Watch has led to his Division promotions to his current position as Precinct Commander of the largest Police Division on Guam; the Northern Precinct in Dededo.

His body of work has given him a unique distinction and perspective on how to run security and rehabilitation programs in large settings like the Department of Corrections. His knowledgeable and proven leadership style, coupled with his effectiveness to promote the attributes of any system or program that he is involved in would be a natural and great fit as being the Director for the Guam Department of Corrections. The Correctional Facility sorely needs his professionalism and ability to effectively lead within the department's head and infrastructure would be a critical appointment for the G.D.O.C.

In the end, leaders like Capt. Joseph S. Carbullido are vital to the success of any law enforcement and security program that the Government of Guam institutes. I can personally attest to that as he has helped affect the arc of my own career in a uniquely positive light. He would be the best choice as Director for the Guam Department of Corrections.

Why are your last names different? Joe Carbullido is my step-dad, but I've called him dad since he married my mom when I was 6 years old. Since that day on June 12, 1999, Joe Carbullido -- dad -- raised my brother Tristan and me as his own.

One of my first memories of my dad was when I was around 6. Before my dad came into my life, I was pretty spoiled and didn't follow any rules. He had been trying to teach me to put away my toys. I was pretty inconsistent about doing so. One day, when I returned home, I found that my small stamp collection was missing. I searched everywhere for it and couldn't find it. I told my mom and dad that I couldn't find the stamp collection, and my dad finally revealed that he had thrown it away because I left it out in the hallway. I threw a fit -- stomped around, cried and cried. None of my tactics worked. The stamp collection was gone.

And from that point on, I made it a point to put away my toys.

I am so grateful for that moment, and all of the future years of discipline and guidance that my dad provided. I don't know where I would be without it.

And with discipline came diligence. My dad is one of the hardest working people I know. Having spent decades in the police department, he was always on-call. With the state of the world today, it's easy to forget that when others are running away from danger, police officers run toward it. I remember my dad driving through typhoons and leaving us at home with our mom so he can answer the call of duty. I remember my dad cutting short a New Year's Eve celebration to rush over to a crime scene. I remember days when his overnight shift schedules meant that he would hardly see his family. His duty and service to the island of Guam came first.

The sacrifices were justified by his love of the job. Though he would not talk about it much -- I don't think discussing criminal activity is the most appropriate topic for the dinner table -- I never heard him complain about being woken up at 2AM and rushing to a crime scene to be briefed on a case. That's how I knew that he really loved the job.

And when you love the job and live in service, you're not afraid to take on new challenges. I am very proud of my dad for taking on this new challenge leading the Department of Corrections. The role is an important one -- imperative to keeping the island of Guam the safe, family-oriented community that we all know and love. Even if he weren't my dad, I would confidently say that there is no one more hard-working, smarter and dedicated than Joe Carbullido to lead the agency. Thank you.

He is down to Earth, honest, and "tells it like it is" meaning that he will give his input on any matter or issue without "sugarcoating" it.

He is a fixture in the Guam Sports Community as he is a Basketball Referee. He also is a pretty good basketball player where he played in several basketball leagues as a member of a Guam Police Department team or for his section for the Police Week Basketball Leagues. He is a part of the 1995 Varsity Football League Championship team of the University of Guam Tritons where we were both Running Backs. No other team had two Police Officers in the Backfield. He is also a musician and his forte is Kalapana songs. When he starts singing and playing the guitar and you close your eyes, it's as if Brian Feary Jr. came back to life.

In conclusion, Joe Carbullido should be confirmed as the Department of Corrections Director. He has the military background, educational background, law enforcement experience, physical capabilities, he's a pillar of the sports community as an official and former athlete, he has the motivation and willingness to be the Director, and most importantly, the Acting Police Commander, the highest ranking uniformed Guam Police Officer, and Operations Bureau Chief of the Guam Police Department is endorsing him.

Thank You Honorable Senators of the 35th Guam Legislature for giving me the opportunity to write a written testimony to support the confirmation of Acting Director Joseph Carbullido as our Director to lead the troops and our leaders at the Guam Department of Corrections. Acting Director Joseph Carbullido is a good leader who started last year in September 2019 and he remained here at DOC for almost one year.

I appreciate all the leaders of the past and present for being our leader and representing our Department. I ask that our leaders support our troops and command staff so that we could accomplish our mission which is Care, Custody, Control, and Rehabilitation. These are our goals and objectives. We have been through many challenges, oversights, successes, failures, and you could name all of it. But the thing is, it is ok to fail because that is what makes us strong and that is how we are going to learn to succeed? We are only humans and we make mistakes of our past. But, one thing is for sure, we did not leave our Department. We just stayed and did our jobs the best we could and I appreciate all the work that our troops and leaders have done in the past and present. We are working to make it better for the future.

We have been waiting for a new corrections facility to be built, which was promised and brought up so many times for the past thirty years and then it was thrown out of the drawing board. Or, the plan to build a Corrections Facility was just not a top priority and it was buried again. Promises were made and there was no real plan or action to build a Corrections Facility. As the years go by, our Facilities, the Adult Correctional Facility, the Women's Facility, Community Corrections Center, and the Detention Facilities are all in need of repairs and rapidly deteriorating. The population is still steady at over 635 inmates/detainees so we need new Facilities for our inmates/detainees and our Corrections Officers/Staff. We deserve this to happen. I am almost retired and I have yet to see this happen. The facilities are suppose to hold Medium Security Level Inmates but we have Maximum Levels, Behavioral Clients, and Detainees. We need to have three Corrections Facilities built and two Detention

Facilities built because the population has not gone down. The only way to reduce the population is to reduce the recidivism rate, which, is very high. In order to reduce the recidivism rate, they need to implement the second chance program which it works in the USA, because there was an Agency that handles inmates/parolees/probationers once they get released from Prison to help them get a place to stay, they help them get a job and public assistance. That is why the Ohio second chance program was a success because they help those who got released from Prison. It is easy to say but it is hard work taking care of humans. Do not think that it is easy because we face more challenges now. The other reason why its overcrowded because they are sending people to jail just for restitution, or because they are contempt of court, traffic ticket, DWI, misdemeanor rather than looking for an alternative to incarceration.

Ever since the beginning of 2019, we had leaders that started at the Department of Corrections. The truth is no one wants to oversee the operations of the prison ever since I started working here thirty years ago. I keep hearing whenever there is a new administration that no one wants to be assigned to Department of Corrections which makes us feel like we are really the step child of law enforcement. But, Acting Director Joseph Carbullido did not leave us, he stayed with us and is doing a great job allowing for us to do our work. He is also a good listener. I would ask for help and he would give good guidance on what to do?

During his tenure, Acting Director Joseph Carbullido, the following was accomplished-the recruitment went from one hundred fifty five (155) Corrections Officers and now we have two hundred and thirteen (213) Corrections Officers. We use to have seventeen (17) civilian personnel and now we have twenty one (21) civilian personnel. We had six (06) Parole Officers and now we have seven (07) Parole officers. We still have recruits that have been recently hired and the hiring for Corrections Officer is still ongoing. We also had the Post 7 Building renovated which was assigned as the COVID Facility and then immediately after, the former Hagatna Precinct was renovated. Uniforms were purchased and issued to inmates. We had the upgrades of the Perimeter in which towers are being built. We currently are waiting for the promotion of COIIs, COIIIs, Sgts. Lts., and Capts. Right now, we are bottom heavy and short of supervisors. This is why we need to promote more Supervisors due to the anticipated retirement of Corrections Officers/Supervisors. We have been getting our OT paid and COVID Differential Pay which is good. On July 30th, one hundred and ninety five Officers/staff were COVID tested with negative results. This Thursday, on August 13, 2020, six hundred plus inmates/detainees will be covid tested. There are other accomplishments done by both Acting Director Joseph Carbullido and Deputy Director Robert Camacho which are still ongoing.

Acting Director Joseph Carbullido, even during this pandemic stood by us and stayed with us here at DOC. He did not quit or give up. He stayed with us to help us and work with us. This is what I call team work? I ask that our leaders help our troops and command staff. I also ask that they help ensure that we accomplish our mission and our task through the purchases of equipment and everything needed to accomplish our mission. I ask our leaders to be aggressive in building new facilities for our growing population.

Lastly, I ask that our leaders look into the implementation of the Prison Industry Program so that when it does becomes successful, we could deposit the funds into the Prison Industry Funds at DOA to help defray the costs for housing, pay for child support, victim funds, restitution inmates expenses such as supplies-personal hygiene, cleaning materials, Corrections Officers equipment, overtime payment, building maintenance, utility bills etc.... Prison Industry is already a law and it can be done. I also ask for the Canteen to be open for so the Inmates/Staff could purchase personal hygiene and snacks. Vendors could lease the space and DOC could also earn a percentage of the profits gained while operating a business at DOC etc....all funds will be deposited into the DOA DOC Revolving Fund.

Once again, I support the confirmation of Acting Director Joseph Carbullido to become our Director of Corrections. I also want to thank Deputy Director Robert Camacho for also joining our team. Welcome to our DOC Family.

#### **NEWS HIGHLIGHTS**

•November 2019- Samantha Brennan resigned as director of the Department of Corrections in November 2019. Her replacement, Frank Ishizaki, resigned in January.

**November 23, 2019**-An internal memo released Thursday assigned now acting DOC Director Joseph Carbuillido responsibility for overseeing DOC operations, with the advice and recommendation of the warden and command staff.

• Joe Carbullido, the current DOC director, was temporarily assigned to the DOC deputy position from Guam Police Department in 2019 after the sudden resignation of Joey Terlaje as deputy director.

January 29, 2020-Department of Corrections director Frank Ishizaki will step down on Friday.

**March 2020**-Robert Camacho, the retired chief of police at the A.B. Won Pat Guam International Airport Authority, joined the Department of Corrections as its deputy director in March.

**April 7, 2020**-Out of an abundance of caution and pending further investigation, acting DOC Director Joseph Carbullido ordered all of the 38 recruits who may have had contact with the recruit who tested positive for COVID-19 to self-quarantine at home.

**April 11, 2020** DOC acting Director Joseph Carbullido issued memorandums on April 6 reminding his staff to practice the 6 feet social distancing requirements and to wear a face mask while at work.

Gov. Lou Leon Guerrero said she'd like to test criminal suspects who might have coronavirus infections to minimize COVID-19 exposure in the prison.

"If we have criminals and there is a suspicion of possibly being COVID potential, then we will, of course, test them," she said.

There have been no positive COVID-19 cases among any Department of Corrections inmates or detainees. But acting Director Joe Carbullido has identified a space to isolate them in case someone does test positive.

**April 30, 2020**-As part of Department of Corrections' commitment in December to hire 60 corrections officers, the administration has sworn in 35 more officers as of Wednesday.

**May 2020**-The officers, sworn in by acting DOC Director Joseph S. Carbullido, now make up a total of 49 officers hired since December of last year.

The administration is actively recruiting additional officers to meet its goal by the end of September.

The recently sworn officers assigned to a platoon brings the total number to 202.

**Buenas yan Håfa Adai**, Mr. Chair Honorable Senator Jose Pedo Terlaje and Honorable Senators of the 35<sup>th</sup> Guam Legislature.

First, I simply want to express my appreciation for the opportunity to testify before you on this confirmation hearing for my appointment as Director of Department of Corrections. Thank you, all. I want to acknowledge and thank the Governor of Guam, the honorable Lou Leon Guerrero and the Lt. Governor of Guam the honorable Josh Tenorio. I am humbled by the trust they placed in me, and I will always remember that it is you, the people of Guam, whom I serve.

I was born to Francisco Muna Carbullido of Agat and Juliana Topasna Santiago Carbullido of Umatac and was born the 10<sup>th</sup> of eleven children. I grew up in the village of Agat. My parents who are both deceased were World War II survivors. My father worked and retired as a carpenter for the Government of Guam Department of Public Works and my mother was a housewife who took care of the family.

I have been married to my beautiful wife Jenny for 21 years and have 4 children who are all adults now. Joleen Nelani, 34 years old, Collin Joseph, 30 years old, Katrina, 28 years old, and John Tristan, 24 years old. I have 2 granddaughters, Rylee, 12 years old and Rayden, 10 years old.

My life in public service started in 1979, when at 18 years old I enlisted in the United States Marine Corps to serve my country. But it wasn't until ten years later, in 1989, that I would make a decision that solidified my career as a public servant.

1979 was the same year I applied to become a police officer for the Guam Police Department. Eight months later, I proudly graduated from the police academy and joined the rank and file as a first-year police officer and never looked back. I worked hard to prove myself and competed for

every promotion and ascended the ranks to my current rank as a Police Captain. I was assigned to just about every area of the police department as a subordinate, supervisor and senior manager.

Those areas include but are not limited to patrol, internal affairs, public affairs, auxiliary, administration and most notably at the Criminal Investigations Division as a Homicide Detective, Supervisor and Manager. I worked on the most heinous violent crimes that no one could imagine would happen in our beautiful island of Guam. Ironically, those violent criminals that I arrested and helped get convicted are now under my care to help rehabilitate.

I am a decorated police veteran receiving numerous awards including the highest award, "The Medal of Valor" for acts of bravery and lifesaving. I am also part of our educated work force in the government, a product of our public school system and the University of Guam. I have a Bachelor of Science degree in Criminal Justice with numerous academic awards graduating with honors as a Magna Cum Laude and a Master's Degree in Public Administration.

There is a great deal of responsibility that comes with protecting the people of Guam. When you're a police officer, you never truly clock out. The work follows you home. It's the same at DOC.

There hasn't been a day in the last thirty years that I have not thought about my mission to protect and serve. And in reflecting on the last three decades of my life, I've realized that what started as a job became a career. That career became my life. That life became my identity just as much a part of me as my mission to be a good son, a good husband, and a good father.

Here I am before you, embarking on a new chapter of public service as the Director of the Department of Corrections, a system that is vital to the safety and security of our island, but one that has seen years of instability.

The mission of the Guam Department of Corrections is to protect the public from the destructive action of law offenders through control and rehabilitation.

I am committed to not only upholding but excelling in that mission. Status quo is not an option.

As the Director of the Department of Corrections, I will place a renewed focus and emphasis on rehabilitation for offenders. The tendency for a convicted criminal to re-offend is both a local and national issue. We have a foundation for success with a handful of re-entry programs currently running, like the Residential Substance Abuse Treatment (RSAT) and the Educational Release, Work Release and Work Credit programs. But it is not enough. There are more programs that we just added and are in motion.

Although it is the philosophy that release preparation begins the first day of incarceration, focus on release preparation intensifies at least 18 months prior to release. The Release Preparation Program includes classes in areas such as résumé writing, job search, and job retention. Many institutions hold mock job fairs to provide inmates an opportunity to practice job interview skills and to expose community recruiters to the skills available among releasing inmates. Qualified inmates may apply for jobs with companies that have posted job openings. The program also

includes presentations by community-based organizations that help ex-inmates find jobs and training opportunities after release.

The Guam Immediate Violation Enforcement (GIVE) Program (better known nationwide as the "Swift, Fair and Certain Sanctions Program). Through this subaward which I signed and agreed to, the Judiciary will compensate DOC for the detention of GIVE Program participants who are sanctioned to jail time at DOC, at a rate of \$130 per day. This will also pay for the costs of physical exams for GIVE participants mandated to more than 14 days of detention. DOC has agreed to allow GIVE participants to receive individual and group drug and alcohol therapy and treatment through the Judiciary's contracted counselors.

A Pre-Apprenticeship Re-entry Program with GCC is in progress and under discussion. The program's intent is to provide inmates with different trades and job skills while we solicit the support of local employers to consider these individuals for job placements upon completion of the program and re-entry back into society.

We do not want revolving doors in our correctional facility. The people of Guam will be better served by rehabilitating criminals and providing them with the resources to become productive members of society when they are released.

A major part of ensuring that we succeed is to modernize the current facility. A new prison facility will alleviate the existing overcrowding problem and solve a large part of staffing and security challenges that are all key to providing adequate services to the prison population and ultimately, protecting the public. I will spearhead the development of a new correctional facility with vigor, urgency and most importantly, an actionable plan. A Master Plan has already been developed and submitted to Governor's Office for her approval. This will take us one step closer to our goal of a new prison. I will work closely with the Governor's Office and this legislative body to pursue all funding options available.

Behavioral and Mental Health Services: DOC and GBHWC have recently agreed to consolidate services by creating a GBHWC annex at DOC to better serve all clients in need of this service. After several discussions between the two agencies an Executive Order by the Governor of Guam was recently signed into effect and a Memorandum of Agreement between the two (2) agencies is forthcoming. Additionally, my vision supported by the current administration is to build a new Forensic Unit within DOC which would house these services.

Upon assuming the helm at DOC, I was faced with a media blitz regarding complaints by federal inmates alleging "inhumane conditions." Rather than denying or fighting the issue, I swiftly addressed this by using a Proactive Management Approach and resolved the matter to the satisfaction of the federal public defender.

With reference to the current COVID-19 environment we are in, DOC under my leadership developed a Pandemic Plan, COVID-19 Policy, COVID-19 Contingency Plan, and Quarantine and Isolation Operations Plan. These measures along with other internal directives and guidelines for prevention including aggressive procurement of protective supplies and equipment are all in place and have so far been successful in the fight against this pandemic.

The DOC Commissary is work in progress. This was recently enacted into law and a Policy is being developed as well as the Mechanisms of the system that need to be in place for implementation. This program will be electronically operated with a controlled Point of Sale (POS) from a contracted vendor. The benefit of having this system is that it will alleviate the high traffic of family members bringing in items to the facility and, consequently, decrease the number of contraband being brought in.

The Corrections Reserve Program: This is also in the works. A draft policy is already completed and awaiting a dedicated funding source to budget the program. DOC will start planning on the target groups to solicit for recruitment. Of course, those trained and experienced are the quickest and most ideal to target, e.g. retired officers, or those with Criminal Justice or LE backgrounds.

Federal Funding: \$2M in Department of Interior (DOI) funding was recently approved under my leadership to be allocated to replace the fire suppression units at both Hagatna and Mangilao facilities. A portion of this funding will also be used to repair or replace the air conditioners and locking mechanisms at the different posts. These are all pre-existing problems that have plagued DOC for years and is mentioned on the Federal Receivership Report which will finally be addressed.

Major Waterline Breakage: According to DOC staff, for many years, a major water breakage existed within the DOC Main Facility. This caused major concerns and affected the water pressure with little to no water at several posts. The toilets could not even be flushed in one of the most populated posts. A water buffalo had to be brought in and used to augment with the water issue. The water bill was increasing every month for years. Recently, I coordinated with DPW and Waterworks agencies and finally got the issue resolved.

Hagatna Detention Facility: We're in the process and near completion of renovating the area between the Federal & Local detention facilities. Accordingly, the wall and the gate were destroyed during one of the typhoons and has never been repaired. This has caused major security problems and was a contributing factor of a recent escape.

Parole Office: The Parole Office has completed its move to the old Hagatna Police Station. The building has been newly renovated and designed to suit the needs of our Parole employees. This includes a Parole Board hearing room.

Video Conferencing: In conjunction with the Judiciary of Guam, DOC is Renovating Space at both the Hagatna and Main Facility in Mangilao to set up a Video Conferencing capability to enable court hearings to be conducted between detainees and their attorneys with the Superior Court of Guam. This capability is greatly needed especially in light of the current pandemic.

Special Operations Response Team: Based on my assessment and recommendations from the DOC management team, I have re-instated the Special Operations Response Team (S.O.R.T). This is much needed to stabilize the safety and security of our employees. This specialized team operates with tactical skill sets and provides rapid response to all prison disturbances and/or incidents, can

conduct cell shakedowns and extractions for contraband and other emergency situations and augment personnel shortages among a list of numerous other capabilities.

Lastly, I am dedicated to improving the experiences of our most valuable resource, the men and women on the front lines of the Department of Corrections. The dedication and courage exhibited by Correctional Officers, Parole Officers, Case Workers, and our Civilian Support Staff who work behind the scenes deserve our utmost respect. The important work of these employees often do not receive the recognition they deserves. Their safety and welfare is a significant area of concern. Recruitment and retention will be a priority focus.

#### My Top Administrative Priorities:

- 1. Conduct Comprehensive Staffing Analysis. This is to try to resolve one of the biggest issues that has plagued the agency for decades. OVERTIME expenditure is a symptom of the actual underlying problem which is "Lack of Staffing." A re-alignment of the current Organizational Structure and Functional Statement will be a part of the analysis.
- 2. Recruitment and Retention. DOC requires adequate staffing and incentives for retention such as more promotions. There's a bottleneck at the bottom of the organization, not enough managers and a lack of leadership training. DOC needs to update its job descriptions for each Corrections Officer position and conduct a compensation study to ensure equal pay and competitive wages compared to other LE agencies.

Currently, about seventy-one (71) GG-1s for Corrections Officer I and (5) Parole Officer I positions have cleared BBMR and Department of Administration; (53) have been brought on board to include several re-employment and the rest are pending completion of the recruitment process. Additionally, twelve (12) GG-1s for civilian positions have cleared BBMR and are pending completion of the recruitment process at DOA. (35) GG-1s for promotions of Corrections Officer positions from COII thru Corrections Assistant Superintendent have been approved by BBMR and are pending review at DOA.

In closing, I would like to take the opportunity to thank my family, friends, colleagues and everyone who took the time to testify in support of my confirmation today. I also want to thank you Mr. Chair, Senator Pedo Terlaje and Senators of the 35<sup>th</sup> Guam Legislature for taking the time to listen to all the testimonies for your consideration on my nomination. I have always adapted and conquered all challenges throughout my career, and on this new journey that God has called upon me to help with, I am once again ready to step up to the plate as the Director of the Department of Corrections. I am ready to take on the challenge if I am privileged enough to be confirmed by this body. *Si Yu'us Ma'åse*.

#### Hafa Adai Mr. Chairman:

I am Ronald (Ron) B. Aguon, Assistant Professor of Public Administration and Legal Studies, University of Guam, School of Business and Public Administration. I am presenting this testimony in support of the confirmation of Joseph (Joe) Carbullido to serve as Director of the Department of Corrections. I will not belabor his qualifications in law enforcement and criminal justice, other than to say that I believe he is highly qualified to lead and manage the Department. My UOG colleague and former GPD Chief and Director of Corrections, Frank Ishizaki, will attest to this.

What I would like to focus on is the Joe Carbullido who was my student in the Bachelor of Science in Criminal Justice (BSCJ) Program, and in the Master of Public Administration (MPA) Program.

I remember Joe was a very diligent undergraduate student with a strong enthusiasm for learning, always expressing pride in his police profession, and sharing his knowledge and experience with the class, most of whom were pre-service students who lack work experience.

It was during his candidacy in the MPA Program where his leadership and management paradigm evolved. The Program provided greater challenges to MPAs in terms of advanced academics and professional studies. We taught administrative law, public management, sanctions, adjudication, among others.

Joe was a top performer in everyone of my courses. His understanding of law, public policy, management and leadership, and administrative procedures were extraordinarily solid. Two ethical values that he steadfastly advocated were the Rule of Law and Respect. Although the Rule of Law predominates in criminal justice, our Program emphasizes the importance of the Rule of Law in public personnel management. Every public agency must abide by the Constitution, the Organic Act, and local and federal statutes, even when performing personnel responsibilities.

For example, one of the perennial complaints of Directors is the difficulty of terminating or disciplining classified employees. This is undoubtedly true. Some attempt to overcome this by



forgoing or bypassing procedures, often resulting in reversible error and costing the agency enormous sums of money in backpay and attorney's fees, and other negatives. We stress to our MPAs that fundamental procedures are essential to due process. The only way to prevent a dismissal at this stage is through compliance. Overcoming procedural hurdles will get the case heard on the evidentiary merits, which must be supported by just cause as required by substantive due process. I'm confident that Joe will be managing under the Rule of Law as a matter of practice, and will avoid the pitfalls of Directors who have acted otherwise.

Respect for employees is a quality that makes a good leader. Recognizing capabilities, being treated fairly, and protecting rights are highly valued by employees and serve as the foundation of trust and reciprocity. Respect is part of Joe's character and will serve him well.

I have focused on personnel management, because, as we know, nothing is accomplished without good people and good leadership. Bad personnel practices produce bad results. These can be preempted by adhering to the Rule of Law, and treating employees with personal and professional respect.

The Department of Corrections is a critical component of the criminal justice system. I believe Joe Carbullido is the right person to manage and lead the agency in pursuit of its mission.

Re: Response to Request for HIPAA Waiver

Senator Terlaje:

I have received a request from your office for a waiver pursuant to the Health Insurance Portability and Accountability Act of 1996 (HIPAA), authorizing disclosure of a mental health evaluation performed by Dr. Andrea M.S. Leitheiser regarding my fitness to serve as Director of the Department of Corrections ("DOC"). A letter from Dr. Leitheiser formalizing her determination that I am "deemed fit from a mental health perspective for promotion to the position of Director [of DOC]" was provided to you by the Office of Governor Lourdes A. Leon Guerrero on July 31, 2020. It is my understanding that you are requesting the complete file from Dr. Leitheiser's evaluation, including any medical information provided therein and the doctor's consequent impressions and notes. For the reasons discussed herein, I respectfully decline to provide a HIPAA waiver at this time.

5 GCA § 3113 authorizes the Governor to appoint the Director of DOC with advice and consent of the Legislature, subject to specific requirements, including that the candidate submit to psychological testing. I have fulfilled this requirement, along with all other requirements under the statute. I am aware that prior DOC directors have voluntarily provided full copies of their evaluations to the Legislature in furtherance of their appointment and confirmation, which is likely the reason behind your request. Although my evaluation was favorable, as evidenced by Dr. Leitheiser's July 7th letter, I hesitate to voluntarily disclose the full evaluation or any other private medical information not required by statute, for the precise reason that it is private. I appreciate that the Legislature is tasked with assessing my qualifications for the position of Director of the Department of Corrections. I am humbled by, and grateful for, the support that you have shown me while I have served as DOC Director on an interim basis, and sincerely look forward to our continued partnership and mutual respect. I hope you will find that my performance over these past several months, coupled with the determinations made by qualified professionals regarding my fitness to continue to serve, meet the standards you have established for this position.

### II. SUMMARY OF TESTIMONY & DISCUSSION

The confirmation hearing was Called-to-Order at 12:36 p.m.

Chairman Jose "Pedo" Terlaje: Good Afternoon, Ladies and Gentlemen, this Confirmation Hearing is now called to order. Todays date is August 12, 2020 and the time is 12:36 p. m. The committee on Public Safety, Border Safety, Military and Veteran's Affairs, Mayors Council of Guam, Infrastructure and Public Transit is now conducting a confirmation hearing today for the Appointment of Joseph S. Carbullido to serve as the Director of Department of Corrections. For





the record and in conformance with Section 8107 of Chapter 8 Title 5 GCA, the first public hearing notice was sent out on Wednesday, August 05, 2020, to adhere to the five working days requirement and the second confirmation hearing adhering to the 48 hours' notice was sent out on Monday, August 10, 2020 and in addition these notices were also sent out to all media and posted on the Guam Legislature's website. I would like to thank everybody for your participation this morning and we have like 16 people that is scheduled to testify this afternoon. Let me just put out the rules of engagement here and the rules of conduct as far as everybody that's going to testify. The host of this hearing will mute all participants until called upon by the chair. When called to speak, please ensure that you are "un-muted" and that you are speaking into your microphone. Members of the Committee and/or the Legislature wishing to speak may indicate their desire to the chair through the in-app chat feature. Individuals testifying shall first be recognized by the Chair before speaking and shall state their name for record-keeping purposes. The order of questioning will begin with the panel of Senators, who shall complete their lines of questioning for each respective item on the agenda. Upon completion of the panel's line of questioning, the Chair will pose questions. Each member will be allowed to pose a question to an individual testifying for a round and will be provided another round, if needed. Questions and testimony shall be confined to the substance or nature of the agenda. We're having audio issues so please bear with me. Let me just start with the rules of engagement here as to the character or the motive of any Senator, or any individual testifying, is NOT permitted. Any violations of this general rule of conduct will result in removal from the public hearing by the host. Now we will have those that are testifying for Mr. Joseph Carbullido proceed first and then we will have Mr. Carbullido testify for himself. So, I'm gonna go down with the listing we have about 16 individuals that will be testifying. So, if you can just keep your testimony in a minimum that will be helpful for all of us. First off, I would like to call on Patricia Taimanglo. Pat go ahead.

**Dr. Patricia Taimanglo (Department of Corrections):** (written testimony provided)

**Chairman Jose "Pedo" Terlaje:** Thank you very much, Pat. Second in line I wanna call Mr. Jose Munoz. Joe go ahead pari I know you have an appointment so your next.

Jose Munoz (Guam Community College): Håfa adai, Si Yu'os Ma'åse for your invitation. I'm here to support the nomination of Joseph Carbullido to be the Director of Department of Corrections. Joe was taught from our Department at GCC under the Criminal Justice courses. He is very capable, very honest and like Dr. Taimanglo said very empathetic. He is a people person and he looks for solutions. I think his experience in law enforcement is unquestionable and we've been very fortunate that Guam Community College at GCC to work with some of the wonderful people in law enforcement on island including Chief Ignacio and Frank Ishizaki. So, I think we can place Joe Carbullido in that framework, and I think he's an excellent candidate on the position as Director for the Department of Corrections. Thank you, sir, and the rest of the committee, for your attention. Take care.





**Chairman Jose "Pedo" Terlaje:** Thank you very much Joe. Next in line is Julie Cruz. Go ahead Julie. Julie can you hear me?

Julie Cruz: Yes, I can. (written testimony provided)

**Chairman Jose "Pedo" Terlaje:** Next in line I'm gonna call on Stephen Ignacio my favorite Police Chief go ahead pari.

Chief Stephen Ignacio (Guam Police Department): Hafa Adai, Senator. Thank you for calling me up next. Good afternoon Pedo Terlaje Chairman of Public Safety for the 35th Guam Legislature. Sorry I gotta scroll through my phone. Good afternoon to all other on this live stream. I'm here to provide testimony today on the confirmation of Joseph S. Carbullido as the Director of the Department of Corrections. I remember vividly Joe came into the Department after I joined possibly a year after I joined, and my first assignment was with Director Carbullido when we were both special agents or investigators at Criminal Investigators Section. We both rose through the organization criminal investigation and becoming Homicide Robbery Investigators and I think that's an important thing to point out because you need to have the ability to pay attention to detail and to be a very thorough and meticulous investigator to achieve a Homicide Robbery Investigator status. Joe has that quality Joe has built upon that quality throughout his career in the Guam Police Department rising through the ranks and ultimately being promoted to Police Captain. Joe there are many words to describe a Joe and if I may refer to him as Joe at this point. He's hard working and intelligent, he has the ability to learn to pay attention to the finer details and he is a very quick learner. I think the fact that he is a quick learner is obvious when Joe moved from the Guam Police Department to the Department of Corrections. Although, it is a law enforcement and Public Safety arena I believe that we all understand that we have two different missions and the ability of Joe to adapt to that change almost overnight it is really something that has to be pointed out as such an accomplishment. In his short tenure I've seen Joe done hiring and he has continued to doing hiring and promotions within his organization. Something that I'm aware that has not happened within the organization for many years. So, in the short tenure that Joe has been there he's achieved many many different things that have not been possible in such a very short period of time. As pointed out upon assuming Directorship in the acting capacity Joe has really brought stability to the Department of Corrections. I am here to provide favorable testimony on his behalf, and I ask the Legislature and the members to confirm Director Carbullido as the next Director of the Department of Corrections. I thank everybody for your time, and I thank you senators for providing me the opportunity to prevent to provide testimony on behalf of Director Carbullido. Thank you.

**Chairman Jose "Pedo" Terlaje:** Thank you, Stephen. Before we proceed I just wanna recognize some of our favorite senators that are here. I wanna recognize my Senator Telo Taitague, I wanna recognize Senator Biscoe Lee and Senator Louise Muna. Thank you, Senators, for joining us and





sharing your thoughts this afternoon. So, next in line to testify I wanna go ahead and call on my old good friend Senator Frank Ishizaki. Thank you, Frank, go ahead.

Frank Ishizaki: Okay I want to make sure I unmute. Can you hear me? Ok.

Chairman Jose "Pedo" Terlaje: Yeah, loud, and clear pari.

Frank Ishizaki: (written testimony provided) Thank you Pedo, thank you Mr. Chair and thank you Senators who are there and everybody. It's a good turnout. I can just say Joe is a great guy and I think he's proven himself at GPD and at Corrections and I gotta disclose that I'm sort of related to him and I hate to do that but my primo Frank Frankie was married to his sister Mary and so we're all kind of connected but in spite of that I respect and like Joe okay. Sorry you know it's just I'm trying to be light on this but I think Joe has a great capacity with everything and I think Chief Steve just highlighted his um fine ability to discriminate you know between all the information and facts and I and he's a quick study and I was honored to know him at GPD when I was Chief for a little bit and I think he was a Sergeant at the time and I think we I think I was responsible for his promotion to a Police Lieutenant and then at DOC he uh and I felt sorry for coming in but I think we worked very well together and so I'm proud to say I'm connected to Joe in different aspects and I can't think of no reason why this body should not confirm him and I fully endorse him and everybody's saying great things so I'll keep it short. Thank you, Pedo.

Chairman Jose "Pedo" Terlaje: Thank you, Frank your still looking young Pari. Next in line I'm gonna call on Tom Tajalle. Tom, go ahead. Tom you have to unmute. Tom, can you hear me? He needs to unmute. Um, ok I'm gonna go to the next one Tom once you're ready just let me know. I want to call on the Acting Police Commander Manny Chong. Go ahead, Manny. Thank you. Manny can you hear me? Go ahead Pari. All of you guys are my Paris you know its election time so it's all of you are my Paris. We're having problems with the audio. If you can hear me can you answer your phone cause my office is trying to call you. Manny can you. Were still having problems. We're gonna go to the next one in line because I think they need to. Manny can you hear me now? We're gonna go ahead and go to the next uh okay moving forward let me call on Kevin Guerrero. Kevin can you hear me?

Lieutenant Kevin Guerrero (Guam Police Department): Buenas Yan hafa adai. Yes, Sir Panel. I'm here on to support Captain Joseph S. Carbullido for Director of DOC and I'm here to provide this testimony. (written testimony provided) I really humbly ask you to support his nomination for directorship. Thank you.

Chairman Jose "Pedo" Terlaje: Thank you and good testimony, sir.

Lieutenant Kevin Guerrero (Guam Police Department): Thank you sir.

Chairman Jose "Pedo" Terlaje: I wanna call on Katrina Palanca. Katrina, go ahead.





**Katrina Palanca:** (written testimony provided) Chairman Jose "Pedo" Terlaje: Thank you very much Katrina. I'm gonna go back to and moving forward again, I want to call on Tom Tajalle. Tom, go ahead.

Tom Tajalle (BT International, LLC): Chairman, I apologize for the for the first, for the first round. Apparently, I had issues with the computer but anyway, I'd like to say hafa adai and goodafternoon Honorable Pedo Terlaje, Chairman of the Committee of Public Safety, committee members, and the honorable members of the 35th Guam Legislature. My name is Tom Tajalle and I am the president of BT International. I come before you today in support of the nominee of Joseph S. Carbullido to serve as the director of the Guam Department of Corrections. Before I begin my testimony, I would like to read a quote from one of our nation's greatest presidents, former President Ronald Reagan, whom I've had the opportunity to meet personally in my early 20's. By the way, I'm still in my early 20's. Ronald Reagan once said about a great leader and I quote, "the greatest leader is not necessarily the one who does the greatest, the greatest thing, but is the one who gets the people to do the greatest thing," and I want to repeat that again. "The greatest leader is not necessarily the one who does the greatest thing, but he is the one who gets the people to do the greatest thing. The greatest leader is not necessarily..." I'm sorry. You would be hard and pressed to find a person with so many awards and sacculates from distinguished and matrious services to the medal of valor and even lifesaving medal. Joe has never thought twice to put himself in harm's way to save another, to help someone else. Throughout his career, he has served in various capacities within the Guam Police Department from patrolling Guam's street, to solving homicides, to spokesperson, to running precincts and divisions leading the rank and file. Each of these positions has given Joe ample experience to grow as a leader become more resilient and identify solutions to challenges. He is a man of his word; a man of integrity and compassion and he exhibits all of the characteristics of a great leader. As we all know, the Department of Corrections has had its fair share of challenges during this couple of years. The department has needed solid leadership and a leader who can bring the staff together as a team to work collectively to address the many issues facing the prison. Even during the pandemic, Joe has proven capable to handle any challenges that comes his way and did it in a way that united the personnel. I am confident in his ability and I know that he is the right person to help the department and move the prison forward for the future and especially during these trying times. Thank you for the opportunity to express my support and I humbly request your favorable consideration of Joseph Carbullido's confirmation. In closing, I would like to read another quote





of what makes a good leader. "A good leader leads the people from above them. A great leader leads the people within them." Mr. Chairman, committee members, and honorable senators, Joe Carbullido is that man and that can lead the Department of Corrections. Thank you for giving me the opportunity to testify on behalf of Joe Carbullido.

Chairman Jose "Pedo" Terlaje: Thank you very much, Tom. I just wanna recognize one of our senators that just stepped in. Senator Jose San Agustin. The chairman of the budget of our Government. Thank you, Joe for showing up. Thank you. Next in line, I wanna call up Manny, Major Manny Chong. We're still having audio problems with Manny.

Major Manny Chong (Guam Police Department): Can you hear me now?

Chairman Jose "Pedo" Terlaje: Yeah, go ahead Manny.

Major Manny Chong (Guam Police Department): Okay. Okay, thank you. Sorry about that.

Chairman Jose "Pedo" Terlaje: No problem.

Manny Chong: Time to get a new phone. Good afternoon Senator Jose Terlaje and everyone in attendance. My name is Major Manuel R. Chong, the Acting Police Commander and the Operations Bureau Chief of the Guam Police Department. (written testimony provided) Thank you, sir.

**Chairman Jose "Pedo" Terlaje:** Thank you very much, Manny. Going forward, I wanna call on my good friend, Pete Roberto. Peter, go ahead sir.

Peter Roberto (Guam Community College): Thank you very much Senator Terlaje and members of the committee. For the record, I'm Pete Roberto, under the Guam Community College and I just want to say first and foremost how excited I was when I heard the news that Joe was given the task to head up to DOC and assist the department. For the past seven year I've known Joe and in fact, of all places, we met in the parking lot and in the parking lot here at GCC, he was walking in and of all places, he was walking into class. You know, Joe has been, he has a passion for teaching. End of story. His desire for education is, goes before him and in fact, the students, even those who are in rank right now, know that they had Joe for class is either police ops or you know criminal investigations in the academy. So I am very happy and I fully support the nomination from Governor Leon Guerrero for Captain Jose, I mean Joseph Carbullido, to step into the role of director. Joe, again, is very familiar with the curriculum here at GCC. He is in fact given a lot of contributions and to his credit, you know, there has been a lot of changes in the curriculum, especially in police or theory, concepts of police operations and criminal investigations. Lastly, I just want to comment on something about Joe. We all know that Captain Carbullido is very much a very kind and very humble man and can be very methodical and kind of quiet, but what people don't see that I had the privilege to see here at GCC is his ability to





collaborate, bring people to the table and actually, he doesn't really push himself on you. He is just a very, he's a strong listener and he actually brings things that are really important to the conversation and so with that, I know that he will really be a great addition to the POST Commission, and I wish him very well. Again, Senator Terlaje, thank you for the opportunity and good luck my good friend Joe. Thank you.

**Chairman Jose "Pedo" Terlaje:** Thank you, Pete. Thank you very much. Next in line, I want to call on the Warden of the Department of Corrections, Mr. Alan Borja. Go ahead, Alan. You have to unmute, Alan.

**Warden Alan Borja (Department of Corrections):** I'm gonna start all over. Buenas yan hafa adai, Mr. Chairman.

Chairman Jose "Pedo" Terlaje: Hafa adai, Warden Borja.

Warden Alan Borja (Department of Corrections): (written testimony provided)

**Chairman Jose "Pedo" Terlaje:** Thank you very much, Alan! Good testimony next in line Therese Tayama. Go ahead Nen, how is your Dad? Go ahead an unmute.

Therese Tayama (Department of Corrections): Thank you for asking Chairman Terlaje my Dad is doing well. Good afternoon everyone, good afternoon Chairman, good afternoon everyone from DOC and the public as well. (Spoken in Chamorro Translated to English) Who are you, Sir? I've never met him in my life. He's been with us as of September. The only thing that I knew of him is that he had served 2 decades in the Guam Police Department. I am the Daughter of a Retired Police Officer. I understand the sacrifices Ma'am that your father has made in service to our island. I can really appreciate that, and this speaks more of your father's character that has only been captured by you so honor to you for that. (Provided written testimony, see Attached)

Chairman Jose "Pedo" Terlaje: Okay, i'm going to allow her.

Therese Tayama (Correction Social Worker Administrator, Department of Corrections): Thank you, Mr. Chairman!

**Donna Cruz (Correction Social Worker II, Department of Correction):** (written testimony provided)

Chairman Jose "Pedo" Terlaje: Okay, okay next in line. I want to call Melanie Brennan.

**Director Melanie Brennan (Department of Youth Affairs):** (written testimony provided)





**Chairman Jose "Pedo" Terlaje:** Thank you, Melanie! Next in line, I want to call on my good friend Bob Camacho. Go ahead. Bob you need to unmute!

Deputy Director Robert Camacho: So sorry! Good afternoon Senator Terlaje, Senator Biscoe and Senator Taitague. Thank you for this opportunity and of course thank you to the Acting Director. Most of the people that decide to come to the Department of Correction as a Director or Deputy Director pretty much. They don't realize the complexities of the Department of Corrections and the overwhelming challenges and I have to say that Joe has met these challenges full force and has addressed these issues, problematic issues with the Department of Corrections with a good heart and great leadership. I'm here to testify in support of Acting Director Joe Carbullido in his confirmation. I've had the honour and privilege of working with him as the Deputy Chief of Police several years ago at the Guam Police Department and also as the Deputy here at the Department of Corrections since March of this year. In both departments he has shown great management and leadership skills. I found Director Joe Carbullido as very qualified and well suited for this position. In the short time that he's been Acting Director he really has stepped up to the plate and garnered a lot of knowledge in such a short time this is quite incredible and this is very complex from legal issues to immigrant issues, food services and medical issues. It's just a whole overwhelming department and probably one of the hardest departments to run and he has managed the department during this extremely difficult time pandemic and through his leadership we're able to prevent I guess as mentioned before to avoid the widespread of Covid in our employees. And tomorrow we will be doing testing for all the 600 some detainees and inmates so we're hoping that works out well. He pushed for more personnel. We have about 70 recruitments that have gone through. He's fought for promotions as mentioned earlier. We had this water when I came in. I found out that we had a very bad water system that's going to the facility and sometimes the water was so slow that inmates had to use buckets to fill up certain areas so that was just resolved after many years of not being fixed that was done because he coordinated with DPW and Guam Water Works and we had to complete it we've also, conducted several critical training establishment of policies with the COVID and other matters of training and we're also applied for several federal grants. So this in the midst of everything else in the midst of all the pandemic and all the restrictions we were still able to do things in normal situations people would have just tapped out and say this is just too overwhelming under this watch we were able to secure over 2 million in the cares act and we re-established the sort team and the internal affairs. And from that time, we established these sword operations we've caught many of contraband to be infiltrated into the facility because of the leadership decision. We're establishing four different sites here at the Department of Corrections for video conferencing with the courts and this saves a lot of time and is cost effective overall. So that alone is a huge undertaking we've renovated the Hagatna Precinct and The Guam Detention Facility and now that we have the Parole Division. We did that within 2 ½ months also, will be establishing the first one behavioral health and wellness center. We've renovated 1 facility that was condemned, and we will be helping with the mental health clients coming from mental health and behavioral health and wellness centers. There are many other accomplishments and I think many people





have already mentioned them. I won't get into that, but to keep brief. I worked with him for the past several months and I've seen that he has truly made a positive impact and his integrity is beyond and he's determined and committed to the mission is probably one of the most difficult agencies to run, but he has shown his ability to lead and is deserving of the confirmation. I've worked for the Department of Corrections for over 23 years. When I came back from retirement, I saw that he's really committed, and he has a certain leadership style very similar to Frank Ishizaki's personality and is able to look at things subjectively and make good decisions. The only disappointment I have is that he didn't tell me he knows how to sing; he's had a hidden talent. Otherwise you know I just want to say job well done Sir. I am in full support of his confirmation. Thank you very much!

Chairman Jose "Pedo" Terlaje: Thank you very much, Bob! Next one in line moving forward is Captain Lizama. I want to call on Captain Lizama to go ahead and do her testimony. Captain Lizama you're on!

Captain Maryhelen Lizama (Department of Corrections): Hello Sir, I'm using the warden's computer! Hafa adai, good afternoon to everyone! I am in support of Director and Acting Director Carbullido to be our Director for the Department of Corrections. We've been working for him for already 1 year. My testimony is like 4 pages long, so I don't want to read it, but I believe you guys have a copy of it. I'm just going to make it short. Everyone has said everything about Director Carbullido, his background in Law Enforcement says it all, especially the military. Also, the support from his family tells me that he's going to do his job good. Okay, because that's what corrections is about, we're watching 600 sum prisoners and they're really like our own children and that's in the interest of rehabilitation. Okay, it's not just about safety and security it's about rehabilitation. It is true that the difficulty is taking care of the prisoners here and why because they're humans, so we have to ensure that they are taking care of 24/7. We have to make sure that their constitutional rights are not violated. Okay, that's another thing Mr. Carbullido started last year in September and so far, the way. I see his demeaner. He's very professional, he's serious on the job. When something needs to be done he does it and also if I ask for help he gives me guidance and that's what I need guidance from my leaders especially in a difficult situation, so I support Director Carbullido even if he was with us only for one year. I'm pretty sure he already learned a lot about the corrections spill because it's not the same as any other law enforcement. Help all of us to do our job. Okay so that is all I have to say, I do not want to make it long because I'm a very chatty person. Okay, all right, thank you senator.

Chairman Jose "Pedo" Terlaje: Thank You Captain Lizama, before I move on to the principle, the acting director, I want to ask our Chairman for Budget because we do have a budget hearing session at two o'clock, I want to ask him, Joe if you can hear me? Joe if you can hear me, I want to ask you something. Joe can you hear me? Hey Joe, I want to ask you here, we're going to go back on the budget session today.





**Senator Joe San Agustin:** When you are done Senator Terlaje because Joe Carbullido's confirmation is important. We need to get him settled, we need to get DOC on track and in black.

**Chairman Jose "Pedo" Terlaje:** Thank you, at this point in time, I want to call on the acting Director, Mr. Joe Carbullido to go ahead and present your testimony. Go ahead Joe.

**Acting Director Joseph Carbullido (Department of Corrections):** Thank you, Senator. (written testimony provided)

Chairman Jose "Pedo" Terlaje: Joe thank you very much. Good presentation and I want to call on our Senators, I want to start off with Senator Regine Biscoe Lee, senator go ahead and then we will go in line with Senator Telo and I will go last with Senator Joe San Agustin since we have the budget that we have scheduled so he said we can go ahead and delay the budget hearing. Go ahead Senator Lee, thank you ma'am.

Senator Regine Biscoe Lee: Si Yu'os Ma'ase Mr. Chair, and thank you all so much for providing testimony for us today. Dr. Taimanglo, Mr. Munoz, and Ms. Cruz I really appreciate your personal and character reference for your brother Chief Ignacio, Senator Frank, Mr. Guerrero, Ms. Polanca, also providing a very personal testimony. Mr. Tajalle, Major Chong, Mr. Roberto, Mr. Borja, Ms. Tayama, thank you Ms. Cruz, Director Brennan and the Deputy Director Mr. Camacho, thank you very much for your service and Captain Lizama thank you so much we really appreciate being able to hear from our community, exactly I mean certain kind of anecdotes about Captain Carbullido, about his leadership, about his determination, his integrity, his hard work, and his commitment to the people of Guam. So, I definitely want to start off by thanking our Governor and Lieutenant Governor for their nomination and Si Yu'os Ma'ase and Semper Fidelis to you Captain Carbullido and your family, your wife, your children, for accepting this nomination. We know that this is not an easy job, I am really glad to have had the opportunity to review your packet, to hear about your many years of service, your commendations, your willingness to continue serving and also that we have one thing in common, were both kalapana fans so that is really good. I want to thank Ms. Tayama and Ms. Cruz for recognizing that DOC remains COVID Free, and I really want to thank you Captain Carbullido for including the plans and policies that you have taken to really protect our employees, our detainees, inmates, and their families from this pandemic. So that was going to be my first question, but you already acknowledged that and answered it in your presentation, so I want to thank you. I also want to thank Dr. Taimanglo for her testimony, very grateful for her service and the work that she and





her team do for our community at DOC and Mr. Carbullido I wanted to give you the opportunity to talk about the level of behavioral health services that are provided to our inmates, our detainees, I know that there has been great concern over the last few years that the capacity just is not there to provide adequate monitoring of you know everyone, the entire at-risk population at DOC, so I wanted to give you the opportunity to talk about the existing situation with regards to behavioral health and what your plans are to improve.

Acting Director Joseph Carbullido (Department of Corrections): Sure, thank you Senator for that question. So, I believe that our forensic unit which deals with the behavioral areas that your concerned about, they are doing a magnificent job, despite maybe four personnel including Dr. Taimanglo. We are in the process of also improving in that area because we are hiring. We are hiring several more employees to add to that unit. Knowing what the importance is of that unit and what their capabilities are as far as the need. So the current protocol is that there is a remedy request that is put in for every inmate or detainee that needs that service, once that remedy request is received, then it goes to one of the psych techs from the forensic unit and they make the assessment and they provide the services that is needed. It is not just that we are waiting for a remedy request to be given by the inmates or detainees, the officers are also responsible for observing and making that decision as far as who may need that service. So yes, I agree that there is a lot to be probably done as far as improvement, to ensure that all of our clients, our clientele is given that service however, at this current time we rely on what we have currently, which is the remedy requests and the observations from the officers.

**Senator Regine Biscoe Lee:** Thank you very much Mr. Carbullido. So, remedy request assessments and the officer observation and then just correct me and are you still requiring that an intake assessment or evaluation is done for every single person coming in.

**Acting Director Joseph Carbullido (Department of Corrections):** That's correct. They are there's an assessment that's made for every detained that comes in or inmate.

**Senator Regine Biscoe Lee:** I also want to thank you for mentioning the EO by the Governor and that you have an MOU forthcoming. I just wanted to give you an opportunity if you're able to share any of those highlights or details with the committee regarding the MOU and what you hope to see with your collaboration with behavioral health and the behavioral health.

Acting Director Joseph Carbullido (Department of Corrections): Yes. So, the intent because of the lack of space up at the Guam Behavioral Wellness Center right now currently there's a lot of challenges that they're going through and we're having to like really struggle to help each other





at this point in time especially with the court mandates when the court you know gives a court commitment order. Sometimes they force the issue and they kind of like at odds when it comes to enforcing the court order because of the lack of space that's required up at the Guam Behavioral Center. So, that's the main basis of why we are we're in discussions of the consolidation of these services. We have an identified area which is our post 7 that's going to be the new Inpatient Adult Unit (IAU) that's what it's going to be referred to which is the annex of the Guam Behavioral Health and Wellness Center. So, once that's standing up and standing which it's not right now because of the Covid situation we've prioritized that area right now for our isolation section. Based on the especially with the testing the priority testing that's forthcoming right now. So, when we get to that point we we're still in ongoing discussions with Guam Behavioral and Wellness Center to come up with the MOU it hasn't been completed but when we get to that point once we're past the hurdles that we're in right now with the ongoing testing then of course that would be stood up and that would kind of remedy the situation with all the influx and court orders and court commitment orders that they Guam Behavioral can't manage right now. So, that's the reason why we've consolidated service so that we can have both the inpatient and outpatient services.

**Senator Regine Biscoe Lee:** Thank you very much. I wanted to ask does DOC owe any money to GMH for medical services that are provided to inmates and detainees and if so can you give us an idea of how much is owed and what the plan is to pay the hospital.

Acting Director Joseph Carbullido (Department of Corrections): So, we have a contract with GMH for medical services that contract I believe somewhere around three million dollars every year and I'm not sure where we're at in our billing. We do fall behind to be honest with you, but I try to push it out as much as I can as fast as I can to make sure that we pay our dues.

**Senator Regine Biscoe Lee:** and how would you characterize the quality of health care that's being delivered based on this contract?

**Acting Director Joseph Carbullido (Department of Corrections):** Based on my observations we've done the best we can as far as providing the medical needs of our population.

Senator Regine Biscoe Lee: Thank you Mr. Carbullido. I also acknowledging that my colleagues also may have questions and I did hear something during your statement and it kind of there's a light bulb went off you were mentioning your concern with kind of breaking the cycle and not having DOC be a revolving door for inmates and that's certainly something that's a concern for me and many members of the legislature as well so I just wanted to give you an opportunity to kind of elaborate on your plans to address this concern about recidivism and not having this be a revolving door.





Acting Director Joseph Carbullido (Department of Corrections): Yeah, so I mentioned that because I'm trying to focus and emphasize rehabilitation. The programs the programs are very important re-entry programs right. So it starts actually when they first come in through our doors so we need a really good programs to ensure that our inmates are given the opportunity to get involved in these programs that are provided to ensure that when by the time they're eligible for parole and to start getting ready to go back into society that we make them ready and be productive members of society instead of just pushing them out and making it a community problem. So, my focus is to ensure that our rehabilitation programs are solid and that everyone has the opportunity to avail to those programs and to prepare them to be productive members of society once there they re-enter back into the community.

Senator Regine Biscoe Lee: Thank you very much Mr. Carbullido again I just want to thank everybody who's provided testimony for this confirmation hearing I think it was very um it really helped to give us an idea I mean I don't know you personally but now I do feel like I kind of know you. It was really great to hear all about all of your years of service about your destination and the integrity that you bring to your work and I certainly appreciate that and I look forward to your confirmation I look forward to confirming you and I just really want to thank you in advance for your work that you'll do on behalf of the people of Guam. Thank you.

Acting Director Joseph Carbullido (Department of Corrections): Thank you, Senator I appreciate it.

Chairman Jose "Pedo" Terlaje: Senator Lee thank you very much. Joe I just wanted to check with you, or do you want me to go because the next speaker would be Telo.

Senator Joe San Agustin: continue to move because I'm next after anyway and I'm gonna support Joe so let's do it. We got Louise there Senator Louise so we're gonna you all got supporters.

Chairman Jose "Pedo" Terlaje: Senator Telo, go ahead. Go ahead.

Senator Telo Taitague: Si Yu'os Ma'ase, Senator Terlaje and Joe I noticed on your background your confirmation hearing at home during lunch and then I'm here at session hall right now getting ready to go into our session. But, I didn't want to miss your confirmation hearing and it meant a lot to you when you hear what everybody has to say and you know I think you were choking up when your sister Julie was speaking on your behalf and that always touches my heart when you get your older sister coming out and talk on behalf I think I saw a tear in your eye there you know. So it's always and Julie is such a sweet person it's a reflection of the family and appreciate hey Julie yes of course and just be there to support you with saying so much about the support you're going to get because you're going to need a lot of support in the position you hold like your daughter has mentioned earlier. So, Joe you know I've known you to be a very quiet guy and I've learned that don't underestimate the quiet ones you know at all. I know that you're





a listener so it's very important but what I usually do is I talk to a few people at the um a few officers correction officers and asked them how it's going with Joe so far. How is it you know as a Director? How's he doing and this is the first time in a year and a half that I've gotten from all people I've spoken to great attributes about you. One of them says oh we're getting paid our overtime you know which has always been an issue so for these individuals to talk highly about you the officers there at DOC it speaks highly about you and I'm really happy to hear that because you know you had me at musician. Fellow musicians we come a long way. So, Joe how long have you been at DOC? You know since you've been here how long has it been?

Acting Director Joseph Carbullido (Department of Corrections): I think I was first detailed up there in September 26 if I'm not mistaken. Okay, September 26 of last year. Yes.

Senator Telo Taitague: So, you've been there long enough to see what's needed and definitely get a report card from some of your correction officers. So, and they gave you all A's so I'm giving you an A as well Joe. Good luck to you and thank you so much for serving in this very difficult position. It's a hard position of all the other directors so my hat's off to you and to all those who testified on him. Tom, I loved your Ronald Regan yes biba. Excellent excellent commentary there uh thank you everybody. Thank you, Joe.

Acting Director Joseph Carbullido (Department of Corrections): Thank you, Senator.

Chairman Jose "Pedo" Terlaje: Thank you, Senator Taitague and um going forward Louise Senator Louise Muna. Go ahead, mam.

Senator Louise Muna: Thank you. Thank you, Mr. Chair. I was hoping that you would pick me next so I could get out of my car I've been actually sitting in here. I was even considering going in the backseat because it's actually darker there but uh that would look really weird, I would feel very awkward talking to Director Joe in the backseat. But anyway, Director I just want to thank you for stepping up to the plate again You know, it's not an easy job. One of the things that I would recommend, you know, when you get confirmed, is that, you know the media is so quick to acknowledge and promote all the controversy and inconsistencies with every agency, and I think maybe a good thing to do is like, you know, just keep in contact with the media and let them know all of the great things you, you know, acknowledged in you testimony. And I think that's a good thing. They should know that because you know, most of the time, people only hear the bad stories and they all need to hear the good things that are happening at the agency. And so, create, you know, create that, create that that positive attitude towards DOC now. And I think that's what people really want to hear; you know. And so, I'm really looking forward to you stepping up there. You know, I know you are, you're from Dededo. I read your packet. I know you're a musician. I've known that for a while now and I also see you at the gyms. So, you know, I think that all around, you're a very good guy. And even though we're hearing all these





testimonies from all of your colleagues and the public service agencies. I think one of the ones, the testimonies that I appreciate most, are the ones that are coming from your family to include your sister Julie and your daughter Katrina and even from Tom. Those are the ones that are important to me because those, those are the testimonies that really speak of your character and how you are gonna carry yourself out as the director for DOC. So, I really appreciate them coming up and talking on your behalf, that those emotional testimonies are very important, especially to us. We need to know who you are, from the inside and out as well. So, thank you very much for stepping up to this plate and you know, we look forward to you doing a lot of positive things for DOC and thank you again Joe and for liking Kalapana as well too.

Acting Director Joseph Carbullido (Department of Corrections): Thank you, senator.

Senator Louise Muna: You're welcome.

Chairman Jose "Pedo" Terlaje: Thank you very much Senator Muna. Going forward, I'm going to allow my favorite senator from budget. Thank you, Joe, for being the last one because, you know, we're late already, but that's okay. Go ahead.

**Senator Joe San Agustin:** Now we're never too late. We're going to take care of Joe. We're going to take care of DOC. You know there are many testimonies that have been presented. Can you hear me okay Joe?

Acting Director Joseph Carbullido (Department of Corrections): Yes, yes sir.

Senator Joe San Agustin: Okay. You guys can hear me well? Okay. You know, the testimonies that have been provided; I've been going in and out of it, but I've been listening to the, to the confirmation and you know senator, Senator Terlaje and Director Joe. You know I like how Tom presented a Reagan quote, but I'm surprised he didn't try to use John F. Kennedy, whereas, ask not what your country can do for you, but what you can do for your country. And what Joe has done, he didn't go and ask the community what he can do. He went and did what he could do for the community, which says a lot and every company starts off with a decision to try.

Acting Director Joseph Carbullido (Department of Corrections): Yes Sir! I'm in favor of trying to reduce the population that we currently have now. I would just like to have it go through the regular process as far as our case works with the classification committee and ensure that they do fall under that eligibility status that you know they're required to so long as it goes through the proper protocol and they're eligible like the recent. We've submitted to the governor already the recent graduating cycle and for her possible commute and commuting in their sentences.

**Chairman Jose "Pedo" Terlaje:** I'm talking about maybe misdemeanor things like that and those are the type of inmates that I'm talking about, so i'll be talking to you and Melanie later on





that one another thing Joe that I wanted to talk to you about about the reserve program because I am not sure I don't remember putting that increase for the reservist from 250 to 500. Is that in your budget Joe? I cannot remember you know when you get to be my age sometimes you forget but this is what I want to do all post certified is gonna be part of that race from 250 to 500 and that's what I'm going to do to make sure that you know we satisfy those workers that are doing that another thing Joe. I've been called by the families to remember Mashburn who was killed by the DOC. I just wanted to give you my thoughts about whether or not they wanted me to change the Department of Correction to Mashburn Correctional Facility. It's up to you I'm gonna take your word for it and if you want me to do something like that to change the name from Mashburn from DOC to Mashburn Correctional Facility. We can talk about that later on though.

Acting Director Joseph Carbullido (Department of Corrections): Yes, Sir!

Chairman Jose "Pedo" Terlaje: I just want to close this confirmation hearing and I'd like to thank all of you who participated into this confirmation hearing for Joseph S. Carbullido and if you have written a testimony you can email it to my email senatorpedo@seantorjpterlaje.com or hand deliver it to my office at 140 Aspinall Avenue Bridge Point Building Hagatna Guam, and the time now is 2:36 and the Committee on Public Safety, Border Safety, Military and Veterans Affairs, Mayors Council of Guam, Infrastructure Public Transit is now adjourned. Thank you very much everybody, thank you Senators! Let's get over there for the budget. Thank you, Joe!

The confirmation hearing was adjourned at 2:36 p.m.




