



Belinda Gonzalvo: Yes, hafa adai and good morning. My name is Belinda Gonzalvo I am the wife of Engineer Manuelino Gonzalvo, I presented myself here today just to give my support to my husband's nomination to the Guam

Chairman Jose "Pedo" Terlaje: if I may interrupt, I need to lay out the rules in as far as this decision is concerned. So, let me just say that when called to speak please ensure that you are unmuted and that you are speaking into your microphone that's number one. Members of the Committee and or the Legislature wishing to speak may indicate their desire to the chair through the in-app chat feature. Individuals testifying shall first be recognized by the Chair yours truly before speaking and shall state their name for record keeping purposes. The order of questioning will begin with the panel of Senators, who shall complete their lines of questioning, the Chair will pose questions. Each member will be allowed to pose a question to an individual testifying for a round and will be provided another round, if needed. Questioning and testimony shall be confined to the substance and nature of the agenda. Personal interference as to the character or the motive of any senator, or any individual testifying, is NOT permitted. Any violations of this general rule of conduct will result in removal from the Public Hearing by the host. Now, Belinda sorry for interrupting but you can go ahead and do your testimony.

Belinda Gonzalvo:

Chairman Jose "Pedo" Terlaje: You're on mute right now let me try to get you on. Belinda can you try to unmute yourself. Ok thank you.

Belinda Gonzalvo: Ok, so I may proceed. Hafa Adai and good morning. My name is Belinda Gonzalvo wife of Manuelino Gonzalvo. I presented myself today in support of my husband's nomination to the Guam Building Code Council. I am confident that my husband will be a valuable member of the board. His knowledge and experience as a professional engineer and as a contractor will be a great contribution to the board. He is a very hard-working man and his dedication to work never cease. Day and night, I see him work communicate collaborate with other professionals and making sure that his projects are well done, and he will take good care of his workers. He is a good employer at the same time and a good provider to our family. So, with all of that I am very confident that he will serve as a good member of the board. Thank you very much.





Chairman Jose "Pedo" Terlaje: Thank you very much Belinda and you know I was looking through Mr. Manuelino your husbands record of accomplishment and I know and I truly believe you that what you had mentioned you know going through his record he has really serve a whole lot of well agencies in that time that line of work and I truly believe you. So, with that Mr. Manuelino Gonzalvo go ahead sir you're online you can try to unmute yourself from there.

Manuelino Gonzalvo, Nominee: all right can you hear me?

Chairman Jose "Pedo" Terlaje: I can hear you now.

Manuelino Gonzalvo, Nominee: Okay, good morning to everyone. Good morning to Mr. Chair, Senator si Pedo Terlaje and we thank you for inviting me to this hearing so that I could start sharing my personal background information's that hoping and praying that it will lead to help to the community as well. I just wanted to want to special mention the it's testimony of my wife. I am very happy and emotional when I hear it from my wife, we seldom talk about things the emotions when were home and thank you for my wife and make me more inspired.

Okay, so my name is Manuelino Manny Gonzalvo they call me actually Manny I guess because the name is so long so I'm they always call me Manny all the time and I'm a fifty three year old um they generally my exposure my work experiences is more on a private sector but as I will explain later on I also was part or I am part of some civic organizations engineering organizations at the moment so that should also help me express what I have talent that I have experiences. So, as a working student I finished my undergrad degree The Bachelor of Science and Civil Engineering in University of Mindanao and then years later I took my Masters in Civil Engineering specializing in a structural side of engineering and while studying while working I'm studying at the same time.

So, I started as a civil engineer side field engineer in a real in Philippines. I was raised and born in the Philippines and moved here in Guam and I was 25 years old. So, basically more than half of my life I'm here doing all the experiences talents that I had developed throughout the years. So, my first work was working for a developer multics realty in Philippines is we develop more on subdivisions and then I went to next to that I went to more now on the engineering design this disable and structural design and I was working for a multinational company in Makati area from 1989 and then to basically up to 1991 before leaving for Guam. So, I worked with two big companies there one is PCGI Philippines Consultant Group the other one is Trans-Asia Consultants Group before which has also a branch in Guam before and then come 1991 I moved to Guam and I worked for Architectural Engineering Services who at that time was owned by John Sherman. So, I sharpened developed all my engineering and common-sense talents in the company and I worked for him like 13, 14 years and during that time that's where I also happen to partake the licenses.





First, was the engineering in trainee and then I have the professional engineering exam that I passed and so I have the I am currently licensed professional engineer in the island of Guam. I also have my active license as a civil engineering in the Philippines. So, my exposure at the time is both engineering design civil and structural at construction at the same time because at that particular time the design built concept is started to shine actually it's been there for a while but Guam adopted that a little bit late. So, one of the noted projects that we did as a design-build project is the outrigger hotel. It was done some time in 1994. So from the foundation design of course from the soil investigation foundation design the whole the whole A and E design I was part of the design group and even on the construction when we needed the materials to buy off island so I was part of it was a good experience and be able to share in coordinate with other disciplines and on top of the outrigger hotel we also did one of the power buildings in Manenggon Hills, the hotel up there. We also did the plaza in Tumon that's owned by the Tanaka Partners. When the economy went down a little bit in 2004 - 2003.

So, I was focused to put up my own company and that's where Z and P Builders started with the construction. I started from small renovations and extensions of the house and because of the trust and good relationship with the client and the customers. I was able to do multiple projects like commercial buildings, Sports Complex like part of the Guam Football Association in Harman Loop Road area, Subdivision office and Federal offices.

So, during the course of my work my number one goal is to establish a good relationship with the client and work with the client so that at the end of the project everybody is happy. I'm aware that there's so many projects. Sometimes it ends up very bad for so many reasons but so far so good and thank god that everything that almost I would say 99% of my project ends up good, at the same time during construction time I'm still active also in the civil structural design work.

So, most of my project I'm the structural designer of record and part of that I did was the hunger down in the National Guard like two years ago in Barrigada. It's a six million project by the Federal of the guard and I was the civil and structural designer of record of the project and at the same time because of the exposure in construction they also hired me as a subcontractor for civil work and structural work and even the erection of the metal building from top to the bottom to the last anchor bolts of the building. So, I have the privilege to be part of the project and at the same time doing the engineering civil and structural part of the design of the project.

There are more than a couple of projects that I did as I've said most of my projects are all in the civil and structural designer of record. So, when someone approached me to offer me to be interested in being a part of the Guam Building Council I did not hesitate to say yes. One reason being is that during my design days I went to attend a couple of times like two or three times attended the symposium for building codes and in the States. So, I have the rest of the changing of the code because the code changes like every three years Guam has still the 2009 and yet the





nationwide is 2018. So at the same time the Public Interest I would say as we age we of course work for the family, we work for the children for school for their better future but there is an instinct of me that it's also time to give back to the community. Okay, then one of the discussion there is a very minimal fee when you go to a meeting and it goes the purpose my concentration is being able to contribute to what I have in terms of talent, experiences, and exposure to the industries. I remember because I'm a member of the I'm Alumnus of the University of the Philippines. So, one time we had that project and one of the projects that we did was to build and give it to the government accursed in the western part of Agana Park area.

So, I was the structural designer of that thing and we went to check the construction and somehow try to refresh that desire to contribute to the public in a way that I can. That's my goal even though I'm still at my young age and I'm still probably left on the peak, but my desire to help the community because I already actually studied that on my experience when people call me especially the small contractors, for example when they try to construct and they don't know about setbacks and they don't know about what needs to be done to get a building permit free of charge, I go to their side and help them. Same thing especially on the religious side I did a lot of projects in terms of engineering that I do the services for the church for free. So that desire to help my fellow man and of course the island of Guam is there and it's burning. That's why our eldest in the States is doing his studies right now and I always tell him come back to Guam and share your profession and right now he is taking law in the States. I hope one day he will come and also help.

So that's the general perspective Mr. Chair of who I am and what are my goals in my life and how to go through the years to come in the island of Guam because whether I like it or not I'm already here for like almost 30 years so this is my home even though I'm from the Philippines this is our home.

Before I end my talk, I want to thank the Governor Lourdes Leon Guerrero and Lieutenant Governor Josh Tenorio for appointing me to the council and again thank Senator Terlaje for giving me a chance to share. I think this is the start of something public that I can contribute to the island of Guam and again thank you, thank you very much.

Chairman Jose "Pedo" Terlaje:: Thank You Manuel and with regarding you had mentioned the Governor and the Lieutenant Governor both of them do make that right choice and I know that if you are confirmed, you'll be an asset to the contractors license on board. Like I mentioned earlier that I used to be in the R and E, but I really don't know too much about structures, engineering, and all that. But I'm pretty sure that with your not only with your educational background but most importantly your skills, your experience, your working experience in engineering and I know you'll be an asset to the government and even to the people of Guam. I want to thank you and your wife for being here with us. I know that with your record of accomplishment that you will do good and you will help out in every way you can to make sure that the Contractors License





Board is really good with the people that have the knowledge to make sure that we maintain those things that we need to do for our people. With that I just want to do a closing statement here. I want to thank you again for taking the challenge and I'm pretty sure that with your record of accomplishments and my recommendation and the recommendation of the body, I am pretty sure that you'll be confirmed. I can assure you right now that with your record of accomplishment most likely not most likely but for sure you're going to be confirmed. I would like to thank all of you for your participation into this confirmation hearing for Manuelino L. I'm on the second floor and if you need anything or if you need to deliver a testimony. I'm open for business all the time. The time now Ladies and Gentlemen is 10:54 and Manny let me just say that I'll be meeting with you.

Manuelino Gonzalvo: Yes sir, Thank You Senator!

Chairman Jose "Pedo" Terlaje: I want to be with all the engineers that have that professional knowledge because you guys are really part of sharing those skills and making sure that we take care of our building especially in Guam where we have earthquakes and all the incidence of disaster I know you guys would do well. I want to thank Belinda for showing up and hopefully we can all meet and kinda just do a round table for the things that we need to address on the issues that we have. Thank you very much! And with that this confirmation hearing is now adjourned. Thank you very much!

The confirmation hearing was adjourned at 10:54 a.m.


