The Virtual Public Hearing was called to order at 5:45 pm.

**SENATOR KELLY MARSH (TAITANO) PHD., CHAIR:** Hafa adai todus hamyo, thank you for your participation in today's virtual public hearing. This virtual public hearing is convened by the Committee on Heritage and the Arts, Parks, Guam Products, Hagåtña

Revitalization, Self Determination, and Regional Affairs. The time is 5:45 pm. This virtual confirmation hearing is now called to order. *Si Yu'os ma'ase'* for your virtual attendance to this afternoon's hearing.

On the agenda for this afternoon or early evening's virtual confirmation hearing, are the appointment of Joseph D. Certeza to serve as a Member of the Board of Directors, Guam Council on the Arts & Humanities; the appointment of Jillette Leon Guerrero to serve as the Director of the Guam Council on the Arts & Humanities; and third, the appointment of Monica Giger to serve as the "Youth Member" on the Department of Parks and Recreation Commission.

The Committee will receive oral testimony for *I Maga'håga's* nominees. It will continue to accept written testimony from the general public, which will be made part of today's public hearing record. So right now, we are fortunate to have the Minority Leader Senator Telo Taitague. *Si Yu'os Ma'åse'* for your attendance. There may be a couple of other Senators that will be joining us later on.

So next, we'll go to introducing Mr. Joseph D. Certeza, the CAHA Board nominee. We have Ms. Jillette Leon Guerrero, the CAHA Acting Director, who is nominated to be full Director, as well as Monica Giger, the DPR Commission Nominee. We have the Department of Parks and Recreation Acting Director, Mr. John Burch, and we also have two of my Committee staff members; Mr. Roland Villaverade and Mr. Victor Lujan.

Thank you so much all of you for joining me. Now before we receive and hear oral testimonies from each nominee listed on our virtual public hearing agenda, I'd first like to provide some general rules of conduct for all those who are participating and in attendance. The conduct of this hearing shall be as follows:

- All participants must abide by rules of conduct and quality assurance standards, including broadcasting from a quiet room with little to no interruptions.
- The use of virtual backgrounds is not permitted.

- Broadcasting from a room with adequate lighting, specifically to ensure that a participant's face is not backlit but visible at all times.
- Please ensure that you are unmuted and that you are speaking clearly into your microphone when it is your time to speak.
- I will invite a nominee in the order listed on the agenda and then recognize individuals who have signed up to testify for the nominee.
- Individuals providing oral testimony shall first be recognized by the chair before speaking and shall state their name and title for record-keeping purposes.
- The order of questioning will begin with the panel of Senators who shall complete their line of questioning for each nominee. It may just be the minority leader and me, so we will just go back and forth and take turns.
- Each panel member will be allowed to pose one question to the nominee and then be provided another round to ask questions, should that be necessary for the nominee or the testifying panel.
- Oral testimonies received shall be confined to the substance or the character of the nominee. Discussion of motives of any Senator or individual testifying is not permitted. Any violation of this rule of conduct will result in removal from the virtual meeting room by the host.
- I ask that all participants keep their comments or testimony to within 5 minutes.

Each Board is unique in its purpose, mission, and role. It may be virtual this year, but you know, we have the national basketball team and others, so it won't always be in our facilities. Still, there may be opportunities that someone with your background and some of the other board member backgrounds that they can be thinking about how this fits into that bigger picture. As to how to serve our youth, using our facilities in various ways, to prepare them for these kinds of activities.

Part of what I wanted just to point out is some of what you will have oversight of, along with the Director and the other Board Members. So, we do have the Territorial Park System, which consists of quite a few Parks throughout the entire island. Maybe one of the things that the Board will be deciding on when they first get together, which is hopefully soon. You're going to be meeting that will be making up a quorum soon is whether you're interested in touring part of a good portion of

these parks and facilities to get an understanding of where we're at. I will say that the Acting Director has been incredibly active, and I'm incredibly grateful that he has been ever since he's gotten in.

He's been rehabilitating a lot of the facilities and just safeguarding the parks and so forth and then getting the budget so Senator San Agustin should be glad to hear that. Getting the budget together, getting the structure of personnel needed together, and he'll be able to work with the Board once you all begin to start meeting about some of those sorts of issues. I think each of you is in excellent hands.

So in addition to the Territorial Park System, there are those facilities that I mentioned, and they get a lot of heavy use and keeping them in good working order and maintenance. It's been an issue for a long time. They get a lot of heavy use, and perhaps there's room there for awareness programs or just helping people understand how to help take care of those facilities so that they continue to serve everybody.

Going back to some of that conversation that I had earlier. Even the arts can be part of this. They can be helping people understand how it works, understand why they should care about contributing to not littering in the parks, and helping take care of the facilities. The artists could be part of what you guys do to convey some of these messages. Part of their responsibilities, of course, are helping keep the island beautiful through the parks and maintaining the parks and the facilities.

The Paseo is there as well. The pools that we've heard about a lot this year and have gone through challenges for many years are part of what you need to look at, and again, I appreciate the Acting Director. He has taken that very seriously. He has looked long and hard at the pools and their needs to assess them and so forth. But again, this will be something that the Board Members will also be looking out. You guys work closely with the Director and give him some guidance on some of the vision that the Board has and that he puts that into action. It's a very close relationship that you guys have. Part of this as well, just to go through some of what you'll be overseeing, is that there are lifeguards and park patrol officers that are part of this whole picture as well.

I don't want to forget... because I think maybe not a lot of people understand that the public cemetery is also under the Department of Parks and Recreation. There may be ways that that comes into some of the discussion of the Board and certainly it's some of the work that the Director does daily.

So, with the Board Members, the duties, one of the first things that you will be doing is appointing the Director. The Board will get together. They will review the work that's been going on and the qualifications of the Director and then determining if they are going to appoint him and discuss a variety of the Department of Parks and Recreation matters.

And you will be responsible for creating a report. So not you alone, obviously, but the Board all together and working with the Department of Parks Recreation. What they do is each year, they develop a report to outline the activities that took place over the year and then their vision for what they will be tackling for the next year.

You've spoken a little bit about some of your vision. For Acting Director Burch...is there anything that I left out that you'd like to add in for her to consider as a Board Member?

MR. JOHN BURCH, ACTING DIRECTOR, DEPARTMENT OF PARKS AND Yes, you left out that we also have historic preservation, which plays a big **RECREATION:** part in preserving our culture and our history.

SENATOR KELLY MARSH (TAITANO) PHD., COMMITTEE CHAIR: Yes, thank you for that reminder. What we did this year and I'm not sure that they've done it in the past, but we put the historic preservation entities together. So, that isn't under my oversight, and I did forget it, so thank you for reminding me. It's a very important part of what the Department of Parks and Recreation does.

My background is in historic preservation, so you would think that I would have remembered that off the bat. But it's true; they have responsibility over a hundred and sixty-six historical sites throughout the island. They have responsibility for nominating new sites. The maintenance of them. The safeguarding of them many other things like that.

Now they do have a historic preservation review board that does work closely with that Historic Resources Division, but that all comes under the Department of Recreation, which means that you have that higher level of oversight there.

MR. JOHN BURCH, ACTING DIRECTOR, DEPARTMENT OF PARKS AND **RECREATION:** Yeah, not much else, Senator. You covered quite a bit.

SENATOR KELLY MARSH (TAITANO) PHD., COMMITTEE CHAIR: Yes. MR. JOHN BURCH, ACTING DIRECTOR, DEPARTMENT OF PARKS AND RECREATION: I plan that I recently just got all the contact numbers and contact email addresses, so I'll be sending out very soon a proposal for them to have their first meeting and select their officers. Because we don't have any officers there and then, of course, decide on the Governor's nominee. Hopefully, by then, I'm hoping that Ms. Giger does receive confirmation so she could be a part of that. But even if not, I will still send them, so also though they won't have voted, their votes won't count. They were still participating. I plan to get that going, so hopefully, they'll have the first meeting this month.

SENATOR KELLY MARSH (TAITANO) PHD., COMMITTEE CHAIR: Great!

MR. JOHN BURCH, ACTING DIRECTOR, DEPARTMENT OF PARKS AND RECREATION: We're planning to be moving forward.

SENATOR KELLY MARSH (TAITANO) PHD., COMMITTEE CHAIR: Great, that's very good to hear, and Ms. Giger and I had talked about that a little bit that we will get your confirmation packet to all, through all the processes as quickly as possible. But even if you are not confirmed until next month as it works its way through the processes, we certainly want you to be a part of the Board meeting so that you're well-versed, you're meeting everybody, and you're part of the activity from the get-go. So, let's see... Was there anything else that anybody wanted to provide as a comment? I think probably pretty good.

So, we've completed our questions and our comments from the Committee, the panel, and everybody else who was here on the confirmation hearing for Ms. Monica Giger to serve as the "Youth Member" to the Department of Parks and Recreation Commission Board of Directors. So what I will do is I will read our adjournment, and I will announce the time of this end.

We are ending that confirmation hearing of *I Maga'håga's* nominee, Ms. Monica Giger, for the position for being a Commission Member of the Department of Parks and Recreation. The time is now 7:10 pm, and I just will go through some closing adjournment business.

So, a public reminder the Committee will continue to receive written testimonies for the next few days.
