

Additionally, through grants and partnerships, the agency hosts quarterly workshops aimed at building capacity for Guam's artisan community. She also led the effort in revising the Strategic Plan for the Council. Guzman advocated for an increase in the annual appropriation for the Council for additional staff.





I am Monica Okada Guzman from the village of Mangilao. It is indeed an honor to come before you this morning to ask for your confirmation on my appointment by Governor Lou Leon Guerrero to serve as a member of the Guam Housing and Urban Renewal Authority Board of Commissioners.

Strengthening communities, one home, one street, one neighborhood, one village and one family at a time is GHURA'S motto and speaks volumes to the breadth of the mission of GHURA and excites me to no end.

As a small business owner, I know the value of hard work. My company, Galaide Group LLC has been in business since 1998 and over the years have been involved in a whole host of community-based projects. I understand the challenges our community faces and just how difficult it is for families to get ahead...especially families with barriers.

Supporting job creation and job retention through neighborhood revitalization efforts is one of the priorities identified in GHURA's 2015-2019 Consolidated Plan and Anti-Poverty Strategy. This is certainly one area which I believe that I can truly contribute to. In 2009 my team and I applied for and was awarded a grant to create and administer an On-The-Job Training and Support Services program through the Federal Highway Administration.

The program was designed to provide training opportunities in transportation related services and targeted towards the underserved sector and included classroom sessions through the Guam Trades Academy and Guam Community College as well as On the Job mentoring from participating contractors. We provided daycare and transportation for individuals with these barriers that prevented them from pursuing training and employment opportunities.

167 participants enrolled and completed various stages of the training, 21% of whom were females and included 16 veterans and 26 individuals with disabilities. Today a number of our participants are actively employed in the construction industry and some are currently enrolled in the apprenticeship program.

The program continues today although scaled down due to budget constraints and we are preparing to launch our next OJTSS grant cycle that will focus on providing training for program management and journeyman certification.

Job creation and or job retention through the support of small business incubator development is another priority outlined in GHURA's strategic plan. As one the founders of the Guam Unique Merchandise and Arts Program, I have been directly involved in small business incubation. I know firsthand that Guam has many aspiring young entrepreneurs wanting to make their mark. Just this past Saturday, we graduated 26 participants in our 16-week GUMA Mentoring and Training program and now some will move forward for incubator funding. This brings the total of our graduates to 246, with 19 new businesses incubated and 79 new jobs created, just in the span of 5 years.

A recently released publication by the National Governor's Association in partnership with the National Endowment for the Arts and the National Assembly of State Arts Agencies titled, "Rural Prosperity Through the Arts and Creative Sector" describes the principals of arts-based rural development and cites examples of how using the creative sector can strengthen economic opportunities and its positive impacts on communities.

In reviewing recent GHURA Board minutes, I was pleasantly surprised to read about the CDBG funded project, the Central Community Arts Hall proposed for Sinajana. This is a shining example of creative thinking... a venue for training and workforce development during the day that will transform into a theater for small productions, presentations and meetings in the evenings and weekends.

This is a prime example of strengthening our community, one project at a time.

With my extensive background in marketing and communications I understand the importance of outreach and I am passionate about our island and our culture. I bring this passion and experience to the GHURA Board of Commissioners. I have to admit, the more and more I learn about the agency, the more motivated I am to serve.

GHURA is so much more than just providing housing assistance to low-and-moderate income renters and homeowners as many would believe. I have learned that GHURA is also about creating opportunities for their client's participation in the workforce and creating positive impacts to our community.

I humbly ask for your support and the opportunity to serve on the GHURA board as a Commissioner and I am now prepared to answer any questions you may have.

Francis Guerrero: Hafa Adai, honorable Chair and members of the committee, good morning, good to see you, I'm here on behalf of Monica Okada Guzman, I have known her for so many years and when she reached out and said Francis, I'm being appointed to the GHURA Board, I was like GHURA it did surprise me; I've known Monica for so many years I'm sorry I'm Francis Guerrero forgot state my name, I've known Monica for so many years and in many different capacities I've worked very closely with her so I truly know what inspires her and what drives her to accomplish things that she does having served with the GUMA Board as well as the CAHA Board, I've worked with her closely on things that she's done to drive arts and arts preservation on Guam. I do know that she's got excellent organizational skills I do know that as a self-employed business person she has huge business acumen that she brings to the table something that could benefit GHURA and its board I also know that in our dealings with GUMA and handling federal funds through a grant that we got, Monica has a strong knowledge and understanding of how federal funding works that I think is something that she brings to the table as well that would help manage GHURA through its board I think the other thing that's the biggest about her that I've noticed in all of the things that she's done there are so many times that she served the people of Guam with so much compassion something that GHURA represents when it deals with all of our people of Guam. They need all the assistance they provide I think she brings to the table a big heart and a big understanding of the people of Guam. Guam as it is today and what Guam needs to deliver for its people, she has served with the government, I know in many capacities as well as in the administration under one of the past governors so she does know the flow of government agencies what it requires what things are needed to do and get things through I know that she works closely with the legislature on many occasions lobbying for just all the things that she does and she's quite good at it. I have to say so that said I think that Monica would be a great addition to the board I think what she brings with her is very fresh and new ideas as the previous speaker mentioned maybe she does become part of what he calls the dream team for GHURA that said I strongly advocate that the legislature approves and Monica's confirmation as member of Guam Housing and Urban Renewal thank you.

Chairman Joe S. San Agustin: Thank you sir ma'am.

Clara Okada Peterson: Speaker Muña, Senator San Agustin, Senator Moylan and Senator Taitague, my name is Clara Okada Peterson and like Francis I've known Monica all my life I'm actually here on behalf of my husband who unfortunately had to leave today and he's asked me if I could you know sit and reread his testimony Carl Peterson. (SEE WRITTEN TESTIMONY). Thank you on a personal note Monica is very organized actually I look up to her in that respect and she's very busy it's gotten to the point when people ask me what she does I say you know that's a really good question because she seems to be in many other activities and when you find out please call me, to give that's just a testament on how she's a very busy person I'm busy too and I feel like when you need to get something done you ask a busy person because they will make the time

endorse her and my family as well endorses her and it would be an honor if you do select her to bin this board thank you.

Chairman Joe S. San Agustin: Thank you matter of fact when I got the email from your husband he was talking more about because we're fellow riders, he's talking more about going to buy another Harley so just to let you know that so that he knows I know that thank you.

Lorraine S. Okada: Good morning your Honorable Chairman, Senator Joe San Agustin, Speaker Tina Muña Barnes, Senator James Moylan and Senator Taitague, my name is Lorraine Sanchez Okada, I reside at 460 Tiyan Place in Barrigada, there's a rhythm there and I am a small business owner the Okada Managing Consulting Services. I strongly support the nomination of Monica Okada Guzman for the position of Board of Commissioners with the Guam Housing and Urban Renewal Authority. I know Monica personally as a sibling in law she always removes the word in law and just considers me a sibling. I know her as a special friend and I know her as a professional in each of these distinctions she has exuded honesty, integrity, selflessness, thoughtfulness and a deep sense of care for others, a visionary leader and is always contributing her time and resources not just to her own business but also to our community as well. I remember back in 2013 when she came up to me and said we need to help these talented and starving artists these individuals are very talented and they can really make a lot of money converting their passion for their art into something sustainable and profitable and so she as a founder of the GUMA which is the Guam Unique Merchandise in Art came up with this idea that if we taught these individuals how to open a business, how to do a business plan, how to market their product, how to sell it, how to make money, we can be able to generate an industry of local artisans today since that dream we have graduated close to 200 graduates from the School of Business and we also have graduated or incubated 19 startup companies or companies that have taken their business to the next level so as you can see Monica not only thinks about herself but she also thinks of the people in this community that need the assistance. Back in 2000 and I believe it's probably 2005, she created a program called the Guam Transportation Training Program where she made sure that our individuals here on this island who are unemployed disadvantaged collecting food stamps and really had no skills to find a job she created this Guam Transportation Program were individuals who are very disadvantaged had the opportunity to attend a training program with the Guam Trades Academy, we graduated close to 400 of these individuals now gainfully employed back in 2009 her assistance was solicited by the Micronesia Empowerment Center to train individuals from Micronesia who have come and migrated to our island lacking the skills, lacking job opportunities she worked closely with this organization and graduated close to a hundred Micronesia migrants who are now gainfully employed so I just want to say that Monica has the ability to identify these neglected groups in our community and build talking about building communities it fits right in with the her membership or her being the part of the board of Director for GHURA because if it's talking about building communities she has proven for the past 15, 20 years that I have known her building communities and generating employment and job skills for these neglected groups of individuals in our islands so I strongly recommend that you consider her and approve her nomination for GHURA Board, thank you.

Chairman Joe S. San Agustin: Thank, thank you Mrs. Flores.

Jayne Flores: Good morning Senator San Agustin and committee members, I'm Jayne Flores the board member of the Guam Women's Chamber of Commerce and the chair of the Chambers Government Committee. (SEE WRITTEN TESTIMONY).

Chairman Joe S. San Agustin: Thank you Miss Flores I like to also recognize that we're joined the panel joined by with Senator Régina Lee most out of the disco Lee but now just Régina who that will work thank you I have one testimony one native endorsement out that I like to read that was sent to my office and was asked by my auntie's that submitted it so as a good nephew I'm going to follow what I've been asked to do okay it says it's (SEE WRITTEN TESTIMONY). Now we will proceed with Monica, ma'am.

Monica Okada Guzman: (SEE WRITTEN TESTIMONY) Before I close, I would like to thank everyone that's here today that took their time to come out and speak in support of me and to my family and my colleagues thank you and Si Yu'us ma'asi.

Chairman Joe S. San Agustin: Thank You Monica, I like to also recognize that other folks that have signed up in your support Joseph Cameron we have also Liz Nepoli we have that's the deputy right, okay we have Pauline Okada and Sarah Dunstan middle name Okada, dream team right Ray but I don't know if Monica got appointed to the right position you know that's because of her background you know I'm just amazed but I like to start out work first with the speaker asking any questions ma'am.

Speaker Tina Rose Muña Barnes: Si Yu'us ma'asi Mr. Chairman an manna si Yu'us to all of you here first I want to thank my Auntie Monica I'll disclose that for the record her mother and my grandmother are first cousins we usually have to disclose that if the relationship is close but I also want to thank I see Uncle Patton and Ling in I see Auntie Pauline, Auntie Sarah and of course she would see Clara who are all here and of course other family members and friends to support you in when Ray said you were going to be a part of his dream team, I said yeah, you're getting a real shining star and when Auntie Tony when the Chair spoke and read and Auntie Tony Sanford former Senators letter and talking about the magic that you will create, I want to say is literally true for the record Mr. Chair, I've been able to work with Mrs. Okada Guzman, I must also disclose that that her husband is very closely related to me we're first cousins and I want you to know that yes he is a Muña Guzman and I want you to know that there has not been a project that she has not worked on that she includes to bring people together create opportunities, make sure people shine while she continues to stay just in the background to see everybody succeed one that brings to mind, Mr. Chair was the most recent one where for many years she did the project almost single-handedly bringing people together it was the festival of Pacific arts in 24 2016 and with all the hard work those she stayed so far behind the scenes after the fact I want to say that the work she does is continues to be recognized internationally and everybody who knows my aunt, Auntie Monica knows that her heart is as good as gold and I'd be literally humbled and honored to see the work of GUMA that you and I see all the players the Chairman is here I saw the work of the students that participated Miss Lorraine, I know that it is not easy to find resources but the opportunity that she creates continues to bring a lot of projects and a lot of federal grants and I know that you're an expert at that I want to say that just you reading your letter wanting to be a part of the GHURA family now I want to say thank you for the blessing because you look at what GHURA has to offer for our residents you look at that you want to tap into those who live within the GHURA community for their training to

look at the training opportunities to look at their expertise in the arts to look at their expertise in what they can be good at and that you're going to pick that up and I want to say that every time you look at you, you can touch something you literally give our people the opportunity to shine and most recently Auntie Clara the GUMA, the GUMA story the over 200 students that have been able to get federal funding just from the little funding that this august body gave I know that you're going to continue to give, I stand and rise in full support I see that you've delineated a lot of projects you want to work with Mr. Ray Topasna. I'm going to tell you they will be really successful with her and your team working together my heart with GHURA is former oversight chair and literally trying to give a better quality of life for our residents is real near and dear to my heart so thank you for stepping up I've got my support I hope that he can put it up for the Mays agenda so that we can approve you right away thank you and thank you for everybody for being here.

Chairman Joe S. San Agustin: Thank You speaker, Senator Lee

Senator Régine Biscoe Lee: Si Yu'us Ma' asi Mr. Chair, good morning everyone and welcome to your Guam Congress building I want to just start by thanking our mega Haga for nominating somebody so capable and to Monica, I had the opportunity of working with you for a number of different projects in the past both personal and professional and so I know from firsthand experience what kind of hard work and dedication you bring to every aspect of your life and so I want to thank you and your family for accepting the governor's nomination and to all of our stakeholders here our community for coming forward and saying very kind things about Miss Monica Guzman one of the things that was mentioned is that Monica builds up communities and she focuses on those who are neglected families with barriers especially veterans our disabled community women and children and you spoke a lot to the breadth of GHURA's mission it's a really big piece of the pie and you know we've had a lot of folks come out here folks from DC folks in our community and we begin to realize that housing really is the key to so many of the challenges that we face. It's the key to a good education you have to have that foundation health employment really getting people in safe and secure housing especially for these struggling families is really the key to help them to prosper help them to thrive and so you mentioned the 2015 and the 2019 consolidated plan looks like we're coming up on the end date for those things I wanted to just ask you know sounds like it's time for a new plan in your mind what would the new plan entail how would the new plan be different from the current consolidated plan that we have.

Monica Okada Guzman: Your right senator it is the 2015 to 2019 consult a consolidated plan and my understanding is they're already working on the 2020 plan I think if you go online, they are accepting comments for on the plan and I'm sure maybe Mr. Topasna I can speak a little more to the content of the plan but if it's anything that is any similar to the 2019 plan there's so many things that they that are included in the plan and I'm sure with just a little bit of overview the Board of Commissioners along with the staff of GHURA will be able to focus and hone in on strategies that are achievable and will be beneficial for the clientele of GHURA and the island in general so more on that thank you.

Senator Régine Biscoe Lee: Thank you very much Mrs. Guzman again I just want to thank you certainly have my support and in terms of achievable strategies I also want to ask should you be confirmed that you continue to come back to this body continue to communicate with us and keep us abreast of your plans and how we can assist in making sure these strategies are achievable and just give the most bang for our buck for the people of Guam, Si Yu'us ma'asi.

Chairman Joe S. San Agustin: Thank you Senator Lee, Senator Telo.

Senator Telo Taitague: Thank You Mr. Chair and wow what a great contribution to this board to have Monica their Ray it's I've known this woman for so long and not only she is fair but she's firm and not only is she kind but she's also creacious so thank you so much Monica I know you have a full plate on you but I'm really glad you're deciding, deciding to do something like this because you know with your background doing something different like in the housing industry is it spreads your idea that actually brings ideas to the forefront of something like this and thinking outside the box you know so your experience is perfect it's on key for this board and you and I we used to go out and have lunch every once in a while, and so I'm excited the next time we go out to lunch so you can tell me about your new adventure at Guam housing and all the way this is what happened and I'm excited for you very excited and it's a great fit for you so good luck to you of course you have my full support and hello to the family thank you so much.

Chairman Joe S. San Agustin: Thank you Senator Telo, Senator Jim.

Senator James C. Moylan: Thank You Mr. Chairman, Mrs. Guzman congratulations I heard great words today I heard the word organized I heard that were busy and then the final one has heard you're in demand so looks like the board got a well welcome a member to the board and so congratulations I'm looking forward to seeing your name on the agenda or for the session and placing my vote so congratulations mame,.

Chairman Joe S. San Agustin: Thank You Senator Jim, Miss Guzman what can I say about you Monica, I known you for a long time known your husband a long time we're in the same party it helps right and then it doesn't matter because what you do it doesn't matter which party you help everybody and that just seems to be your nature and as the speaker's ask that hopefully we'll get this out well I'm only going give it a two days for folks to give their testimony I'll get the packet ready and submitted in as soon as possible cor so we can get into this session floor the earliest session for I just wish best of luck to Mr. Ray because of his dream team or the dream team forming up there the board he's actually got a blessing all he has to do now is take notes from the board and run of it and you know as Senator Lee has ask that come back to this body what I'll do is I'll coordinate with Ray that maybe we'll do some roundtables to find out what's going on in GHURA and half the board all come and tell us all about it do some PowerPoints so we can tell the people who want the exciting news or whatever's going on I know Ray's going to enjoy that because he's able to push this out but you know I do look forward to you know your confirmation you know you've got five of us up here the others we'll just we'll just help out because they know that most of them know your background Monica and if anybody doesn't put up his hand when they ask for your vote I'll be like really come on you know you're it's come up with somebody else but if there's anyone else that would like to testify please come forward and there being none this committee will conclude the public hearing for miss Monica Guzman the time is now 9:42. The committee will continue to receive testimony for the next few days no later than Thursday at 5:00 p.m. and please address your written testimony to The Committee on General Government Operation and Housing, via email senatorjoessanagustin@gmail.com Si Yu'us Ma'asi for your attendance and participation today sharing and for those at home thank you for watching.
