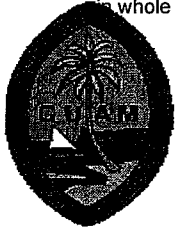



My name is Dr. Kenneth Gofigan Kuper and I am Assistant Professor of Political Science and CHamoru Studies at the University of Guam. I am writing this letter in full support of Nolan Flores' appointment to the Guam Public Library System Board of Directors. He has proven himself to be a hard worker, analytical thinker, taskmaster, and a dedicated and passionate young man. In the Political Science program at UOG, we encourage students to think critically about the mechanisms and structures of power around them and emphasize to them the role they can have in governance. Some students excel at this analysis and critical thought, and Nolan is at the top of his cohort. Nolan enrolled in my International Relations course this past semester and finished in the top 3 of the class. He displayed intellectual rigor, an ability to lead groupwork, and a polished writing ability. Nolan is the type of student who makes professors excited pondering that student's future because we know they are going to exceed and accomplish great things, and he can bring this intellect and analytical skill into the board.

Beyond being my student, I also selected Nolan to serve as my Teaching and Research Assistant this past semester. In his role as my Teaching and Research Assistant, I tasked Nolan with creating an annotated bibliography and research guide for my Introduction to Government and Politics class. The bibliography was meant to assist my students in carrying out their task of writing an essay on political status. To compile the bibliography, Nolan read through countless pages of articles, task force position papers, Guam history books, and Micronesian political history literature. He then condensed this information into a digestible format for my students. Reading through Nolan's research, he demonstrated a capacity for intense research which makes him well-suited to handling any anticipated workload serving on the board may throw his way.

Overall, Nolan would be a great addition to the board, and I highly recommend him. Selecting him would help a young, bright CHamoru man learn skills and insights necessary to helping his home, his island, and his people.

Representative of the Guam Public System Board of Directors. We have some of the names, I can't understand some of the handwriting, but I see Ms. Santos, Rowena, Linda Aguon, June Aflague, Nicole Nelson, Nolan Flores, Hilary Flores, Bernie Quidachay, Kyle Mandapat, Richard Flores and Marissa Mears, okay, thank you everyone for being here. I'd like to call Miss Nelson and Mr. Flores forward and since this is a, you're on the same board, go ahead and have a seat up here, since we're on the same board, we can do you guys at the same time, but if there's anyone that like to give testimony in favor of the two, please come forward. Okay, I'll address Ms. Santos first and then Mr. Mandapat and then we'll move forward with Mr. Flores's testimony and then Miss Nelson's, okay, thank you. Ms. Santos please state your name for the record.

Kyle Mandapat: *Håfa Adai*, my name is Kyle Mandapat and I'm here today as the Chairman of the Board for the Guam Public Library System, as we continue to move forward and make the changes as our name is mentioning in terms of

bringing the library to the next level and to continuing the service that we provide to the children and the community here on our beautiful island, two very, very, very important parts of that puzzle and that plan moving forward are in the technology sector and in enticing some of our youth to continue to see the value in the services that we provide and some of the resources, that are available to them, that don't include a tablet or googling, these two members and appointees, will help us in that, in those areas very much as we continue to move forward, as I said we've got a limited amount of members on our board as it stands and we've been functioning with what I call minimum quorum, with just four members, which again is the absolute minimum that we would need to call quorum and with these two new additions to the board, we'll be able to have a little bit more leeway and greater voice, in these two sectors that I think are very important to the continued modernization of our agency and our group along with the services that we provide. With Nolan, being such a very, very strong voice in the youth community all his great service, all of his great volunteer work really lends to his legacy that he's already begun to build, as one of the more passionate members of his age group and demographic with him comes the youth and the energy and some of the new modern views, that we'll be able to apply to our services and to some of the things that were doing at the library that will help us appeal more to younger groups and to the future group so, that'll be coming through to patronize our facilities. He has gone far beyond in terms of his volunteerism and he's a part of several groups at U.O.G. and I have it on good authority, from people just coming up to me, hearing that he's gonna be a part of this or wants to be a part of this, who say he is a hard worker and his resume proves that. So, we look forward to working with him and with your support to continue like I said, the evolution of our Library system to incorporate, some of the younger and more modern things that the youth and children of today are now considering the norm, that we in yester-year talk, called the future right. Moving on to Miss Nelson, her service to the Government and to the people of Guam, is well documented. Vice-Speaker Telen C. Nelson: *Biba*, and Guam. Mr. Flores, thank you Mr. Chair.

Nolan Flores: *Buenas and Håfa Adai* Vice-Speaker Nelson, *Senadot* Castro, *Senadot* Taitague. *Guaho si'* Nolan Flores, *Si Yu'os Ma'åse* for this opportunity to testify. Firstly, I'd like to share a bit about myself, it has been covered already, but I'll share it anyway. I'm a proud son of *Guåhan*, who was born and raised on this beautiful island. I'm a 2018 graduate of Southern High School and I'm currently a Sophomore at Unibetsedat Guahan, majoring in political science, in both my time in High School and at the University, I've taken an interest in serving our island and our people throughout the years. I've been provided many great opportunities to organize and participate in various community events, most recently I was an intern of the Public Policy Institute with Speaker Tina Muna Barnes and Minority Leader Will Castro, is through these events and experience that I've realized my profound passion for the betterment of our island and our people. I hope to bring the same passion to the Guam for change, I hope to bring the same passion for change to the G.P.L.S. Board of Directors and I hope to continue the outstanding work of the Guam Public Library System and all those who further It's mission. Vice-Speaker Telena C. Nelson: Thank you Mr. Flores. Miss Nelson.

Nicole Nelson: Good afternoon Vice-Speaker Nelson, Senator William Castro and Senator Telo Taitague. Thank you for the opportunity to testify, I'd also like to thank Governor Lou Leon Guerrero for my nomination to the Guam Public Library System Board of Directors. Vice-Speaker Telena C. Nelson: Thank you Miss Nelson. I'd like to open it up to my colleagues for their questions first or comments, Minority Leader Senator Castro.

Senator William Castro: Thank you Vice-Speaker. Vice-Speaker, if I may just offer comments to each of the nominees, is that appropriate? Okay, thank you. *Si Yu'os Ma'åse*, for the opportunity with the candidate I support him, he's a very smart man, he's straight in his path and has a lot of courage for our people and our brothers and sisters, the Chamorro Nation. I know Nolan, he's a fine young man,

he's an excellent representative of his family, his university, community and Madam Vice-Speaker with no exception, a fine surrogate of the Democratic Party of Guam. Senator Telo Taitague: Thank you Madam Chair and thank you for the opportunity. I'd like to thank everyone, who's here today to support the nominees, I'm... This means a lot to individuals, who are being up here today, it's nerve-racking and having you behind them is a great support so, I want you guys to know that. Ms. Santos, thank you for pushing this board to get up and going and I was really surprised about how long it's taken to get quorum. So, I'm really happy, that we're moving forward on this end and you definitely have a great group of people here. Mr. Chair, as Senator Castro mentioned earlier the, I liked what you said the evolution of the Library that was excellent word to be used and that definitely describes on who you're putting onto this board, which is the next generation and

so, Mr. Flores, I was listening intently to Senator Castro's comments about you, he's actually worked with you before and I'm very impressive, very impressive. So, I'm gonna try and convince you later on to be a Republican, so, get ready for that. I will talk to you after this. So, you have my support as well and thank you for stepping up to the plate, this is the beginning, you're studying Political Science so, I have a funny feeling Guam is gonna know more about you in the future, but thank you for doing this and for disclosure, I have to state that Nicole is my Step-Daughter, though was my Step-Daughter and I still continue, to continue to say she is my Daughter and we keep in touch. Vice-Speaker Telena C. Nelson: Thank you Senator Taitague. I'd like to thank those that came forward to give testimony on behalf of our two appointees. I'd like to thank the family or Mr. Flores and Miss Nelson for being present today and showing their support and I'd like to thank you for the willingness to serve, right. Some of the challenges we have at the Library is funding and so, I'm going to need your help and you know the use of the energy that you have as a youth to advocate for the Library, because it's part is a central part of our education system and so, hopefully I see you in the upcoming months, going door to door to each Senator's Office, saying here's a plan, this is where we want to be in these certain phases and we need this money and explain to us how really it's going to impact the children

for many years, there's been some neglect with the Guam Public Library System, since 2010 right. So, now that we're looking in this avenue, a lot of us younger folks are starting to come forward and be willing to serve, then it's a great time to start advocating for these things. I do have some questions for you, what insight Mr. Flores, we'll start with you first, what insight or skills, do you have to offer to the Guam Public Library System?

Nolan Flores: So, I've begun to familiarize myself with, what the Library, as it has changed a bit, since what I've known it, I've been working closely with Director Santos and I definitely think, I have the important, the knowledge of the importance of education and this, this free space of information the Library provides, as well as knowledge on realizing, how it can better promote the efforts of other government agencies, such as our culture revitalization efforts as well as language revitalization, other things we're trying to do on our island, yeah.

Vice-Speaker Telena C. Nelson: Miss Nelson.

Nicole Nelson: I think that my background in I.T., I've actually worked on book digitizing projects before, so, that's one of the main projects I really want to help out with, with G.P.L.S', is a e-book program and I've also worked on automation projects, which I think would help with various Library projects.

Vice-Speaker Telena C. Nelson: Thank you, we also have extension, right, in our villages of the Library System, so those are areas, we need to work in as well, because and some areas are only open for a minimal amount of time, because of the budget they receive. So, like I said, I'm gonna need your help, so that we can grow this so that we can reach out to the community that you know their villages, so that the students can start having longer hours to be in the Library and better resources, because even the amounts of books that are in there are very limited, because of the lack of resources that the Library is given from just as a whole in the appropriations process and allocations. What are some of the goals, you have for the Library?

Nolan Flores: I definitely think the Library needs to advertise itself, really as this the center of information for students as well as even for me as a college students having somewhere to study, even where it's not a café or what somewhere, where that information is right there to access any other, there are efforts with the, with the café going on to further just promote the Library to the youth and show them that this is a place, where you can come and learn.

Nicole Nelson: Yeah, yes like you said, it's a great place for students to go, but also for like the marginalized, who don't have access to internet, they can use it an internet café, if you will. That way you can job search or you can take classes, um that's another thing that I want to get heavily involved into, is teaching our youth and our *manamko*, how to use technology and I think, we can start out by offering like basic courses for free, as well as tutoring students.

Vice-Speaker Telena C. Nelson: Thank you, I'm happy to recommend your appointment, I look forward to your confirmation by this, by this body and I'm going to ask my team, if they can work extra hard to see if we can get this in November Session, so we can get the Library rolling. Our November Session is next week, so we're going to have to do a little extra work and hopefully, I have the colleagues support to try to move you guys forward. Congratulations and God-willing and I look forward to the work, you'll do for the Guam Library System, once again, I'd like to thank you for your willingness to serve the community and also to the family members of the both of you, thank you for your continued support in them, thank you.

Arlene Santos: Thank you Vice-Speaker.

Vice-Speaker Telena C. Nelson: Thank you Ms. Santos.

Kyle Mandapat: Thank you very much.


