## Profile

Upon returning home to Guam from San Francisco in 1979 at the request of his father, Ambrosio T. Shimizu, Paul began immediately working at the family company, Ambros, Inc. Over the next few years, while assisting in various roles from warehouse operations to sales and account management, Paul quickly built a strong understanding of the business and its customers. In April 1982 Ambros Inc., held its first islandwide promotional concert showcasing famous San Francisco Bay Area blues artist Elvin Bishop at Paseo Stadium. This effort generated a new division, SHIMBROS Audio/Productions, a sound reinforcement company to support its many live entertainment promotions.

SHIMBROS has produced hundreds of events ranging from small club acts to major concerts, and from small business meetings to international conventions. Of particular note are the concert productions spanning the 11-year period between 1982 and 1993. Resources, relationships, and one of the finest crews were developed during this time, setting the foundation for the years to follow. Artists and events from that time period include: numerous Liberation Day productions, GMIF productions/concerts, Japan Festival, 1998 Micronesian Island Fair (sponsored by GVB, Continental Micronesia, and AK), FestPac, Relay for Life, Island Visit of President Bill Clinton, Blue Angels Air Show, Make-A-Wish, Philippine Basketball Association (PBA), Santana, UB40, 3 Doors Down, Doobie Brothers, Maxi Priest, and the Stylistics to name a few.

Balancing commitments between Ambros, Inc. operations and SHIMBROS' growth necessitated a strategic pivot in 2015 wherein SHIMBROS now focuses solely on key productions on an ad-hoc basis. Paul is currently focused on working with Ambros' current management team to build out new products and distributorships in Oceania – travelling frequently overseas. He remains also actively involved in the community through work with the Archdiocese of Agana, in addition to village and school events as time permits.

- (e) Provide advice and technical assistance to tourism development organizations in planning programs to attract visitors, and develop and disseminate literature for distribution to visitors, and potential visitors to this territory;
- (f) Cooperate with regional agencies promoting Micronesia and the Mariana Islands as a tourist destination;
- (g) Encourage and support local activities, programs and development which would enhance Guam as an attractive tourist destination;
- (h) Support the marketing of local arts, handicrafts and other manufactured products to visitors; and
- (i) Encourage local cultural activities for tourist and general public enjoyment.

**Paul Shimizu:**

**Chairperson Therese Terlaje:**

Currently GVB allocates 14 and a half million dollars to marketing efforts primarily in Japan and Korea markets. \$950,000 to visitor safety such as contracting visitor safety officers for the Tumon area and a little over million dollars on destination development such as street cleaning and maintenance and others.

Do you agree with in general that type of allocation breakdown or do you have other ideas of how that should be allocated?

**Paul Shimizu:**

I agree in part with the allocation. I do need to see a little bit more of the breakdown but in overall I do agree.

**Chairperson Therese Terlaje:**

All right, we just received the GVB budget yesterday by the way. So GVB budget and so the details are now available and we will be discussing that further in further hearings.

How would you ensure that more small businesses on Guam could access the tourism market?

**Paul Shimizu:**

The small business community is quite large. Their contribution to the economy and what they do in terms of supporting tax in the GRT portion of their sales. To support them, they need to welcome all visitors at whatever levels that they receive them during activities that are near to their retail establishments. It doesn't matter; we just need them to be in the same page, open arms, welcome them to do business there as well.

Welcome to your Guam Congress Building and I say this often but I really it helps to have people from the community, people who know the person being nominated and being confirmed to give their input and they're working with that person there to just speak on their expertise and their background.

And we've heard a little bit of that in terms of Mr. Shimizu being a GVB member, being a member of the chamber, and GHRA and other boards that are related to GVB. And I know that board members are all going to be a part of putting that blueprint together. So currently we have marketing committees for Japan and Russia, for China, all those marketing committees. We have Culture and Heritage subcommittee, Visitor Safety Destination, Management Research but I think the thing that kind of fits really well with your background is the sports and events piece of GVB.

I know that's something that they're probably really looking to you to provide some insight for. So I just wanted to give you an opportunity to talk a little bit about your experience in doing events and how that can be an economic multiplier when we bring in just like this weekend with the incredible United Guam marathon, we had so many I mean thousands of people coming to visit Guam for this particular event.

Some of them are repeat visitors but some of them are coming for the first time just to participate in this event. So I wanted to give you an opportunity to talk a little bit about your event experience. And how you look to bring that to the board to provide that economic multiplier for GVB.

Thank you, Senator. Yes and foremost congratulations to all the people behind the effort for the Guam marathon. It was a very successful event in my observations having over 4,000 participants in that event is incredible.

You know how hard it is to get 4,000 people to come to a music event? It takes a lot of work you know there's a lot of advance marketing. You know you've got to the information to the people early enough. The different demographics.

My background in producing music events and sporting events has to deal with a very thorough checklist. And in that checklist you have to include items and procedures that you normally don't really think of.

And you might tend to forget and I was observing this Guam Marathon and it brought me back to some really big events that we have produced on the island. And just meeting and talking with the key players in there, they've done a lot of their homework.

You know it was well worth their effort and tireless work that they put into that. And if I'm not mistaken, I think there was may be more than eight hundred (800) people

But that type of an experience for tourism just thinking about you know the hikes you know the many waterfalls that we have been there quite a few places that I'm sure that our tourists, our visitors would be interested in having a look and experiencing it.

It may not just be you know the taking a ride around the island itself but there you know a lot of spots that are worth your stop and the effort to actually get out and go visit.

You know it may take some walking but that's a part of us, where we make it comfortable. And our visitors able to do that trek and visit too many spots that I can

mention it at the moment right now but partly tourism I think that could be pushed for especially the independence that come over.

**Senator Kelly Marsh Taitano:**

*Si Yu'os ma'åse'* for that. You know in your mentioning that it made me think of some ideas as well.

So, one of the things that I have taught in my history of Guam class is and many of us perhaps notice that Mount Lamlam or it might be a misnomer with Mount Jumullong if I'm saying that correctly.

But it's the tallest mountain in the world. There are two different ways to measure the height of the mountain; one of them is from the very foot of the mountain. So our foot of our mountain begins in the Marianas Trench that makes it the tallest mountain in the world.

And so I dot sure to what degree we've capitalized on that but I've told my students, I was like you've got to go climb it because nature has done most of the work for you; all you have is the tiny pink at the top that you have to climb.

So I like the way that you're thinking. Something else that you also mentioned with the picking up the trash. I think that there is an opportunity for things like tourism with the cause, people that want to come out and contribute to our environmental issues and other causes with our community.

So I don't know if that's been tapped into but that's always kind of made an impression on me and I'm definitely a big proponent of environmental and ecotourism type of development.

So that's excellent and I just want to mention we're having a resolution in a couple of hours to congratulate our slingers who placed well in the international competition in Spain.

And so when you were talking about sports tourism again I'm not sure to what degree of if there's potential to develop more traditional sports tourism amongst our region. I think that could have a lot of appeal and be a big draw not only for people within our

Illegal dumping or any other kind of environmental concern?

**Paul Shimizu:**

Illegal dumping it just tarnishes our image. It creates an ugly sight for our visitors that we you know that's not us you know but again if we can make the effort you know for all our people here on the island, to be responsible and you know make the effort to put trash where it belongs and to you know adhere to the rules and regulations of disposing disposal trash.

Again its just referring to Senator Moylan, the bathrooms you know its one thing to open the door but you know if it's not clean inside it's also an ugly scene you know and that's something that goes hand in hand with you know waste disposal and emissions.

You know appearance of our public facilities or parks bathrooms especially those things matter and they make an impression. And we want to make sure our visitors take a good impression back with them. So they can tell others to come over and make our destination something that is worth their time and effort.

Thank you. And something that's been referenced, the GVB Tourism 2020 plan. I know that GVB and the board has made many strides in this area of where there's a whole list of weaknesses that were listed for our tourism industry and something that I know we've heard in past conformation hearings for GVB is that we're looking for a workforce that's both friendly and competent.

So as a businessman, I wanted to ask you your thought about helping to develop our workforce to meet our tourism industry needs so that our workers in the tourism industry are just that, both friendly, hospitable and competent.

**Paul Shimizu:**

I just I can just think of just three words Senator. It's training, training, and training; need to train everyone. Everyone involved in the visitors industry. Everyone. Every walk of life. That our people. Hospitality is everything you need to you know bring that

Everyone has to take, make the effort and get themselves trained. To be more hospitable you know let these visitors feel welcomed if you will. And training you know everyone needs to go through it you know everyone needs to be reminded. You know it's very important to be reminded you know it's very important that we project a great image out there of arm hospitality.

So it says in addition Mr. Shimizu is very familiar with the Guam Visitors Bureau. He has helped with productions of different GVB signature events including GMIF, he also understands the value of sports tourism as he himself is a gold medalist having won awards in the South Pacific Games and also traveled to represent Guam in the Olympics in Athens.

And so you know you had mentioned it earlier in terms of Tokyo 2020 and the Olympics is upon us and I know that we have in the past organized certain teams to travel to Guam in advance of the games to do some training perhaps we could look at packages to include a stop on Guam for folks who are visiting Tokyo either before or
