





- Appointment packet forwarded to this committee for public consideration on November 21, 2019

Publication was conducted in the **Guam Daily Post**, a newspaper of general circulation, fulfilling the 5-Day Notice and 48 Hour Notice of the Open Government Law requirements respectively.

The confirmation hearing for Mr. Pelagio S. Sardoma commenced at 9:00 a.m.

II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Perez: As in the previous testimony, we heard this role is so critical. I know Mr. Sardoma has served on this board for many years. We do appreciate that you're accepting this nomination again at this time to serve a critical role.

Chairperson Perez called up the appointee and those who signed up to testify.

Art Ilagan: Thank you, again Senators my name is Art Ilagan. I am here in support of Mr. Pelagio Sardoma. As a member of the Real Estate Board I've known Mr. Pel, since we were young. His son and my son we're classmates in St. Anthony. I got to know him personally but most importantly I know his background was in, he was a CPA. He's a tax preparer, he's also a realtor. Through his experience I asked him to help us with the real estate board and he accepted. He's been in since I believe 2004, same time as Cynthia. He's been there ever since. He has been through

a lot. He has his own private practice and in the early part of his appointment there was a lot of issues that he and the board had to address and which they did successfully. Mr. Pel was very instrumental. He's always in the meetings whenever there's a meeting set up, he's always there early and ready to serve. I am in support of Mr. Pel's nomination to continue. This is his third Governor he will also be serving. He is very dedicated to his work, the board. I would be remiss if he wasn't reappointed. Thank you.

Pelagio Sardoma, *Appointee*: Good morning Senators. My name is Pelagio Sardoma. I have been a member of the board for about 14 years now. I am glad the Governor has nominated me and if confirmed I will do the best I can, just like what I've been doing in the past.

Chairperson Perez: As you can see, you know this board is so critical but it's a very, it seems somewhat obscure into the public's eye. Just a couple of things, some regards to your background or you have, you're a broker for a real estate and just a question about any conflicts of interests. Are you able to identify when those conflicts of interest occur? Maybe start off with that question, do you have any conflict of interest and how do you identify that?

Mr. Sardoma: Then I did not get well the question Senator?

Chairperson Perez: Are there any conflicts of interest? Do you have any conflict of interest?

Mr. Sardoma: No, there's no conflicts of interest but right now we have a mission. She mentioned that there are quite a few appeals remaining and, on the list, I have one. The client that I prepared their books. I also prepared their income tax return so probably when it comes to the table to vote on then probably, I will just excuse myself.

Chairperson Perez: Thank you and so like Attorney Ecube, what are some of the priorities that you see as a board member in the experiences that you've had. What do you see as one of the priorities?

Mr. Sardoma: I guess most of the issues has been already discussed by Ms. Cynthia and as a member whatever is supposed to be tabled in front of us then we can act upon.

Chairperson Perez: I'm sorry can you restate that... Can you restate what you said? Do you mind restating what you said, or do you mind repeating what you said? What are the priorities you see in your experiences, some of the challenges? What are some of the things that you feel is a priority for the board?

Mr. Sardoma: The way I look at it is that as the last appraisal was about four years ago and base in the new law there will be another scheduled appraisal very soon. Then I guess the same as and the latest appraisal we foresee several appeals again.

Chairperson Perez: Thank you for answering the questions. I do appreciate that you accepted the nomination to serve as a board member. Thank you.

Chairperson Perez open the floor to her colleagues

Senator Terlaje: Mr. Sardoma, thank you again for being willing to continue your service on this board. I was looking through an old confirmation packet of yours from 2017 and at that time you had testified that your attendance at the board meetings has been 100 percent. Is it still that? Is it still like that?

Mr. Sardoma: Oh yes.

Senator Terlaje: I want to thank you especially for that. That is very important, and you set an excellent example for the rest of board members. *Si Yu'os ma'åse'*. The last time the reappraisal was done, there was a huge increase in the taxes. When you said, I think you had 800 appeals from that, but you were able to clear all of those I see, at the time. Now we have 100 pending perhaps...

Mr. Sardoma: Less than 50 remaining.

Senator Terlaje: Less than 50.

Mr. Sardoma: I think it's less than 50 out of the 800 appeals, I think about less than 50 which about to...

Senator Terlaje: Great. Did you notice any trends in those appeals, such as is there something that we could do better, I guess on the government side? Was there any trend in those appeals that perhaps the government could use as a lesson and do better in our actions going forward or was it just particular cases?

Mr. Sardoma: I think as far as the government is concerned there's usually no problem. The problem is that as you know this is a mass appraisal and chances are that you know even a professional pressure like that could make one or two mistakes. That's where the appeals arise from.

Senator Terlaje: I forgot to ask the Chairperson when she was here but if I could ask you if you don't mind. My understanding was that at that time of that appraisal the government had contracted for a firm to do mapping. We were able, at least me as a public person, I was able to access maps of land or government. Access through a website land numbers, I mean land lot numbers. I think even at least a map and then that lot number. For example, if I wanted to know who, what was a lot number of this place, I could look at map, see the beach and locate where that is and then find a lot number. Then I could go and make inquiry as to that lot number but now that is not available anymore. The explanation I was given is that it belongs to the contractor and not the government of Guam. Are you familiar with that at all? Was that procured through your board at all?

Mr. Sardoma: I believe that was not presented to the board, that problem, the mapping problem.

Senator Terlaje: Are you familiar with that Mr. Ilagan? It that might have been when you were the Director.

Mr. Ilagan: It started when I was Director, but it moved into John Camacho's administration. It started with my administration. It was our, I guess looking through technology. We even went through off island. We saw how they did their assessments. What we did was we looked at ours and how we could improve it and even make future assessments easier based on what was already recorded. Like you said you can go in there and see the problem. With overview it only looks down at the building, doesn't show how many stories are out there, so somebody needs to go out there to see what it really looks like. That contract was done between the Calvo administration and which was John's. I believe what Cynthia was saying, the board should get involved because they are the ones that are hearing the appeals, on how the assessments were made. I think they should have a great input into what should they require of the contract so that they're done properly. I think Cynthia and Pel have acquired vast experience in the last 14 years on how they should get this thing done so that they can perfect system so that when you do a continual five-year assessment it's... They're ready, you can just do another picture and then say hey you got an extra building here you got to pay for that. It becomes easier.

Senator Terlaje: Yes, I would hope so. That's why it was very confusing to me why that is not available to the government anymore.

Mr. Ilagan: I think what the problem is the way they do the budget. If you look at the budget of GovGuam it seems, and it was like that when I was Director. What they do is they come up with the revenues for the whole government and they say okay this is for Rev and Tax; this is for DOE. They don't ask each department what they really need. When I was Director I didn't agree with the budget. If you look at the hearings, I don't know why they didn't fire me back then. I would say that if you want your department especially Rev and Tax, it's a revenue generating department, you got to improve it to make sure that all income that's out there, that's due the government should be recorded and we should go after them. When your records are not that good, and you go after people who already pay taxes then you have issues with GovGuam really. Senator Lou, she's a banker when you make a deposit today even like two hours later it's going to show up your in your account as a credit, why can't the government do that? When you make a payment at Treasurer of Guam, the computers are there to key it in. It goes into the general ledger so that you know what the amounts are for GovGuam. Then it would go into the taxpayers account and it's right there, it's recorded. I think there's issues there that we try to address. We did the POS system and it costs the government five or six million dollars, but it took care of bounced checks. We didn't have that much bounced checks. Now we have a humongous bounced checks. \$20 who's going to go after a \$20 check. It's very difficult when it costs more to go after \$20 check. When you allow somebody to use their credit cards and not charge them that's the cost of the government. Now we have checks humongous checks that at Rev and Tax. When I was there, they gave it back to motor vehicle, they gave it back to a real estate, they give it back to business license, go collect those things. Who's a collector, they're not, they're gonna sit on that. They don't even have enough staff to work their office so they can service the people. If we just upfront get a system that would allow crediting and allowing revenues that are coming in report, record it right there and credit the taxpayers right there. It's just the system, we have the computer, we need the programmers to get that done and we're good to go.

Senator Terlaje: Thank you, Mr. Ilagan. Thank you, Mr. Sardoma again for your service and please let us know if you find as over the years of, from your years of experience what, how the

government can improve. For example, you're getting your information from the Department of Revenue and Taxation and if you feel there's improvement that they are, that you have suggested and they are being slow to implement please bring it up with especially the Chairperson who is here today. Si Yu'os ma'åse' Mr. Sardoma.

Chairperson Perez: Thank you, again Mr. Sardoma and we appreciate your testimony and your accepting the nomination. You have my support thank you.

Chairperson Perez then adjourned the confirmation hearing for Mr. Pelagio S. Sardoma.
